B. Unless otherwise expressly stated in this Agreement, no addition to, or alteration of the terms of 2 this Agreement or any Exhibits, whether written or verbal, made by the parties, their officers, employees 3 or agents shall be valid unless made in the form of a written amendment to this Agreement, which has been formally approved and executed by both parties.

III. ASSIGNMENT OF DEBTS

7 Unless this Agreement is followed without interruption by another Agreement between the parties hereto for the same services and substantially the same scope, at the termination of this Agreement, 8 9 CONTRACTOR shall assign to COUNTY any debts owing to CONTRACTOR by or on behalf of persons receiving services pursuant to this Agreement. CONTRACTOR shall immediately notify by 10 mail each of these persons, specifying the date of assignment, the County of Orange as assignee, and the 11 address to which payments are to be sent. Payments received by CONTRACTOR from or on behalf of 12 13 said persons, shall be immediately given to COUNTY.

IV. <u>COMPLIANCE</u>

A. COMPLIANCE PROGRAM - ADMINISTRATOR has established a Compliance Program for 16 17 the purpose of ensuring adherence to all rules and regulations related to federal and state health care programs. 18

19 1. ADMINISTRATOR shall provide CONTRACTOR with a copy of the policies and 20 procedures relating to ADMINISTRATOR's Compliance Program, Code of Conduct and access to General Compliance and Annual Provider Trainings. 21

22 2. CONTRACTOR has the option to provide ADMINISTRATOR with proof of its own 23 Compliance Program, Code of Conduct and any Compliance related policies and procedures. CONTRACTOR's Compliance Program, Code of Conduct and any related policies and procedures shall 24 be verified by ADMINISTRATOR's Compliance Department to ensure they include all required 25 elements by ADMINISTRATOR's Compliance Officer as described in this Paragraph IV 26 27 (COMPLIANCE). These elements include:

35 3. If CONTRACTOR does not provide proof of its own Compliance program to ADMINISTRATOR, CONTRACTOR shall acknowledge to comply with ADMINISTRATOR's 36 Compliance Program and Code of Conduct, the CONTRACTOR shall 37 submit to the

c. Compliance related training and/or education program and proof of completion.

d. Communication methods for reporting concerns to the Compliance Officer.

ADMINISTRATOR within thirty (30) calendar days of execution of this Agreement a signed
 acknowledgement that CONTRACTOR shall comply with ADMINISTRATOR's Compliance Program
 and Code of Conduct.

4. If CONTRACTOR elects to have its own Compliance Program, Code of Conduct and any 4 5 Compliance related policies and procedures review by ADMINISTRATOR, then CONTRACTOR shall submit a copy of its compliance Program, code of Conduct and all relevant policies and procedures to 6 7 ADMINISTRATOR within thirty (30) calendar days of execution of this Agreement. 8 ADMINISTRATOR's Compliance Officer, or designee, shall review said documents within a 9 reasonable time, which shall not exceed forty five (45) calendar days, and determine if 10 CONTRACTOR's proposed compliance program and code of conduct contain all required elements to 11 the ADMINISTRATOR's satisfaction as consistent with the HCA's Compliance Program and Code of Conduct. ADMINISTRATOR shall inform CONTRACTOR of any missing required elements and 12 13 CONTRACTOR shall revise its compliance program and code of conduct to meet ADMINISTRATOR's required elements within thirty (30) calendar days after ADMINISTRATOR's 14 15 Compliance Officer's determination and resubmit the same for review by the ADMINISTRATOR.

5. Upon written confirmation from ADMINISTRATOR's Compliance Officer that the
CONTRACTOR's compliance program, code of conduct and any Compliance related policies and
procedures contain all required elements, CONTRACTOR shall ensure that all Covered Individuals
relative to this Agreement are made aware of CONTRACTOR's compliance program, code of conduct,
related policies and procedures and contact information for the ADMINISTRATOR's Compliance
Program.

B. SANCTION SCREENING – CONTRACTOR shall screen all Covered Individuals employed or
 retained to provide services related to this Agreement semi-annually to ensure that they are not
 designated as Ineligible Persons, as pursuant to this Agreement. Screening shall be conducted against
 the General Services Administration's Excluded Parties List System or System for Award Management,
 the Health and Human Services/Office of Inspector General List of Excluded Individuals/Entities, the
 California Medi-Cal Suspended and Ineligible Provider List, and the Social Security Administration
 Death Master File and/or any other list or system as identified by the ADMINISTRATOR.

29 1. For purposes of this Paragraph IV (COMPLIANCE), Covered Individuals includes all 30 employees, interns, volunteers, contractors, subcontractors, agents, and other persons who provide 31 health care items or services or who perform billing or coding functions on behalf of 32 ADMINISTRATOR. Notwithstanding the above, this term does not include part-time or per-diem employees, contractors, subcontractors, agents, and other persons who are not reasonably expected to 33 34 work more than one hundred sixty (160) hours per year; except that any such individuals shall become 35 Covered Individuals at the point when they work more than one hundred sixty (160) hours during the calendar year. CONTRACTOR shall ensure that all Covered Individuals relative to this Agreement are 36 37 made aware of ADMINISTRATOR's Compliance Program, Code of Conduct and related policies and

procedures (or CONTRACTOR's own compliance program, code of conduct and related policies and
 procedures if CONTRACTOR has elected to use its own).

2. An Ineligible Person shall be any individual or entity who:

a. is currently excluded, suspended, debarred or otherwise ineligible to participate in
federal and state health care programs; or

b. has been convicted of a criminal offense related to the provision of health care items or
services and has not been reinstated in the federal and state health care programs after a period of
exclusion, suspension, debarment, or ineligibility.

9 3. CONTRACTOR shall screen prospective Covered Individuals prior to hire or engagement.
10 CONTRACTOR shall not hire or engage any Ineligible Person to provide services relative to this
11 Agreement.

4. CONTRACTOR shall screen all current Covered Individuals and subcontractors semiannually to ensure that they have not become Ineligible Persons. CONTRACTOR shall also request that
its subcontractors use their best efforts to verify that they are eligible to participate in all federal and
State of California health programs and have not been excluded or debarred from participation in any
federal or state health care programs, and to further represent to CONTRACTOR that they do not have
any Ineligible Person in their employ or under contract.

5. Covered Individuals shall be required to disclose to CONTRACTOR immediately any
debarment, exclusion or other event that makes the Covered Individual an Ineligible Person.
CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual providing
services directly relative to this Agreement becomes debarred, excluded or otherwise becomes an
Ineligible Person.

6. CONTRACTOR acknowledges that Ineligible Persons are precluded from providing
federal and state funded health care services by contract with COUNTY in the event that they are
currently sanctioned or excluded by a federal or state law enforcement regulatory or licensing agency.
If CONTRACTOR becomes aware that a Covered Individual has become an Ineligible Person,
CONTRACTOR shall remove such individual from responsibility for, or involvement with, COUNTY
business operations related to this Agreement.

7. CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual or
 entity is currently excluded, suspended or debarred, or is identified as such after being sanction
 screened. Such individual or entity shall be immediately removed from participating in any activity
 associated with this Agreement. ADMINISTRATOR will determine appropriate repayment from, or
 sanction(s) to CONTRACTOR for services provided by ineligible person or individual.
 CONTRACTOR shall promptly return any overpayments within forty-five (45) business days after the
 overpayment is verified by ADMINISTRATOR.

36 C. GENERAL COMPLIANCE TRAINING – ADMINISTRATOR shall make General
37 Compliance Training available to Covered Individuals.

CONTRACTORS that have acknowledged to comply with ADMINISTRATOR's
 Compliance Program shall use its best efforts to encourage completion by all Covered Individuals;
 provided, however, that at a minimum CONTRACTOR shall assign at least one (1) designated
 representative to complete the General Compliance Training when offered.

D. SPECIALIZED PROVIDER TRAINING – ADMINISTRATOR shall make Specialized
 Provider Training, where appropriate, available to Covered Individuals.

CONTRACTOR shall ensure completion of Specialized Provider Training by all Covered
 Individuals relative to this Agreement.

3. Such training will be made available to each Covered Individual annually.

4. ADMINISTRATOR will track online completion of training while CONTRACTOR shall

E. MEDICAL BILLING, CODING, AND DOCUMENTATION COMPLIANCE STANDARDS

1. CONTRACTOR shall take reasonable precaution to ensure that the coding of health care claims, billings and/or invoices for same are prepared and submitted in an accurate and timely manner and are consistent with federal, state and county laws and regulations. This includes compliance with federal and state health care program regulations and procedures or instructions otherwise communicated by regulatory agencies including the Centers for Medicare and Medicaid Services or their agents.

CONTRACTOR shall not submit any false, fraudulent, inaccurate and/or fictitious claims
for payment or reimbursement of any kind.

36 3. CONTRACTOR shall bill only for those eligible services actually rendered which are also
 37 fully documented. When such services are coded, CONTRACTOR shall use proper billing codes which

accurately describes the services provided and must ensure compliance with all billing and
 documentation requirements.

4. CONTRACTOR shall act promptly to investigate and correct any problems or errors in
coding of claims and billing, if and when, any such problems or errors are identified.

5 5. CONTRACTOR shall promptly return any overpayments within forty-five (45) business

F. Failure to comply with the obligations stated in this Paragraph IV (COMPLIANCE) shall
constitute a breach of the Agreement on the part of CONTRACTOR and ground for COUNTY to
terminate the Agreement. Unless the circumstances require a sooner period of cure, CONTRACTOR
shall have thirty (30) calendar days from the date of the written notice of default to cure any defaults
grounded on this Paragraph IV (COMPLIANCE) prior to ADMINISTRATOR's right to terminate this
Agreement on the basis of such default.

V. CONFIDENTIALITY

A. CONTRACTOR shall maintain the confidentiality of all records, including billings and any audio and/or video recordings, in accordance with all applicable federal, state and county codes and regulations, as they now exist or may hereafter be amended or changed.

CONTRACTOR acknowledges and agrees that all persons served pursuant to this
 Agreement are clients of the Orange County Mental Health services system, and therefore it may be
 necessary for authorized staff of ADMINISTRATOR to audit client files, or to exchange information
 regarding specific clients with COUNTY or other providers of related services contracting with
 COUNTY.

CONTRACTOR acknowledges and agrees that it shall be responsible for obtaining written
 consents for the release of information from all persons served by CONTRACTOR pursuant to this
 Agreement. Such consents shall be obtained by CONTRACTOR in accordance with CCC, Division 1,
 Part 2.6, relating to confidentiality of medical information.

3. In the event of a collaborative service agreement between Mental Health services providers,
CONTRACTOR acknowledges and agrees that it is responsible for obtaining releases of information,
from the collaborative agency, for clients receiving services through the collaborative agreement.

B. Prior to providing any services pursuant to this Agreement, all members of the Board of Directors or its designee or authorized agent, employees, consultants, subcontractors, volunteers and interns of the CONTRACTOR shall agree, in writing, with CONTRACTOR to maintain the confidentiality of any and all information and records which may be obtained in the course of providing such services. This Agreement shall specify that it is effective irrespective of all subsequent resignations or terminations of CONTRACTOR members of the Board of Directors or its designee or authorized agent, employees, consultants, subcontractors, volunteers and interns.

VI. COST REPORT

2 A. CONTRACTOR shall submit a Cost Report to COUNTY no later than sixty (60) calendar days 3 following the period for which they are prepared or termination of this Agreement. CONTRACTOR 4 shall prepare the individual and/or consolidated Cost Report in accordance with all applicable federal, 5 state and COUNTY requirements, GAAP and the Special Provisions Paragraph of this Agreement. CONTRACTOR shall allocate direct and indirect costs to and between programs, cost centers, services, 6 7 and funding sources in accordance with such requirements and consistent with prudent business 8 practice, which costs and allocations shall be supported by source documentation maintained by 9 CONTRACTOR, and available at any time to ADMINISTRATOR upon reasonable notice. In the event 10 CONTRACTOR has multiple Agreements for mental health services that are administered by HCA, 11 consolidation of the individual Cost Reports into a single consolidated Cost Report may be required, as stipulated by ADMINISTRATOR. CONTRACTOR shall submit the consolidated Cost Report to 12 COUNTY no later than five (5) business days following approval by ADMINISTRATOR of all 13 14 individual Cost Reports to be incorporated into a consolidated Cost Report.

If CONTRACTOR fails to submit an accurate and complete individual and/or consolidated
 Cost Report within the time period specified above, ADMINISTRATOR shall have sole discretion to
 impose one or both of the following:

a. CONTRACTOR may be assessed a late penalty of five hundred dollars (\$500) for each
business day after the above specified due date that the accurate and complete individual and/or
consolidated Cost Report is not submitted. Imposition of the late penalty shall be at the sole discretion

COUNTY during the term of the Agreement shall be immediately reimbursed to COUNTY.

B. The individual and/or consolidated Cost Report shall be the final financial and statistical report
submitted by CONTRACTOR to COUNTY, and shall serve as the basis for final settlement to
CONTRACTOR. CONTRACTOR shall document that costs are reasonable and allowable and directly

or indirectly related to the services to be provided hereunder. The individual and/or consolidated Cost
 Report shall be the final financial record for subsequent audits, if any.

3 C. Final settlement shall be based upon the actual and reimbursable costs for services hereunder, less applicable revenues and any late penalty, not to exceed COUNTY's Maximum Obligation as set 4 forth in the Referenced Contract Provisions of this Agreement. CONTRACTOR shall not claim 5 expenditures to COUNTY which are not reimbursable pursuant to applicable federal, state and 6 COUNTY laws, regulations and requirements. Any payment made by COUNTY to CONTRACTOR, 7 8 which is subsequently determined to have been for an unreimbursable expenditure or service, shall be 9 repaid by CONTRACTOR to COUNTY in cash, or other authorized form of payment, within thirty (30) calendar days of submission of the individual and/or consolidated Cost Report or COUNTY may elect 10 11 to reduce any amount owed CONTRACTOR by an amount not to exceed the reimbursement due COUNTY. 12

D. Unless approved by ADMINISTRATOR, costs that exceed the Statewide Maximum Allowance
(SMA) rates per Medi-Cal Unit of Services, as determined by the DHCS, shall be unreimbursable to
CONTRACTOR.

E. In the event that CONTRACTOR is authorized to retain unanticipated revenues as described in
the Budget Paragraph of Exhibit A to this Agreement, CONTRACTOR shall specify in the Cost Report
the services rendered with such revenues.

Any attempted assignment or delegation in derogation of this paragraph shall be void.

B. CONTRACTOR may not assign the rights hereunder, either in whole or in part, without theprior written consent of COUNTY.

If CONTRACTOR is a nonprofit organization, any change from a nonprofit corporation to
 any other corporate structure of CONTRACTOR, including a change in more than fifty percent (50%)
 of the composition of the Board of Directors within a two (2) month period of time, shall be deemed an

assignment for purposes of this paragraph, unless CONTRACTOR is transitioning from a community 1 2 clinic/health center to a Federally Qualified Health Center and has been so designated by the Federal 3 Government. Any attempted assignment or delegation in derogation of this subparagraph shall be void.

4 2. If CONTRACTOR is a for-profit organization, any change in the business structure, 5 including but not limited to, the sale or transfer of more than ten percent (10%) of the assets or stocks of CONTRACTOR, change to another corporate structure, including a change to a sole proprietorship, or a 6 7 change in fifty percent (50%) or more of Board of Directors or any governing body of CONTRACTOR at one time shall be deemed an assignment pursuant to this paragraph. Any attempted assignment or 8 9 delegation in derogation of this subparagraph shall be void.

10 3. If CONTRACTOR is a governmental organization, any change to another structure, 11 including a change in more than fifty percent (50%) of the composition of its governing body (i.e. Board of Supervisors, City Council, School Board) within a two (2) month period of time, shall be deemed an 12 13 assignment for purposes of this paragraph. Any attempted assignment or delegation in derogation of this subparagraph shall be void. 14

X. EQUIPMENT

A. Unless otherwise specified in writing by ADMINISTRATOR, Equipment is defined as all 13 property of a Relatively Permanent nature with significant value, purchased in whole or in part by 14 15 ADMINISTRATOR to assist in performing the services described in this Agreement. "Relatively Permanent" is defined as having a useful life of one year or longer. Equipment which costs \$5,000 or 16 over, including freight charges, sales taxes, and other taxes, and installation costs are defined as Capital 17 Assets. Equipment which costs between \$600 and \$5,000, including freight charges, sales taxes and 18 19 other taxes, and installation costs, or electronic equipment that costs less than \$600 but may contained 20PHI or PII, are defined as Controlled Equipment. Controlled Equipment includes, but is not limited to 21 phones, tablets, audio/visual equipment, computer equipment, and lab equipment. The cost of 22 Equipment purchased, in whole or in part, with funds paid pursuant to this Agreement shall be 23 depreciated according to GAAP.

B. CONTRACTOR shall obtain ADMINISTRATOR's prior written approval to purchase any
Equipment with funds paid pursuant to this Agreement. Upon delivery of Equipment, CONTRACTOR
shall forward to ADMINISTRATOR, copies of the purchase order, receipt, and other supporting
documentation, which includes delivery date, unit price, tax, shipping and serial numbers.
CONTRACTOR shall request an applicable asset tag for said Equipment and shall include each
purchased asset in an Equipment inventory.

C. Upon ADMINISTRATOR's prior written approval, CONTRACTOR may expense to COUNTY the cost of the approved Equipment purchased by CONTRACTOR. To "expense," in relation to Equipment, means to charge the proportionate cost of Equipment in the fiscal year in which it is purchased. Title of expensed Equipment shall be vested with COUNTY.

D. CONTRACTOR shall maintain an inventory of all Equipment purchased in whole or in part
 with funds paid through this Agreement, including date of purchase, purchase price, serial number,
 model and type of Equipment. Such inventory shall be available for review by ADMINISTRATOR,

and shall include the original purchase date and price, useful life, and balance of depreciated Equipment
 cost, if any.

E. CONTRACTOR shall cooperate with ADMINISTRATOR in conducting periodic physical
inventories of all Equipment. Upon demand by ADMINISTRATOR, CONTRACTOR shall return any
or all Equipment to COUNTY.

F. CONTRACTOR must report any loss or theft of Equipment in accordance with the procedure
approved by ADMINISTRATOR and the Notices Paragraph of this Agreement. In addition,
CONTRACTOR must complete and submit to ADMINISTRATOR a notification form when items of
Equipment are moved from one location to another or returned to COUNTY as surplus.

G. Unless this Agreement is followed without interruption by another agreement between the
parties for substantially the same type and scope of services, at the termination of this Agreement for
any cause, CONTRACTOR shall return to COUNTY all Equipment purchased with funds paid through
this Agreement.

H. CONTRACTOR shall maintain and administer a sound business program for ensuring the
 proper use, maintenance, repair, protection, insurance, and preservation of COUNTY Equipment.

XI. FACILITIES, PAYMENTS AND SERVICES

A. CONTRACTOR agrees to provide the services, staffing, facilities, and supplies in accordance with this Agreement. COUNTY shall compensate, and authorize, when applicable, said services. CONTRACTOR shall operate continuously throughout the term of this Agreement with at least the minimum number and type of staff which meet applicable federal and state requirements, and which are necessary for the provision of the services hereunder.

B. In the event that CONTRACTOR is unable to provide the services, staffing, facilities, or supplies as required, ADMINISTRATOR may, at its sole discretion, reduce the Maximum Obligation for the appropriate Period as well as the Total Maximum Obligation. The reduction to the Maximum Obligation for the appropriate Period as well as the Total Maximum Obligation shall be in an amount proportionate to the number of days in which CONTRACTOR was determined to be unable to provide services, staffing, facilities or supplies.

XII. INDEMNIFICATION AND INSURANCE

A. CONTRACTOR agrees to indemnify, defend with counsel approved in writing by COUNTY, and hold COUNTY, its elected and appointed officials, officers, employees, agents and those special districts and agencies for which COUNTY's Board of Supervisors acts as the governing Board ("COUNTY INDEMNITEES") harmless from any claims, demands or liability of any kind or nature, including but not limited to personal injury or property damage, arising from or related to the services, products or other performance provided by CONTRACTOR pursuant to this Agreement. If judgment is entered against CONTRACTOR and COUNTY by a court of competent jurisdiction because of the concurrent active negligence of COUNTY or COUNTY INDEMNITEES, CONTRACTOR and
 COUNTY agree that liability will be apportioned as determined by the court. Neither Party shall
 request a jury apportionment.

B. Prior to the provision of services under this Agreement, CONTRACTOR agrees to purchase all
required insurance at CONTRACTOR's expense, including all endorsements required herein, necessary
to satisfy COUNTY that the insurance provisions of this Agreement have been complied with.
CONTRACTOR agrees to keep such insurance coverage, Certificates of Insurance, and endorsements
on deposit with COUNTY during the entire term of this Agreement. In addition, all subcontractors
performing work on behalf of CONTRACTOR pursuant to this Agreement shall obtain insurance
subject to the same terms and conditions as set forth herein for CONTRACTOR.

D. All SIRs and deductibles shall be clearly stated on the COI. If no SIRs or deductibles apply, indicate this on the COI with a zero (0) by the appropriate line of coverage. Any SIR or deductible in an amount in excess of \$50,000 (\$5,000 for automobile liability) shall specifically be approved by the CEO/Office of Risk Management upon review of CONTRACTOR's current audited financial report. If CONTRACTOR's SIR is approved, CONTRACTOR, in addition to, and without limitation of, any other indemnity provision(s) in this Agreement, agrees to all of the following:

In addition to the duty to indemnify and hold the COUNTY harmless against any and all
 liability, claim, demand or suit resulting from CONTRACTOR's, its agents, employee's or

XIII. INSPECTIONS AND AUDITS

2 A. ADMINISTRATOR, any authorized representative of COUNTY, any authorized representative 3 of the State of California, the Secretary of the United States Department of Health and Human Services, 4 the Comptroller General of the United States, or any other of their authorized representatives, shall have 5 access to any books, documents, and records, including but not limited to, financial statements, general ledgers, relevant accounting systems, medical and client records, of CONTRACTOR that are directly 6 7 pertinent to this Agreement, for the purpose of responding to a beneficiary complaint or conducting an 8 audit, review, evaluation, or examination, or making transcripts during the periods of retention set forth 9 in the Records Management and Maintenance Paragraph of this Agreement. Such persons may at all 10 reasonable times inspect or otherwise evaluate the services provided pursuant to this Agreement, and the 11 premises in which they are provided.

B. CONTRACTOR shall actively participate and cooperate with any person specified in
Subparagraph A. above in any evaluation or monitoring of the services provided pursuant to this
Agreement, and shall provide the above–mentioned persons adequate office space to conduct such
evaluation or monitoring.

C. AUDIT RESPONSE

Following an audit report, in the event of non-compliance with applicable laws and
 regulations governing funds provided through this Agreement, COUNTY may terminate this Agreement
 as provided for in the Termination Paragraph or direct CONTRACTOR to immediately implement
 appropriate corrective action. A plan of corrective action shall be submitted to ADMINISTRATOR in
 writing within thirty (30) calendar days after receiving notice from ADMINISTRATOR.

C. COMPLAINT PROCESS – CONTRACTOR shall establish procedures for advising all clients

 ADMINISTRATOR or COUNTY's Patients' Rights Office.

Best Practices means a term that is often used interchangeably with "evidence-based practice" and is best defined as an "umbrella" term for three levels of practice, measured in relation to 24 25 recovery-consistent mental health practices where the recovery process is supported with scientific intervention that best meets the needs of the Client at this time. 26 27 EBP means Evidence-Based Practices and refers to the interventions utilized for which 28 there is consistent scientific evidence showing they improved Client outcomes and meets the following 29 criteria: it has been replicated in more than one geographic or practice setting with consistent results; it is recognized in scientific journals by one or more published articles; it has been documented and put 30 31 into manual forms; it produces specific outcomes when adhering to the fidelity of the model. 32 b. Promising Practices means that experts believe the practices are likely to be raised to the next level when scientific studies can be conducted and are supported by some body of evidence, 33 (evaluation studies or expert consensus in reviewing outcome data); it has been endorsed by recognized 34 35 bodies of advocacy organizations and finally, produces specific outcomes. Emerging Practices means that the practice(s) seems like a logical approach to 36 c. addressing a specific behavior which is becoming distinct, recognizable among Clients and clinicians in 37

practice, or innovators in academia or policy makers; and at least one recognized expert, group of

6. <u>Care Coordinator</u> is a MHS, CSW, or MFT that provides mental health, crisis intervention
and case management services to those Clients who seek services in the COUNTY operated outpatient
programs.

7 7. <u>Case Management Linkage Brokerage</u> means a process of identification, assessment of 8 need, planning, coordination and linking, monitoring, and continuous evaluation of Clients and of 9 available resources and advocacy through a process of casework activities in order to achieve the best 10 possible resolution to individual needs in the most effective way possible. This includes supportive 11 assistance to the Client in the assessment, determination of need, and securing of adequate and 12 appropriate living arrangements.

8. <u>CAT</u> means Crisis Assessment Team and provides 24 hour mobile response services to any
adult who has a psychiatric emergency. This program assists law enforcement, social service agencies,
and families in providing crisis intervention services for the mentally ill. CAT is a multi-disciplinary
program that conducts risk assessments, initiates involuntary hospitalizations, and provides case
management, linkage, follow ups for individuals evaluated.

9. <u>Certified Reviewer</u> means an individual that obtains certification by completing all
requirements set forth in the Quality Improvement and Program Compliance Reviewer Training
Verification Sheet.

21 10. <u>Client or Member</u> means an individual, referred by COUNTY or enrolled in
 22 CONTRACTOR's program for services under the Agreement, who experiences severe mental illness.

11. <u>Clinical Director</u> means an individual who meets the minimum requirements set forth in
Title 9, CCR, and has at least two (2) years of full-time professional experience working in a mental
health setting.

12. <u>Crisis Stabilization Unit (CSU)</u> means a psychiatric crisis stabilization program that operates 24 hours a day that serves Orange County residents, aged 18 and older, who are experiencing a psychiatric crisis and need immediate evaluation. Clients receive a thorough psychiatric evaluation, crisis stabilization treatment, and referral to the appropriate level of continuing care. As a designated outpatient facility, the CSU may evaluate and treat Clients for no longer than 23 hours.

13. <u>CSW</u> means Clinical Social Worker and refers to an individual who meets the minimum
 professional and licensure requirements set forth in Title 9, CCR, Section 625, and has two (2) years of
 post-master's clinical experience in a mental health setting.

34 14. <u>Data Collection System</u> means software designed for collection, tracking and reporting
 35 outcomes data for Clients enrolled in the FSP Programs.

a. <u>3 M</u> means the Quarterly Assessment Form that is completed for each Client every
three months in the approved data collection system.

Data Analysis Specialist means a person who is responsible for ensuring the program 2 maintains a focus on outcomes by reviewing outcomes and analyzing data, as well as working on 3 strategies for gathering new data from the Clients' perspective which will improve understanding of Clients' needs and desires towards furthering their recovery. This individual will provide feedback to 4 5 the program and work collaboratively with the employment specialist, education specialist, benefits specialist, and other staff in the program in strategizing improved outcomes in these areas. This position 6 7 will be responsible for attending all data and outcome related meetings and ensuring that program is 8 being proactive in all data collection requirements and changes at the local and state level.

9 c. <u>Data Certification</u> means the process of reviewing State and COUNTY mandated

d. <u>KET</u> means Key Event Tracking and refers to the tracking of a Client's movement or
 changes in the approved data collection system. A KET must be completed and entered accurately each

 categories include: residential status, employment status, education, legal status, emergency intervention
 episodes, and benefits establishment.

e. <u>PAF</u> means Partnership Assessment Form and refers to the baseline assessment for
each Client that must be completed and entered into the data collection system within thirty (30) days of
the Partnership date.

15. <u>DCR</u> means Data Collection and Reporting and refers to the DHCS developed data
collection and reporting system that ensures adequate research and evaluation regarding the
effectiveness of services being provided and the achievement of outcome measures. COUNTY is
required to report Client information and outcomes of the FSP program directly to the FSP DCR system
by XML file submission of the three different type of Client assessments (PAF, KET, and 3M).

16. <u>Diagnosis</u> means the definition of the nature of the Client's disorder. When formulating the
diagnosis of Client, CONTRACTOR shall use the diagnostic codes as specified in the most current
edition of the DSM published by the American Psychiatric Association. DSM diagnoses will be
recorded on all IRIS documents, as appropriate.

17. <u>DSH</u> means Direct Service Hours and refers to a measure in minutes that a clinician spends
 providing Client services. DSH credit is obtained for providing mental health, case management,

18. <u>Engagement</u> means the process by which a trusting relationship between worker and

36 19. <u>Face-to-Face</u> means an encounter between the Client and provider in which they are both

ESP means Full Service Partnership and refers to a type of program described by the State 2 in the requirements for the COUNTY plan for use of MHSA funds and which includes Clients being full 3 partners in the development and implementation of their treatment plan. A FSP is an evidence-based 4 and strength-based model, with the focus on the individual rather than the disease. Multi-disciplinary 5 teams will be established including the Client, psychiatrist, and PSC. Whenever possible, these multi- 6 disciplinary teams will include a mental health nurse, marriage and family therapist, clinical social 7 worker, peer specialist, and family members. 4 21. Housing Specialist means a specialized position dedicated to developing the full array of
5 housing options for their program and monitoring their suitability for the population served in
6 accordance with the minimal housing standards policy set by the COUNTY for their program. This
7 individual is also responsible for assisting Clients with applications to low income housing, housing
8 subsidies, senior housing, etc.

9 22. Individual Services and Support Funds – Flexible Funds means funds intended for use to
10 provide Clients and/or their families with immediate assistance, as deemed necessary, for the treatment
11 of their mental illness and their overall quality of life. Flexible Funds are generally categorized as
12 housing, transportation, food, clothing, medical, and miscellaneous expenditures that are individualized
13 and appropriate to support Client's mental health treatment activities.

14 23. Intake means the initial meeting between a Client and CONTRACTOR's staff and includes15 an evaluation to determine if the Client meets program criteria and is willing to seek services.

16 24. Intern means an individual enrolled in an accredited graduate program accumulating
17 clinically supervised work experience hours as part of field work, internship, or practicum requirements.
18 Acceptable graduate programs include all programs that assist the student in meeting the educational
19 requirements in becoming a licensed MFT, a licensed CSW, or a licensed Clinical Psychologist.

20 25. IRIS means Integrated Records Information System and refers to a collection of 21 applications and databases that serve the needs of programs within the COUNTY and includes 22 functionality such as registration and scheduling, laboratory information system, billing and reporting 23 capabilities, compliance with regulatory requirements, electronic medical records, and other relevant 24 applications.

25 26. Job Coach/Developer means a specialized position dedicated to developing and increasing
26 employment opportunities for the Clients and matching the job to the Client's strengths, abilities,
27 desires, and goals. This position will also integrate knowledge about career development and job
28 preparation to ensure successful job retention and satisfaction of both employer and employee.

29 27. Medical Necessity means the requirements as defined by CCR, Title 9 and as listed in the
 30 COUNTY MHP Medical Necessity for Medi-Cal Reimbursed Specialty Mental Health Services that
 31 includes Diagnosis, Impairment Criteria, and Intervention Related Criteria.

32 28. Member Advisory Board means a member-driven board which shall direct the activities,
33 provide recommendations for ongoing program development, and create the rules of conduct for the
34 program.

29. Mental Health Services means interventions designed to provide the maximum reduction of
 mental disability and restoration or maintenance of functioning consistent with the requirements for
 learning, development, and enhanced self-sufficiency. Services shall include:

a. <u>Assessment</u> means a service activity, which may include a clinical analysis of the
 history and current status of a beneficiary's mental, emotional, or behavioral disorder, relevant cultural
 issues and history, diagnosis and the use of testing procedures.

b. <u>Collateral</u> means a significant support person in a beneficiary's life and is used to
define services provided to them with the intent of improving or maintaining the mental health status of
the Client. The beneficiary may or may not be present for this service activity.

c. <u>Co-Occurring Integrated Treatment Model</u> means, in evidence-based Integrated
Treatment programs, Clients who receive a combined treatment for mental illness and substance abuse
disorders from the same practitioner or treatment team.

d. <u>Crisis Intervention</u> means a service, lasting less than twenty-four (24) hours, to or on
behalf of a Client for a condition which requires more timely response than a regularly scheduled visit.
Service activities may include, but are not limited to, assessment, collateral. and therapy.

e. <u>Medication Support Service</u> means those services provided by a licensed physician, registered nurse, or other qualified medical staff, which includes prescribing, administering, dispensing, and monitoring of psychiatric medications or biologicals and which are necessary to alleviate the symptoms of mental illness. These services also include evaluation and documentation of the clinical justification and effectiveness for use of the medication, dosage, side effects, compliance, and response to medication, as well as obtaining informed consent, providing medication education, and plan development related to the delivery of the service and/or assessment of the beneficiary.

f. <u>Rehabilitation Service</u> means an activity which includes assistance in improving,
 maintaining, or restoring a Client's or group of Clients' functional skills, daily living skills, social and
 leisure skills, grooming and personal hygiene skills, meal preparation skills, support resources, and/or
 medication education.

g. <u>Targeted Case Management</u> means services that assist a beneficiary to access needed
medical, educational, social, prevocational, vocational, rehabilitative, or other community services. The
service activities may include, but are not limited to, communication, coordination and referral;
monitoring service delivery to ensure beneficiary access to service and the service delivery system;
monitoring of the beneficiary's progress; and plan development.

h. <u>Therapy</u> means a service activity which is a therapeutic intervention that focuses
primarily on symptom reduction as a means to improve functional impairments. Therapy may be
delivered to an individual or group of beneficiaries which may include family therapy in which the
beneficiary is present.

33 30. <u>Mental Health Worker</u> means an individual that assists in planning, developing, and 34 evaluating mental health services for Clients; provides liaison between Clients and service providers; 35 and has obtained a Bachelor's degree in a behavioral science field such as psychology, counseling, or 36 social work, or has two years of experience providing client related services to Clients experiencing 37 mental health, drug abuse, or alcohol disorders. Education in a behavioral science field such as

psychology, counseling, or social work may be substituted for up to one year of the experience
requirement.

3 31. <u>MFT</u> means Marriage and Family Therapist and refers to an individual who meets the 4 minimum professional and licensure requirements set forth in CCR, Title 9, Section 626.

32. <u>MHS</u> means Mental Health Specialist and refers to an individual who has a Bachelor's
Degree and four years of experience in a mental health setting and who performs individual and group
case management studies.

8 33. <u>MHSA</u> means Mental Health Services Act and refers to the law that provides funding for
9 expanded community Mental Health Services. It is also known as "Proposition 63."

34. <u>MORS</u> means Milestones of Recovery Scale and refers to a recovery scale that COUNTY
will be using for the Adult mental health programs in COUNTY. The scale will provide the means of
assigning Clients to their appropriate level of care and replace the diagnostic and acuity of illness-based
tools. MORS is ideally suited to serve as a recovery-based tool for identifying the level of service
needed by participating members. The scale will be used to create a map of the system by determining
which milestone(s) or level of recovery (based on the MORS) are the target groups for different
programs across the continuum of programs and services offered by COUNTY.

35. <u>NOA-A</u> means Notice of Action and refers to a Medi-Cal requirement that informs the
beneficiary that he/she is not entitled to any specialty mental health service. The COUNTY has
expanded the requirement for an NOA-A to all individuals requesting an assessment for services and
found not to meet the Medical Necessity criteria for Specialty Mental Health Services.

36. <u>NPI</u> means National Provider Identifier and refers to the standard unique health identifier
that was adopted by the Secretary of HHS under HIPAA for health care providers. All HIPAA covered
healthcare providers, individuals, and organizations must obtain an NPI for use to identify themselves in
HIPAA standard transactions. The NPI is assigned for life.

37. <u>NPP</u> means Notice of Privacy Practices and refers to a document that notifies individuals of
uses and disclosures of PHI that may be made by or on behalf of the health plan or health care provider
as set forth in HIPAA.

38. <u>Outreach</u> means the Outreach to potential Clients to link them to appropriate Mental Health
Services and may include activities that involve educating the community about the services offered and
requirements for participation in the programs. Such activities should result in the CONTRACTOR
developing their own Client referral sources for the programs they offer.

32 39. <u>Peer Recovery Specialist/Counselor</u> means an individual who has been through the same or
 33 similar recovery process as those he/she is now assisting to attain their recovery goals while getting paid
 34 for this function by the program. A Peer Recovery Specialist/Counselor's practice is informed by
 35 his/her own experience.

36 40. <u>Pharmacy Benefits Manager</u> means the organization that manages the medication benefits
37 that are given to Clients that qualify for medication benefits.

41. <u>PHI</u> means Protected Health Information and refers to individually identifiable health information usually transmitted by electronic media and maintained in any medium as defined in the regulations, or for an entity such as a health plan, transmitted or maintained in any other medium. It is created or received by a covered entity and relates to the past, present, or future physical or mental health or condition of an individual, provision of health care to an individual, or the past, present, or future payment for health care provided to an individual.

42. <u>Pre-Licensed Psychologist</u> means an individual who has obtained a Ph.D. or Psy.D. in
Clinical Psychology and is registered with the Board of Psychology as a registered Psychology Intern or
Psychological Assistant, acquiring hours for licensing, and waivered in accordance with Welfare and
Institutions Code section 575.2. The waiver may not exceed five (5) years.

43. <u>Pre-Licensed Therapist</u> means an individual who has obtained a Master's Degree in Social
Work or Marriage and Family Therapy and is registered with the BBS as an Associate CSW or
Associate MFT acquiring hours for licensing. An individual's registration is subject to regulations
adopted by the BBS.

44. <u>Program Director</u> means an individual who has complete responsibility for the day to day
function of the program. The Program Director is the highest level of decision making at a local,
program level.

45. <u>Promotora de Salud Model</u> means a model where trained individuals, Promotores, work
towards improving the health of their communities by linking their neighbors to health care and social
services and educating their peers about mental illness, disease, and injury prevention.

46. <u>Promotores</u> means individuals who are members of the community who function as natural
helpers to address some of their communities' unmet mental health, health and human service needs.
They are individuals who represent the ethnic, socio-economic, and educational traits of the population
they serve. Promotores are respected and recognized by their peers and have the pulse of the
community's needs.

47. PSC means Personal Services Coordinator and refers to an individual who will be part of a 26 27 multi-disciplinary team that will provide community based Mental Health Services to adults that are 28 struggling with persistent and severe mental illness as well as homelessness, rehabilitation, and recovery 29 principles. The PSC is responsible for clinical care and case management of assigned Client and 30 families in a community, home, or program setting. This includes assisting Clients with mental health, 31 housing, vocational, and educational needs. The position is also responsible for administrative and 32 clinical documentation as well as participating in trainings and team meetings. The PSC shall be active in supporting and implementing the program's philosophy and its individualized, strength-based, 33 culturally/linguistically competent, and client-centered approach. 34

48. <u>Psychiatrist</u> means an individual who meets the minimum professional and licensure
requirements set forth in Title 9, CCR, Section 623.

49. <u>Psychologist</u> means an individual who meets the minimum professional and licensure
 requirements set forth in Title 9, CCR, Section 624.

50. <u>QIC</u> means Quality Improvement Committee and refers to a committee that meets quarterly to review one percent (1%) of all "high-risk" Medi-Cal Clients to monitor and evaluate the quality and appropriateness of services provided. At a minimum, the committee is comprised of one (1) CONTRACTOR administrator, one (1) Clinician, and one (1) Physician who are not involved in the clinical care of the cases.

8 51. <u>Recovery</u> means a process of change through which individuals improve their health and
9 wellness, live a self-directed life, and strive to reach their full potential. The four major dimensions to
10 support a life in recovery are:

a. Health: Overcoming or managing one's disease(s) as well as living in a physically and
emotionally healthy way;

b. Home: A stable and safe place to live;

c. Purpose: Meaningful daily activities, such as a job, school, volunteerism, family
caretaking, or creative endeavors, and the independence, income, and resources to participate in society;
and

d. Community: Relationships and social networks that provide support, friendship, love,and hope.

19 52. <u>Referral</u> means the act of sending an individual to another person or place for services,
20 help, advice, etc. When indicated, follow-up shall be provided within five (5) working days to assure
21 that the Client has made contact with the referred service.

53. <u>SUD</u> means Substance Use Disorder and refers to a condition in which the use of one or
 more substances leads to a clinically significant impairment or distress per the latest DSM.

54. <u>Supportive Housing PSC</u> means a person who provides services in a supportive housing structure. This person will coordinate activities which will include, but not be limited to: independent living skills, social activities, supporting communal living, assisting residents with conflict resolution, advocacy, and linking Clients with the assigned PSC for clinical issues. The Supportive Housing PSC will assist with building and maintaining relationships with housing management and owner operators, and consult with the multidisciplinary team of staff assigned by the program.

55. <u>Supervisory Review</u> means ongoing clinical case reviews in accordance with procedures
 developed by ADMINISTRATOR to determine the appropriateness of Diagnosis and treatment and to
 monitor compliance to the minimum ADMINISTRATOR and Medi-Cal charting standards.
 Supervisory review is conducted by the program/clinic director or designee.

56. <u>Token</u> means the security device which allows an individual user to access the COUNTY's
computer based IRIS.

57. <u>UMDAP</u> means the Uniform Method of Determining Ability to Pay and refers to the
 method used for determining the annual Client liability for Mental Health Services received from the
 COUNTY mental health system and is set by the State of California.

58. <u>Vocational/Educational Specialist</u> means a person who provides services that range from pre-vocational groups, trainings, and supports to obtain employment out in the community based on the Clients' level of need and desired support. The Vocational/Educational Specialist will provide "one on one" vocational counseling and support to Clients to ensure that their needs and goals are being met. The overall focus of the Vocational/Educational Specialist is to empower Clients and provide them with the knowledge and resources to achieve the highest level of vocational functioning possible.

10 59. <u>WRAP</u> means Wellness Recovery Action Plan and refers to a Client self-help tool for
 11 monitoring and responding to symptoms to achieve the highest possible levels of wellness, stability, and
 12 quality of life.

B. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify the
Common Terms and Definitions Paragraph of this Exhibit A to the Agreement.

CONTRACTOR and ADMINISTRATOR mutually agree that the Total Budget identified in Subparagraph II.A. of this Exhibit A to the Agreement includes Indirect Costs not to exceed fifteen percent (15%) of Direct Costs, and which may include operating income estimated at two percent (2%). In the event CONTRACTOR collects fees and insurance, including Medicare, for services 1 2 provided pursuant to the Agreement, CONTRACTOR may make written application to 3 ADMINISTRATOR to retain such revenues; provided, however, the application must specify that the 4 fees and insurance will be utilized exclusively to provide mental health services. ADMINISTRATOR 5 may, at its sole discretion, approve any such retention of revenues. Approval by ADMINISTRATOR shall be in writing to CONTRACTOR and will specify the amount of said revenues to be retained and 6 7 the quantity of services to be provided by CONTRACTOR. Fees received from private resources on behalf of Medi-Cal Clients shall not be eligible for retention by CONTRACTOR. 8

9 E. The parties agree that the above budget reflects an average Medi-Cal Client caseload of
10 approximately thirty-five percent (35%) to be maintained by CONTRACTOR. CONTRACTOR agrees
11 to accept COUNTY referrals that may result in an increase in this average.

F. FLEXIBLE FUNDS

CONTRACTOR shall develop a P&P, or revise the existing P&P, regarding Flexible Funds
 and submit to ADMINISTRATOR no later than twenty (20) calendar days from the start of the
 Agreement. ADMINISTRATOR and CONTRACTOR shall finalize and approve the P&P, in writing,
 no later than thirty (30) days from the start of the Agreement. If the Flexible Funds P&P has not been
 approved after thirty (30) days from the start of the Agreement, any subsequent Flexible Funds
 expenditures may be disallowed by ADMINISTRATOR.

2. CONTRACTOR shall ensure that utilization of Flexible Funds is individualized andappropriate for the treatment of Client's mental illness and overall quality of life.

3. CONTRACTOR shall report the utilization of their Flexible Funds monthly on a form
approved by ADMINISTRATOR. The Flexible Funds report shall be submitted with
CONTRACTOR's monthly Expenditure and Revenue Report.

4. CONTRACTOR shall ensure that all staff are trained and have a clear understanding of the
approved Flexible Funds P&P. CONTRACTOR will provide signature confirmation of the Flexible
Funds P&P training for each staff member that utilizes these Flexible Funds for a Client.

5. CONTRACTOR shall ensure the Flexible Funds P&P will include, but not be limited to,the following:

a. Purpose for which Flexible Funds are to be utilized. This shall include a description of
what type of expenditures are appropriate, reasonable, justified, and that the expenditure of Flexible
Funds shall be individualized according to the Client's needs. Include a sample listing of certain
expenditures that are allowable, unallowable, or require discussion with ADMINISTRATOR;

b. Identification of specific CONTRACTOR staff designated to authorize Flexible Funds
expenditures and the mechanism used to ensure this staff has timely access to Flexible Funds. This may
include procedures for check requests/petty cash, or other methods of access to these funds;

36 c. Identification of the process for documenting and accounting for all Flexible Funds
37 expenditures, which shall include, but not be limited to, retention of comprehensible source

documentation such as receipts, copy of Client's lease/rental agreements, general ledgers, and needs 1 2 documented in Client's treatment plan;

3 d. Statement indicating that Flexible Funds may be utilized when other community 4 resources such as family/friends, food banks, shelters, charitable organizations, etc. are not available in a 5 timely manner, or are not appropriate for a Client's situation. 7 e. Statement indicating that no single Flexible Funds expenditure, in excess of \$1,000, 8 shall be made without prior written approval of ADMINISTRATOR. In emergency situations, 9 CONTRACTOR may exceed the \$1,000 limit, if appropriate and justified, and shall notify ADMINISTRATOR the next business day of such an expense. Said notification shall include total costs 10 11 and a justification for the expense. Failure to notify ADMINISTRATOR within the specified timeframe may result in disallowance of the expenditure; 12

13 f. Statement that pre-purchases shall only be for food, transportation, clothing, and 14 motels, as required and appropriate;

15 g. Statement indicating that pre-purchases of food, transportation, and clothing vouchers and/or gift cards shall be limited to a combined \$5,000 supply on-hand at any given time and that all 16 voucher and/or gift card purchases and disbursement shall be tracked and logged by designated 17 CONTRACTOR staff. Vouchers and/or gift cards shall be limited in monetary value to less than 18 19 twenty-five (\$25) each, unless otherwise approved in advance by ADMINISTRATOR in writing;

h. Statement indicating that pre-purchases for motels shall be on a case-by-case basis and 2021 time-limited in nature and only utilized while more appropriate housing is being located. Pre-purchase 22 of motel rooms shall be tracked and logged upon purchase and disbursement;

i. Statement indicating that Flexible Funds are not to be used for housing for Clients that 24 have not been enrolled in CONTRACTOR's program, unless approved, in advance and in writing, by ADMINISTRATOR: 25

BUDGET/STAFFING MODIFICATIONS - CONTRACTOR may request to shift funds 32 between programs, or between budgeted line items within a program, for the purpose of meeting 33 specific program needs or for providing continuity of care to its Clients, by utilizing a Budget/Staffing Modification Request form provided by ADMINISTRATOR. CONTRACTOR shall submit a properly 34 35 completed Budget/Staffing Modification Request to ADMINISTRATOR for consideration, in advance, which will include a justification narrative specifying the purpose of the request, the amount of said 36 funds to be shifted, and the sustaining annual impact of the shift as may be applicable to the current 37

contract period and/or future contract periods. CONTRACTOR shall obtain written approval of any
 Budget/Staffing Modification Request(s) from ADMINISTRATOR prior to implementation by
 CONTRACTOR. Failure of CONTRACTOR to obtain written approval from ADMINISTRATOR for
 any proposed Budget/Staffing Modification Request(s) may result in disallowance of those costs.

5 H. FINANCIAL RECORDS - CONTRACTOR shall prepare and maintain accurate and complete financial records of its cost and operating expenses. Such records will reflect the actual cost of the type 6 7 of service for which payment is claimed. Any apportionment of or distribution of costs, including indirect costs, to or between programs or cost centers of CONTRACTOR shall be documented, and will 8 9 be made in accordance with generally accepted principles of accounting and Medicare regulations. The 10 Client eligibility determination and fee charged to and collected from Clients, together with a record of 11 all billings rendered and revenues received from any source on behalf of Clients treated pursuant to the Agreement, must be reflected in CONTRACTOR's financial records. 12

I. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify theBudget Paragraph of this Exhibit A to the Agreement.

III. PAYMENTS

A. COUNTY shall pay CONTRACTOR monthly, in arrears, at the provisional amount of 17 \$252,118 per month. All payments are interim payments only, and subject to final settlement in 18 accordance with the Cost Report Paragraph of the Agreement for which CONTRACTOR shall be 19 20reimbursed for the actual cost of providing the services, which may include Indirect Administrative 21 Costs, as identified in Subparagraph II.A. of this Exhibit A to the Agreement; provided, however, the 22 total of such payments does not exceed the Maximum Obligation for each period as stated in the 23 Referenced Contract Provisions of the Agreement and provided further, CONTRACTOR's costs are 24 reimbursable pursuant to COUNTY, state, and/or federal regulations. ADMINISTRATOR may, at its 25 discretion, pay supplemental invoices for any month for which the provisional amount specified above has not been fully paid. 26

In support of the monthly invoice, CONTRACTOR shall submit an Expenditure and
 Revenue Report as specified in the Reports Paragraph of this Exhibit A to the Agreement.
 ADMINISTRATOR shall use the Expenditure and Revenue Report to determine payment to
 CONTRACTOR as specified in Subparagraphs A.2. and A.3., below.

If, at any time, CONTRACTOR's Expenditure and Revenue Reports indicate that the
 provisional amount payments exceed the actual cost of providing services, ADMINISTRATOR may
 reduce COUNTY payments to CONTRACTOR by an amount not to exceed the difference between the
 year-to-date provisional amount payments to CONTRACTOR and the year-to-date actual cost incurred
 by CONTRACTOR.

36 3. If, at any time, CONTRACTOR's Expenditure and Revenue Reports indicate that the 37 provisional amount payments are less than the actual cost of providing services, ADMINISTRATOR

15 16 may authorize an increase in the provisional amount payment to CONTRACTOR by an amount not to
 exceed the difference between the year-to-date provisional amount payments to CONTRACTOR and
 the year-to-date actual cost incurred by CONTRACTOR.

B. CONTRACTOR's invoice shall be on a form approved or supplied by COUNTY and provide
such information as is required by ADMINISTRATOR. Invoices are due the tenth (10th) calendar day
of each month. Invoices received after the due date may not be paid within the same month. Payments
to CONTRACTOR should be released by COUNTY no later than thirty (30) calendar days after receipt
of the correctly completed invoice.

9 C. All invoices to COUNTY shall be supported, at CONTRACTOR's facility, by source
10 documentation including, but not limited to, ledgers, journals, time sheets, invoices, bank statements,
11 canceled checks, receipts, receiving records, and records of services provided.

D. ADMINISTRATOR may withhold or delay any payment if CONTRACTOR fails to comply
 with any provision of the Agreement.

E. COUNTY shall not reimburse CONTRACTOR for services provided beyond the expiration
and/or termination of the Agreement, except as may otherwise be provided under the Agreement, or
specifically agreed upon in a subsequent Agreement.

F. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify thePayments Paragraph of this Exhibit A to the Agreement.

IV. <u>REPORTS</u>

A. CONTRACTOR shall maintain records and make statistical reports as required by
 ADMINISTRATOR and the DHCS on forms provided by either agency.

B. FISCAL

24 1. CONTRACTOR shall submit monthly Expenditure and Revenue Reports to ADMINISTRATOR. These reports will be on a form acceptable to, or provided by, 25 ADMINISTRATOR and will report actual costs and revenues for CONTRACTOR's program described 26 27 in the Services Paragraph of this Exhibit A to the Agreement. Such reports will also include actual productivity as defined by ADMINISTRATOR. The reports will be received by ADMINISTRATOR 28 29 no later than the twentieth (20th) day following the end of the month being reported. CONTRACTOR 30 must request in writing any extensions to the due date of the monthly required reports. If an extension is approved by ADMINISTRATOR, the total extension will not exceed more than five (5) calendar days. 31

32 2. CONTRACTOR shall submit monthly Year-End Projection Reports to 33 ADMINISTRATOR. These reports will be on a form acceptable to, or provided by, ADMINISTRATOR and will report anticipated year-end actual costs and revenues 34 for 35 CONTRACTOR's program described in the Services Paragraph of this Exhibit A to the Agreement. 36 Such reports will include actual monthly costs and revenue to date and anticipated monthly costs and 37 //

revenue to the end of the fiscal year. Year-End Projection Reports will be submitted in conjunction with
 the Monthly Expenditure and Revenue Reports.

3 C. STAFFING - CONTRACTOR shall submit monthly Staffing Reports to ADMINISTRATOR. These reports will be on a form acceptable to, or provided by, ADMINISTRATOR and will, at a 4 5 minimum, report the actual FTEs of the positions stipulated in the Staffing Paragraph of this Exhibit A to the Agreement and will include the employees' names, licensure status, monthly salary, 6 7 hire and/or termination date, and any other pertinent information as may be required by 8 ADMINISTRATOR. The reports will be received by ADMINISTRATOR no later than twenty (20) 9 calendar days following the end of the month being reported. If an extension is approved by ADMINISTRATOR, the total extension will not exceed more than five (5) calendar days. 10

D. PROGRAMMATIC

12 1. CONTRACTOR shall submit programmatic reports to ADMINISTRATOR, as indicated 13 below, on a form acceptable to or provided by ADMINISTRATOR, which will be received by 14 ADMINISTRATOR no later than twenty (20) calendar days following the end of the month/quarter 15 being reported unless otherwise specified. Mental Health Programmatic reports shall include, but not 16 limited to, the following:

a. A description of CONTRACTOR's progress in implementing the provisions of this Agreement,

b. Report of placement and movement of Clients along the continuum of services,

c. Voluntary and involuntary hospitalizations and special incidences,

d. Vocational programs, educational programs, including new job placements, Clients in
 continuing employment.

e. Reporting of the numbers of Clients based upon their level of function in the MORSLevel system.

f. Chart compliance by percentage of compliance with all Medi-Cal records, in addition
to any pertinent facts or interim findings, staff changes, status of Licenses and/or Certifications, changes
in population served and reasons for any such changes.

g. CONTRACTOR statement whether the program is or is not progressing satisfactorily
in achieving all the terms of this Agreement, and if not, shall specify what steps will be taken to achieve
satisfactory progress.

CONTRACTOR shall document all adverse incidents affecting the physical and/or
 emotional welfare of Clients, including but not limited to serious physical harm to self or others, serious
 destruction of property, developments, etc., and which may raise liability issues with COUNTY.
 CONTRACTOR shall notify and submit incident reports on an approved form to COUNTY within
 twenty-four (24) hours of any such serious adverse incident.

CONTRACTOR shall advise ADMINISTRATOR of any special incidents, conditions, or
 issues that adversely affect the quality or accessibility of client-related services provided by, or under
 contract with, the COUNTY as identified in the HCA P&Ps.

E. ADDITIONAL REPORTS – Upon ADMINISTRATOR's request, CONTRACTOR shall make
such additional reports as required by ADMINISTRATOR concerning CONTRACTOR's activities as
they affect the services hereunder. ADMINISTRATOR shall be specific as to the nature of information
requested and allow up to thirty (30) calendar days for CONTRACTOR to respond.

F. CONTRACTOR agrees to enter psychometrics into COUNTY's EHR system as requested by
ADMINISTRATOR. Said psychometrics are for the COUNTY's analytical uses only, and shall not be
relied upon by CONTRACTOR to make clinical decisions. CONTRACTOR agrees to hold COUNTY
harmless, and indemnify pursuant to Section XI, from any claims that arise from non-COUNTY use of
said psychometrics.

G. CONTRACTOR and ADMINISTRATOR may mutually agree, in writing, to modify theReports Paragraph of this Exhibit A to the Agreement.

V. <u>SERVICES</u>

A. FACILITY – CONTRACTOR shall maintain a facility which meets the minimum requirements
for Medi-Cal and Medicare eligibility for the provision of Enhanced Recovery Full Service Partnership
Services for exclusive use by COUNTY at the following location, or any other location approved, in
advance, in writing, by ADMINISTRATOR:

2100 North Broadway, Suite 100 and 101 Santa Ana, CA 92706

1. The facility shall include space to support the services identified within the Agreement.

26 2. The facility shall be open from 8:00 a.m. until at least 5:00 p.m. in adherence with the
27 COUNTY established schedule; however, CONTRACTOR shall modify these hours of operation in
28 order to meet Clients' needs. Additionally, CONTRACTOR agrees to provide access to its Clients
29 twenty-four (24) hours per day, seven (7) days per week.

30 3. CONTRACTOR shall maintain a holiday schedule consistent with the COUNTY's holiday
31 schedule, unless otherwise approved, in advance and in writing, by ADMINISTRATOR.

32 4. CONTRACTOR shall obtain a NPI - The standard unique health identifier adopted by the
33 Secretary of HHS under HIPAA of 1996 for health care providers.

B. INDIVIDUALS TO BE SERVED – Serious and persistent mentally ill adults, ages eighteen
(18) years and older, who are legally residing in COUNTY and otherwise eligible for public services
under federal and state law. All individuals served must meet CCR Title IX medical necessity criteria.
The Enhanced Recovery FSP program shall provide services to Clients from two distinct populations.

The first population to be served are individuals who are on LPS conservatorship (public or
 private) and currently residing in long-term care facilities and preparing for discharge, or in Residential
 Rehabilitation Care facilities, or in the community, who, given the opportunity, could regain control of
 their independence and achieve enhanced recovery. These individuals often have a history of
 institutionalization and/or failed placements due to their mental illness and may need additional support
 to successfully reintegrate and remain in the community. Referrals for this population may come from
 the COUNTY, long-term care facilities, and the community.

8 2. The second population to be served are individuals charged with misdemeanor or felony
9 offenses that are related to their mental illness, and may be of questionable competence to stand trial.
10 Referrals for this population will come from the COUNTY through the Collaborative Assisted
11 Intervention (AI) Court.

C. PROGRAM PHILOSOPHIES – CONTRACTOR's program shall be guided by the following
 values, philosophies, and approaches to recovery in the services provided:

Ensuring Cultural Considerations – CONTRACTOR shall tailor services to the Clients'
 worldview and belief systems and to enhance the therapeutic relationship, intervention, and outcome.
 Consideration to how Clients' identify in terms of race, ethnicity, sexual orientation, and spirituality
 shall be considered when developing and providing services.

Being Fully Served, Ensuring Integrated Experience – To begin to understand and apply
 FSP practices, one must first understand the concepts inherent in the carefully selected phrase Full
 Service Partnership, including the idea of what it means to "be fully served" and providing an integrated
 service experience within the FSP. Individuals who have been diagnosed with a serious mental illness
 shall receive mental health services through an individual service plan where both the Client and their
 PSC agree that they are getting the services they want and need, in order to achieve their wellness and
 recovery goals.

3. Tailoring Service Coordination to Client Stage of Recovery – CONTRACTOR shall
identify and define levels of service and supports that create a continuum of services based on the
Clients' stages of Recovery to ensure that Clients are "fully served."

4. Outreach and Engagement – CONTRACTOR shall form the foundation of a partnership by
successfully bringing individuals into the FSP as well as retaining Clients in the FSP while they need
services.

5. Welcoming Environments – CONTRACTOR shall convey a sense of welcoming to Clients
that reflects the belief in recovery. The healing and recovery process will not truly begin until a Client
feels welcomed and accepted into the services and supports provided by the FSP team.

34 6. Stage of Readiness for Change – CONTRACTOR shall focus on Clients' Stage of
35 Readiness for Change toward changing behaviors and have concrete interventions and supports to
36 support the Client's move towards recovery in that specific area of their life.
37 //

1 7. Client or Person Centered Treatment Planning and Service Delivery - CONTRACTOR 2 shall promote a foundation for healing through the relationship between the Client and Personal Services 3 Coordinator or FSP team through the use of Client or Person Centered Treatment Planning and Service 4 Delivery.

5 8. Fostering Independence, Self-Determination and Transitioning to Community Supports – CONTRACTOR shall assist Clients in becoming more engaged in their recovery to reduce reliance on 6 7 the mental health system, as mental health interventions become less necessary.

8 9. Community Capacity Building - CONTRACTOR shall assist Clients in managing and 9 living productive lives in their community; to reduce unnecessary Client reliance on the mental health system; and to increase capacity within the system to serve new Clients. 10

11 10. Use of Strength-Based Approach - CONTRACTOR shall help Clients identify and use their individual strengths in treatment as an effective way to help Clients achieve their goals and believe 12 that recovery is possible. 13

14 11. Client Self-Management – CONTRACTOR shall assist Clients in learning to assume more 15 responsibility for their overall care by becoming more involved in decision-making and successfully 16 manage their symptoms.

17 12. Integrated Services for Clients with Co-Occurring Substance Use and Mental Health 18 Disorders – CONTRACTOR shall integrate substance use and mental health services into one treatment 19 plan as it is critical to the recovery process for both disorders. Integrated Dual Disorder Treatment model is an approach that helps people recover by offering treatments that combine or integrate mental 20health and substance use interventions at the level of the clinical encounter. Ultimately, the goal of 21 22 Integrated Dual Disorder Treatment is to help people manage both their mental illness and substance use 23 disorders so that they can pursue their own meaningful life goals.

24 13. Role of Medication and Therapy – CONTRACTOR shall understand the potential role and 25 value of therapy, counseling, and medication as treatment modalities within a FSP. CONTRACTOR shall identify strategies for FSP teams to work collaboratively with Clients to find the best approach to 26 27 support their success.

28 14. Reconnecting with Family - CONTRACTOR shall facilitate the recovery process and add 29 an element of social support to the Client and include the family in services when appropriate.

30

15. Increasing Social Supports and Community Integration – CONTRACTOR shall work with 31 Clients to shift Clients' support from weighing heavily on the mental health system to weighing more 32 heavily in the community. CONTRACTOR shall focus on increasing Clients' social network and increasing their opportunities to meet new people as Clients recovery progresses. 33

16. Education, Employment and Volunteering - CONTRACTOR shall work with Clients to 34 35 engage in activities that are meaningful, create self-sufficiency, and give back to the community.

17. Reducing Involvement in the Criminal Justice System - CONTRACTOR shall minimize 36 37 Client contact with law enforcement and the judicial system.

Linkage to and Coordination of Health Care – CONTRACTOR shall ensure all FSP Clients
 have access to needed comprehensive health care. Access to these services is particularly critical since
 mental health Clients often have undiagnosed and untreated medical conditions that result in chronic
 medical conditions and premature death.

5 19. Coordination of Inpatient Care/Incarceration – CONTRACTOR shall ensure coordination
6 of services when FSP Clients are in a psychiatric hospital or incarcerated and plan for a successful
7 discharge.

8 20. Team Service Approach and Meeting Structure – CONTRACTOR shall utilize the FSP
9 team as a whole in treatment and service planning and develop a structure for team meetings to discuss
10 cases and coordinate care.

11 21. Use of Peer Staff – CONTRACTOR shall identify meaningful roles for peer employees as
12 part of a FSP team. Employing peers is transformational and not only helps individuals give back to the
13 system that helped them recover, but also, if done with care, will reduce the stigma associated with
14 mental illness.

15 22. Creating an Array of Readily Available Housing Options – CONTRACTOR shall create an
16 array of readily available housing options and provide safe and affordable housing for each Client.

17 23. Graduation - Graduation is the expected outcome for all Clients and is not only crucial to
18 the Clients as validation of their accomplishments and belief in their potential, but is also crucial for
19 capacity and flow through our system. CONTRACTOR shall work with Clients and provide them with
20 support needed to develop the confidence to move to lower levels of care or full community integration.

21 24. Evidence-Based Practices - CONTRACTOR shall focus on using EBPs whenever possible.
 22 CONTRACTOR shall have staff with the needed expertise to collect and analyze data and outcomes in
 23 line with established fidelity measures. This staff will ensure desired outcomes are achieved and
 24 routinely tested for accuracy.

25 25. CONTRACTOR shall conduct ongoing evaluation of practices and outcomes to ensure that
all components of MHSA FSP philosophy, as outlined above, are successfully implemented and
achieving desired results. These results shall be made available to COUNTY and the general public via:
the MHSA website, quarterly outcome focused management meetings and public forums upon request
and approval from COUNTY.

D. PROGRAM SERVICES – CONTRACTOR's program shall include, but not be limited to the
 following services under the provision of Enhanced Recovery FSP services:

<u>Crisis Intervention and Management Services</u>: Emergency response services enabling the
 Client to cope with the crisis while maintaining his/her functioning status within the community and
 aimed at preventing further decompensation. This may include assessment for involuntary
 hospitalization. This service must be available twenty-four (24) hours per day, seven (7) days per week.

36 2. <u>Medication Support Services</u>: Evaluate need for medication, clinical effectiveness, side
 37 effects of medication and obtaining informed consent.

a. Medication education shall be provided including discussing risks, benefits and 1 2 alternatives with the Clients or significant support persons.

3 b. Plan development related to decreasing impairments, delivering of services, evaluating the status of the Client's community functions, and prescribing, dispensing, and administering 4 5 psychotropic medications shall be discussed with the Client and documented.

6 3. <u>Co-Occurring Services</u>: Follow a program that uses a stage-wise treatment model that is 7 non-confrontational, follows behavioral principles, considers interactions between mental illness and 8 substance abuse, and has gradual expectations of abstinence. Mental health and substance use research 9 has strongly indicated that to recover fully, a Client with a co-occurring disorder needs treatment for 10 both problems, as focusing on one does not ensure the other will go away. Co-occurring services 11 integrate assistance for each condition, helping people recover from both in one setting at the same time. All treatment team members shall be co-occurring capable. When appropriate, the American Society of 12 Addiction Medicine (ASAM) criteria shall be utilized to identify an appropriate level of co-occurring 13 14 treatment indicated. Individuals with co-occurring issues shall be provided a range of co-occurring 15 services including linkage to medical detox, social detox, residential treatment, etc.

4. Vocational and Educational Services: As part of the continuum of Recovery it is important 16 17 that members develop an "identity" other than that of a mental health Client; towards this end, members 18 will be supported in exploring a full range of opportunities, including but not limited to, volunteer 19 opportunities, part-time/full-time work, supported employment, competitive employment, and educational opportunities. CONTRACTOR's staff shall have a dedicated Vocational/Educational 20 Specialist to assist enrolled members with these services. 21

22 a. Educational Services: CONTRACTOR shall engage Clients in activities to support 23 them in achieving the highest educational functioning possible. Services and activities may include 24 General Education Diploma preparation, and linkage to colleges, vocational training and adult schools.

25 b. Pre-Vocational/Vocational Services: CONTRACTOR shall engage Clients in prevocational/vocational s activities that assist them in determining their skills, interests, values, and 26 27 realistic career goals, and services that help them in developing work skills, gaining work experience, 28 and finding employment. Activities and services may include, but not be limited to the following areas: 29 career exploration, identification of personal strengths, values, and talents, resume writing, job seeking 30 skills, interviewing skills, job coaching, job placement, job retention, and symptom management in the 31 workplace. The intent of these activities and services is to actively engage Clients in identifying and 32 developing their own positive work identities; building self-confidence and vocational skills; and 33 ultimately obtaining and maintaining employment. CONTRACTOR shall assist Clients to find employment settings that match the members' interests, abilities, aptitudes, strengths and individualized 34 35 goals, and provide supportive services to ensure vocational success.

36 c. Job Coaching/Developing: The Employment Specialist shall assist Clients in the 37 exploration of various career options as well as actively strategizing collaborative relationships in the

private and public sector to create job opportunities for members. This position will work closely with
management staff and the Data Analyst to explore and implement evidence-based best practices in this
area.

4

5. Family and Peer Support Services:

a. Connection to community, family, and friends is a critical element to Recovery and
shall be an integral part of CONTRACTOR's services. The PSCs will work to include Client's natural
support system in treatment and services; peers will be hired as Peer Recovery Specialists to assist
members in their Recovery.

b. Supportive Socialization and Meaningful Community roles: CONTRACTOR shall
provide client-centered services that will assist Clients in their Recovery, self-sufficiency, and in
seeking meaningful life activities and relationships.

12 c. Family Support Services: CONTRACTOR shall create a culture that embraces families in the recovery process. Family therapy is found to be an integral part of the success of this population's 13 recovery. CONTRACTOR shall have a licensed family therapist who has a minimum of two (2) years 14 15 of experience working with family theory and practice. The family therapist will continuously evaluate the needs of the family members, and provide services accordingly. These services will include but not 16 be limited to; multi-family groups, psycho-educational groups, and family therapy. 17 Some of the components of family treatment should include, but not be limited to: communication, family dynamics, 18 19 and resource development.

6. <u>Transportation Services</u>: CONTRACTOR shall provide transportation services which may
 include, but not be limited to: provision of bus tickets; transportation to appointments deemed necessary
 for the Client care; or transportation for emergency psychiatric evaluation or treatment.

7. <u>Money Management/Representative Payee Support Services</u>: CONTRACTOR shall
designate a bonded Representative Payee Services to provide money management services to those
Clients who are not able to manage their finances independently. These Clients include those that have
funding, but are not able to or willing to meet their basic needs without assistance. Money management
will also include individual and/or group education regarding personal budgeting.

8. <u>On-call Services</u>: CONTRACTOR shall provide on-call services. CONTRACTOR staff
must be available twenty-four (24) hours per day, seven (7) days per week for intensive case
management and crisis intervention for enrolled Clients. The on-call staff must be able to respond in
person in a timely manner when indicated.

<u>9. Linkage to Financial Benefits/Entitlements</u>: CONTRACTOR shall employ a Benefits
 Specialist to assist Clients in accessing financial benefits and/or entitlements.. The Specialist shall be
 knowledgeable of benefits/entitlements, such as SSI/SSDI, CalFresh, General Relief, and shall work
 with Clients to gather records, complete the application process, and secure benefits/entitlements as
 quickly as possible.

10. Housing Services: CONTRACTOR shall provide a continuum of housing support to FSP 1 2 Clients. This service category includes a comprehensive needs assessment, linkage and placement in a 3 safe living arrangement, and ongoing support to sustain an appropriate level of housing. CONTRACTOR shall prioritize obtaining appropriate housing and providing supportive services for 4 5 individuals immediately upon enrollment, and throughout the recovery process. CONTRACTOR shall use a Housing First model, an approach that is centered on the belief that individuals can achieve 6 7 stability in permanent housing directly from homelessness and that stable housing is the foundation for 8 pursuing other health and life goals; thus services are oriented to help individuals obtain permanent housing as quickly and with as few intermediate steps as possible. CONTRACTOR shall provide 9 10 supports to help Clients engage in needed services and identify and address housing issues in order to 11 achieve and maintain housing stability. CONTRACTOR shall develop working relationships and collaborations with COUNTY's Housing Services, local housing authorities, community housing 12 13 providers, property owners, property management staff, etc. to ensure that Clients have access to an array of readily available housing options, facilitate successful transition and placement, and maximize 14 15 the Clients' ability to live independently in the community. All Housing options provided by a FSP must meet the minimum requirements set by the COUNTY. CONTRACTOR's staff shall include a 16 Housing Specialist and, if needed, a Supportive Housing PSC to provide housing services and supports 17 to all enrolled members. Housing options shall include, but not be limited to: 18

a. Emergency Housing - Immediate shelter for critical access for Clients who are
homeless or have no other immediate housing options available. Emergency housing is a time-limited
event and shall only be utilized until a more suitable housing arrangement can be secured.

b. Motel Housing – For individuals who may be unwilling or are inappropriate for a
shelter, or when no shelter is available, motel housing may be utilized. Motel housing is time-limited in
nature and shall only be utilized as a last resort until a more appropriate housing arrangement can be
secured. Pre-purchase of motel rooms shall be in accordance with CONTRACTOR's P&P, as identified
in the Responsibilities Paragraph of this Exhibit A.

c. Transitional Housing – For individuals who may benefit from an intermediate step
between shelter and permanent housing. Transitional housing is generally time-limited, up to eighteen
(18) months, and provides structures and programming in the context of housing such as Board and Care
or Room and Board. CONTRACTOR may look into housing options such as master leasing.

d. Permanent Housing – Obtaining permanent housing is an overarching goal for all FSP
 members. Permanent housing refers to housing where tenants have leases that confer the full rights,
 responsibilities and legal protections under housing laws; and includes, but is not limited to, utilization
 of Continuum of Care Vouchers and living independently in homes/apartments and County based
 housing projects.

e. Residential Substance Use Treatment Programs and Sober Living Homes as a housing
 option shall be available when appropriate to provide the Clients with the highest probability of success
 towards Recovery.

11. <u>Integration and Linkage to Primary Care</u> – CONTRACTOR shall work to provide every
Client with a Nursing Assessment, and linkage to a Primary Care Provider to meet the ongoing medical
needs of the Client. CONTRACTOR shall routinely coordinate care planning and treatment with the
primary care physician through obtaining records and consultation. CONTRACTOR shall provide to
the Primary Care Provider when indicated.

9 12. <u>Group Services</u> – CONTRACTOR shall offer a variety of groups based on Client interest
10 and need and may include, but not be limited to: Men's and Women's Groups, Relapse Prevention,
11 Recovery & Wellness, Life Skills, Coping Skills, etc.

12 13. <u>Meaningful Community Roles</u> – CONTRACTOR shall assist each member to find some
meaningful role in his/her life that is separate from the mental illness. The person needs to see himself
or herself in "normal" roles such as employee, son, mother, and neighbor. CONTRACTOR shall work
with each member to join the larger community and interact with people who are unrelated to the mental
illness.

17 14. <u>Intensive Case Management Services</u> – CONTRACTOR shall provide intensive case
 18 management services which shall include a smaller caseload size, team management, an emphasis on
 19 outreach and engagement, and an assertive approach to maintaining contact with Clients.

15. <u>Rehabilitation Services and Therapy</u> - CONTRACTOR shall provide rehabilitation services
to assist Clients to improve, maintain, or restore their functional skills such as daily living skills, social
and leisure skills, grooming and personal hygiene skills, meal preparation skills, support resources,
and/or medication education. As appropriate, CONTRACTOR shall provide trauma-informed therapy
to support Clients in their recovery process. Rehabilitation and therapy may be provided individually, in
a group, or with family members.

16. <u>Peer-Run Center</u> – CONTRACTOR shall operate a Peer-run Center. This peer-run center
will be located at the program site and will provide an opportunity for Clients to develop organizational,
social, and leadership skills as they design a program that meets Clients' needs. All activities and
groups offered are designed and run by Clients enrolled in CONTRACTOR's FSP. CONTRACTOR
shall establish a Peer Advisory Committee to provide client input into program development and quality
improvement.

E. <u>Program Specific Services</u> – Enhanced Recovery Members

CONTRACTOR shall coordinate Clients' needs and services with the Residential
 Rehabilitation providers while the Clients are residing in Residential Rehabilitation facilities.

2. CONTRACTOR shall coordinate engagement services and placement of Clients into the
 FSP with ADMINISTRATOR once Clients are identified and ready to be discharged from long-term

care facilities such as an IMD, Therapeutic Residential Center (TRC), or Mental Health Rehabilitation
 Center (MHRC).

3. CONTRACTOR shall develop transition activities for members who are coming from an
IMD, TRC, or MHRC that details the expectations of the FSP, the responsibilities of the members, FSP,
and other partners involved in the members' recovery, and the ultimate goal of community integration
and graduation.

7 4. CONTRACTOR shall have monthly meetings with ADMINISTRATOR to review
8 members' progress and share information such as housing status, group attendance, medication
9 compliance, hospitalization, and progress towards recovery.

5. CONTRACTOR staff shall have a thorough understanding of LPS conservatorship, the
 conservatorship process, and the resources and supports available for conservatees and private
 conservators.

6. CONTRACTOR shall provide family support services that address the specific needs of
families and/or private conservators including, but not limited to, outreach and engagement, educational
and support groups, and family therapy. As needed, services shall be provided in the evenings and/or
weekends to accommodate family members' and/or private conservators' schedule and needs.

17 18 F. <u>Program Specific Services</u> – Assisted Intervention (AI) Court Members

1. CONTRACTOR shall coordinate services within the guidelines set forth by the court.

CONTRACTOR shall work in a collaborative nature and create a culture and environment
 that shall involve all interested parties such as, but not limited to, the court, ADMINISTRATOR, Public
 Defender, District Attorney, Probation, Clients' families, and the various housing operators.

3. CONTRACTOR shall perform three (3) scheduled and one (1) unscheduled drug testing
each month and report any unfavorable findings to the court.

24 4. CONTRACTOR shall assist members in making their scheduled court dates and, in some
25 instances, attending court hearings with the members.

5. CONTRACTOR shall develop a process for providing members with information that
details the expectations of the court, the responsibilities of the members, FSP, and other partners

G. <u>Collaboration Requirements</u> – CONTRACTOR shall coordinate services, as appropriate, with
 ADMINISTRATOR, Public Guardian's Office, Collaborative Courts, Public Defender's Office, District
 Attorney's Office, Probation, designated Residential Rehabilitation providers, long-term care facilities,
 and other providers and community resources.

CONTRACTOR shall maintain ongoing collaboration with a variety of stakeholders
 involved with individual Clients, including family members and significant others; employers;
 long-term care facilities; COUNTY departments and agencies, such as, but not limited to, Collaborative
 Courts, Probation Department, Public Defender's Office, Public Guardian, and LPS Mental Health.

service coordination in English, Spanish, Vietnamese, Farsi, Arabic and Korean. CONTRACTOR shall
work with the COUNTY or other interpreters for other languages as needed. Direct capacity to conduct
culturally and linguistically appropriate outreach and to serve Clients in other Asian languages and ASL
is highly desirable.

22 c. Integrated Service Team – The Integrated Service Team shall include 23 ADMINISTRATOR and CONTRACTOR staff. The Integrated Service Team shall maintain weekly 24 communication and meet at least monthly to coordinate supports, problem solve, and develop exit 25 strategies/discharge planning. CONTRACTOR staff shall be available to respond to all Clients on a twenty-four (24)-hour per day/seven (7) days per week basis. The identified Residential Rehabilitation 26 27 providers shall also participate on the Integrated Service Team.

28 1) ADMINISTRATOR Role: ADMINISTRATOR staff shall participate on the
29 Integrated Service Team.

2) CONTRACTOR Role: CONTRACTOR shall coordinate and facilitate the

H. Residential Rehabilitation Facilities are an integral component of this program and shall be part
of the collaborative team which includes, but not be limited to, ADMINISTRATOR, CONTRACTOR,
and Residential Care staff. This collaborative team shall review all cases before accepting from longterm care facilities and discuss needs, supports, and areas of risk and work as a single unit in strategizing
and implementing the services necessary to allow the new member the best opportunity to succeed.

I. CONTRACTOR shall develop a collaborative partnership with ADMINISTRATOR's staff who
 will be assigned to work as the liaison between the Collaborative Court and the CONTRACTOR.

J. Discharge of Clients from the program shall be determined by the Clients' movement along the recovery continuum and shall be a coordinated effort between the ADMINISTRATOR and CONTRACTOR.

K. CONTRACTOR shall not engage in, or permit any of its employees or subcontractors, to
conduct research activity on COUNTY Clients without obtaining prior written authorization from
ADMINISTRATOR.

L. CONTRACTOR shall not conduct any proselytizing activities, regardless of funding sources,
with respect to any individual(s) who have been referred to CONTRACTOR by COUNTY under the
terms of the Agreement. Further, CONTRACTOR agrees that the funds provided hereunder will not be
used to promote, directly or indirectly, any religion, religious creed or cult, denomination or sectarian
institution, or religious belief.

M. CONTRACTOR shall have a commitment to meeting the required response times for hospitals
(twenty-four [24] hour response time), and other COUNTY institutions, e.g. jails or clinics (forty-eight
[48] hours).

N. CONTRACTOR shall achieve, at minimum, a ten percent (10%), annual graduation rate for theprogram of the average census at end of year.

O. CONTRACTOR shall have an identified individual who shall:

20 1. Complete one hundred percent (100%) chart review of Client charts regarding clinical
21 documentation and ensure all charts are in compliance with medical necessity and Medi-Cal chart

Y. CONTRACTOR shall have active participation in State and regional MHSA forums andactivities.

Z. CONTRACTOR shall have ongoing collaboration with the Adult and Older Adult Performance
Outcomes and Data Office on MHSA countywide projects, as well as individual performance outcome
measures.

AA. CONTRACTOR shall provide the NPP for the COUNTY, as the MHP, at the time of the first service provided under the Agreement to individuals who are covered by Medi-Cal and have not previously received services at a COUNTY operated clinic. CONTRACTOR shall also provide, upon request, the NPP for the COUNTY, as the MHP, to any individual who received services under the Agreement.

AB. CONTRACTOR shall attend meetings as requested by COUNTY including, but not limited to:

25 1. Case conferences, or other meetings, as requested by ADMINISTRATOR to address any
26 aspect of clinical care.

27 2. Monthly COUNTY management meetings with ADMINISTRATOR to discuss contractual

B. CONTRACTOR shall make its best effort to provide services pursuant to the Agreement in a manner that is culturally and linguistically appropriate for the population(s) served. CONTRACTOR shall maintain documents of such efforts which may include; but not be limited to: records of participation in COUNTY-sponsored or other applicable training; recruitment and hiring P&Ps; copies of literature in multiple languages and formats, as appropriate; and descriptions of measures taken to enhance accessibility for, and sensitivity to, individuals who are physically challenged.

C. CONTRACTOR shall notify ADMINISTRATOR, in writing, within seventy-two (72) hours, of any staffing vacancies or filling of vacant positions that occur during the term of the Agreement.

D. CONTRACTOR shall notify ADMINISTRATOR, in writing, at least seven (7) days in advance, of any new staffing changes; including promotions, temporary FTE changes, and internal or external temporary staffing assignment requests that occur during the term of the Agreement.

E. CONTRACTOR shall ensure that all staff, including interns and volunteers, are trained and have a clear understanding of all P&Ps. CONTRACTOR shall provide signature confirmation of the P&P training for each staff member and place it in their personnel files.

F. CONTRACTOR shall ensure that all staff complete the COUNTY's Annual Provider Trainingand Annual Compliance Training.

C. OBLIGATIONS AND ACTIVITIES OF CONTRACTOR AS BUSINESS ASSOCIATE

The Parties acknowledge that federal and state laws relating to electronic data security and 24 privacy are rapidly evolving and that amendment of this Business Associate Contract may be required to 25 provide for procedures to ensure compliance with such developments. The Parties specifically agree to take such action as is necessary to implement the standards and requirements of HIPAA, the HITECH 26 27 Act, the HIPAA regulations and other applicable laws relating to the security or privacy of PHI. 3. Each workforce member who receives information privacy and security training must sign a certification, indicating the member's name and the date on which the training was 8 9 completed. These certifications must be retained for a period of six (6) years following the termination of Agreement. 10

b. Employee Discipline. Appropriate sanctions must be applied against workforce
members who fail to comply with any provisions of CONTRACTOR's privacy P&Ps, including
termination of employment where appropriate.

c. Confidentiality Statement. All persons that will be working with PHI COUNTY
discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of
COUNTY must sign a confidentiality statement that includes, at a minimum, General Use, Security and
Privacy Safeguards, Unacceptable Use, and Enforcement Policies. The statement must be signed by the

 must have sufficient administrative, physical, and technical controls in place to protect that data, based
 upon a risk assessment/system security review.

d. Removable Media Devices. All electronic files that contain PHI COUNTY discloses to

Applications and systems that 20cannot be patched due to operational reasons must have compensatory controls implemented to 21 22 minimize risk, where possible.

23 g. User IDs and Password Controls. All users must be issued a unique user name for 24 accessing PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, 25 or transmits on behalf of COUNTY. Username must be promptly disabled, deleted, or the password changed upon the transfer or termination of an employee with knowledge of the password, at maximum 26 27 within twenty-four (24) hours. Faxes containing PHI COUNTY discloses to CONTRACTOR or 5 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall not be left unattended and fax machines shall be in secure areas. Faxes shall contain a confidentiality statement 6 7 notifying persons receiving faxes in error to destroy them. Fax numbers shall be verified with the intended recipient before sending the fax. 8

9 f. Mailing. Mailings containing PHI COUNTY discloses to CONTRACTOR or 10 CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY shall be sealed and 11 secured from damage or inappropriate viewing of PHI to the extent possible. Mailings which include five hundred (500) or more individually identifiable records containing PHI COUNTY discloses to 12 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY in 13 a single package shall be sent using a tracked mailing method which includes verification of delivery 14 15 and receipt, unless the prior written permission of COUNTY to use another method is obtained.

F. BREACH DISCOVERY AND NOTIFICATION

17 1. Following the discovery of a Breach of Unsecured PHI, CONTRACTOR shall notify COUNTY of such Breach, however both parties agree to a delay in the notification if so advised by a 18 19 law enforcement official pursuant to 45 CFR § 164.412.

a. A Breach shall be treated as discovered by CONTRACTOR as of the first day on which 20 21 such Breach is known to CONTRACTOR, or by exercising reasonable diligence, would have been 22 known to CONTRACTOR.

2. CONTRACTOR shall provide the notification of the Breach immediately to the COUNTY 26 27 Privacy Officer. CONTRACTOR's notification may be oral, but shall be followed by written notification within twenty-four (24) hours of the oral notification. 28

3. CONTRACTOR's notification shall include, to the extent possible:

30 a. The identification of each Individual whose Unsecured PHI has been, or is reasonably 31 believed by CONTRACTOR to have been, accessed, acquired, used, or disclosed during the Breach;

1) A brief description of what happened, including the date of the Breach and the date 36 of the discovery of the Breach, if known; 37

4 3) Any steps Individuals should take to protect themselves from potential harm

4) A brief description of what CONTRACTOR is doing to investigate the Breach, to
7 mitigate harm to Individuals, and to protect against any future Breaches; and

8 5) Contact procedures for Individuals to ask questions or learn additional information,
9 which shall include a toll-free telephone number, an E-Mail address, Web site, or postal address.

4. COUNTY may require CONTRACTOR to provide notice to the Individual as required in
45 CFR § 164.404, if it is reasonable to do so under the circumstances, at the sole discretion of the
COUNTY.

5. In the event that CONTRACTOR is responsible for a Breach of Unsecured PHI in violation
of the HIPAA Privacy Rule, CONTRACTOR shall have the burden of demonstrating that
CONTRACTOR made all notifications to COUNTY consistent with this Subparagraph F and as
required by the Breach notification regulations, or, in the alternative, that the acquisition, access, use, or
disclosure of PHI did not constitute a Breach.

18 6. CONTRACTOR shall maintain documentation of all required notifications of a Breach or
19 its risk assessment under 45 CFR § 164.402 to demonstrate that a Breach did not occur.

7. CONTRACTOR shall provide to COUNTY all specific and pertinent information about the
Breach, including the information listed in Section E.3.b.(1)-(5) above, if not yet provided, to permit
COUNTY to meet its notification obligations under Subpart D of 45 CFR Part 164 as soon as
practicable, but in no event later than fifteen (15) calendar days after CONTRACTOR's initial report of
the Breach to COUNTY pursuant to Subparagraph F.2 above.

8. CONTRACTOR shall continue to provide all additional pertinent information about the
Breach to COUNTY as it may become available, in reporting increments of five (5) business days after
the last report to COUNTY. CONTRACTOR shall also respond in good faith to any reasonable
requests for further information, or follow-up information after report to COUNTY, when such request
is made by COUNTY.

9. If the Breach is the fault of CONTRACTOR, CONTRACTOR shall bear all expense or
31 other costs associated with the Breach and shall reimburse COUNTY for all expenses COUNTY incurs

H. PROHIBITED USES AND DISCLOSURES

CONTRACTOR shall not disclose PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY about an individual to 25 a health plan for payment or health care operations purposes if the PHI pertains solely to a health care 26 27 item or service for which the health care provider involved has been paid out of pocket in full and the individual requests such restriction, in accordance with 42 USC § 17935(a) and 45 CFR § 164.522(a). 28

29 2. CONTRACTOR shall not directly or indirectly receive remuneration in exchange for PHI COUNTY discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on 30 31 behalf of COUNTY, except with the prior written consent of COUNTY and as permitted by 42 USC § 17935(d)(2). 32

I. OBLIGATIONS OF COUNTY

1. COUNTY shall notify CONTRACTOR of any limitation(s) in COUNTY's notice of 34 35 privacy practices in accordance with 45 CFR § 164.520, to the extent that such limitation may affect CONTRACTOR's Use or Disclosure of PHI. 36

COUNTY shall notify CONTRACTOR of any changes in, or revocation of, the permission

a. Provide an opportunity for CONTRACTOR to cure the material Breach or end the
violation within thirty (30) business days; or

b. Immediately terminate the Agreement, if CONTRACTOR is unwilling or unable to
cure the material Breach or end the violation within thirty (30) days, provided termination of the
Agreement is feasible.

Upon termination of the Agreement, CONTRACTOR shall either destroy or return to
 COUNTY all PHI CONTRACTOR received from COUNTY or CONTRACTOR created, maintained,
 or received on behalf of COUNTY in conformity with the HIPAA Privacy Rule.

a. This provision shall apply to all PHI that is in the possession of Subcontractors or
 agents of CONTRACTOR.

c. In the event that CONTRACTOR determines that returning or destroying the PHI is not

requirements to be complied with are sections E, F, and G, and in Attachment 4 to the IEA, Electronic 1 2 Information Exchange Security Requirements, Guidelines and Procedures for Federal, State and Local 3 Agencies Exchanging Electronic Information with the SSA. CONTRACTOR also agrees to ensure that any of CONTRACTOR's agents or subcontractors, to whom CONTRACTOR provides DHCS PII agree 4 5 to the same requirements for privacy and security safeguards for confidential data that apply to CONTRACTOR with respect to such information. 6

d. Mitigation of Harmful Effects. To mitigate, to the extent practicable, any harmful 8 effect that is known to CONTRACTOR of a use or disclosure of DHCS PI or PII by CONTRACTOR or 9 its subcontractors in violation of this Personal Information Privacy and Security Contract.

10 e. CONTRACTOR's Agents and Subcontractors. To impose the same restrictions and 11 conditions set forth in this Personal Information and Security Contract on any subcontractors or other agents with whom CONTRACTOR subcontracts any activities under the Agreement that involve the 12 disclosure of DHCS PI or PII to such subcontractors or other agents. 13

14 Availability of Information. To make DHCS PI and PII available to the DHCS and/or f. 15 COUNTY for purposes of oversight, inspection, amendment, and response to requests for records, injunctions, judgments, and orders for production of DHCS PI and PII. If CONTRACTOR receives 16 DHCS PII, upon request by COUNTY and/or DHCS, CONTRACTOR shall provide COUNTY and/or 17 DHCS with a list of all employees, contractors and agents who have access to DHCS PII, including 18 19 employees, contractors and agents of its subcontractors and agents.

20 g. Cooperation with COUNTY. With respect to DHCS PI, to cooperate with and assist 21 the COUNTY to the extent necessary to ensure the DHCS's compliance with the applicable terms of the 22 CIPA including, but not limited to, accounting of disclosures of DHCS PI, correction of errors in DHCS 23 PI, production of DHCS PI, disclosure of a security Breach involving DHCS PI and notice of such 24 Breach to the affected individual(s).

25 h. Breaches and Security Incidents. During the term of the Agreement, CONTRACTOR 26 agrees to implement reasonable systems for the discovery of any Breach of unsecured DHCS PI and PII 27 or security incident. CONTRACTOR agrees to give notification of any Breach of unsecured DHCS PI 28 and PII or security incident in accordance with Subparagraph F, of the Business Associate Contract, Exhibit B to the Agreement. 29

i. Designation of Individual Responsible for Security. CONTRACTOR shall designate 30 31 an individual, (e.g., Security Officer), to oversee its data security program who shall be responsible for 32 carrying out the requirements of this Personal Information Privacy and Security Contract and for 33 communicating on security matters with the COUNTY.
