AMENDMENT NUMBER ONE TWO TO AGREEMENT N1000009934 BETWEEN THE COUNTY OF ORANGE AND COMMUNITY SERVICE PROGRAMS, INC.

This AMENDMENT NUMBER ONE TWO to Contract Number N1000009934 (hereinafter "AMENDMENT NUMBER ONE TWO") between the County of Orange, a political subdivision of the state of California (hereinafter "COUNTY") and Community Service Programs, Inc. (hereinafter "CONTRACTOR") with a place of business at 1821 East Dyer Road, Suite 200, Santa Ana, CA 92705, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Domestic Violence Victim Services, Contract number N1000009934 (hereinafter "ORIGINAL AGREEMENT") for a five (5) year term of May 13, 2008 through and including May 12, 2013;

WHEREAS, COUNTY and CONTRACTOR extended the ORIGINAL AGREEMENT (hereinafter "AMENDMENT NUMBER TWO") for a one (1) year term of May 13, 2013 through and including May 12, 2014 at a not-to-exceed amount of \$60,000; desires to extend the ORIGINAL AGREEMENT for a one (1) year term by \$60,000 for a new not to-exceed amount of \$135,000 and CONTRACTOR agrees to provide these services at the rates set forth in the ORIGINAL AGREEMENT.

WHEREAS, COUNTY desires to extend the ORIGINAL AGREEMENT for an additional six (6) months for a cost not to exceed \$30,000 for a new not –to-exceed amount of \$90,000 for the period of May 13, 2013 through and including November 12, 2014 and CONTRACTOR agrees to provide these services at the rates set forth in the ORIGINAL AGREEMENT.

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

- a. Additional Terms and Conditions, Section Term of Contract, of the ORIGINAL AGREEMENT is amended to read in its entirety as follows:
 - 1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 5/13/08 through and including 5/12/14 11/12/14, unless otherwise terminated by
