AND  
INSITE TELECOM, INC.

This AMENDMENT NUMBER THREE to Contract Number MA-060-16012109 (hereinafter "AMENDMENT NUMBER THREE") between the County of Orange, a political subdivision of the State of California, (hereinafter "COUNTY") and InSite Telecom, Inc. (hereinafter "CONTRACTOR") with a place of business at 521 W. Briardale Ave., Orange, CA 92865, is made and entered upon execution of all necessary signatures.

**RECITALS**

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Radio Tower Transmission Equipment Maintenance on June 17, 2016, as Contract Number MA-060-16012109 (hereinafter "ORIGINAL CONTRACT"), for a one (1) year term of July 1, 2016 through and including June 30, 2017 renewable for four (4) additional one (1) year terms; and

WHEREAS, the Board of Supervisors approved a one-time increase of \$145,928.00 on February 28, 2017 for the contract term of July 1, 2016 through June 30, 2017, for the removal of old coax antennas and the installation of new coax, antennas and weatherproofing all connections, for a new not to exceed contract amount of \$240,928.00 (hereinafter "AMENDMENT NUMBER ONE");

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on June 6, 2017 as Contract Number MA-060-17011548 for a one-year term of July 1, 2017 through and including June 30, 2018 as well as increased the not to exceed contract amount by \$153,746.00 for a new not to exceed amount of \$248,476.00 (hereinafter "AMENDMENT NUMBER TWO");

WHEREAS, COUNTY desires to increase the current Contract amount of \$248,476.00 of Contract Number MA-060-17011548 by \$70,000 for a new not to exceed amount of \$318,476.00 for the contract term of 7/1/2017 through and including 6/30/2018 to complete the modification of the antenna system for both old 800 CCCS equipment and new P25 equipment; and

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-18011367 for a one-year term of July 1, 2018 through and including June 30, 2019 in an amount not to exceed of \$145,000.00 and the CONTRACTOR has agreed to provide those services at the rates set forth in the AMENDMENT NUMBER TWO;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

- a. Additional Terms and Conditions, Section Term of Contract of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

2. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 7/1/16 through and including 6/30/19, unless otherwise terminated by COUNTY. The period of 7/1/16 through and including 6/30/17 shall be known as Contract number MA-060-16012109. The period of 7/1/17 through and including 6/30/18 shall be known as Contract number MA-060-17011548. The period of 7/1/18 through and including 6/30/19 shall be known as Contract number MA-060-18011367. This Contract may be renewed for two (2) additional one-year terms by mutual written agreement of both Parties. The County does not have to give a reason if it elects not to renew.

- b. Attachment B, Pricing, “Contract ~~S~~shall ~~N~~ot ~~e~~Exceed” amount has been modified to read as follows:

Contract shall not exceed \$318,476.00 per Contract year term for Contract # MA-060-17011548 for the term of 7/1/2017 through and including 6/30/2018.

Contract shall not exceed \$145,000.00 per Contract year term for Contract # MA-060-18011367 for the term of 7/1/2018 through and including 6/30/2019.

5. All other provisions of the ORIGINAL CONTRACT, AMENDMENT NUMBER ONE and AMENDMENT NUMBERTWO herein and to the extent they are not inconsistent with this AMENDMENT NUMBER THREE, remain unchanged and in full force and effect.
