

AMENDMENT TO CONTRACT MA-063-14011816 16011409 TO RENEW FOR THE THIRD FINAL TERM AS MA-063-16011409 17011459 WITH INTRATEK COMPUTER INC

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, Social Services Agency (SSA), a political subdivision of the State of California with place of business at 500 N. State College Blvd., Orange, CA 92868-1673 (referred to as "County"), and Intratek Computer Inc., with a place of business at 9950 Irvine Center Drive, Irvine, CA 92618, (referred to as "Contractor"), for IT Professional Help Services. County and Contractor may be individually referred to as "Party", or collectively referred to as "Parties".

WHEREAS, the County and Contractor entered into a Subordinate Agreement MA-063-13011607 (referred to as "Contract"), in the amount of \$444,472 effective June 1, 2013 through May 31, 2014 per the terms, conditions and pricing of Regional Cooperative Agreement MA-017-12011688 (referred to as "RCA") effective June 1, 2012 renewed through May 31, 2017; and

WHEREAS, both Parties agreed to amend Amendment #1 to change the Contractor's address from 200 E. Sandpointe Ave., Ste 520, Santa Ana, CA 92707 to the new address 9950 Irvine Center Drive, Irvine, CA 92618; and

WHEREAS, both Parties agreed to renew the Contract for the second a two-year term as Contract MA-063-14011816, in the amount of \$380,917, effective June 1, 2014 through May 31, 2016; and

WHEREAS, both Parties agreed to renew the Contract for a one-year term as Contract MA-063-16011409 in the amount of \$127,187, effective June 1, 2016 through May 31, 2017 and amended Attachment B Classification Rate Schedule; and

WHEREAS, both Parties agree to amend renew Contract for one (1) additional consecutive year term to be co-terminus with per the term of the RCA, extended through May 31, 2018; and

WHEREAS, County and Contractor agree that this Contract is effective upon mutual agreement of both parties and County of Orange Board of Supervisor's approval; and

NOW THEREFORE, the Parties agree as follows:

- Renew Contract MA-063-14011816 16011409 for third a final one-year term effective June 1, 2016 2017 through May 31, 2017 2018 as Contract MA-063-16011409 17011459 for an annual amount not to exceed \$127,187.
