

AMENDMENT TO CONTRACT MA-063-14011823 16011413 TO RENEW FOR THE THIRD FINAL TERM AS MA-063-16011413 17011461 WITH SUPERBTECH INC

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, Social Services Agency (SSA), a political subdivision of the State of California with place of business at 500 N. State College Blvd., Orange, CA 92868-1673 (referred to as "County"), and SuperbTech Inc., with a place of business at 5800 Hannum Ave., Ste. 150, Culver City, CA 90230-6553, (referred to as "Contractor"), for IT Professional Help Services. County and Contractor may be individually referred to as "Party", or collectively referred to as "Parties".

WHEREAS, the County and Contractor entered into a Subordinate Agreement MA-063-13011706 (referred to as "Contract"), in the amount of \$1,006,344 effective June 1, 2013 through May 31, 2014 per the terms, conditions and pricing of Regional Cooperative Agreement MA-017-12011692 (referred to as "RCA") effective June 1, 2012 renewed through May 31, 2017; and

WHEREAS, both Parties agreed to renew the Contract for the second a two-year term as Contract MA-063-14011823, in the amount of \$2,016,514, effective June 1, 2014 through May 31, 2016; and

WHEREAS, both Parties agreed to renew the Contract for a one-year term as Contract MA-063-16011413 in the amount of \$676,857, effective June 1, 2016 through May 31, 2017 and amended Attachment B Classification Rate Schedule; and

WHEREAS, both Parties agree to amend renew Contract for one (1) additional consecutive year term to be co-terminus with per the term of the RCA, extended through May 31, 2018; and

WHEREAS, County and Contractor agree that this Contract is effective upon mutual agreement of both parties and County of Orange Board of Supervisor's approval; and

NOW THEREFORE, the Parties agree as follows:

- Renew Contract MA-063-14011823 16011413 for third a final one-year term effective June 1, 2016 2017 through May 31, 2017 2018 as Contract MA-063-16011413 17011461 for an amount not to exceed \$676,857.
