

**AMENDMENT NO.1  
TO THE AGREEMENT FOR

This Amendment No.1 to the AGREEMENT (the "Amendment"), is made and entered into the \_\_\_\_\_ day of \_\_\_\_\_, 2014, between the County of Orange, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and Jeff Oviedo & Associates, Inc. hereinafter referred to as the "Project Manager", together collectively referred to as the "Parties".

**WHEREAS**, On April 23, 2013, the COUNTY and Project Manager entered into an Architect-Engineer Agreement for the John Wayne Airport (JWA) Project Management Services in the not-to-exceed amount of \$1,050,000 herein referred to as ("Agreement"); and

**WHEREAS**, Increases in the Airport's need for project management services have necessitated a revision to the Agreement, to perform Project Management Services through the term of the Agreement; and

**WHEREAS**, Project Manager wishes to continue to provide Project Management Services under the terms of the Agreement as amended below.

**NOW THEREFORE**, the terms of the Agreement shall remain in full force and effect, and shall be amended as follows:

- I. County shall pay to the Project Manager for performance of the Agreement the additional not-to-exceed fee of \$ 656,640, to be invoiced for services rendered on an hourly, Time & Material basis, effective upon County's approval of Amendment No. 1 and through April 22, 2016. This additional fee will result in a new not-to-exceed Agreement amount of \$ 1,706,640.

The foregoing is in accordance with our Agreement and subject to the following:


1. The aforementioned change and work affected thereby, is subject to all Agreement stipulations and covenants; and
2. All claims against the County which are incidental to or as a consequence of the aforementioned changes are fully satisfied and the A-E firm hereby releases the County from all said claims.
