This AMENDMENT NUMBER ~~ONE TWO~~ to ~~Subordinate~~ Contract Number MA-060-15011702 (hereinafter "AMENDMENT NUMBER ~~ONE TWO~~") between the County of Orange, a political subdivision of the state of California (hereinafter "COUNTY") and Vertiq Software LLC. (hereinafter "CONTRACTOR") with a place of business at 18625 Sutter Blvd., Suite 500, Morgan Hill, CA 95037, is made and entered upon execution of all necessary signatures.

RECITALS

WHEREAS, COUNTY and CONTRACTOR executed a ~~Subordinate~~ Contract for Coroner Medical Examiner (CME) Software Maintenance and Support on May 19, 2015, as Contract Number MA-060-15011702 (hereinafter "ORIGINAL CONTRACT") for a two (2) year term of June 1, 2015 through and including May 31, 2017, renewable for three (3) additional, one-year terms; and

WHEREAS, COUNTY and CONTRACTOR ~~desires to renew~~ed the ORIGINAL CONTRACT on March 14, 2017 as Contract Number MA-060-17011508 for a one (1) year term of June 1, 2017 through and including May 31, 2018 in the amount of \$15,000 ~~and the CONTRACTOR has agreed to remove those services at the rates set forth in the ORIGINAL CONTRACT;~~ (hereinafter "AMENDMENT NUMBER ONE");

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term of June 1, 2018 through and including May 31, 2019 in the amount of \$15,000 as Contract Number MA-060- 18011834, and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

ARTICLES

- a. Additional Terms and Conditions, Section 2, Term of Contract, is amended to read in its entirety as follows:
  1. Term of Contract:  
 This Contract shall commence upon execution of all necessary signatures, and continue in effect from 6/1/15 through and including 5/31/18~~9~~, unless otherwise terminated by COUNTY. The period of 6/1/15 through and including 5/31/17 shall be known as Contract Number MA-060-15011702. The period of 6/1/17 through and including 5/31/18 shall be known as

Contract Number MA-060-17011508. The period of 6/1/18 through and including 5/31/19 shall be known as Contract Number MA-060-18011834. Contract may be renewed ~~up to for two one~~ (2) additional one (1) year terms upon mutual agreement of both parties. The County does not have to give reason if it elects not to renew.

2. A true and correct copy of the ORIGINAL CONTRACT (Contract Number MA-060-15011702) is attached hereto as Exhibit A and incorporated by this reference.

3. A true and correct copy of the AMENDMENT NUMBER ONE (Contract Number MA-060-17011508) is attached hereto as Exhibit B and incorporated by this reference.

4. All other provisions of the ORIGINAL CONTRACT, ~~and AMENDMENT NUMBER ONE~~ except as amended herein and to the extent they are not inconsistent with this AMENDMENT NUMBER ~~ONE TWO~~, remain unchanged in full force and effect.
