WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT, as Contract Number MA-060-15011749 for a one-year term of June 19, 2015 through and including June 18, 2016 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in this AMENDMENT NUMBER THREE:

WHEREAS, COUNTY desires to renew the and CONTRACTOR renewed the ORIGINAL CONTRACT on May 19, 2015, as Contract Number MA-060-15011749 (hereinafter "AMENDMENT NUMBER THREE"), for a one-year term of June 19, 2015 through and including June 18, 2016;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT, as Contract Number MA-060-16012062 for a one-year term of June 19, 2016 through and including June 18, 2017 in an amount not to exceed \$56,467.60; and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in this AMENDMENT NUMBER FOUR;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:
