The term of this Agreement shall be July $\frac{1714}{1}$, 20156 through August $\frac{1614}{1}$, 20156.

B. SERVICES BY COUNTY:

COUNTY, through its Sheriff-Coroner and deputies, officers and employees, hereinafter referred to as "SHERIFF", shall be responsible for and render to STATE the following services at the 20156 Orange County Fair:

- SHERIFF shall render law enforcement services during the 2015 Orange County Fair, beginning at 0800 hours on July <u>1714</u>, 201<u>56</u>, and terminating at 1600 hours on August <u>1614</u>, 201<u>56</u>. Such services shall include the enforcement of STATE statutes and, in SHERIFF's sole discretion, the enforcement of the City of Costa Mesa Municipal Code.
- SHERIFF shall be responsible for and render to STATE law enforcement services at all areas of the Orange County Fairgrounds during the dates and hours referenced herein.
- SHERIFF shall provide all staffing, supervision, communications, supplies
 and equipment necessary to deliver services, as required by planned
 staffing assignment levels previously agreed upon by STATE and SHERIFF.
- 4. By mutual agreement in writing between the STATE, through the Fair Director or designee, and the COUNTY, through SHERIFF, planned staffing assignment levels may be increased or decreased, depending on the need.

C. MEGAN'S LAW SCREENING OF SHERIFF PERSONNEL:

SHERIFF shall ensure that SHERIFF personnel assigned to provide law enforcement services pursuant to this Agreement will comply with all Megan's Law requirements.

D. PAYMENT:

- STATE agrees to pay COUNTY the total cost of the services described in Section B of this Agreement. COUNTY's costs include salaries, wages, benefits, services, supplies, equipment, transportation, and divisional, departmental and COUNTY overhead.
- Rates provided by position title to STATE for use in the STATE Standard
 Agreement as referenced herein may not be indicative of actual deployment
 under Section B of this Agreement.
- 3. The Maximum Obligation of STATE for services rendered under Section B of this Agreement is \$500,00000.\$500,000
- COUNTY shall invoice STATE within thirty (30) days of the termination of this Agreement for the cost of services rendered under Section B of this Agreement.
- STATE shall pay COUNTY in accordance with COUNTY Billing Policy, adopted by the Board of Supervisors through Minute Order dated October 27, 1992 (Attachment A).

E. ALTERATION OF TERMS:

This Agreement, together with Standard Agreement No. SA-062-15FTSA-081-16FT, fully expresses all understanding of STATE and COUNTY with respect to the subject matter of this Agreement and shall constitute the total Agreement between the parties for these purposes. No addition to, or alteration of, the terms of this Agreement shall be valid unless made in writing, formally approved and executed by duly authorized agents of both parties.

F. STATUS OF COUNTY:

COUNTY is, and shall at all times be deemed to be, an independent contractor and shall be wholly responsible for the manner in which it performs the services

required of it by the terms of this Agreement. Nothing herein contained shall be construed as creating the relationship of employer and employee, or principal

F. STATUS OF COUNTY: (Continued)

and agent, between STATE and COUNTY or any of COUNTY's agents or employees. COUNTY and its SHERIFF shall retain all authority for rendition of services, standards of performance, control of personnel, and other matters incident to the performance of services by COUNTY pursuant to this Agreement. COUNTY, its agents and employees, shall not be entitled to any rights or privileges of STATE employees and shall not be considered in any manner to be STATE employees.
