WHEREAS, COUNTY and CONTRACTOR desires to renewed the ORIGINAL CONTRACT (hereinafter "AMENDEMENT NUMBER TWO"), as Contract Number MA-060-16011749, on June 28, 2016 -for a one (1) year term of July 1, 2016 through and including June 30, 2017 and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT, as Contract Number MA-060-17011637 for a one (1) year term of July 1, 2017 through and including June 30, 2018 and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES
