WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT, as Contract Number MA-060-12011470 (hereinafter "AMENDMENT NUMBER TWO"), for a one (1) year term of July 1, 2012 through and including June 30, 2013;

WHEREAS, COUNTY desires to renew and CONTRACTOR renewed the ORIGINAL CONTRACT, as Contract Number MA-060-13012028 (hereinafter "AMENDMENT NUMBER THREE"), for an additional one year term for a one (1) year term of July 1, 2013 through and including June 30, 2014;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT, as Contract Number MA-060-14011774 to be effective for a one year term of July 1, 2014 through and including June 30, 2015 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

a. Additional Terms and Conditions, Section **Term of Contract**, of the ORIGINAL AGREEMENT is amended to read in its entirety as follows:

The period of 7/1/14 through and including 6/30/15 shall be known as Contract number MA-060-14011774. This Contract is non-renewable.
