# AMENDMENT NUMBER THREE FOUR TO CONTRACT MA-060-11012429 BETWEEN THE COUNTY OF ORANGE AND MCM TECHNOLOGY LLC

This AMENDMENT NUMBER THREE FOUR to Contract number MA-060-11012429 (hereinafter "AMENDMENT NUMBER THREE FOUR") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and MCM Technology, LLC, (hereinafter "CONTRACTOR") with a place of business at 3510 Vann Rd., Ste 105., Birmingham, AL 35235; is made and entered upon execution of all necessary signatures.

### RECITALS

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Maintenance and Support Services for Communications Accounting & Asset Management Software Agreement Number MA-060-11012429, (hereinafter "ORIGINAL CONTRACT"), for a one (1) year term of June 27, 2011 through and including June 26, 2012, renewable for four (4) additional, one-year terms; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT, as Contract Number MA-060-12011867 (hereinafter "AMENDMENT NUMBER ONE"), for a one (1) year term effective June 27, 2012 through and including June 26, 2013;

WHEREAS, COUNTY and CONTRACTOR amended the ORIGINAL CONTRACT (hereinafter "AMENDMENT NUMBER TWO"), to change payment terms to be paid in advance, as per revised ATTACHMENT C "Compensation and Pricing Provisions" of the ORIGINAL CONTRACT;

WHEREAS, COUNTY and CONTRACTOR amended the ORIGINAL AGREEMENT (hereinafter "AMENDMENT NUMBER THREE"), to (1) extend the term of the ORIGINAL CONTRACT for a one (1) year period of June 27, 2013 through and including June 26, 2014, as Contract Number MA-060-13011752, (2) revise Attachment B "Pricing" to increase the not to exceed amount for items #3 through #5, (3) revise Attachment C "Compensation and Pricing Provisions" to change the payment term and (4) revise Provision F "Acceptance and Payment" to reflect payment in advance;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT, as Contract Number MA-060-14011693 for a one (1) year term of June 27, 2014 through and including June 26, 2015 at the new contract not to exceed amount of \$31,615.18 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in the ORIGINAL CONTRACT;

**NOW THEREFORE,** in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

## 1. **ARTICLES**

a. Additional Terms and Conditions, Section **Term of Contract**, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

### 1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 6/27/11 through and including 6/26/14 15, unless otherwise terminated by COUNTY. The period of 6/27/11 through and including 6/26/12 shall be known as Contract number MA-060-11012429. The period of 6/27/12 through and including 6/26/13 shall be known as Contract number MA-060-12011867. The period of 6/27/13 through and including 6/26/14 shall be known as Contract number MA-060-13011752. The period of 6/27/14 through and including 6/26/15 shall be known as Contract number MA-060-14011693. This Contract may be renewed for two (2) one (1) additional one (1) year terms by mutual agreement of both Parties. Each renewal of this Contract may require approval by the Board of Supervisors. The COUNTY does not have to give a reason if it decides not to renew.

b. Attachment B, **Pricing** of the ORIGINAL CONTRACT is amended to increase the contract not to exceed amount as follows:

All obligations of the Parties that would have been terminated on June 26, 2013 14 are hereby extended to June 26, 2014 15.
