"The Housing Full Service Partnership (FSP) will expand services to the South Service Planning Area of Orange County and will serve previously homeless adults living with a serious mental illness, who may have a co-occurring substance use disorders and who are residing in permanent housing but are at risk of losing their housing. The Housing FSP Program is a specialized field-based program that effectively engages individuals who have come from homelessness, and provides intensive and comprehensive treatment and support that focuses on preventing loss of housing while increasing housing sustainability. The program will provide services that are recovery oriented and will include intensive case management, crisis intervention, on-site housing support, transportation, medication support, individual, family and group therapy, co-occurring services, vocational and educational support, linkage to financial benefits/entitlements, family and peer support and development of

supportive socialization, meaningful community roles, money management skills or coordination of representative payee services. "
