Comment on item 6

To those on the Board of Supervisors,

You must substantially change this proposed budget of county discretionary dollars to provide for the essential Community Resources and Benefits, specifically affordable housing and services versus your continuous inflation in the area of Public Protection with often deadly "Social Control" techniques. There is NOTHING currently in this budget to fund permanent affordable housing but another significant increase in Sheriff's spending. You need to get out of the pricey shelter business (which has been a dismal failure) and invest in Housing First. Cutting all funding to Musick expansion would also save many dollars and lives.

To meet other goals, plan now to put a housing bond measure on the ballot to fund permanent, affordable housing which is so desperately needed and key to meeting your assigned current Housing Element RHNA work goals. Orange County citizens are ready to support such a measure, especially when they realize the levels of housing insecurity in their neighborhood. We need assurances and oversight opportunities of how you will manage American Rescue Plan and state budget revise monies recently and specifically allocated to ending Homelessness and housing insecurity.

You also need to include community access and transparency of the budget process through participatory budgeting plans. You are making very poor decisions with our tax dollars and we have the right to be part of the process. The County Budget Primer page, paragraph 5 states: "The County Budget Office plans and conducts public budget workshops." Sounds like a great idea! When have you ever done that? Again your misrepresentation of your practices and purported interest in the wider community is disgraceful.

As you probably can imagine, your ongoing budgetary decisions do not reflect my values--and they are literally killing people by denying them life-saving housing and services if not being killed by sheriffs on the street.
