# STATE OF FLORIDA

# OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 21-81

(Prohibiting COVID-19 Vaccine Passports)

WHEREAS, on March 9, 2020, I issued Executive Order 20-52, subsequently extended, declaring a state of emergency for the entire State of Florida as a result of COVID-19; and

WHEREAS, on December 23, 2020, I issued Executive Order 20-315, as subsequently extended by Executive Orders 21-46, 21-47, 21-62, 21-67, and 21-79, directing Florida's initial phase of vaccine distribution and prioritizing seniors first; and

WHEREAS, the State of Florida is leading the effort to distribute the vaccine to elderly and vulnerable populations of the State and has successfully provided vaccines to nearly 3.5 million seniors; and

WHEREAS, many Floridians have not yet had the opportunity to obtain a COVID-19 vaccination, some have infection-acquired immunity, and others may be unable to obtain a COVID-19 vaccination due to health, religious, or other reasons; and

WHEREAS, Florida seeks to ensure that every Floridian who desires a COVID-19 vaccine can obtain one, but such vaccines will not be mandated; and

WHEREAS, no COVID-19 vaccine is required by law; and

WHEREAS, individual COVID-19 vaccination records are private health information which should not be shared by mandate; and

WHEREAS, so-called COVID-19 vaccine passports reduce individual freedom and will harm patient privacy; and

WHEREAS, requiring so-called COVID-19 vaccine passports for taking part in everyday life—such as attending a sporting event, patronizing a restaurant, or going to a movie theater—would create two classes of citizens based on vaccination; and

WHEREAS, it is necessary to protect the fundamental rights and privacies of Floridians and the free flow of commerce within the state.

NOW, THEREFORE, I, RON DESANTIS, as Governor of Florida, by virtue of the authority vested in me by Article IV, Section 1(a) of the Florida Constitution and by the Florida Emergency Management Act, as amended, and all other applicable laws, promulgate the following Executive Order:

Section 1. No Florida government entity, or its subdivisions, agents, or assigns, shall be permitted to issue vaccine passports, vaccine passes, or other standardized documentation for the purpose of certifying an individual's COVID-19 vaccination status to a third party, or otherwise publish or share any individual's COVID-19 vaccination record or similar health information.

Section 2. Businesses in Florida are prohibited from requiring patrons or customers to provide any documentation certifying COVID-19 vaccination or post-transmission recovery to gain access to, entry upon, or service from the business.

Section 3. All executive agencies under my direction shall work to ensure businesses comply with this order. Any provision of Florida Statutes is hereby suspended solely to the extent it restricts a Florida agency from requiring compliance with this order as a condition for a license, permit, or other state authorization necessary for conducting business in Florida.

Section 4. All businesses must comply with this order to be eligible for grants or contracts funded through state revenue.

Section 5. The requirements in this order do not otherwise restrict businesses from instituting COVID-19 screening protocols in accordance with state and federal law to protect

public health, and nothing herein shall be construed to interfere with individuals' rights to access their own personal health information under federal law.

Section 6. This order is effective immediately and shall remain in effect for the duration of Executive Order 20-52, as extended.

- 1) It is time to end this ongoing "state of emergency" in Orange County. As per CA HSC 104080, "Whenever a local health emergency is declared by a local health officer pursuant to this section, the local health emergency shall not remain in effect for a period in excess of seven days unless it has been ratified by the board of supervisors, or city council, whichever is applicable to the jurisdiction. The board of supervisors, or city council, if applicable, shall review, at least every 30 days until the local health emergency is terminated, the need for continuing the local health emergency and shall proclaim the termination of the local health emergency at the earliest possible date that conditions warrant the termination." Why are we still in this "state of emergency"? Our covid numbers continue to fall and the vaccinations continue to increase. - > I am concerned about the county's proposed policy to allow local businesses to require proof of COVID vaccination for entry into their stores. This policy is to be read today. While the board is invested in creating a safe environment for the community, I do not agree that a policy of mandatory COVID vaccination is a responsible method of protecting the community's health.

- > Secondly, the COVID vaccines are and will remain experimental for some time. When the FDA fully approves the COVID vaccines and removes their emergency authorizations, institutions will likely feel that it is acceptable to mandate these vaccines. However, even if the FDA does not deem the vaccines experimental, they have only been available for less than a year, and past laboratory tests of different COVID vaccines on rats and cats have resulted in 100% of participants' deaths once the vaccinated animals were subjected to the live virus. -- CA HSC 24171 and 24172 declare that individuals have the right to determine what is done to their own bodies and to refuse consent to medical experimentation without duress, coercion or influence. Community members should be able to decide for themselves if they want to take a new vaccine with relatively new RNA technology into their bodies. I am not even mentioning the numerous cases of severe side effects and even deaths resulting from these vaccines, just in San Diego county this past spring.

My name is Kelli Bourne and I am a long time resident of Orange County.

I would like to express my support and gratitude for maintaining vaccination sites throughout OC, including a move to community-based vaccine disbursement in high-impact communities.

Dear Orange County Board of Supervisors,

My wife and I have been residents of Orange County the last 35 years, 42 of the last 49 years. We've raised our children here, and now they are raising their children here. Sadly, a consistent topic of discussion among our family, as well as several of our friends and neighbors, has been the mismanagement of the pandemic by the Board of Supervisors, our elected representatives. Those of us who have occasionally tuned in to watch Board meetings, have witnessed how most of the people there making public comments, are those who have denied the seriousness of COVID-19 and vehemently protested the public health guidelines put forward by the local, state, national, and even global public health experts. These public health officials (e.g. Dr. Nichole Quick), who have been elevated to their positions specifically to protect the public, and their recommendations are derived from ongoing data provided by our nation's leading epidemiologists, virologists, infectious disease specialists, and emergency doctors. Unfortunately, this small segment of the public - the only ones who felt emboldened to gather indoors to attend Board meetings, apparently wielded influence on the Board's decisions through several of the early months of the pandemic; and their continued greponderance of science-denying rhetoric is driving unfounded rumors and propaganda that not only in a continues to do notable damage to the reputation of Orange County (as we hear all about it from our relatives and friends across the country), but is now causing the Board additional work in trying to shut down these rumors (e.g., forced vaccinations, mandatory vaccine passports, etc.).

And as such, we've all strictly followed the guidelines of social distancing, masking in public, no gatherings (even with family indoors, etc). And like most people we know, the first priority for every member of our family this year was to schedule and receive the vaccine as soon as possible – to help ensure the safety of each other and our community. And we recognize and believe what the vast majority of the experts have said, that our schools, businesses, careers, and personal lives will not return to what we remember as 'normal' until at least 70% to 80% of our nation's population is vaccinated.

As infections, hospitalizations and deaths continue to fall and our county and state move towards opening, we truly believe we should all have and need access to digital proof of being vaccinated; as the vaccine cards issued don't fit in a wallet, are not durable, and more importantly — are easily forged. As international travel begins to open up, most nations are requiring proof of vaccine (or current COVID test results), and many businesses (airlines, sports venues, concert halls, theaters, etc.) are actively considering requiring proof of vaccination in order to protect their employees, their clientele, and their business from any further shutdowns.

As such, we urge the Board to ignore the noise from the fringe minority, eliminate any further delays, by expeditiously taking the appropriate action of approval for Cura-Patient, the developers, to add this vital, necessary, and valuable feature to the Othena app; as Los Angeles County and other counties have already done.

When the pandemic began, my family and took every health precaution advised, we pulled our children out of school and had them attend virtually, we worked from home, wore masks when we went out for essential supply runs only, and did not see family or friends. Unfortunately, a medical situation required that I have a surgical procedure in mid-December 2020, and I ended up contracting COVID. Within 72 hours of my symptoms, my husband and 11 year old daughter started having symptoms. Thankfully, our 17 year old daughter was asymptomatic, and was able to take care of the three of us during this time. Not only did we have to deal with our symptoms, we were also aware that the hospitals were surging, there was no room at any of the ICUs, and Orange County was running out of ventilators. Our youngest daughter recovered within a week, but it took me 7 weeks until I felt somewhat normal. However, my husband, who prior to COVID was in near perfect health, is still trying to recover all these months later. He is now asthmatic, still deals with bouts of exhaustion, and has other "long hauler" symptoms.

Three out of the four of us have been relieved to receive the vaccine, and our youngest daughter will be getting the vaccine in August when she turns 12, but until then, we need to keep her safe. By approving the continuance of the health emergency, this will help us, and many other Orange County parents, keep our kids safe until OC's youngest residents are able to be vaccinated and protected against this cruel virus that has already claimed the lives of nearly 600,000 Americans, and nearly 63,000 Californians.
