10 ORANGE, a political subdivision of the State of California, hereinafter referred to as
11 "COUNTY", to amend, effective July 1, 2014, that certain Agreement between the
12 parties commencing July 1, 2013, hereinafter referred to as the "Agreement".

~~The term of this Agreement shall be for five (5) years, commencing July 1, 2013 and terminating June 30, 2018, unless earlier terminated by either party or extended in the manner set forth herein.~~

~~B. OPTIONAL TERMINATION:~~

~~COUNTY or CITY may terminate this Agreement, without cause, upon one hundred and eighty (180) days written notice to the other party.~~

~~C. REGULAR SERVICES BY COUNTY:~~

~~1. COUNTY, through its Sheriff-Coroner and deputies, officers and employees, hereinafter referred to a "SHERIFF", shall render to CITY law enforcement services as hereinafter provided. Such services shall include the enforcement of lawful State statutes.~~

~~— Sheriff shall be responsible for the enforcement of all lawful CITY ordinances, except those enforced by CITY. CITY shall be responsible for the enforcement of all lawful CITY ordinances, except those enforced by Sheriff. Except as otherwise directed by CITY's Council, SHERIFF and CITY's Manager shall jointly determine which of CITY's lawful ordinances SHERIFF shall be responsible for enforcing.~~

~~2. The night, day and evening patrol and supervisory shifts will be established by SHERIFF. Personnel of each shift may work varying and different times and may be deployed to other shifts when, in the opinion of SHERIFF and CITY Manager, the need arises. Any long-term shift deployment change will be reported to the City Council.~~

~~3. Each fiscal year, at a date to be determined by CITY, COUNTY shall submit to CITY, in writing, a recommended level of service for the following fiscal year. CITY shall remit to COUNTY, in writing, its response to the recommended level of service. If the parties are unable to agree by June 30 of any fiscal year on the level of service to be provided by COUNTY to CITY~~

1 **C. ~~REGULAR SERVICES BY COUNTY:~~ (Continued)**

2 ~~or on the amount to be paid by CITY for services to be provided by COUNTY~~
3 ~~for the following fiscal year, this Agreement will terminate as of September~~
4 ~~30 of the following fiscal year. If the parties do not agree by June 30 on the~~
5 ~~level of service and cost of services for the following fiscal year, between~~
6 ~~July 1 and September 30 of the following fiscal year, COUNTY will provide~~
7 ~~the level of service provided in the preceding fiscal year, and CITY shall be~~
8 ~~obligated to pay the costs of such services. The full cost of such services~~
9 ~~may exceed the cost of similar services provided in the prior fiscal year.~~

10 1. For the period July 1, 2014 through June 30, 2015, REGULAR SERVICES BY
11 COUNTY, Subsection C-4 of the Agreement is amended to read as follows:

12 "C-4. The level of service, other than for licensing, to be provided by COUNTY for
13 the period July 1, 20~~14~~¹³ through June 30, 20~~15~~¹⁴, shall be as follows:

23 (each 80 hours per two-week pay period)
24 Deployment to be determined by SHERIFF in cooperation with CITY
25 Manager.

26 **General Investigation Services:**

- 27 • Two (2) Investigators (each 80 hours per two-week pay period)
- 28 • Two (2) Investigative Assistants (each 80 hours per two-week pay period)

19 ~~CITY at less than 100% of a full-time SHERIFF position, COUNTY retains~~
20 ~~the option to terminate such service in the event other city or cities that~~
21 ~~contract for the balance of the time of the employee providing the service no~~
22 ~~longer pays for such service and CITY does not request the Agreement be~~
23 ~~amended to pay 100% of the cost of the employee providing such service.~~
24 ~~The Maximum Obligation of CITY set forth in Subsection F-3 will be adjusted~~
25 ~~accordingly.~~

26 ~~6. Reports, Copies, Licensing & Permits:~~

- 27 ~~SHERIFF will handle requests for services such as: copies of Sheriff~~
28 ~~Department documents.~~

1 ~~Fees for reports, copies, etc., as related to the services provided in this~~
2 ~~Agreement, will be at the COUNTY's established rates.~~

3 ~~Licensing and permit fees required or authorized by CITY ordinance or~~
4 ~~resolution will be at the rate established by CITY and will be collected and~~
5 ~~retained by CITY.~~

6 ~~COUNTY shall not provide any attorney advisory, administrative, hearing,~~
7 ~~litigation or other attorney services related to any licensing or permits~~
8 ~~required by CITY ordinances or resolutions.~~

9 ~~**C. REGULAR SERVICES BY COUNTY:** (Continued)~~

10 ~~On the effective date of a City ordinance so providing, fees generated or~~
11 ~~collected by Sheriff contract personnel for response to false alarms in the~~
12 ~~CITY will be at CITY established rates and will be credited to CITY on an~~
13 ~~annual basis.~~

14 ~~7. All services contracted for in this Agreement may not be operational on the~~
15 ~~precise date specified in this Agreement. In those instances, SHERIFF shall~~
16 ~~notify CITY Manager of the date or dates such service or services are to be~~
17 ~~implemented. COUNTY shall reduce the monthly charges to CITY, based~~
18 ~~on the actual date of implementation of the service or services. Charges~~
19 ~~shall be reduced on the next monthly billing tendered in accordance with~~
20 ~~Subsection F-5 of this Agreement.~~

21 ~~8. The telephone system currently installed in the Stanton Police Building has~~
22 ~~the capability of call forward dialing, which is necessary to accommodate~~
23 ~~after-hours incoming calls to the station by forwarding these calls to~~
24 ~~SHERIFF's complaint desk for disposition. In the event the described call-~~
25 ~~forward capability is not compatible with the COUNTY's telephone system, a~~
26 ~~new system will be required, and all costs incurred for equipment and~~
27 ~~installation will be CITY's responsibility.~~

1 ~~9. COUNTY or CITY, upon thirty (30) days notice and mutual written~~
2 ~~Agreement, shall increase or decrease service levels.~~

3 ~~10. During emergencies, such as mutual aid situations, SHERIFF will attempt~~
4 ~~to leave in CITY the Lieutenant in charge of CITY Police Services.~~

5 ~~— If SHERIFF determines that the Lieutenant is needed elsewhere, SHERIFF~~
6 ~~will notify CITY's Manager within four (4) hours. SHERIFF will return~~
7 ~~Lieutenant to CITY as soon as possible once the emergency situation is~~
8 ~~under control. During the Lieutenant's absence, SHERIFF will designate an~~
9 ~~acting Police Services Chief.~~

10 **~~C. REGULAR SERVICES BY COUNTY: (Continued)~~**

11 ~~11. With the limitations set forth below, SHERIFF, on behalf of COUNTY, and~~
12 ~~CITY Manager, on behalf of CITY, are authorized to execute written~~
13 ~~amendments to this Agreement to increase or decrease the level of service~~
14 ~~set forth in Subsection C-4, when SHERIFF and CITY Manager mutually~~
15 ~~agree that such increase or decrease in the level of service is appropriate.~~
16 ~~Any such amendment to the Agreement shall concomitantly increase or~~
17 ~~decrease the cost of services payable by CITY set forth in Subsection F-2~~
18 ~~and the Maximum Obligation of CITY set forth in Subsection F-3, in~~
19 ~~accordance with the current year's COUNTY law enforcement cost study.~~
20 ~~SHERIFF and CITY Manager shall file copies of any such amendments to~~
21 ~~this Agreement with the Clerk of COUNTY's Board of Supervisors and~~
22 ~~CITY's. Amendments to this Agreement executed by SHERIFF and CITY~~
23 ~~Manager may not, in the aggregate, increase or decrease the cost of~~
24 ~~services payable by CITY by more than one percent (1%) of the total cost~~
25 ~~originally set forth in Subsection F-2 and the Maximum Obligation originally~~
26 ~~set forth in Subsection F-3.~~

27 ~~Prior approval by COUNTY's Board of Supervisors and CITY's Council is~~
28 ~~required before execution of any amendment that brings the aggregate total~~

1 of changes in costs payable by CITY to more than one percent (1%) of the
2 total cost originally set forth in Subsection F-2 and the Maximum Obligation
3 originally set forth in Subsection F-3 of the Agreement.

4 **~~ENHANCED AND SUPPLEMENTAL SERVICES BY COUNTY:~~**

5 ~~Enhanced services for events on CITY property. At the request of CITY,~~
6 ~~through its City Manager, SHERIFF may provide enhanced law enforcement~~
7 ~~services for functions, such as community events, conducted on property~~
8 ~~that is owned, leased or operated by CITY. SHERIFF shall determine~~
9 ~~personnel and equipment needed for such enhanced services. To the~~

10 **~~D. ENHANCED AND SUPPLEMENTAL SERVICES BY COUNTY: (Continued)~~**
11 ~~extent the services provided at such events are at a level greater than that~~
12 ~~specified in Subsection C-4 of this Agreement, CITY shall reimburse~~
13 ~~COUNTY for such additional services, at an amount computed by SHERIFF,~~
14 ~~based on the current year's COUNTY law enforcement cost study. The cost~~
15 ~~of these enhanced services shall be in addition to the Maximum Obligation~~
16 ~~of CITY set forth in Subsection F-3 of this Agreement. SHERIFF shall bill~~
17 ~~CITY immediately after each such event.~~

18 ~~Supplemental services for occasional events operated by private individuals and~~
19 ~~entities on non-CITY property. At the request of CITY, through its City~~
20 ~~Manager, and within the limitations set forth in this subsection D.2.,~~
21 ~~SHERIFF may provide supplemental law enforcement services to preserve~~
22 ~~the peace at special events or occurrences that occur on an occasional~~
23 ~~basis and are operated by private individuals or private entities on non-CITY~~
24 ~~property. SHERIFF shall determine personnel and equipment needed for~~
25 ~~such supplemental services, and will provide such supplemental services~~
26 ~~only if SHERIFF is able to do so without reducing the normal and regular~~
27 ~~ongoing services that SHERIFF otherwise would provide to CITY pursuant to~~
28 ~~this Agreement. Such supplemental services shall be provided only by~~

1 regularly appointed full-time peace officers, at rates of pay governed by a
2 Memorandum of Understanding between COUNTY and the bargaining
3 unit(s) representing the peace officers providing the services. Such
4 supplemental services shall include only law enforcement duties and shall
5 not include services authorized to be provided by a private patrol operator,
6 as defined in Section 7582.1 of the Business and Professions Code. Law
7 enforcement support functions, including, but not limited to, clerical functions
8 and forensic science services, may be performed by non-peace officer
9 personnel if the services do not involve patrol or keeping the peace and are
10 **D. ENHANCED AND SUPPLEMENTAL SERVICES BY COUNTY:** (Continued)
11 incidental to the provision of law enforcement services. CITY shall reimburse
12 COUNTY its full, actual costs of providing such supplemental services at an
13 amount computed by SHERIFF, based on the current year's COUNTY law
14 enforcement cost study. The cost of these supplemental services shall be in
15 addition to the Maximum Obligation of CITY set forth in Subsection F-3 of
16 this Agreement. SHERIFF shall bill CITY immediately after each such event.
17 Supplemental services for events operated by public entities on non-CITY
18 property. At the request of CITY, through its City Manager, and within the
19 limitations set forth in this subsection D.3., SHERIFF may provide
20 supplemental law enforcement services to preserve the peace at special
21 events or occurrences that occur on an occasional basis and are operated
22 by public entities on non-CITY property. SHERIFF shall determine personnel
23 and equipment needed for such supplemental services, and will provide
24 such supplemental services only if SHERIFF is able to do so without
25 reducing services that SHERIFF otherwise would provide to CITY pursuant
26 to this Agreement, CITY shall reimburse COUNTY its full, actual costs of
27 providing such supplemental services at an amount computed by SHERIFF,
28 based in the current year's COUTNY law enforcement cost study. The cost

If said events are in addition to the level of services listed in Subsection C-4 of this Agreement, CITY shall reimburse COUNTY for such additional services at~~

~~**D. ENHANCED AND SUPPLEMENTAL SERVICES BY COUNTY:** (Continued) an amount computed by SHERIFF, based upon the current year's COUNTY law enforcement cost study. The cost of these services shall be in addition to the Maximum Obligation of CITY set forth in Subsection F-3 of this Agreement. SHERIFF shall bill CITY immediately after said services are rendered.~~

~~In accordance with Government Code 51350, COUNTY has adopted Board Resolution 89-1160 which identifies Countywide services, including but not limited to helicopter response. SHERIFF through this contract provides enhanced helicopter response services. The cost of enhanced helicopter response services is included in the cost of services set forth in Subsection F-2 and in the Maximum Obligation of CITY set forth in Subsection F-3. COUNTY shall not charge any additional amounts for enhanced helicopter services after the cost of services set forth in Subsection F-2 and in the Maximum Obligation set forth in Subsection F-3 has been established in any fiscal year without written notification to the CITY.~~

~~**PATROL VIDEO SYSTEMS:**~~

~~As part of the law enforcement services to be provided to CITY, COUNTY has provided, or will provide, patrol video systems (hereinafter called "PVS") that~~

1 ~~are or will be mounted in patrol vehicles designated by COUNTY for use~~
2 ~~within CITY service area.~~

3 ~~SHERIFF has the exclusive right to use said PVS for law enforcement services~~
4 ~~related to this Agreement.~~

5 ~~2. For the period July 1, 2014 through June 30, 2015, PATROL VIDEO SYSTEM,~~
6 ~~Subsection E-3 of the Agreement is amended to read as follows:~~

7 ~~“E-3. CITY shall pay COUNTY the full costs to COUNTY of a) the~~
8 ~~acquisition and installation of Patrol Video Systems that are or will be~~
9 ~~mounted in patrol vehicles assigned to CITY, and b) recurring costs, as~~
10 ~~deemed necessary by COUNTY, including the costs of maintenance and~~
11 ~~contributions to a fund for replacement and upgrade of such PVS when they~~
12 ~~become functionally or technologically obsolete.~~

13 ~~The costs to be paid by CITY for recurring costs, including maintenance and~~
14 ~~replacement/upgrade of PVS, are included in the costs set forth in~~
15 ~~Subsection F-2 and the Maximum Obligation of CITY set forth in Subsection~~
16 ~~F-3 of this Agreement unless CITY has already paid such costs. CITY shall~~
17 ~~not be charged additional amounts for maintenance or replacement/upgrade~~
18 ~~of said PVS during the period July 1, 20~~14~~¹³ through June 30, 20~~15~~¹⁴.”~~

19 ~~3. If, following the initial acquisition of PVS referenced above, CITY requires~~
20 ~~PVS for additional patrol cars designated for use in the CITY service area,~~
21 ~~COUNTY will purchase said additional PVS. Upon demand by COUNTY,~~
22 ~~CITY will pay to COUNTY a) the full costs of acquisition and installation of~~
23 ~~said additional PVS, and b) the full recurring costs for said PVS, as deemed~~
24 ~~necessary by COUNTY, including the costs of maintenance, and~~
25 ~~contributions to a fund for replacement and upgrade of such PVS when they~~
26 ~~become functionally or technologically obsolete. Said costs related to~~
27 ~~additional PVS are not included in, and are in addition to, the costs set forth~~

~~4. COUNTY will replace and/or upgrade PVS as needed. The costs of replacing/upgrading PVS shall be paid by COUNTY from the replacement/upgrade funds to be paid by CITY in accordance with the foregoing. CITY shall not be charged any additional charge to replace or upgrade PVS after the cost of services set forth in Subsection F-2 and the Maximum Obligation set forth in F-3 has been established in any fiscal year without written notification to the CITY.~~

~~F. PAYMENT:~~

~~1. Pursuant to Government Code Section 51350, CITY agrees to pay to COUNTY the costs of performing the services mutually agreed upon in this Agreement. The cost of services includes salaries, wages, benefits, mileage, services, supplies, equipment, and divisional, departmental and COUNTY General overhead.~~

3. For the period of July 1, 2014 through June 30, 2015, PAYMENT, Subsections F-2, and F-3 of the Agreement are amended to read as follows:

"F-2. Unless the level of service described in Subsection C-4 is decreased or increased in accordance with Subsection C-9 or C-11, the cost of services described in Subsection C-4 of this Agreement, other than licensing services, to be provided by the COUNTY for the period July 1, 2014 through June 30, 2015 shall be as follows:

6 4. For the period July 1, 2014 through June 30, 2015, PAYMENT Subsections F-5, of
7 the Agreement is amended to read as follows:

8 “F-5. COUNTY shall invoice CITY monthly. During the period July 1, 20~~1413~~
9 through June 30, 20~~1514~~, said invoices will require payment by CITY of one-
10 twelfth (1/12) of the Maximum Obligation of CITY set forth in Subsection F-3
11 of this Agreement, as said Maximum Obligation may have been increased or
12 decreased in accordance with Subsections C-9 or C-11. If a determination
13 is made that increases described in Subsection F-10 must be paid,
14 COUNTY thereafter shall include the pro-rata charges for such increases in
15 its monthly invoices to CITY for the balance of the period between July 1,
