RECOMMENDED ACTION(S)

Authorize County Procurement Officer or authorized Deputy to conduct a new Request for Proposal solicitation for Federal Legislative Advocacy Services and direct County Executive Office to return with recommended action before November 30, 2019.

SUMMARY:

Authorizing the County Procurement Officer or authorized Deputy to conduct Request for Proposal solicitation and return with recommended action before November 30, 2019, will provide the County with critical advocacy representation before the United States Government.

BACKGROUND INFORMATION:

On October 25, 2016, your Board of Supervisors (Board) selected Potomac Partners DC to be the County's Federal Legislative Advocate and directed the County Purchasing Agent or authorized Deputy to enter into negotiations and return to the Board with the proposed agreement for approval. On November 22, 2016, your Board authorized the County Purchasing Agent or authorized Deputy to execute a Contract with Potomac Partners DC to provide Federal Legislative Advocacy Services for a three-year period commencing on January 1, 2017, through December 31, 2019, and renewable for two additional years with Board approval for a cumulative total of \$1,285,000.

CEO requests authorization to direct the County Procurement Officer or authorized Deputy to conduct a new Request for Proposal (RFP) solicitation for Federal Legislative Advocacy Services. CEO will bring a recommended action to your Board before November 30, 2019, including a three-year contract with a two-year extension option to realign with future two-year legislative cycles.

- July 15: RFP submitted via BidSync
- August 16: Deadline to return completed Proposals
- August-September: Evaluation of Proposals
- October-November: Negotiations/Board Approval of Recommended Contract Award
