This AMENDMENT NUMBER THREE FOUR to Contract number MA-060-14011934 (hereinafter "AMENDMENT NUMBER THREE FOUR") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and Waters Technologies Corporation (hereinafter "CONTRACTOR") with a place of business at 34 Maple St., Milford, MA 01757, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract on July 14, 2015 for Service, Preventative Maintenance and Consumables for Liquid Chromatograph Mass Spectrometer, Contract Number MA-060-14011934 (hereinafter "ORIGINAL CONTRACT"), for a one (1) year term of July 14, 2015 through and including July 13, 2016, in the amount of \$195,000 renewable for four (4) additional one-year terms; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on June 28, 2016 as Contract Number MA-060-16011886 for a one (1) year term of July 14, 2016 through and including July 13, 2017 in the amount of \$195,000 (hereinafter "AMENDMENT NUMBER ONE");

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on June 6, 2017 as Contract Number MA-060-17011370 for a one (1) year term of July 14, 2017 through and including July 13, 2018 and increased the current not to exceed amount of \$195,000 by \$55,000 for a new not to exceed amount of \$250,000 to cover the costs of an additional Preventative Maintenance each year (hereinafter "AMENDMENT NUMBER TWO");

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on July 2, 2018 as Contract Number MA-060-18011560 (hereinafter "AMENDMENT NUMBER THREE") for a one (1) year term of July 14, 2018 through and including July 13, 2019 in the amount of \$250,000;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-19011552 for a one (1) year term of July 14, 2019 through and including July 13, 2020 and revise ATTACHMENT B, Pricing to add consumable items for purchase and increase the existing Contract not to exceed amount of \$250,000 by \$25,000 for a new Contract not to exceed amount of \$275,000 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in this AMENDMENT NUMBER FOUR; and

WHEREAS COUNTY desires to amend Paragraph S., Change of Ownership of the ORIGINAL CONTRACT in its entirety and the Contractor has confirmed in writing that they

understand and are in compliance with the County's Conflict of Interest Policy as stated in Article S herein;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

- a. General Terms and Conditions, Letter S, of the ORIGINAL CONTRACT is amended to read as follows:
- S. Change of Ownership/Name, Litigation Status, Conflict with County Interests: Contractor agrees that if there is a change or transfer in ownership of Contractor's business prior to completion of this Contract, and the County agrees to an assignment of the Contract, the new owners shall be required under the terms of sale or other instruments of transfer to assume Contractor's duties and Contractor obligations contained in this Contract and complete them to the satisfaction of the County.

County reserves the right to immediately terminate the Contract in the event the County determines that the assignee is not qualified or is otherwise unacceptable to the County for the provision of services under the Contract.

In addition, Contractor has the duty to notify the County in writing of any change in the Contractor's status with respect to name changes that do not require an assignment of the Contract. The Contractor is also obligated to notify the County in writing if the Contractor becomes a party to any litigation against the County, or a party to litigation that may reasonably affect the Contractor's performance under the Contract, as well as any potential conflicts of interest between Contractor and County that may arise prior to or during the period of Contract performance. While Contractor will be required to provide this information without prompting from the County any time there is a change in Contractor's name, conflict of interest or litigation status, Contractor must also provide an update to the County of its status in these areas whenever requested by the County.

The Contractor shall exercise reasonable care and diligence to prevent any actions or conditions that could result in a conflict with County interests. In addition to the Contractor, this obligation shall apply to the Contractor's employees, agents, and subcontractors associated with the provision of goods and services provided under this Contract. The Contractor's efforts shall include, but not be limited to establishing rules and procedures preventing its employees, agents, and subcontractors from providing or offering gifts, entertainment, payments, loans or other considerations which could be deemed to influence or appear to influence County staff or elected officers in the performance of their duties.

b. Additional Terms and Conditions, Section 2, Term of Contract, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

2. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 7/14/15 through and including 7/13/19 7/13/20, unless otherwise terminated by COUNTY. The period of 7/14/15 through and including 7/13/16 shall be known as Contract number MA-060-14011934. The period of 7/14/16 through and including 7/13/17 shall be known as Contract number MA-060-16011886. The period of 7/14/17 through and including 7/13/18 shall be known as Contract number MA-060-17011370. The period of 7/14/18 through and including 7/13/19 shall be known as Contract number MA-060-18011560. The period of 7/14/19 through and including 7/13/20 shall be known as Contract number MA-060-19011552. This Contract shall not be renewed. The County is not under any obligation to provide Contractor with a reason should it elect not to renew this Contract.
