This AMENDMENT NUMBER ~~ONE~~ TWO to Contract Number MA-060-16011940 (hereinafter "AMENDMENT NUMBER ~~ONE~~ TWO") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and MCM Technology, LLC. (hereinafter "CONTRACTOR") with a place of business at 3510 Vann Road, Suite 105, Birmingham, AL 35235; is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Maintenance & Support Services for Communications Accounting & Asset Management Software on May 5, 2016, as Contract Number MA-060-16011940 (hereinafter "ORIGINAL CONTRACT"), for a one-year term of June 27, 2016 through and including June 26, 2017, renewable for four (4) additional one-year terms; and

WHEREAS, COUNTY ~~desires to renew~~ and CONTRACTOR renewed the ORIGINAL CONTRACT on May 15, 2017 as Contract Number MA-060-17011671 for a one-year term of June 27, 2017 through and including June 26, 2018 ~~in an amount not to exceed \$35,909.99 and the CONTRACTOR has agreed to provide those services at the rates set forth in the ORIGINAL CONTRACT~~ (hereinafter "AMENDMENT NUMBER ONE");

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-18011557 for a one-year term of June 27, 2018 through and including June 26, 2019 and the CONTRACTOR has agreed to provide those services at the rates set forth in the ORIGINAL CONTRACT;

NOW, THEREFORE, in consideration of the mutual obligations set forth herein, Both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

- a. Additional Terms and Conditions, Section 2 - Term of Contract of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

2. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 6/27/16 through and including 6/26/19, unless

otherwise terminated by COUNTY. The period of 6/27/16 through and including 6/26/17 shall be known as Contract Number MA-060-16011940. The period of 6/27/17 through and including 6/26/18 shall be known as Contract Number MA-060-17011671. The period of 6/27/18 through and including 6/26/19 shall be known as Contract Number MA-060-18011557. This Contract may be renewed for two (2) additional one-year terms by mutual written agreement of both parties. The County is not under any obligation to provide Contractor with a reason should it elect not to renew this Contract, nor is the County obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

2. A true and correct copy of the ORIGINAL CONTRACT (Contract Number MA-060-16011940) is attached hereto as Exhibit A and incorporated by this reference.
3. A true and correct copy of AMENDMENT NUMBER ONE (Contract Number MA-060-17011671) is attached hereto as Exhibit B and incorporated by this reference.
4. All other provisions of the ORIGINAL CONTRACT and AMENDMENT NUMBER ONE, except as amended herein and to the extent they are not inconsistent with this AMENDMENT NUMBER TWO, remain unchanged and in full force and effect.
