

AMENDMENT NO. 23 FOR SOFTWARE MAINTENANCE AND SUPPORT SERVICES FOR NURSING SYSTEM

This Amendment Number Two Three (hereinafter "Amendment") to Contract No. MA-042-13011507 (hereinafter "Contract") is made and entered into this 1st day of August, 2015 6 or upon execution of all necessary signatures between Advocate Technology Solutions, LLC. (hereinafter "Contractor"), with a place of business at 1010 E. Union St., Ste. 203, Pasadena, CA 91106, and the County of Orange/Health Care Agency, a political subdivision of the State of California, (hereinafter "County"), with a place of business at 200 W. Santa Ana Blvd., Ste. 650, Santa Ana, CA 92701, which are sometimes individually referred to as "Party", or collectively referred to as "Parties".

WHEREAS, the Parties entered into Contract MA-042-13011507 for Software Maintenance and Support Services, effective August 1, 2013 through July 31, 2014 in an amount not to exceed \$123,000; and

WHEREAS, the Parties issued Amendment Number One to renew Contract MA-042-13011507, decreased by \$33,000 as MA-042-14012150 for Software Maintenance and Support Services, effective August 1, 2014 through July 31, 2015 in an amount not to exceed \$90,000; and

WHEREAS, the County desires to renew MA-042-14012150 as MA-042-15011703 for Software Maintenance and Support Services, effective August 1, 2015 through July 31, 2016 in an amount not to exceed \$90,000; and

WHEREAS, the County desires to extend MA-042-15011703 for Software Maintenance and Support Services, effective August 1, 2016 through July 31, 2017 in an amount not to exceed \$150,000; and

NOW, THEREFORE, the Parties mutually agree as follows:

- 1. MA-042-14012150 shall be renewed as MA-042-15011703 extended for Software Maintenance and Support Services, under the same scope of work, effective August 1, 2015 6 through July 31, 2016 7 in an amount not to exceed \$90,000 \$150,000.
- 2. Contractor shall reference invoices effective August 1, 2015 with MA-042-15011703.

This Amendment modifies the Contract only as expressly set forth above. It does not modify, alter, or amend the Original Contract in any other way except as stated herein; all other terms and conditions of the Original Contract shall remain in full force and effect, including its Amendment(s) and/or Modification(s) which is/are incorporated herein.
