# AMENDMENT NUMBER ONE TWO TO CONTRACT MA-060-14011843 BETWEEN THE COUNTY OF ORANGE AND PEPPERDINE UNIVERSITY

This AMENDMENT NUMBER TWOONE to Contract number MA-060-14011843 (hereinafter "AMENDMENT NUMBER ONETWO") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and Pepperdine University (hereinafter "CONTRACTOR") with a place of business at 18111 Von Karman Avenue, Suite 209, Irvine, CA 92618 is made and entered upon execution of all necessary signatures.

### **RECITALS**

WHEREAS, COUNTY and CONTRACTOR executed a Contract to provide Youth Diversion Counseling Services, as Contract Number MA-060-14011843 (hereinafter "ORIGINAL CONTRACT"), for a one (1) year term of July 1, 2014 through and including June 30, 2015, renewable for four (4) additional, one-year terms;

WHEREAS, COUNTY and CONTRACTOR desires to renewed the ORIGINAL CONTRACT (hereinafter "AMENDMENT NUMBER ONE"), as Contract Number MA-060-15011748, on April 29, 2015 for a one (1) year term of July 1, 2015 through and including June 30, 2016; and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT, as Contract Number MA-060-16011749 for a one (1) year term of July 1, 2016 through and including June 30, 2017 and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

**NOW THEREFORE**, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

### 1. ARTICLES

a. ORIGINAL CONTRACT, Section CONTRACT TERM, is amended to read in its entirety as follows:

### 1. **Contract Term:**

This Contract shall commence upon execution of all necessary signatures and continue in effect from 7/1/14 through and including 6/30/167, unless otherwise terminated by County. —The period of 7/1/14 through and

including 6/30/15 shall be known as Contract Number MA-060-14011843. The period of 7/1/15 through and including 6/30/16 shall be known as Contract Number MA-060-15011748. -The period of 7/1/16 through and including 6/30/17 shall be known as Contract Number MA-060-16011749. This Contract may be renewed for up to three-two (23) additional, one-year terms, upon mutual agreement of both Parties. Each renewal of this Contract may require approval by the County Board of Supervisors. The County does not have to give reason if it elects not to renew.

All obligations of the Parties that would have been terminated on June 30, 20156 are thereby extended to June 30, 20176.
