This AMENDMENT NUMBER ~~SIX~~ SEVEN to Contract Number MA-060-12010640 (hereinafter “AMENDMENT NUMBER ~~SIX~~ SEVEN”) between the County of Orange, a political subdivision of the State of California (hereinafter “COUNTY”) and All City Management Services, Inc. (“CONTRACTOR”) with a place of business at 10440 Pioneer Blvd., Suite 5, Santa Fe Springs, CA 90670, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Crossing Guard Services under Contract Number MA-060-12010640 on October 25, 2011 (hereinafter “ORIGINAL CONTRACT”) for a one (1) year term of November 1, 2011 through and including October 31, 2012, renewable for four (4) additional one-year terms; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on September 11, 2012 for the period of November 1, 2012 through and including October 31, 2013 as Contract Number MA-060-13010214 (hereinafter “AMENDMENT NUMBER ONE”);

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on October 8, 2013 for the period of November 1, 2013 through and including October 31, 2014 as Contract Number MA-060- 14010323 and increased the hourly rate from \$13.89 to \$14.24 as well as increased the total Contract value by \$20,000.00 for a new not to exceed amount of \$530,000.00 (hereinafter “AMENDMENT NUMBER TWO”);

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on October 29, 2014 for the period of November 1, 2014 through and including October 31, 2015 as Contract Number MA-060-15010322 and added two (2) additional Crossing Guards and increased the Contract value of \$530,000.00 by \$27,340.80 for a new not to exceed amount of \$557,340.80 (hereinafter “AMENDMENT NUMBER THREE”);

WHEREAS, COUNTY and CONTRACTOR retroactively amended Attachment B, Pricing for Contract Number MA-060-14010323 on April 14, 2015 to increase the not to exceed amount by \$25,000.00 for a new total amount of \$555,000.00 for the period of 11/1/2013 through and including 10/31/2014; and

WHEREAS, COUNTY and CONTRACTOR also amended Attachment B, Pricing, for AMENDMENT NUMBER THREE on April 14, 2015 to increase the not to exceed

amount by \$25,000.00 for a new total amount of \$582,340.80 for the period of 11/1/2014 through and including 10/31/2015 (hereinafter "AMENDMENT NUMBER FOUR);

WHEREAS, COUNTY and CONTRACTOR amended the ORIGINAL CONTRACT on August 4, 2015 to add one additional crossing guard at Ladera Ranch Elementary, Sellas Rd North / Sienna Pkwy (Site# 39) for North Patrol (Unit 1411); and increased the not to exceed amount by \$23,347.00 to cover costs of the additional guard and summer schools on a track schedule, resulting in a new not to exceed amount of \$605,687.80 to Contract Number MA-060-15010322 (hereinafter "AMENDMENT NUMBER FIVE");

~~WHEREAS, the additional crossing guard for Site #39 cost will be \$3,347.00 and additional funding of \$20,000.00 was also needed for crossing guard services for schools that are on a track schedule. COUNTY and CONTRACT agreed to increase the not to exceed amount of Contract Number MA-060-15010322 to \$605,687.80 (hereinafter "AMENDMENT NUMBER FIVE");~~

WHEREAS, COUNTY and CONTRACTOR renewed ~~desires to renew~~ the ORIGINAL CONTRACT on October 27, 2015, as Contract Number MA-060-16010363 (hereinafter "AMENDMENT NUMBER SIX") for a one (1) year term of November 1, 2015 through and including October 31, 2016 as well as increased the hourly rate from \$14.24 to \$16.79 effective January 1, 2016, for a new not to exceed amount of \$693,928.40; ~~and the CONTRACTOR has agreed to provide those services at the rates set forth in this AMENDMENT NUMBER SIX;~~

WHEREAS, COUNTY desires to amend the ORIGINAL CONTRACT to add one additional crossing guard at Hewes Middle School, Foothill Blvd./Old Foothill Blvd. (Site# TBD) and one additional crossing guard at Las Flores Elementary/Middle Schools, Antonio Pkwy at Sweetwater/Sable (Site # TBD) for North Patrol (Unit 1411); and

WHEREAS, the additional crossing guards will cost \$24,177.60 for a new not to exceed Contract amount of \$718,106.00, and the CONTRACTOR has agreed to provide those services at the rates set forth in AMENDMENT NUMBER SIX and this AMENDMENT NUMBER SEVEN;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

The period of 11/1/14 through and including 10/31/15 shall be known as Contract number MA 060 15010322. The period of 11/1/15 through and including 10/31/16 shall be known as Contract number MA 060 16010363. This Contract is non-renewable.~~
