WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 1 to renew the Agreement for an additional one-year term, effective August 14, 2013 through August 13, 2014 in the amount not to exceed \$2,300.00.

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 2 to add Tokenization Subscription services; and

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 3 to renew the Agreement effective August 14, 2014 through August 13, 2015; and

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 4 to renew the Agreement effective August 14, 2015 through August 13, 2016; and

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 5 to renew the Agreement effective August 14, 2016 through August 13, 2017.

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 6 to renew the Agreement effective August 14, 2017 through August 13, 2018.

WHEREAS, the parties amended the ORIGINAL AGREEMENT with Amendment No. 7 to renew the Agreement effective August 14, 2018 through August 13, 2019.

WHEREAS, the parties desire to extend the Agreement for an additional two-year term, effective August 14, 2019 through August 13, 2021, for an amount not-to-exceed \$20,000 over the two-year term.

NOW, THEREFORE, the parties mutually agree:

- 1. <u>Term of Agreement</u>. The term of the ORIGINAL Agreement is hereby extended for an additional two-year term effective August 14, 2019 through August 13, 2021, for an amount not-to-exceed \$20,000 over the two-year term.
- 2. The remaining provisions of the ORIGINAL AGREEMENT with Amendments shall remain the same and in full effect and force.
