WHEREAS, COUNTY and CONTRACTOR executed a ~~Subordinate Agreement~~ Contract on June 20, 2009 for Software Support and Maintenance Services, as Contract Number N1000010985 (hereinafter "ORIGINAL ~~AGREEMENT~~ CONTRACT"), for a one (1) year term of June 29, 2009 through and including June 28, 2010, renewable for four (4) additional one (1) year terms;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL ~~AGREEMENT~~ CONTRACT on June 10, 2010, as Contract MA-060-10013242 (hereinafter "AMENDMENT NUMBER ONE"), for a one (1) year term of June 29, 2010 through and including June 28, 2011;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL ~~AGREEMENT~~ CONTRACT on June 7, 2011, as Contract Number MA-060-~~11012335~~ 11012705 (hereinafter "AMENDMENT NUMBER TWO"), for a one (1) year term of June 29, 2011 through and including June 28, 2012;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL ~~AGREEMENT~~ CONTRACT on June 4, 2012, as Contract Number MA-060-12011485 (hereinafter "AMENDMENT NUMBER THREE"), for a one (1) year term of June 29, 2012 through and including June 28, 2013;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on May 30, 2013, as Contract number MA-060-13011793 (hereinafter "AMENDMENT NUMBER FOUR"), for a one (1) year term of June 29, 2013 through and including June 28, 2014; ~~desires to continue receiving services for an additional one (1) year term and the CONTRACTOR has agreed to continue provide those services at the rates set forth in the MASTER AGREEMENT;~~

**WHEREAS**, COUNTY desire to renew the ORIGINAL CONTRACT as Contract Number MA-060-14012099 for a one year term of June 29, 2014 through and including June 28, 2015 and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT;

**NOW THEREFORE**, in consideration of the mutual obligations set forth herein, COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

- a. Additional Terms and Conditions, Section 2 **Term of Contract** is amended in its entirety as follows:

**1. Term of Contract:**

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 6/29/09 through and including 6/28/~~14~~ 15, unless otherwise terminated by COUNTY. The period of 6/29/09 through 6/28/10 shall be known as Contract number N1000010985. The period of 6/29/10 through 6/28/11 shall be known as Contract number MA-060-10013242. The period of 6/29/11 through and including 6/28/12 shall be known as Contract number MA-060-11012335. The period of 6/29/12 through and including 6/28/13 shall be known as Contract number MA-060-12011485. The period of 6/29/13 through and including 6/28/14 shall be known as Contract number MA-060-13011793. The period of 6/29/14 through and including 6/28/15 shall be known as Contract number MA-060-14012099.
