AMENDMENT #1 TO AGREEMENT D14-005 FOR ON-CALL ARCHITECT-ENGINEER SERVICES

RECITALS

WHEREAS, the DISTRICT and A/E entered into AGREEMENT D14-005 (hereinafter referred to as "AGREEMENT") for On-Call Architect-Engineer Services, effective April 1, 2014 through March 31, 2017 in an amount not to exceed \$400,000; and,

WHEREAS, both Parties now desire to extend the AGREEMENT expiration date from March 31, 2017 to March 31, 2018 and increase the AGREEMENT amount by \$250,000; and,

NOW THEREFORE, the Parties agree as follows:

ARTICLES

- 1. Paragraph I "Term and Maximum Compensation" shall be amended and shall read in its entirety as follows:
 - **I. Term and Maximum Compensation:** The term of this AGREEMENT shall be effective April 1, 2014 to March 31, 2018, with a maximum compensation of \$650,000, except as permitted in paragraph J below.
- 2. All other terms and conditions contained in the AGREEMENT shall remain unchanged and with full force and effect.
