II. ALTERATION OF TERMS

13 A. This Agreement, together with Exhibit A attached hereto and incorporated herein, fully
14 expresses the complete understanding of COUNTY and CONTRACT EMPLOYEE with respect to the
15 subject matter of this Agreement.

16 B. Unless otherwise expressly stated in this Agreement, no addition to, or alteration of the terms of
17 this Agreement or any Exhibits, whether written or verbal, made by the parties, their officers, employees
18 or agents shall be valid unless made in the form of a written amendment to this Agreement, which has
19 been formally approved and executed by both parties.

III. COMPLIANCE

22 A. HCA has established a Compliance Program for the purpose of ensuring adherence to all rules
23 and regulations related to federal and state health care programs.

24 B. ADMINISTRATOR shall ensure that CONTRACT EMPLOYEE is made aware of the relevant
25 Policies and Procedures relating to the Compliance Program.

26 C. CODE OF CONDUCT – ADMINISTRATOR has developed a Code of Conduct for adherence
27 by all of ADMINISTRATOR’s employees and contract providers. CONTRACT EMPLOYEE shall
28 acknowledge in writing within thirty (30) calendar days of the receipt of the Code of Conduct and shall
29 be required to adhere to said HCA Code of Conduct.

30 D. CONTRACT EMPLOYEE shall comply with the United States Department of Health and
31 Human Services, OIG requirements related to eligibility for participation in federal and state health care
32 programs.

33 1. CONTRACT EMPLOYEE affirmatively asserts that they are not Ineligible Persons as
34 defined hereunder.

35 2. CONTRACT EMPLOYEE further acknowledges that ADMINISTRATOR shall review at
36 least semi-annually all individual CONTRACT EMPLOYEES for eligibility against the General

1 Services Administration's Excluded Parties List System or System for Award Management, the Office

6 3. Ineligible Persons may include both entities and individuals and are defined as any
 7 individual or entity who:

8 a. Is currently excluded, suspended, debarred or otherwise ineligible to participate in
 9 federal and state health care programs; or

10 b. Has been convicted of a criminal offense related to the provision of health care items or
 11 services and has not been reinstated in the federal and state health care programs after a period of
 12 exclusion, suspension, debarment, or ineligibility.

13 4. CONTRACT EMPLOYEE acknowledges that Ineligible Persons are precluded from
 14 providing federally and state funded health care services by contract with COUNTY in the event that
 15 they are currently sanctioned or excluded by a federal or state law enforcement regulatory or licensing
 16 agency. CONTRACT EMPLOYEE shall notify COUNTY immediately if CONTRACT EMPLOYEE
 17 becomes an Ineligible Person. COUNTY shall terminate this Agreement immediately in the event that
 18 CONTRACT EMPLOYEE is identified as an Ineligible Person during the term of this Agreement.

19 E. MEDICAL BILLING, CODING, AND DOCUMENTATION COMPLIANCE STANDARDS

20 1. CONTRACT EMPLOYEE shall take reasonable precaution to ensure that the coding of
 21 health care claims and billing for same are prepared and submitted in an accurate and timely manner and
 22 are consistent with federal, state and county laws and regulations. This includes compliance with
 23 federal and state health care program regulations and procedures or instructions otherwise
 24 communicated by regulatory agencies including the Centers for Medicare and Medicaid Services or
 25 their agents.

26 2. CONTRACT EMPLOYEE shall not submit any false, fraudulent, inaccurate and/or
 27 fictitious claims for payment or reimbursement of any kind.

28 3. CONTRACT EMPLOYEE shall bill only for eligible services actually rendered and fully
 29 documented. When such services are coded, CONTRACT EMPLOYEE shall use accurate billing codes
 30 which accurately describes the services rendered and must ensure compliance with all billing and
 31 documentation requirements.

32 4. CONTRACT EMPLOYEE shall immediately notify ADMINISTRATOR when
 33 CONTRACT EMPLOYEE becomes aware of errors in the coding or billing of claims.

34 5. CONTRACT EMPLOYEE shall cooperate with compliance investigations and correct any
 35 problems or errors in coding of claims and billing, if and when, any such problems or errors are
 36 identified.

1 F. COMPLIANCE TRAINING – ADMINISTRATOR will provide and CONTRACT
2 EMPLOYEE shall complete Compliance Training when offered initially, as well as any refresher
3 training provided on an annual basis.

4 G. Unless otherwise specified in this Agreement and in accordance with the Termination
5 Paragraph of this Agreement, COUNTY may terminate this Agreement upon five (5) calendar days
6 written notice if CONTRACT EMPLOYEE fails to perform any of the terms of this Compliance
7 Paragraph. At ADMINISTRATOR’s sole discretion, CONTRACT EMPLOYEE may be allowed up to
8 thirty (30) calendar days for corrective action.

9 **IV. CONFIDENTIALITY**

10 A. CONTRACT EMPLOYEE shall maintain the confidentiality of all records, including billings
11 and any audio and/or video recordings, in accordance with all applicable federal and state codes and
12 regulations, including 42 USC 290dd-2 (Confidentiality of Records), as they now exist or may hereafter
13 be amended or changed.
14

15 B. Prior to providing any services pursuant to this Agreement, CONTRACT EMPLOYEE shall
16 agree, in writing, with ADMINISTRATOR to maintain the confidentiality of any and all information
17 and records which may be obtained in the course of providing such services.
18

19 **V. CONFLICT OF INTEREST**

20 A. The parties hereto acknowledge that CONTRACT EMPLOYEE may be affiliated with one or
21 more organizations or professional practices located in Orange County. CONTRACT EMPLOYEE
22 therefore warrants that he/she shall not violate any applicable law, rule or regulation of any
23 governmental entity relating to conflict of interest. Except as specified in the Services Paragraph of this
24 Agreement, CONTRACT EMPLOYEE shall not knowingly undertake any act which unjustifiably
25 results in any relative benefit to any organization or professional practice with which he/she is affiliated
26 as a direct or indirect result, whether economic or otherwise in nature, of the performance of duties and
27 obligations required by this Agreement, when compared to the result such act has on any other
28 organization or professional practice.

29 B. CONTRACT EMPLOYEE shall annually submit an Outside Employment and/or Other
30 Affiliation Statement to their supervisor.

32 **-VII. COUNTERPARTS**

33 This Agreement may be executed in several counterparts, all of which shall constitute but one and
34 the same instrument. Faxed and/or electronically scanned signatures shall have the same force and
35 effect as an original signature.

VIII. INDEMNIFICATION

COUNTY agrees to indemnify and defend CONTRACT EMPLOYEE from any and all claims resulting from acts or omissions of CONTRACT EMPLOYEE while acting pursuant to the terms of this Agreement, and to hold CONTRACT EMPLOYEE harmless as to any third parties for any act thus indemnified.

IX.VIII. LICENSES AND LAWS

A. CONTRACT EMPLOYEE, its officers, agents, employees, affiliates, and subcontractors shall, throughout the term of this Agreement, maintain all necessary licenses, permits, approvals, certificates, accreditations, waivers, and exemptions necessary for the provision of the services hereunder and required by the laws, regulations and requirements of the United States, the State of California, COUNTY, and all other applicable governmental agencies. CONTRACT EMPLOYEE shall notify ADMINISTRATOR immediately and in writing of his/her inability to obtain or maintain, irrespective of the pendency of any hearings or appeals, permits, licenses, approvals, certificates, accreditations, waivers and exemptions. Said inability shall be cause for termination of this Agreement.

B. ENFORCEMENT OF CHILD SUPPORT OBLIGATIONS

1. CONTRACT EMPLOYEE agrees to furnish to ADMINISTRATOR within thirty (30) calendar days of the award of this Agreement:

a. In the case of an individual contractor, his/her name, date of birth, social security number, and residence address;

b. In the case of a contractor doing business in a form other than as an individual, the name, date of birth, social security number, and residence address of each individual who owns an interest of ten percent (10%) or more in the contracting entity;

c. A certification that CONTRACT EMPLOYEE has fully complied with all applicable federal and state reporting requirements regarding its employees;

d. A certification that CONTRACT EMPLOYEE has fully complied with all lawfully served Wage and Earnings Assignment Orders and Notices of Assignment, and will continue to so comply.

2. Failure of CONTRACT EMPLOYEE to timely submit the data and/or certifications

1 required by Subparagraphs 1.a., 1.b., 1.c., or 1.d. above, or to comply with all federal and state
 2 employee reporting requirements for child support enforcement, or to comply with all lawfully served
 3 Wage and Earnings Assignment Orders and Notices of Assignment, shall constitute a material breach of
 4 this Agreement; and failure to cure such breach within sixty (60) calendar days of notice from
 5 COUNTY shall constitute grounds for termination of this Agreement.

6 3. It is expressly understood that this data will be transmitted to governmental agencies
 7 charged with the establishment and enforcement of child support orders, or as permitted by federal
 8 and/or state statute.

9 C. CONTRACT EMPLOYEE shall be subject to and comply with all applicable governmental
 10 laws, regulations and requirements and all internal policies and procedures of ADMINISTRATOR, as
 11 they exist now or may be hereafter amended or changed.

12 D. If CONTRACT EMPLOYEE provides treatment and bills for services to Medi-Cal eligible
 13 clients, CONTRACT EMPLOYEE shall at all times be capable and authorized by the state of California
 14 to do so while working under the terms of this Agreement.

15 **IX. NONDISCRIMINATION**

16 The CONTRACT EMPLOYEE shall not discriminate in the provision of services, the allocations of
 17 benefits, or in the accommodation in facilities on the basis of ~~ethnic group identification~~, race, religious
 18 creed, color, national origin, religion, ancestry, genetic information, color, creed, sex, marital status, sex,
 19 gender, gender identity, gender expression, national origin, age, (40 and over), sexual orientation,
 20 military and veteran status, medical condition, or physical or mental disability in accordance with Title
 21 IX of the Education Amendments of 1972 as they relate to 20 USC §1681 - §1688; Title VI of the Civil
 22 Rights Act of 1964 (42 USC §2000d); the Age Discrimination Act of 1975 (42 USC §6101); and Title 9,
 23 Division 4, Chapter 6, Article 1 (§10800, et seq.) of the California Code of Regulations; and Title II of
 24 the Genetic Information Nondiscrimination Act of 2008, 42 USC 2000ff, et seq.) as applicable, and all
 25 other pertinent rules and regulations promulgated pursuant thereto, and as otherwise provided by state
 26 law and regulations, as all may now exist or be hereafter amended or changed.

27 **XI. NOTICES**

28 A. Unless otherwise specified, all notices, claims, correspondence, reports and/or statements
 29 authorized or required by this Agreement shall be effective:

30 1. When written and deposited in the United States mail, first class postage prepaid and
 31 addressed as specified in the Referenced Contract Provisions of this Agreement or as otherwise directed
 32 by ADMINISTRATOR;

1 4. When accepted by U.S. Postal Service Express Mail, Federal Express, United Parcel
2 Service, or other expedited delivery service.

3 B. Termination Notices shall be addressed as specified in the Referenced Contract Provisions of
4 this Agreement or as otherwise directed by ADMINISTRATOR and shall be effective when faxed,
5 transmission confirmed, or when accepted by U.S. Postal Service Express Mail, Federal Express, United
6 Parcel Service, or other expedited delivery service.

7 C. CONTRACT EMPLOYEE shall notify ADMINISTRATOR, in writing, within twenty-four
8 (24) hours of becoming aware of any occurrence of a serious nature, which may expose COUNTY to
9 liability. Such occurrences shall include, but not be limited to, accidents, injuries, or acts of negligence,
10 or loss or damage to any COUNTY property in possession of CONTRACT EMPLOYEE. Any
11 CONTRACT EMPLOYEE providing services to custody patients shall provide a copy of such written
12 notification to the Sheriff of Orange County.

13 D. CONTRACT EMPLOYEE shall also notify ADMINISTRATOR, in writing, within twenty-four
14 (24) hours of becoming aware of any formal complaint filed with the applicable State Licensing Board
15 or any County Clerk’s Office regarding CONTRACT EMPLOYEE s and the nature of the complaint.
16 CONTRACT EMPLOYEEs, who are physicians, shall also notify ADMININSTRATOR of any past or
17 pending action against CONTRACT EMPLOYEE by any State Medical Board.

18 #
19 E. CONTRACT EMPLOYEE shall give written notice to ADMINISTRATOR of any defective
20 equipment, dangerous or deteriorating conditions of the premises, poor quality of supplies or services
21 actually known to CONTRACT EMPLOYEE.

22 F. For purposes of this Agreement, any notice to be provided by COUNTY may be given by
23 ADMINISTRATOR.

24
25 **XII. RESEARCH AND PUBLICATION**

26 CONTRACT EMPLOYEE shall not utilize information and data received from COUNTY or
27 developed as a result of this Agreement for the purpose of personal publication.

28
29 **XIII. RETIREMENT PLAN**

30 COUNTY shall enroll eligible CONTRACT EMPLOYEE in an appropriate County of Orange tax-
31 deferred compensation plan. CONTRACT EMPLOYEE will have a fixed employee contribution of
32 7.5% of compensation. This contribution is deducted from each regular paycheck on a pre-tax basis and
33 is in lieu of Old Age, Survivors, and Disability Insurance contributions.

34
35 **XIII. SEVERABILITY**

36 If a court of competent jurisdiction declares any provision of this Agreement or application thereof

1 to any person or circumstances to be invalid or if any provision of this Agreement contravenes any
 2 federal, state or county statute, ordinance, or regulation, the remaining provisions of this Agreement or
 3 the application thereof shall remain valid, and the remaining provisions of this Agreement shall remain
 4 in full force and effect, and to that extent the provisions of this Agreement are severable.

5 6 **XIV. TERM**

7 The term of this Agreement shall commence and terminate as specified in the Referenced Contract
 8 Provisions of this Agreement until the services required by this Agreement are satisfactorily completed,
 9 or until terminated by COUNTY. CONTRACT EMPLOYEE agrees that time is of the essence, and that
 10 it shall diligently and competently begin providing the services hereunder immediately upon execution
 11 of this Agreement by both parties. CONTRACT EMPLOYEE agrees to provide said services within the
 12 time limits hereinafter specified.

13 14 **XVI. TERMINATION**

15 A. Either party may terminate this Agreement immediately, without cause, upon written notice
 16 given the other party.

17 B. CONTINGENT FUNDING

18 1. Any obligation of COUNTY under this Agreement is contingent upon the following:

19 #
 20 a. The continued availability of federal, state and county funds for reimbursement of
 21 COUNTY's expenditures, and

22 b. Inclusion of sufficient funding for the services hereunder in the applicable budget
 23 approved by the Board of Supervisors.

24 2. In the event such funding is subsequently reduced or terminated, COUNTY may terminate
 25 or renegotiate this Agreement immediately upon written notice given CONTRACT EMPLOYEE.

26 C. After receiving a Notice of Termination CONTRACT EMPLOYEE shall do the following:

27 1. Comply with termination instructions provided by ADMINISTRATOR in a manner which
 28 is consistent with recognized standards of quality care and prudent business practice.

29 2. Obtain immediate clarification from ADMINISTRATOR of any unsettled issues of contract
 30 performance during the remaining contract term.

31 3. Return to COUNTY, in the manner indicated by ADMINISTRATOR, any equipment and
 32 supplies purchased with funds provided by COUNTY.

33 D. The rights and remedies of COUNTY provided in this Termination Paragraph shall not be
 34 exclusive, and are in addition to any other rights and remedies provided by law or under this Agreement.

I. PAYMENTS

A. For services provided in accordance with the terms of this Agreement, COUNTY shall pay CONTRACT EMPLOYEE biweekly, in arrears, at the following flat rate:

B. CONTRACT EMPLOYEE shall personally provide the services specified in this Agreement in accordance with a schedule of assigned hours prepared by ADMINISTRATOR, which may be adjusted by ADMINISTRATOR from time to time.

C. COUNTY may alter the hourly rate by action of the Board of Supervisors effective thirty (30) days after notice to CONTRACT EMPLOYEE.

D. In addition to the hourly rate specified above and, when required by CONTRACT EMPLOYEE's assignment, ADMINISTRATOR may, at its sole discretion, authorize supplemental pay of \$1.00 per hour for bilingual services. The determination of whether an assignment requires bilingual services and whether the employee is qualified to receive bilingual pay shall be made solely by ADMINISTRATOR.

E. COUNTY shall compensate «JOB_TITLE» with a Night Shift differential rate of \$2.25 per hour in addition to the hourly rate specified in Subparagraph I.A. of this Exhibit A to the Agreement for each hour «JOB_TITLE» actually works on an assigned Night Shift. For the purposes of this paragraph, Night Shift shall mean an assigned work shift of seven (7) consecutive hours or more which includes at least four (4) hours of work between the hours of 4 p.m. and 8 a.m. Overtime which is worked as an extension of an assigned day shift shall not qualify CONTRACT EMPLOYEE for Night Shift differential.

F. COUNTY shall pay CONTRACT EMPLOYEE at one-fourth (1/4) of CONTRACT EMPLOYEE's basic hourly rate for On-Call Services for the entire period of such assignment when such assignment is at the direction and specific request of ADMINISTRATOR or designee.

G. All claims by CONTRACT EMPLOYEE must be supported by time sheets and any other documents required by COUNTY's Auditor-Controller. All payments are subject to applicable federal,

1 state, and local withholding taxes.

2 H. TRAVEL

3 1. COUNTY shall reimburse CONTRACT EMPLOYEE for appropriate and reasonable travel
4 expenses which are required in the performance of duties under this Agreement approved, in advance
5 and in writing, by ADMINISTRATOR. CONTRACT EMPLOYEE shall provide supporting
6 documentation in the form required by COUNTY's Auditor-Controller when requesting travel
7 reimbursement.

8 2. COUNTY shall reimburse CONTRACT EMPLOYEE at the mileage rate set by the Internal
9 Revenue Service for the business use of an automobile as provided by the COUNTY's Auditor
10 Controller which is approved by ADMINISTRATOR.

11 I. CONTRACT EMPLOYEE shall not claim reimbursement for services provided beyond the
12 expiration and/or termination of this Agreement, except as may otherwise be provided for under this
13 Agreement.

14 J. COUNTY shall comply with the provisions of the Healthy Workplaces, Healthy Families Act of
15 2014 (AB 1522) effective July 1, 2015. CONTRACT EMPLOYEE's working for 30 or more days
16 within a year from the commencement of employment are entitled to paid sick days, to be accrued at a
17 rate of no less than one hour for every 30 hours worked. CONTRACT EMPLOYEE is entitled to use
18 accrued sick days beginning on the 90th day of employment. CONTRACT EMPLOYEE use of paid
19 sick days is limited to 24 hours or 3 days in each year of employment.

21 **II. SERVICES**

22 A. CONTRACT EMPLOYEE is employed as a <JOB_TITLE> under the terms of this Agreement.
23 CONTRACT EMPLOYEE agrees that, to the best of his/her ability and experience, he/she shall perform
24 in accordance with the contract, all of the duties and obligations required by the terms of this

26 B. CONTRACT EMPLOYEE shall:

27 1. Personally provide the services required of him/her on COUNTY premises or other location
28 as designated by ADMINISTRATOR; and

29 2. Comply with all aspects of Public Law 103-227, also known as the Pro Children Act of
30 1994 (ACT), which required that smoking not be permitted in any portion of any indoor facility; and

31 3. When providing services to CalOptima clients, comply with the terms and conditions of the
32 Coordination and Provision of Public Health Care Services Contract entered into by and between
33 Orange County Health Authority, a public agency, dba Orange Prevention and Treatment Integrated
34 Medical Assistance, dba CalOptima, and the County of Orange, through its division known as the
35 Orange County Health Care Agency.

1 shall accept the professional and administrative direction of ADMINISTRATOR or designee pursuant to
2 this Agreement.

3 D. CONTRACT EMPLOYEE shall be permitted to provide services to others outside of this
4 Agreement, similar to those permitted under this Agreement, provided the services:

- 5 1. Do not interfere with CONTRACT EMPLOYEE's duties under this Agreement; and
- 6 2. Are not performed on COUNTY property; and
- 7 3. Are not performed during those hours when CONTRACT EMPLOYEE is obligated to
- 8 perform for COUNTY.

9 E. CONTRACT EMPLOYEE shall not, in the course of rendering services under this Agreement,
10 refer any patient to any professional practice or organization in which CONTRACT EMPLOYEE, or
11 CONTRACT EMPLOYEE's spouse has any direct or indirect financial interest, without the prior
12 written consent of ADMINISTRATOR. Granting or withholding such consent shall be at the sole
13 discretion of ADMINISTRATOR.

14 F. ON CALL SERVICES – If specified by ADMINISTRATOR, CONTRACT EMPLOYEE shall
15 provide “On-Call Services,” when supported by a written On-Call Schedule or other authorization
16 signed by ADMINISTRATOR:

17 1. Provide services of the kind and type described in this Agreement as determined necessary
18 by ADMINISTRATOR irrespective of time of day or night.

19 2. When scheduled by the ADMINISTRATOR, CONTRACT EMPLOYEE shall remain
20 reachable by telephone or electronic signaling device within fifteen (15) minutes after signals are sent
21 and remain reachable for the entire period of such assignment. CONTRACT EMPLOYEE shall refrain
22 from activities which might impair his or her ability to respond and perform assigned services. In this
23 regard, CONTRACT EMPLOYEE shall immediately notify ADMINISTRATOR of any defect, or
24 suspected defect, in the signaling device.

25 3. If no signaling device is provided, and when so designated by ADMINISTRATOR,
26 CONTRACT EMPLOYEE shall provide ADMINISTRATOR with an address and telephone number at
27 which CONTRACT EMPLOYEE can be reached at any time. When changing locations, CONTRACT
28 EMPLOYEE shall notify ADMINISTRATOR, as instructed by ADMINISTRATOR, of the new address
29 and telephone number at which CONTRACT EMPLOYEE can be reached; provided, however no such
30 notice need be given if CONTRACT EMPLOYEE will be absent from a location, or unavailable by
31 telephone, for a period not in excess of thirty (30) minutes.

32 G. CALL-BACK SERVICES – When CONTRACT EMPLOYEE is required to return on a
33 “Call-Back” basis, CONTRACT EMPLOYEE shall be compensated for four (4) hours of work, at the
34 contract hourly rate, and will be required to remain at the worksite until CONTRACT EMPLOYEE's
35 services are not required. If CONTRACT EMPLOYEE is required to remain beyond the initial four (4)
36 hours, CONTRACT EMPLOYEE shall be compensated for all additional hours worked at the contract

hourly rate. This provision is only intended to compensate CONTRACT EMPLOYEE for “Call-Back” Services and does not supersede CONTRACT EMPLOYEE's regular work schedule. There shall not be any duplication of pay rates.

H. NATIONAL PROVIDER IDENTIFIER (NPI) – The standard unique health identifier adopted by the Secretary of Health and Human Services under Health Insurance Portability and Accountability Act (HIPAA) of 1996 for health care providers.

1. All HIPAA covered healthcare providers, individuals and organizations must obtain an NPI for use to identify themselves in HIPAA standard transactions. The NPI is assigned to individuals for life.

2. CONTRACT EMPLOYEE shall obtain an NPI upon commencement of this Agreement or prior to providing services under this Agreement. CONTRACT EMPLOYEE shall report to ADMINISTRATOR, on a form approved or supplied by ADMINISTRATOR, all NPI information as soon as it is available.

I. REMOTE SECURE ACCESS (RSA) TOKENS – ADMINISTRATOR will provide CONTRACT EMPLOYEE the RSA security device Token to access the HCA computer based Integrated Records Information System (IRIS) at no cost to the CONTRACT EMPLOYEE upon initial training.

1. CONTRACT EMPLOYEE recognizes RSA Tokens are assigned to a specific individual staff member with a unique password. RSA Tokens and passwords shall not be shared with anyone.

2. CONTRACT EMPLOYEE shall return to ADMINISTRATOR all RSA Tokens under the following conditions:

- a. Token of CONTRACT EMPLOYEE who is no longer performing work related to this Agreement.
- b. Token of CONTRACT EMPLOYEE who no longer requires access to the HCA IRIS.
- c. Tokens that are malfunctioning.

3. CONTRACT EMPLOYEE shall reimburse the COUNTY for the actual cost of RSA Tokens lost, stolen, or damaged through acts of negligence.

III. CULTURAL COMPETENCY

CONTRACT EMPLOYEE shall make its best efforts to provide services pursuant to this Agreement in a manner that is culturally and linguistically appropriate for the population(s) served, which may include, but is not limited to, utilization of interpreter services or other language assistance services. CONTRACT EMPLOYEE shall participate in COUNTY-sponsored or other applicable training directed by ADMINISTRATOR.
