# AMENDMENT NUMBER SEVEN TO CONTRACT MA-060-13011678 BETWEEN THE COUNTY OF ORANGE AND IDENTIFICATION AND SECURITY INTEGRATORS, INC

This AMENDMENT NUMBER SEVEN to Contract Number MA 060 13011678 (hereinafter "AMENDMENT NUMBER SEVEN") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and Identification and Security Integrators, Inc. (hereinafter "CONTRACTOR") with a business address of 5850 Elba Place, Woodland Hills, CA 91367, is made and entered upon execution of all necessary signatures.

### **RECITALS**

WHEREAS, COUNTY and CONTRACTOR executed a Contract for ID Card Printer Supplies, Maintenance and Repair on May 16, 2013, as Contract Number MA-060-13011678 (hereinafter "ORIGINAL CONTRACT"), for a one-year term of May 16, 2013 through and including May 15, 2014, renewable for four (4) additional one-year terms; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT, as Contract Number MA 060 14011315 on February 25, 2014 (hereinafter "AMENDMENT NUMBER ONE"), for a one (1) year term of May 16, 2014 through and including May 15, 2015;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT, as Contract Number MA-060-15011522 on April 21, 2015 (hereinafter "AMENDMENT NUMBER TWO"), for a one-year term of May 16, 2015 through and including May 15, 2016;

WHEREAS, COUNTY and CONTRACTOR amended the ORIGINAL CONTRACT on March 30, 2016 (hereinafter AMENDMNT NUMBER THREE") to increase the not to exceed amount by \$64,886.40 for a new Contract not to exceed amount of \$89,886.40; to add units 7472/Theo Lacy, 7473/Musick, 7478/Intake-Release Center to the Contract and to add item numbers 14 through 17 to Attachment B;

WHEREAS, COUNTY AND CONTRACTOR renewed the ORIGINAL CONTRACT on April 19, 2016 as Contract Number MA-060-16011854 (hereinafter "AMENDMENT NUMBER FOUR") for a one year term of May 16, 2016 through and including May 15, 2017 and increased the Contract not to exceed amount of \$89,866.40 for a new not to exceed Contract amount of \$91,500;

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on May 12, 2017 as Contract Number MA 060-17011699 (hereinafter "AMENDMENT NUMBER FIVE") for a one year term of May 16, 2017 through and including May 15, 2018 and the Contract not to exceed amount of \$91,500;

WHEREAS, COUNTY and CONTRACTOR amended the ORIGINAL CONTRACT on June 20, 2017 (hereinafter "AMENDMENT NUMBER SIX") and added line item number 18 to ATTACHMENT B, Pricing in the Contract not to exceed amount of \$91,500;

WHEREAS, COUNTY desires to amend the ORIGINAL CONTRACT to add line item numbers 19 through 21 to ATTACHMENT B, Pricing and increase the Contract not to exceed amount of \$91,500 by \$8,000 for a new Contract not to exceed amount of \$99,500 and the CONTRACTOR has agreed to provide these goods/services at the rates set forth in this amendment NUMBER SEVEN,

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:
