Dear Chairwoman Bartlett:

I am writing to express my support for Zoning Code Amendment CA 19-01, which will address the increase in licensed care facilities and group homes in single-family residential neighborhoods in unincorporated Orange County. The amendment will require group homes, including sober living homes, to obtain a ministerial permit through which they will agree to operate in a manner consistent with the nature of the single-family residential neighborhoods in which they are located.

The Orange County District Attorney's Office (OCDA) utilizes a proactive approach to address the proliferation of unlicensed, unregulated sober living homes in the County and the subsequent problems that manifest with these homes. In May 2017, the OCDA filed the *Ghostline Labs* cases against owners of a sober living company who operated multiple homes in three different counties and allegedly engaged in a \$22 million insurance fraud scheme. In January 2018, my office established the Sober Living-Home Investigation and Prosecution (SLIP) team to address reports of fraud and abuse in recovery homes. Since its inception, the task force has received multiple reports of fraud as well as daily complaints on the negative impact these homes have on the neighborhoods where they are located.

The proposed new ordinance to amend the zoning code will provide law enforcement with additional tools to improve public safety in neighborhoods with sober living homes. It will also help to ensure that the residents of sober living homes have the opportunity to live in residential surroundings as they undergo substance abuse treatment.

I sincerely appreciate your partnership in helping to make communities throughout Orange County safe and vibrant places to live, work and visit. The sooner we address the issue of unregulated group homes in the unincorporated County areas, the quicker the OCDA, local law enforcement and the community can work together to keep Orange County the safest among the surrounding counties.
