ALTHOUGH THERE WERE ONLY 6 PEOPLE LEFT IN THE ENTIRE AUDIENCE SINCE THEY'VE BEEN WAITING FOR OVER 7 HOURS TO SPEAK, AFTER THE CLERK ANNOUNCED THERE WERE "12" SPEAKERS AND CHAIRMAN BARTLETT REDUCED THE TIME TO SPEAK TO ONLY 2 MINUTES FROM THE ADOPTED 3 MINUTES... AND THE CHAIRMAN EXITED THE MEETING... NOT ONE OFFICIAL SPOKE UP TO CHALLENGE THIS EGREGIOUS LACK OF DISCRETION SHOWN AGAIN BY THIS CHAIRMAN... A TEXTBOOK EXAMPLE OF THIS "CANCER":

OMISSION: CLERK CONSPIRING WITH CHAIRMAN TO SILENCE PUBLIC

COMMISSION: COUNTY COUNSEL, CEO, REMAINING 3 SUPERVISORS SILENT AS A CHURCH MOUSE... WHICH LEADS ME TO MY NEXT POINT.

WE'RE ALL FAMILIAR WITH THE WATERGATE SCANDAL (1972) AS WELL AS THE CITY OF BELL SCANDAL (2010). THE SAME YEAR THE FRAUDULENT KLUBNIKIN CASES STARTED THERE IS A NEW SCANDAL THAT IS ABOUT TO BREAK BY ANY SELF-RESPECTING INTREPID REPORTER... THIS COMING SCANDAL IS SO BLATANT THAT A BLIND BABOON WITH AN EYE-PATCH COULD EASILY SPOT IT:

"I SEE NOTHINK-GATE"

AGAIN AS REPEATEDLY STATED IN COMPLAINT AFTER COMPLAINT, ON ELECTION DAY 11.8.16 WHEN VOTERS WERE VOTING SUPERVISORS INTO OFFICE, SUPERVISORS WERE REMOVING THEIR OWN CONSTITUENTS FROM THE ENTIRE MEETING SO AGENDA COMMENTS AFTER CALLED BY THE CLERK WOULDN'T BE HEARD BY SUPERVISORS... SO SUPERVISORS COULD JUST ROBBERSTAMP ITEMS BY EXCLUDING PUBLIC PARTICIPATION... A TRULY DEPLOABLE ACT AGAINST THE PUBLIC.

THIS CHAIRMAN (BARTLETT) WAS THE FIRST IN THE HISTORY OF THE COUNTY TO DEVISE SUCH A DUBIOUS SCHEME TO TOTALLY ELIMINATE PUBLIC PARTICIPATION AFTER AN AGENDA ITEM WAS CALLED BY THE CLERK. THIS WAS DONE DECEPTIVELY THROUGH BAIT AND SWITCH AS REPEATEDLY STATED. THIS "COMMISSION" INCLUDES BUT NOT LIMITED TO:

1. THIS ITEM WAS NOT ON THE AGENDA RELEASED TO THE PUBLIC (TO PREVENT PUBLIC PARTICIPATION)... BUT ADDED ON THE SUPPLEMENTAL 11.8-16 #533A
2. THIS ITEM DIDN'T EVEN HAVE AN AGENDA STAFF REPORT BUT JUST A "MEMO" CONSISTING OF ONLY 3 LINES NOTING THAT PUBLIC COMMENTS WERE TO BE MOVED TO THE BEGINNING OF EACH MEETING INSTEAD OF THE END OF MEETING
3. CHAIRMAN CONCEALED THAT AGENDA COMMENTS WERE TO BE CO-MINGLED WITH PUBLIC COMMENTS... AN UNSCRUPULOUS FIDUCIARY WILL CO-MINGLE PUBLIC AND PRIVATE FUNDS IN ORDER TO MONEY LAUNDER (SAME DECEPTIVE TACTIC)
4. CHAIRMAN CONCEALED THAT THE MAXIMUM TIME WOULD BE REDUCED FROM 9 MINUTES DOWN TO ONLY 3 MINUTES

WHEREAS CHAIRMAN MOORLACH PENALIZED 3 MILLION OF HIS OWN CONSTITUENTS IN ORDER TO SILENCE ONE VOICE... SINCE I HAD EXPOSED THE CRIMINAL COVERUP BY THE INTERNAL AUDITOR 12.4.12 AGENDA #19... WHEREBY SUPERVISORS JUST LIMITED PUBLIC PARTICIPATION...

CHAIRMAN BARTLETT AND SUPERVISORS ENTIRELY REMOVED THE PUBLIC FROM PARTICIPATION ON ANY AGENDA ITEM AFTER CALLED BY THE CLERK (11.8.16 AGENDA #533A... MADE NO DISTINCTION BETWEEN AGENDA COMMENTS AND PUBLIC HEARING).

THE FRUIT OF THIS DESPICABLE ACT BY CHAIRMAN BARTLETT WITH COMPLICITY OF FELLOW SUPERVISORS (REMOVING THE PUBLIC) WAS WITHIN MONTHS THE NEW CHAIRMAN STEEL HAD THE COUNTY FACING A LAWSUIT WITH THE FEDERAL AVIATION COMMISSION SINCE THE FIXED BASE OPERATOR CONTRACT WITH TWA WAS NOT PROPERLY VETTED... SUPERVISOR THEN HAD TO PULL ANOTHER EMILY (EMILIA) AND RESCIND THEIR FBO CONTRACT VOTE... AFTER AN ENTIRE YEAR WITHOUT ANY PUBLIC PARTICIPATION BY THE PUBLIC ON AGENDA ITEMS AFTER CALLED BY THE CLERK (CHAIRMAN STEEL'S WATCH)... CHAIRMAN DO THEN PULLED ANOTHER NEVER MIND EMILY LITTELL AND RESCINDED CHAIRMAN BARTLETT'S ORDINANCE TO REMOVE THE PUBLIC... UNDER THE FALSE FLAG OF PUTTING PUBLIC COMMENTS IN THE FRONT OF THE MEETING... BAIT AND SWITCH ON STEROIDS!

NOT AN ISOLATED INCIDENT BUT DONE NUMEROUS TIMES!

THIS CHAIRMAN'S ATTITUDE OF:

"SCREW YOU AND THE HORSE YOU CAME ON... I'M A SUPERVISOR!"

HAS EXPOSED THE ABSOLUTE CRIMINAL WHITEWASH BY THE ORANGE COUNTY GRAND JURY IN COVERING UP THE DEATHS OF 28 PEOPLE WHILE IN CUSTODY... A REPORT THAT IS OF COURSE RUBBERSTAMPED BY THIS BOARD.

YOU DON'T NEED TO BE A TRAINED FORENSIC EXPERT TO SEE THIS WHITEWASH. ALL THAT'S NEEDED IS TO HAVE WATCHED AN EPISODE OR 2 OF COLUMBO. WHETHER IT'S THE OT SIMPSON MURDER TRIAL OR AN EPISODE OF ER, THE MAIN QUESTION THAT ANY LEGITIMATE INVESTIGATION STARTS WITH IS:

"...WHEN PRECISELY DID THE DEATH OCCUR?"

OF COURSE THE OCGJ OMITTED THIS VITAL PIECE OF INFORMATION FROM THEIR REPORTS SO THEY COULD PAINT A BROAD STROKE OF HYPERTENSION DEATHS.

WITHOUT DISCLOSING THE "TIME OF DEATH" HOW ELSE CAN AUTHORITIES ZERO IN AND REDUCE THE POSSIBILITIES WHETHER THE DEATH WAS DUE TO RECKLESSNESS, OR DUE TO NEGLIGENT ACTS OR GOD FORBID DUE TO HOMICIDE?

THE OCGJ WENT OUT OF ITS WAY TO CONCEAL THE "WHEN" DID THESE DEATHS OCCUR... ALL ON WEEK DAYS... ALL ON WEEKENDS... ALL ON HOLIDAYS... AT NIGHT... AT MORNING... DURING A STAFF CHANGE... DURING VISITING HOURS... AFTER VISITING HOURS... THE DAY OUTSIDE AGENCIES VISIT... THE DAY AFTER "BLANK" HAPPENS?... HOW ELSE CAN YOU DETERMINE WHETHER AN ALIBI IS TRUE OR BOGUS? THIS GRAND JURY REPORT WAS EMBARRASSINGLY INCOMPLETE AND DIDN'T EVEN SCRATCH THE SURFACE OF A VERY SERIOUS PROBLEM OF DEATHS WHILE IN CUSTODY... BASED UPON THE ADMISSABLE UNDISPUTED EVIDENCE FILED WITH THE COURT AS WELL AS FILED WITH SUPERVISORS SINCE 2011 (FILED WITH SUPERVISORS SINCE JUDGE SHERMAN AND JUDGE MARY FINGAL SCHULTE ONLY ALLOWED ME TO SAY MY NAME AT THE HEARINGS UP TO THE APPOINTMENT OF THE COUNTY APPOINTED FIDUCIARY), THE KLUBNIKIN CASES CONSERVATOR AND TRUST WERE INITIATED THROUGH A BLATANT FRAUD ON THE COURT SCHEME, WHICH CONTINUES TODAY.

THROUGH THIS FRAUD ON THE COURT SCHEME COURT OFFICIALS WERE ABLE TO SEIZE AN ESTATE, DAMAGE THE ESTATE BY NOT PAYING ONE SOLITARY MORTGAGE PAYMENT IN ORDER TO MALICIOUSLY DAMAGE THE ESTATE, THEN SELL OFF 2 BEACH HOMES THAT WERE OCCUPIED WITH LONG TERM TENANTS. THESE SAME OFFICIALS WERE ABLE TO STEAL OVER \$180K IN FEES THROUGH UNHOLY ALLIANCES WITH PROBATE JUDGES.

THIS WAS DONE WITH FALSE CHARGES AGAINST ME OF FINANCIAL ABUSE AGAINST MY MOM, YET NOT ONE PIECE OF PAPER IS ATTACHED TO ANY PETITION TO SUPPORT THAT FALSE ALLEGATION AGAINST ME. NOT ONE. JUST WORDS TYPED ON A PETITION IS ALL THE PROOF OF THIS FINANCIAL ABUSE.

THIS WAS DONE WITH CREATING A FALSE EXIGENT NON-EXISTENT MORTGAGE CRISIS THAT 3 OF 4 PROPERTIES WERE IN FORECLOSURE... WHEN OFFICIAL RECORDED DOCUMENTS FILED IN SAN LUIS OBISPO COUNTY AS WELL AS RECORDED IN ORANGE COUNTY PROVES THAT IN FACT ONLY ONE PROPERTY WAS IN FORECLOSURE AND ON LINE TO BE BROUGHT CURRENT AS ALWAYS.
