## AMENDMENT NUMBER TWO CONTRACT NUMBER MA-012-17010285 FOR LANDSCAPE MAINTENANCE SERVICES

This Amendment Number Two, hereinafter referred to as "Amendment", is made and entered into upon execution of all necessary signatures, between the County of Orange, a political subdivision of the State of California, hereinafter referred to as "County" and BrightView Landscape Services Inc., with a place of business at 1960 South Yale Street, Santa Ana, CA 92704, hereinafter referred to as "Contractor", with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

## RECITALS

- 1. **Term of Contract is Renewed:** The term of the Contract MA-012-17010285 shall be renewed for a period of one (1) year, effective November 1, 2018 through and including October 31, 2019, in an amount not to exceed \$1,900,000. This Contract is renewable for two (2) additional one (1) year periods, unless otherwise terminated by either Party according to terms and conditions stated herein.
- 2. All other Contract Terms and Conditions remain unchanged: This Amendment modifies the Contract only as expressly set forth above. This Amendment does not modify, alter or amend the Contract in any other way whatsoever. Except as otherwise expressly set forth herein, all terms and conditions contained in the Contract, including its Amendments are incorporated by this reference as if fully set forth herein and shall remain in full force and effect as amended herein.
