# JOHN WAYNE AIRPORT AGREEMENT FOR ARCHITECT-ENGINEER SERVICES

THIS AGREEMENT ("Agreement"), is made and entered into on the \_\_\_\_\_\_\_ day \_\_\_\_\_\_\_, 2016, between the County of Orange, a political subdivision of the State of California, hereinafter referred to as "COUNTY" or "JWA," and AECOM TECHNICAL SERVICES, INC., hereinafter referred to as "A-E". This Agreement will be administered by the Director of John Wayne Airport or his designee, herein after referred to as "JWA".

#### WITNESSETH:

IT IS MUTUALLY AGREED between the parties hereto that:

#### 1. TERM OF AGREEMENT

The "Term" of this Agreement shall commence upon the date of award as evidenced by the Orange County Board of Supervisors Minute Order awarding this Agreement (Contract Award Date). The A-E shall not commence services under this Agreement until it has obtained all insurance required and such insurance has been approved by COUNTY. The A-E shall have 7 days from the Contract Award Date to submit complete insurance documents, and COUNTY may take up to 14 days to approve said insurance. Also, A-E may not work on the site until its Safety Plan is approved by the COUNTY. Services shall be completed within three years from date of award.

#### 2. A-E SCOPE OF SERVICES

A-E shall diligently perform in a competent and professional manner those tasks and duties set forth in Appendix 1 - Scope of Services, attached hereto, in the time set forth in the Article titled Time for Performance below. The attached Appendix 1 - Scope of Services is hereby incorporated into this Agreement by reference. COUNTY, at its discretion, may reduce, limit or amend the Scope of Services and the corresponding costs upon written notification to A-E as described in the Article titled Changes in Scope of Services of this Agreement.

#### 3. LIMITATIONS OF AUTHORITY

A-E shall not become involved in areas of responsibility outside of the Scope of Services unless specific exceptions are established by JWA in writing. A-E shall not:

- 1) Exceed, or authorize deviation from JWA's Construction Budget
- 2) Exceed, or authorize deviation from JWA's Construction Schedule
- 3) Authorize deviations from the Construction Documents
- 4) Authorize any work that may involve cost or schedule impacts to the COUNTY
- 5) Authorize change orders
- 6) Provide superintendence of the construction work
- 7) Provide expediting services for the Contractor
- 8) Provide advice to the Contractor regarding construction techniques or sequences of construction unless specifically outlined in the Construction Documents

Additionally, A-E has no authority to amend any contract between COUNTY and any other party.

#### 4. TIME FOR PERFORMANCE

The A-E shall submit for the COUNTY's approval a cost-loaded Project Design Schedule for the performance of the A-E's Design Phase Basic Services per the Scope of Services attached. The Project Design Schedule shall be submitted within 14 days of the Contract Award Date. The Project Design Schedule shall be prepared using Primavera 6 or Microsoft Project. The Project Design Schedule shall include allowances for periods of time required for the COUNTY's review and for approval by authorities having jurisdiction over the Project. A-E shall comply with the time limits and milestones established in this schedule and approved by the COUNTY.

Should it become necessary to revise the Project Design Schedule, A-E shall request approval of such revision in writing. If such design schedule revision is approved by JWA, then the revised schedule will be referred to as the Revised Project Design Schedule.

#### 5. COORDINATION OF DRAWINGS

A-E shall be responsible for the coordination of all design documents relating to A-E's Scope of Services, regardless of whether such drawings or documents are prepared or performed by A-E, by A-E's sub-consultants, or by others. If others have performed preliminary, schematic, or design development work, A-E nevertheless accepts full responsibility for that work as fully as if such work had been performed by the A-E itself. A-E shall be responsible for the coordination and internal checking of all drawings within

its Scope of Services and for the accuracy of all dimensional and layout information contained in them. The A-E shall be responsible for the completeness and accuracy of all drawings and all specifications within its Scope of Services and for their compliance with all applicable codes, ordinances, regulations, laws, and statutes.

A-E shall advise COUNTY of any need for securing tests, analyses, studies, reports, or sub-consultant services in connection with the development of the design and construction documents for the Project.

#### 6. RECORD DRAWINGS

A-E shall provide Record Drawings, to the satisfaction of JWA, showing the asconstructed condition of the Project on archive quality sheets (30" x 42"), and in digital format, including PDF and Microstation. Record Drawings shall incorporate all changes in the work made during construction, based on marked-up prints, as-built drawings provided by the Contractor, shop drawings and other data known by the A-E, and shall accurately reflect the final construction of the work. Record Drawings shall include without limitation the following systems: architectural, structural, civil, mechanical electrical, plumbing, fire protection, fire alarm, security and landscape. A-E shall provide the Record Drawings to COUNTY promptly after the completion of construction. A-E shall upload Record Drawings in PDF format into the "Oracle Primavera Unifier Project Document Management System" (Unifier).

#### 7. COMPENSATION FOR SERVICES

#### A. Not-To-Exceed Compensation and Reimbursable Expenses

COUNTY shall pay to A-E for performance of this Agreement the not-to-exceed amount of \$2,639,758 for A-E's approved work in accordance with the Scope of Services. A-E shall only be entitled to payment for work as directed by COUNTY and completed by A-E within its Scope of Services as set forth in Appendix 1. In no event shall A-E be entitled to compensation and reimbursement that would result in the total payment by the COUNTY under this Agreement exceeding \$2,639,758 unless change order(s) or amendment(s) to this Agreement have been approved by COUNTY, pursuant to the Article titled Changes in Scope of Services.

#### B. Rates for A-E's Personnel

COUNTY agrees to compensate A-E for services performed by its personnel during the Bid & Award, Construction, and Close-out phases based on the hourly rates set forth in Appendix 2 for each Job Classification. The hourly rate for each job classification represents the maximum rate for that job classification. However, the COUNTY reserves the right to negotiate with A-E a lower rate for any given job classification based on the qualifications of the candidate being considered for that job classification.

# C. Labor Cost Projections and Cost Control

A-E shall exercise diligent effort to maintain best management practices in control of the productivity of its personnel in performance of their tasks within the Scope of Services, and report to JWA in a timely fashion any conditions, unusual circumstances, or elements that may impact or be cause for change to A-E's Scope of Services or cost.

On a regular basis, and as frequently as COUNTY may consider appropriate, A-E shall submit to JWA its personnel's labor hours and cost expenditures for hourly-based time and material phases of the scope of services for prior service periods and projections for upcoming service periods, and shall report potential variances, if any,

in expenditures and productivity which may result in the exhaustion of funds in the Agreement prior to its full term. A-E shall promptly submit a request for change order or amendment for JWA's review if A-E becomes aware of conditions or circumstances that may warrant a change in any of the Scope of Services, or which may cause labor productivity and/or expenditures to vary measurably.

# D. Reimbursable Expenses

Other than as provided below, reproduction expenses incurred by A-E for A-E's own in-house reproduction will not be reimbursed by COUNTY. The A-E's invoice shall not include, any items deemed by the COUNTY as overhead expenses. A-E expenses beyond the schedule of fees or outside the Reimbursable Expenses enumerated below will not be considered. This includes, but is not limited to, travel, mileage or other expenses deemed by the COUNTY as overhead. A-E shall invoice hourly-based service fees in accordance with Appendix 2, in proportion to the work completed and to the extent that outside consultants, subcontractors, and approved direct project expenses have been approved by JWA. Other reimbursable expenses that may be required are subject to prior written approval by JWA.

A-E shall be entitled to reimbursement for the following Reimbursable Expenses. No other expenses shall be reimbursed without prior written authorization of the COUNTY:

- 1) The actual costs of special equipment to be rented, leased or purchased by A-E for use exclusively in the performance of the Scope of Services, to the extent such rental, lease, purchase and costs have been approved in writing by JWA. All special equipment purchased by A-E under this subsection shall become the property of JWA at the termination of this Agreement.
- 2) The actual cost of third-party tools and software recommended by A-E and approved in writing by JWA. Third-party tools and software costs to include, but not limited to, purchase, lease, maintenance, external web hosting when appropriate, and server applications for multiple users to be specified by JWA.
- 3) Reproduction expenses paid to outside vendors, to the extent such vendors and reproduction rates have been approved by JWA.
- 4) Other actual costs and/or payments specifically approved and authorized in writing by JWA and incurred by A-E in performance of this Agreement.
- 5) Air travel and lodging costs shall be reimbursed only if approved in advance and in writing by JWA and are subject to the following restrictions:
  - a) Alcohol of any type will not be reimbursed
  - b) Dry cleaning will not be reimbursed
  - c) Hotel movies will not be reimbursed

- d) Valet parking is reimbursable only if no other parking option is available.
- e) Meals will be reimbursed for personnel on authorized business travel only at a flat per diem rate of \$60 per day.
- f) Air travel is reimbursed at the fare for "Coach Class" seating. "Business Class" or "First Class" fares will not be reimbursed.
- g) Lodging reimbursement shall be based on actual, reasonable, and necessary costs. Hotel rates associated with authorized business travel exceeding \$200.00 per day must be approved in writing by JWA. This written approval must be submitted with the billing for reimbursable expenses.
- h) Phone charges during hotel stays associated with business support of the Scope of Services must be identified. Personal phone charges will not be reimbursed.
- i) Car rental is reimbursable at the cost for mid-size or lower size vehicle. Larger size vehicle rentals must be approved in advance in writing by JWA. This written approval must be submitted with the billing for reimbursable expenses. Luxury or Sports car rentals of any type will not be reimbursed.
- j) Reimbursement of mileage for the business use of a personal vehicle during the conduct of business within the Scope of Services of this Agreement shall be based on the Internal Revenue Service Standard Mileage Rate in effect at the time. Mileage between the A-E's "Home Based" office location and JWA, as well as mileage within JWA's property, will not be reimbursed.
- k) Cost of "Home Based" Xerox copies, faxes, and other supplies and materials associated with them will not be reimbursed.
- l) Cost of cellular phones, cell phone usage plans and usage minutes, and other mobile communication devices will not be reimbursed.

Reimbursable expenses shall be submitted no more frequently than once every month. All reimbursable expenses must be documented with receipts and documentation must be submitted with billing. Reimbursables without back-up documentation will not be paid. A-E is responsible for submitting reimbursable billings in a format that is acceptable to JWA Accounting.

#### **E.** Request for Payment

Services under this Agreement shall be billed monthly using JWA's "Progress Payment Request" form provided by JWA and/or other electronic format of "Progress Payment Request" approved and made available by JWA, via Unifier. Approved and authorized reimbursable expenses shall be included in the payment request. A-E will

not be entitled to any mark-up on reimbursable expenses. A-E will not be entitled to reimbursement for any expense incurred in performance of this Agreement or in connection with the Scope of Services that is not specified in Appendix 1.

A-E shall submit the invoice as a record into Unifier with the following documents attached as electronic backup. Payment documentation shall include customary information including, but not limited to:

- 1) Signed payment request cover sheet.
- 2) Timesheets including; employee name, hours worked, service dates for hourly fee services certified by A-E's authorized designee.
- 3) Up-to-date running account of hours and cost for the project.
- 4) Authorization letters and receipts for approved Reimbursable Expenses.
- 5) Progress Report: Each activity of A-E and staff must be defined by their job title and description of work completed.
- 6) List of employees who worked on the Scope of Services during the month covered by the Request for Payment, including their names, job titles, hourly rates, and assignments.

COUNTY will pay A-E a fee on an hourly basis subject to the respective not-to-exceed limits for services performed based on the hourly rates set forth. Fees for Architect-Engineer Services shall be in accord with the hourly rates set forth in Appendix 2 except as provided in the Article titled Changes in Scope of Services. COUNTY will not pay hourly labor charges, fees, or test charges without back-up documentation. A-E is responsible for submitting invoicing in a format that is acceptable to JWA.

In the event that A-E anticipates the cost for Architect-Engineer Services in excess of the authorized amounts, the COUNTY shall be notified immediately in writing. COUNTY shall not be required to pay for Architect-Engineer Services in excess of these amounts unless the COUNTY otherwise agrees by Change Order.

Requests for payment should be submitted to JWA no later than 15 days following the period in which the services were performed. Requests for Payment must be approved by the COUNTY's Auditor/Controller before payment may be made.

#### 8. CHANGES IN SCOPE OF SERVICES

The COUNTY may at any time direct any amendments or changes in work in the Scope of Services under this Agreement, including any reductions in the Scope of Services. The cost for work and reimbursable expenses that are part of changes in scope of services shall be billed in accordance with the Article titled Compensation for Services above. If COUNTY desires a change in the services, a written change order shall be issued by

COUNTY. The written change order shall set forth the nature of the change. If changes in Scope of Services cause an increase in costs and/or time, compensation shall, at COUNTY's discretion, be based either on a negotiated fixed fee or an hourly rate basis with a not-to-exceed amount using the hourly rates set forth in Appendix 2.

If A-E believes that a change in the Scope of Services is appropriate, it may submit a written request to the COUNTY to issue a change order or amendment. A-E shall present to COUNTY a detailed request for change in Scope of Services or compensation or other conditions from what is set forth in this Agreement. COUNTY shall be provided sufficient time for the review, analysis, processing, and issuance of written change order(s) or amendments(s). COUNTY may reject A-E's request for change, propose a revision to the requested change, or approve such change as requested by the A-E. If changes in Scope of Services cause an increase in costs and/or time, compensation shall, at COUNTY's discretion, be based either on a negotiated fixed fee or an hourly rate basis with a not-to-exceed amount using the hourly rates set forth in Appendix 2.

All changes to the Scope of Services shall be approved in accordance with the current version of the COUNTY's Contract Policy Manual. If changes to the Scope of Services cause an increase in compensation, such increase in compensation shall be based on the terms of this Agreement.

# 9. A-E'S PERSONNEL

#### A. Assigning Personnel

Throughout the term of this Agreement, the A-E shall provide those personnel qualified to perform the required Scope of Services upon the Project. Upon request by COUNTY, A-E shall submit a staff authorization request for proposed personnel and for a given job classification, upon which COUNTY will render a decision on whether the proposed personnel meets the qualifications sought under the Agreement.

A-E shall also provide such fully-qualified administrative, managerial, clerical, secretarial and other support personnel as are necessary, and approved by JWA. A-E shall furnish the necessary personnel to complete the services in a timely fashion and in accordance with the requirements for the Project. A-E shall have the authority to commit A-E's resources as needed and as requested by JWA.

A-E shall not bill the COUNTY for the services of any personnel not assigned to the Project without the COUNTY's prior written approval of the person by name and the person's specific hourly billing rate.

#### B. Assigned Personnel

Reassignment of A-E's personnel requires prior written consent by JWA. A-E shall not be entitled to compensation for personnel who are removed from the project or the individuals who replace them without the written consent of JWA.

# C. Removal of personnel at COUNTY's Discretion

COUNTY may, at its sole discretion, require A-E to remove from the Project any of its personnel assigned to the performance of the Scope of Services. A-E shall remove such person(s) from the Project promptly after request from JWA. The A-E shall make its best efforts to replace any person so removed within seven (7) days with a person of like qualifications acceptable to COUNTY. Alterations to A-E's staff at COUNTY's request do not constitute changes to the Scope of Services.

## D. Qualifications/Licensing

A-E represents that all personnel provided under this Agreement are fully qualified for the offices or positions to which they are assigned, and that they meet or exceed the qualifications for their positions.

A-E and each of its subcontractors at any tier, if any, shall maintain in full force and effect at all times during the term of this Agreement such licenses, registrations or permits as may be required by the State of California or any other local, regional, County, State or Federal governmental entities. A-E shall promptly inform COUNTY of any lapse of license, investigation, or disciplinary action against A-E, its employees, or its subcontractors on this project.

#### E. Organization/Assignments

Within thirty days of the execution of this Agreement, A-E shall prepare and submit to JWA an organizational chart detailing A-E's Project activities by employee name, job title, and organizational unit, and showing lines of command and responsibility. A-E shall update the organizational chart to show any proposed changes at least 30 days, or sooner if JWA deems necessary, prior to the change taking effect, and shall submit the updated chart to JWA.

# F. List of Employees

A-E shall provide JWA with a list of employees on the Project prior to A-E's first billing, including employee names, job titles, assignments, and rates of pay. A-E shall submit this list with each monthly pay request. COUNTY reserves the right to withhold payment from A-E's pay requests until such information is submitted. If any of A-E's staff change, A-E shall submit a revised list of employees.

#### G. Compliance with Employment Laws

A-E shall be solely responsible for complying with all laws pertaining to the employment of all of A-E's personnel, including but not limited to, compliance with all applicable laws and regulations concerning workers' compensation, social security, minimum wage, unemployment insurance, hours of labor, services, working

conditions, equality in employment, and like subjects affecting employers engaged in public projects.

# 10. SUBCONSULTANTS

The retention by the A-E of any sub-consultant that is different from those noted in Appendix 2 shall be approved in writing by the COUNTY. A-E shall ensure that the contract for each of its sub-consultants providing services on this Project contain the requirements set forth in the following articles of this Agreement: Accounting Records/Audit; Nondiscrimination; and County of Orange Child Support Enforcement.

COUNTY may, at its sole discretion, require A-E to remove from the Project any of its sub-consultants assigned to the performance of the Scope of Services. The A-E shall remain responsible to the COUNTY for any and all services and obligations required under this Agreement, whether performed by A-E or its subcontractors.

A-E shall pay each subcontractor in the time periods required by law. Any subconsultants employed by A-E shall be independent contractors and not agents of the COUNTY. A-E shall ensure that its sub-consultants satisfy all substantive requirements for the work set forth by this agreement, including insurance and indemnification.

#### 11. NON-EMPLOYMENT OF COUNTY EMPLOYEES BY A-E

A-E agrees that it will neither negotiate, offer, or give employment to any full-time, regular employee of COUNTY in professional classifications of the same skills required for the performance of this Agreement who is involved in this Project in a participatory status during the life of this Agreement regardless of the assignments said employee may be given or the days or hours employee may work.

#### 12. EMPLOYMENT ELIGIBILITY VERIFICATION

The A-E warrants that it fully complies with all Federal and State statutes and regulations regarding the employment of aliens and others and that all its employees performing work under this Contract meet the citizenship or alien status requirement set forth in Federal statutes and regulations. The A-E shall obtain, from all employees performing work hereunder, all verification and other documentation of employment eligibility status required by Federal or State statutes and regulations including, but not limited to, the Immigration Reform and Control Act of 1986, 8 U.S.C. §1324 et seq., as they currently exist and as they may be hereafter amended. The A-E shall retain all such documentation for all covered employees for the period prescribed by the law. The A-E shall indemnify, defend with counsel approved in writing by COUNTY, and hold harmless, the COUNTY, its agents, officers, and employees from employer sanctions and any other liability which may be assessed against the A-E or the COUNTY or both in connection with any alleged violation of any Federal or State statutes or regulations pertaining to the

eligibility for employment of any persons performing work under this Contract.

#### 13. OWNERSHIP OF DOCUMENTS

All documents, drawings, designs, plans, specifications, models, schedules, estimates, and other A-E work or materials in all forms and media pertaining to A-E's Scope of Services furnished hereunder shall be and remain the property of COUNTY, and may be used by COUNTY as it may require without limitation, without any additional cost to COUNTY. However, A-E does not accept responsibility for COUNTY's use of A-E's work under this Agreement for other projects.

A-E will provide all such work and materials to COUNTY upon request, including copies of all work or materials prepared in electronic or digital format on computer disk or other applicable media. The rights and obligations of this Article shall survive the termination or completion of this Agreement.

#### 14. CONFIDENTIALITY

All ideas, memoranda, specifications, plans, procedures, drawings, descriptions, and all written or other information submitted to A-E in connection with the performance of this Agreement shall be held confidential by A-E and/or anyone acting under the supervision of A-E and shall not, without the prior written consent of COUNTY, be used for any purposes other than the performance of the Project described in Appendix 1, nor be disclosed to any person, partnership, company, corporation or agency, not connected with the performance of the Project.

Nothing furnished to A-E which is generally known among counties in Southern California shall be deemed confidential.

A-E and/or anyone acting under the supervision of A-E shall not use COUNTY name or insignia, photographs of the work, or any other publicity pertaining to the work in any magazine, trade paper, newspaper, or other medium without the express written consent of COUNTY.

# 15. PUBLICATION

No copies of sketches, schedules, written documents, computer based data, photographs, maps or graphs, including graphic art work, resulting from performance or prepared in connection with this Agreement, are to be released by A-E and/or anyone acting under the supervision of A-E to any person, partnership, company, corporation, or agency, without prior written approval by the COUNTY, except as necessary for the performance of the services of this Agreement. All press contacts, including graphic display information to be published in newspapers, magazines, etc., are to be administered only after COUNTY approval.

A-E agrees that it will not issue any news releases or make any contact with the media in connection with either the award of this Agreement or any subsequent amendment of, or effort under this Agreement. A-E must first obtain review and approval of said media contact from the COUNTY through the COUNTY'S Project Manager. Any requests for interviews or information received by the media should be referred directly to the COUNTY. A-E is not authorized to serve as a media spokesperson for COUNTY projects without the prior specific written consent of JWA.

A-E shall not release information in any manner or form on behalf of the COUNTY or JWA pertaining to the nature, scope, or details of the Project in any organized public or private event, setting, or ceremony, without the prior specific written consent of JWA.

#### 16. RIGHT TO OFFSET

COUNTY, without waiver or limitation of any of its rights or remedies, shall be entitled from time to time to deduct from any amounts due or owing by COUNTY to A-E in connection with this Agreement, any and all amounts owed by A-E to COUNTY in connection with this Agreement. COUNTY will provide A-E with written notice including justifications of amounts withheld.

#### 17. AVAILABILITY OF FUNDS

Each payment or obligation of COUNTY is contingent upon the availability of local, State, or Federal government funds which are appropriated or allocated for the payment of such an obligation. If the funds are not allocated and available for the continuance of the services performed, then this Agreement may be terminated or suspended by COUNTY at its convenience. COUNTY shall notify A-E promptly of any product or service that will be affected by a shortage of funds and shall make its best efforts to notify A-E prior to the A-E's commitment or expenditure of funds. No penalty shall accrue to COUNTY in the event this provision is exercised, and COUNTY shall not be obligated or liable for any future payments due or for any damages as a result of suspension or termination under this Article.

#### 18. TERMINATION FOR CONVENIENCE

Notwithstanding any other provision of this Agreement, COUNTY may, at any time, and without cause, terminate this Agreement in whole or in part, upon written notice to A-E. Such termination shall be effected by delivery to A-E of a notice of termination specifying the effective date of the termination and the extent of the services to be terminated.

In the event of such termination, COUNTY shall pay A-E amounts owing to it for the services completed and reimbursable expenses incurred prior to the effective date of the termination, and such payment shall be A-E's sole remedy against COUNTY. Under no

circumstances will A-E be entitled to anticipatory or unearned profits, consequential or special damages, or any other damages as a result of a termination or partial termination of this Agreement.

#### 19. TERMINATION FOR DEFAULT

Notwithstanding any other provision of this Agreement, if A-E fails to perform any of its obligations under this Agreement, COUNTY may, without prejudice to any other rights or remedies it may have, cause further payment to be held in abeyance, and/or may terminate this Agreement by giving written notice to A-E specifying the cause and the date of termination.

In the event of such termination, COUNTY shall pay A-E for the portion of services performed up to the date of termination, including reimbursable expenses incurred up to that time, less any sums as may be withheld by COUNTY in its sole discretion to cover all costs, claims, damages or losses incurred by COUNTY or likely to be incurred as a result of or in connection with A-E's failure to perform. Such payment shall be A-E's sole remedy against the COUNTY. The COUNTY may set off against and deduct from any amounts payable to A-E all damages suffered by COUNTY due to any such default and failure to perform by A-E. If COUNTY has, as of the date of the termination of this Agreement, already paid A-E an amount which exceeds the amount which may be due to A-E, A-E shall refund to COUNTY the excess amount promptly after notice from COUNTY.

If the sum of the total cost to COUNTY of completing the services plus amounts previously paid to A-E exceeds the total amount the COUNTY would have paid to A-E under this Agreement for the completed services, the A-E shall promptly pay the difference to COUNTY.

Under no circumstances will A-E be entitled to anticipatory or unearned profits or special damages as a result of a termination of this Agreement.

In the event COUNTY does not insist upon strict performance by A-E, or waives one or more of A-E's defaults, such event(s) shall not be deemed or construed as a waiver or a relinquishment to any extent of any right of COUNTY to insist on strict performance or to assert a default on any future occasion, nor will such be deemed to amend or modify the terms of this Agreement. Nothing in this Article shall be construed or deemed to be a waiver of any remedy in law or in equity that COUNTY may have.

# 20. OBLIGATIONS UPON TERMINATION

In the event of termination for convenience or for default, the A-E shall immediately stop services in accordance with the notice and comply with any other direction as may be specified in the notice or as subsequently provided by COUNTY. A-E shall insert in any contract with a subcontractor that the subcontractor shall stop services on the date of and

to the extent specified in a notice of termination, and shall require all subcontractors at any tier to insert the same in any lower tier contracts.

Upon termination, A-E shall turn over to COUNTY all finished and unfinished reports and other written services of any kind or quality prepared or generated in connection with the services under this Agreement, including providing copies on computer disks or other applicable media of all such services or materials that were prepared in electronic or digital form.

Upon termination, A-E shall immediately advise COUNTY of all outstanding agreements, subcontracts, rental agreements, and purchase orders which A-E has with others pertaining to performance of the services, and shall furnish COUNTY with complete copies thereof. Upon request by COUNTY, A-E shall assign to COUNTY, in form and content satisfactory to COUNTY, A-E's title to materials and equipment for the services and all its interest in any agreements, subcontracts, rental agreements, and purchase orders designated by COUNTY. A-E shall include provisions in all of its subcontracts, rental agreements, purchase orders, and other agreements related to its services under this Agreement providing that its rights thereunder may be assigned to COUNTY and that in the event of such assignment, the other contracting party agrees to be bound to the COUNTY, and shall require all subcontractors at any tier to insert the same in any lower tier contracts.

#### 21. RESPONSIBILITY FOR DAMAGES OR INJURY

COUNTY and its officers and employees shall not be answerable or accountable in any manner for any loss or damages that may happen to the work or any part thereof; for any loss or damage to any of the materials or other things used or employed in performing the work; for injury to or death of any person, either workers or the public; or for damage to property from any cause which might have been prevented by A-E, its subcontractors at any tier, or any of their workers, agents or anyone employed or otherwise retained by them or for which they may be deemed responsible.

#### 22. DAMAGES

COUNTY's rights under this Agreement shall be cumulative and in addition to, and not in limitation of, all other legal or equitable rights or remedies available to COUNTY.

## 23. SUSPENSION OF SERVICES

# A. COUNTY's Options

The COUNTY, at its sole discretion, may at any time by written notice to A-E suspend further performance of all or any portion of the services by A-E. Said notice of suspension shall specify the date of suspension and the estimated duration of the suspension. Upon receiving any such notice of suspension, A-E shall promptly

suspend further performance of the services to the extent specified, and during the period of such suspension shall properly care for and protect all services in progress and information, materials, supplies, and equipment A-E has on hand for performance of the services.

Upon the request of COUNTY, A-E shall promptly deliver to COUNTY copies of outstanding purchase orders, agreements, and subcontracts of A-E for materials, equipment, and services for the services, and shall take such action relative to such purchase orders, agreements, and subcontracts as may be directed by COUNTY.

COUNTY may at any time withdraw the suspension of performance of the services as to all or part of the suspended services by written, verbal, or facsimile notice to A-E specifying the effective date and scope of withdrawal, and A-E shall resume diligent performance of the services for which the suspension is withdrawn on the specified effective date of withdrawal.

# B. No Agreement Modification

No suspension or withdrawal of suspension shall entitle A-E to any prospective profits or other losses or damages of any kind resulting from such suspension or withdrawal of suspension.

Furthermore, no damages, compensation, or claims shall be payable or owing by COUNTY to A-E for any interruption or cessation of A-E's business, or loss of income arising from any suspension or withdrawal of suspension.

#### 24. A-E'S REVIEW OF PROJECT DOCUMENTS AND FIELD CONDITIONS

A-E represents and agrees that it will review and become fully informed as to the state of any existing drawings, specifications and studies for work on the Project, that A-E will visit the job site and examine the actual job conditions and limitations of the Project, and that A-E will obtain information sufficient to allow it to proceed with the Scope of Services described herein. A-E is and will be relying strictly and solely upon its own such review and examinations and the advice and counsel of its agents and officers. A-E shall advise COUNTY of any need for securing any tests, analyses, studies, reports, or services in connection with assigned work and the management thereof. Except as expressly set forth in this Agreement, COUNTY is not making and has not made any warranty or representation with respect to site conditions or limitations.

#### 25. ACCOUNTING RECORDS/AUDIT

Pursuant to and in accordance with Section 8546.7 of the California Government Code, in the event that this Agreement involves expenditures of public funds aggregating in excess of Ten Thousand Dollars (\$10,000), the parties shall be subject to examination

and audit by the California State Auditor for a period of three (3) years after final payment under this Agreement.

A-E's records shall upon reasonable notice be open to inspection and subject to audit and/or reproduction during normal business working hours. COUNTY's representatives or agents shall have reasonable access to A-E's facilities, shall be allowed to interview all current or former employees to discuss matters pertinent to the performance of this Agreement and shall be provided adequate and appropriate workspace, including use of a copier, in order to conduct audits in compliance with this Article. The COUNTY or its designee may conduct such audits or inspections throughout the term of this Agreement and for a period of three (3) years after final payment or longer if required by law. COUNTY representatives or agents may (without limitation) conduct verifications such as verifying information and amounts through interviews and written confirmations with A-E employees, field and agency labor, subcontractors, and vendors.

A-E's records shall include any and all information, materials, data of every kind and character, including without limitation, records, books, papers, documents, notes, receipts, vouchers, drawings, and any and all other agreements, sources of information and matters that may in COUNTY'S judgment have any bearing on or pertain to any matters, rights, duties, or obligations under or covered by any contract document.

Such records shall include hard copy, as well as computer readable data, written policies and procedures, accounting records of time and expenditures, time sheets, payroll registers, payroll records, cancelled payroll checks, subcontract files, change order files, back charge logs, invoices, and any other A-E records which may have a bearing on matters of interest to the COUNTY in connection with the A-E's dealings with the COUNTY to the extent necessary to adequately permit an evaluation and verification of any or all of the following: (1) compliance with Agreement requirements; (2) compliance with COUNTY business ethics/conflict of interest expectations; (3) compliance with Agreement provisions regarding the pricing of change orders; (4) accuracy of A-E representations regarding pricing of invoices; (6) accuracy of A-E representations related to claims submitted by A-E or any A-E payees.

A-E represents and agrees that failure by A-E to maintain such records in compliance with this Article precludes A-E from maintaining any request or claim for compensation from or against COUNTY for any time periods for which such records were not kept, and constitutes a waiver by A-E of any such claim(s) against County for such time period(s).

A-E shall also include a clause in its agreements with subcontractors, and shall require subcontractors to include a clause in its agreements with sub-subcontractors which reserves the right for a COUNTY representative to audit any cost, payment or settlement resulting from any items set forth in this agreement, during the performance of this agreement and for a period of not less than three years after final payment is made or until all disputes, appeals, litigation or claims arising from this agreement have been resolved, whichever is later. This clause shall also require subcontractors to retain all

necessary records for a period of not less than three years after final payment is made or until all disputes, appeals, litigation or claims arising from this agreement have been resolved, whichever is later.

If an audit or examination in accordance with this Article discloses overpricing or overcharges (of any nature) by the A-E to the COUNTY in excess of one percent (1%) of the total contract billings, in addition to making adjustments for the overcharges, the A-E shall reimburse the reasonable actual cost of the COUNTY's audit to the COUNTY. Any adjustments and/or payments which must be made as a result of such audit or examination shall be made within a reasonable amount of time (not to exceed 90 days) from presentation of COUNTY's findings to A-E. Notwithstanding this requirement, the COUNTY may exercise its right to offset, as described in the Article titled Right to Offset of this Agreement, for collection of any reimbursements due to the COUNTY as provided for in this Article.

#### 26. ASSIGNMENT

A-E shall not assign any right, nor delegate any duty, under this Agreement, or any portion thereof, without the written consent of COUNTY. Any attempted assignment or delegation without COUNTY's prior written consent shall be void.

## 27. SOLE AND ONLY AGREEMENT

This Agreement constitutes the sole and only agreement between the parties hereto with respect to the services herein described, and correctly sets forth the obligations of each party. Any representations or agreements not specifically contained herein are null and void. Any amendments hereto shall be made in writing, effective only when signed by both parties.

# 28. NO ALTERATION OF AGREEMENT TERMS

A-E has no authority to alter, modify, amend, or change the terms of this Agreement or any agreement entered into with COUNTY or any agreement for any work to be performed on or relating to this Project, except as provided in the Article titled Changes in Scope of Services.

#### 29. NO WAIVER BY COUNTY

In the event the COUNTY does not insist upon strict performance by A-E or does not exercise any right or option herein conferred, such event shall not be deemed or construed as a waiver or a relinquishment to any extent of any right of COUNTY to insist on strict performance or to assert or rely upon any such terms or options on any future occasion.

#### 30. INDEMNITY

To the fullest extent permitted by law, the A-E shall defend, indemnify, and hold harmless the COUNTY, its officers and employees (collectively referred to as "indemnitees" or individually as "indemnitee") from and against any and all claims, lawsuits, orders, judgments, damages, penalties, fines, costs, liabilities, losses or actions of every kind and description arising out of, pertaining to, or relating to the negligence, recklessness, or willful misconduct of the A-E. In the event an indemnitee(s) is/are named as a defendant(s) in any such lawsuit, the A-E shall, at the request of the COUNTY, represent the indemnitee(s) with qualified counsel approved in writing by the COUNTY.

A-E's indemnity obligation shall not apply in the event of any loss, damage, or expense arising from the sole and /or active negligence or willful misconduct of the COUNTY or its agents, servants or independent contractors. If judgment is entered against A-E and the COUNTY by a court of competent jurisdiction because of the concurrent negligence of the COUNTY, its officers and employees, and the A-E, then the A-E and the COUNTY agree that such liability will be apportioned as determined by the trier of fact.

The rights and obligations set forth in this Article shall survive the termination or completion of this Agreement.

#### 31. PATENT INDEMNITY

The A-E shall indemnify and hold harmless the COUNTY, its agents, officers, and employees from and against any and all liability, including costs for infringement or dilution of any United States letters, patent, trademark, or any other intellectual property contained in the A-E's drawings and specifications or other documents that are created or provided under this Agreement.

#### 32. ERRORS AND OMISSIONS AND NEGLIGENT PERFORMANCE

In the event of errors or omissions, or negligent performance by the A-E in the performance of this Agreement which result in damages and costs to COUNTY greater than what would have resulted if there were no such errors or omissions or negligence, any additional damages and costs incurred by the COUNTY, including without limitation direct and consequential damages as a result thereof, shall be borne by the A-E. Any COUNTY payment to the A-E shall not be deemed or construed as acceptance or waiver by COUNTY of errors or omissions or negligence by the A-E.

#### 33. DELAY

#### A. Excuse

If A-E is delayed in performing any obligation under this Agreement by acts of civil or military authority, fires, floods, or earthquakes beyond the reasonable control of A-E, such delay shall be excused and the period of such delay shall be added to the time for performance of the obligation delayed.

#### **B.** Obligations

In the event any delay due to the foregoing causes or events set forth in this Article occurs or is anticipated, A-E shall promptly notify the COUNTY in writing of such delay or anticipated delay and the cause and estimated duration of such delay. In the event of any delay, whether such delay is excused or not, A-E shall exercise due diligence to shorten and avoid the delay and shall keep the COUNTY advised as to the continuance of the delay and steps taken to shorten or terminate the delay, and any costs associated therewith.

#### C. Partial Failure of Performance

Partial failure of performance due to any delay shall not terminate the Agreement or excuse a failure by A-E to resume performance of its obligations hereunder as promptly as possible upon termination of delay.

# D. Recovery Plan

Immediately upon learning of any event that may lead to a delay in the progress of the Scope of Services, A-E shall prepare a plan for recovery to the original Project Design Schedule, including any associated costs, impacts or related effects thereof. Upon receipt of such plan, COUNTY may direct A-E to execute the plan described, or a modification thereof.

#### 34. INSURANCE

Prior to the provision of services under this contract, the A-E agrees to purchase all required insurance at A-E's expense and to deposit with the County Certificates of Insurance, including all endorsements required herein, necessary to satisfy the County that the insurance provisions of this contract have been complied with and to keep such insurance coverage and the certificates therefore on deposit with the County during the entire term of this contract. The County reserves the right to request the declarations page showing all endorsements and a certified copy of the policy. In addition, all subcontractors performing work on behalf of A-E pursuant to this contract shall obtain insurance subject to the same terms and conditions as set forth herein for A-E.

A-E shall ensure that all subcontractors performing work on behalf of pursuant to this agreement shall be covered under A-E's insurance as an Additional Insured or maintain insurance subject to the same terms and conditions as set forth herein for A-E. A-E shall not allow subcontractors to work if subcontractors have less than the level of coverage

required by County from A-E under this agreement. It is the obligation of A-E to provide notice of the insurance requirements to every subcontractor and to receive proof of insurance prior to allowing any subcontractor to begin work. Such proof of insurance must be maintained by A-E through the entirety of this agreement for inspection by County representative(s) at any reasonable time.

All self-insured retentions (SIRs) or deductibles shall be clearly stated on the Certificate of Insurance. If no deductibles or SIRs apply, indicate this on the Certificate of Insurance with a zero (0) by the appropriate line of coverage. Any deductible or SIR in an amount in excess of \$25,000 (\$5,000 for Automobile Liability) shall specifically be approved by the County Executive Office (CEO)/Office of Risk Management upon review of A-E's current audited financial report. A-E shall be responsible for reimbursement of any deductible to the insurer.

If the A-E fails to maintain insurance acceptable to the County for the full term of this contract, the County may terminate this contract.

# **Qualified Insurer**

The policy or policies of insurance must be issued by an insurer with a minimum rating of A- (Secure A.M. Best's Rating) and VIII (Financial Size Category as determined by the most current edition of the Best's Key Rating Guide/Property-Casualty/United States or ambest.com). It is preferred, but not mandatory, that the insurer be licensed to do business in the state of California (California Admitted Carrier). If the insurance carrier does not have an A.M. Best rating of A-/VIII, the CEO/Office of Risk Management retains the right to approve or reject a carrier after a review of the company's performance and financial ratings. If the insurance carrier is not an admitted carrier in the state of California and does not have an A.M. Best rating of A-/VIII, the CEO/Office of Risk Management retains the right to approve or reject carrier after a review of the company's performance and financial ratings.

The policy or policies of insurance maintained by the A-E shall provide the minimum limits and coverage as set forth below:

#### Coverage

#### **Minimum Limits**

Commercial General Liability \$1,000,000 per occurrence \$2,000,000 aggregate

Automobile Liability including coverage for owned, non-owned and hired vehicles.

\$10,000,000 per occurrence for vehicles with access to the airfield; \$1,000,000 per occurrence for all other vehicles. Workers' Compensation Statutory

Employers' Liability Insurance \$1,000,000 per occurrence

Professional Liability Insurance \$1,000,000 per claims made or per occurrence

\$2,000,000 aggregate

# **Required Coverage Forms**

The Commercial General Liability coverage shall be written on Insurance Services Office (ISO) form CG 00 01, or a substitute form providing liability coverage as broad.

The Business Auto Liability coverage shall be written on ISO form CA 00 01, CA 00 05, CA 00 12, CA 00 20, or a substitute form providing liability coverage as broad.

## **Required Endorsements**

The Commercial General Liability policy shall contain the following endorsements, which shall accompany the Certificate of Insurance:

- 1) An Additional Insured endorsement using ISO form CG 2010 or CG 2033 or a form at least as broad naming the County of Orange, its elected and appointed officials, officers, employees, agents as Additional Insureds.
- 2) A Primary Non-Contributing endorsement evidencing that the A-E's insurance is primary and any insurance maintained by the County of Orange shall be excess and non-contributing.

The Workers' Compensation policy shall contain a waiver of subrogation endorsement waiving all rights of subrogation against the County of Orange, its elected and appointed officials, officers, employees and agents.

All insurance policies required by this contract shall waive all rights of subrogation against the County of Orange and members of the Board of Supervisors, its elected and appointed officials, officers, agents and employees when acting within the scope of their appointment or employment.

A-E shall notify County in writing within thirty (30) days of any policy cancellation and ten (10) days for non-payment of premium and provide a copy of the cancellation notice to County.

Failure to provide written notice of cancellation may constitute a material breach of the contract, upon which the County may suspend or terminate this Contract.

If A-E's Professional Liability policy is a "claims made" policy, A-E shall agree to maintain Professional Liability coverage for Two (2) years following completion of contract.

The Commercial General Liability policy shall contain a severability of interests clause (standard in the ISO CG 001 policy).

Insurance certificates should be forwarded to the agency/department address listed on the solicitation. If the A-E fails to provide the insurance certificates and endorsements within seven (7) days of notification by Project Manager or the agency/department Facilities Division, award may be made to the next qualified vendor.

County expressly retains the right to require A-E to increase or decrease insurance of any of the above insurance types throughout the term of this Contract. Any increase or decrease in insurance will be as deemed by County of Orange Risk Manager as appropriate to adequately protect County.

County shall notify A-E in writing of changes in the insurance requirements. If A-E does not deposit copies of acceptable certificates of insurance and endorsements with County incorporating such changes within thirty (30) days of receipt of such notice, this Contract may be in breach without further notice to Contractor, and County shall be entitled to all legal remedies.

The procuring of such required policy or policies of insurance shall not be construed to limit A-E's liability hereunder or to fulfill the indemnification provisions and requirements of this Contract, nor act in any way to reduce the policy coverage and limits available from the insurer.

# 35. ACCIDENTS

All known job site and other project-related accidents, injuries, and illnesses sustained by A-E's or subcontractors' employees who require medical attention (other than first aid), shall be orally reported to COUNTY at the time of the incident. Written reports, satisfactory in form and content to COUNTY shall be submitted by A-E promptly after each such incident.

#### 36. INDEPENDENT CONTRACTOR

A-E is an independent contractor. Nothing in this Agreement shall be deemed to make A-E, its subcontractors, or any of their respective officers, employees, representatives, or agents, the agents or employees of COUNTY. A-E shall have responsibility for and control over the details and means for performing the work provided that A-E is in compliance with the terms of the Agreement. Anything in this Agreement which may appear to give COUNTY the right to direct A-E as to the details of the performance of the work or to exercise a measure of control over A-E shall mean that A-E shall follow the desires of COUNTY only with respect to the results of the work.

#### 37. SAFETY PLAN

The A-E must prepare and submit to COUNTY a safety plan for review and comment prior to beginning services. This safety plan shall comply with all OSHA, COUNTY, and Federal Aviation Administration (FAA) services, safety, and health rules governing the conduct of its employees, agents, and subcontractors at and about the Project job site. A-E agrees that it shall ensure that its supervisory personnel, employees, agents, and subcontractors at the job site comply strictly with such rules.

COUNTY reserves the right, from time to time, to make recommendations to revise the safety plan and revise any safety rules therein. A-E shall comply fully with such rules as revised in accordance with the foregoing provisions.

#### 38. COMPLIANCE WITH LAWS

A-E shall comply with and give all notices required by all laws, ordinances, rules, regulations, and lawful orders of government authorities applicable to the A-E's performance of the Scope of Services and all other provisions of this Agreement. A-E shall promptly notify COUNTY in writing if A-E has reason to believe that any part of A-E's work is at variance with any law, ordinance, code, rule, or regulation of public authority. If the A-E or its subcontractors perform any work that is contrary to laws, statutes, ordinances, building codes, and rules and regulations applicable to the Project, the A-E shall assume full responsibility for such work and shall indemnify and hold COUNTY harmless for all costs, losses or damages attributable thereto.

If applicable, A-E is responsible for ensuring that all California Department of Industrial Relations (DIR) requirements are complied with for A-E and its subcontractors, including but not limited to ensuring state prevailing wage, licensing and registration requirements under the California Labor Code are complied with.

#### 39. BUSINESS ETHICS

A-E employees, agents, subcontractors, vendors (or their representatives) shall not make or cause to be made any cash payments, commissions, employment, gifts, entertainment, free travel, loans, free work, substantially discounted work, or any other considerations to (1) COUNTY representatives, employees, or their relatives, or (2) representatives of subcontractors, or material suppliers or any other individuals, organizations, or businesses receiving funds in connection with this project.

A-E employees (or their relatives), agents, or subcontractors shall not receive any cash payments, commissions, employment, gifts, entertainment, free travel, loans, free work, or substantially discounted work or any other considerations from representatives of subcontractors, or material suppliers or any other individuals, organizations, or businesses receiving funds in connection with this project.

A-E agrees to notify a designated COUNTY representative within 48 hours of any instance where the A-E becomes aware of a failure to comply with the provisions of this Article.

#### 40. NONDISCRIMINATION

#### A. Compliance with Regulations

The A-E shall comply with the regulations relative to nondiscrimination in Federally assisted programs of the Department of Transportation (hereinafter, "DOT") Title 49, Code of Federal Regulations, Part 21, as they may be amended from time to time (hereinafter referred to as the Regulations), which are incorporated herein by reference and made a part of this Agreement.

#### **B.** Nondiscrimination

The A-E, with regard to the services performed by it during the Agreement, shall not discriminate on the grounds of race, color, disability, or national origin in the selection and retention of subcontractors, including procurement of materials and leases of equipment. A-E shall not participate either directly or indirectly in the discrimination prohibited by Section 21.5 of the Regulations, including employment practices when the contract covers a program set forth in Appendix B of the Regulations.

# C. Solicitations for Subcontracts, Including Procurement of Materials and Equipment

In all solicitations, either by competitive bidding or negotiation, made by A-E for services to be performed under a subcontract, including procurement of materials or lease of equipment, each potential subcontractor or supplier shall be notified by A-E of A-E's obligations under this Agreement and the regulations relative to nondiscrimination on the grounds of race, color, disability, or national origin.

# D. Information and Reports

A-E shall provide all information and reports required by the regulations or directives issued pursuant thereto and shall permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the sponsor or the FAA to be pertinent to ascertain compliance with such regulations, orders and instructions.

Where any information required of A-E is in the exclusive possession of another who fails or refuses to furnish this information, A-E shall so certify to the sponsor or the FAA, as appropriate, and shall set forth what efforts it has made to obtain the information.

# **E. Sanctions for Noncompliance**

In the event of A-E's noncompliance with the nondiscrimination provisions of this contract, the COUNTY shall impose such contract sanctions as it or the FAA may determine to be appropriate, including but not limited to:

- 1) Withholding of payments to A-E under the Agreement until A-E complies, and/or
- 2) Termination or suspension of the Agreement, in whole or in part.

# F. Incorporation of Provisions

The A-E shall include the provisions of sub-articles A through E of this Article in all of its subcontracts and other agreements pertaining to the services under this Agreement, including procurement of materials and leases of equipment, unless exempt by the regulations or directives issued thereto. The A-E shall take such action with respect to any subcontract or procurement as the COUNTY or the FAA may direct as a means of enforcing such provisions, including sanctions for noncompliance. Provided, however, in the event A-E becomes involved in, or is threatened with, litigation with a subcontractor or supplier as a result of such direction, A-E may request the sponsor to enter into such litigation to protect the interests of the Sponsor and, in addition, A-E may request the United States to enter into such litigation to protect the interests of the United States.

#### 41. DISADVANTAGED BUSINESS ENTERPRISE (DBE)

- A. **Policy** It is the policy of John Wayne Airport, under the direction of its governing body, the Orange County Board of Supervisors, to promote the objectives of the Department of Transportation with respect to the participation of Disadvantaged Business Enterprises (DBEs) in DOT assisted contracts. This policy has been formulated to comply with 49 CFR Part 26. The objectives of the program are as follows:
  - (1) To ensure nondiscrimination in the award and administration of DOT-assisted contracts in the Department's highway, transit, and airport financial assistance programs;
  - (2) To create a level playing field on which DBEs can compete fairly for DOT-assisted contracts:
  - (3) To ensure that the Department's DBE program is narrowly tailored in accordance with applicable law;
  - (4) To ensure that only firms that fully meet this part's eligibility standards are permitted to participate as DBEs;

- (5) To help remove barriers to the participation of DBEs in DOT-assisted contracts;
- (6) To assist the development of firms that can compete successfully in the marketplace outside the DBE programs; and
- (7) To provide appropriate flexibility to recipients of Federal financial assistance in establishing and providing opportunities for DBEs.

John Wayne Airport has in the past, as a matter of both principle and law, established an Affirmative Action Program to ensure that no person is discriminated against on the grounds of race, color, national origin or sex in any program associated with the airport. John Wayne Airport administers a DBE program in compliance with 49 CFR Part 26 as an extension of its Affirmative Action Program.

The DBE program was developed to ensure that disadvantaged business enterprises receive a fair percentage and fair dollar volume of the DOT-assisted contractual business administered by the airport. All provisions of this regulation will be strictly adhered to as well as wholeheartedly endorsed and practiced by John Wayne Airport and its agents and employees. This policy statement has been circulated throughout the John Wayne Airport organization, in the local DBE community, and through dissemination to DBE publications and organizations.

- B. **DBE Goal** John Wayne Airport has not established a contract goal for the utilization of firms owned and controlled by socially and economically disadvantaged persons, but encourages participation by firms owned and controlled by socially and economically disadvantaged persons. John Wayne Airport has an overall goal of 9.6%.
- C. **Eligibility of DBEs** Any firm wishing to qualify as a DBE is invited to apply for certification from the California Unified Certification Program (CUCP). Information and instruction for applying for DBE certification may be found at <a href="https://www.californiaucp.org">www.californiaucp.org</a>
- D. **Requested Information** Firms who wish to include DBE participants are asked to submit the following information regarding intended participation by DBEs:
  - (1) The names and addresses of DBE firms that will participate in the contract;
  - (2) A description of the work that each DBE will perform.

This information should be submitted on the DBE Participation forms provided and attached as an Appendix to the SOQ, thereby not affecting the SOQ page count.

(DBE Participation Form found at the end of this Agreement)

#### 42. COUNTY OF ORANGE CHILD SUPPORT ENFORCEMENT

In order to enhance the child support collection efforts of the County of Orange Family Support Enforcement, A-E is required to provide the following information as listed on the attached form:

- If the A-E is an individual contractor: Name, date of birth, social security number, and residence address.
- If A-E is doing business in a form other than as an individual: Name, date of birth, social security number, and residence address of *each* individual who owns an interest of 10 percent or more in the contracting entity.

In addition, the A-E must provide:

- A certification that the A-E has fully complied with all applicable Federal and State reporting requirements regarding its employees, and
- A certification that the A-E has fully complied with all lawfully served Wage and Earnings Assignment Orders and Notices of Assignment and will continue to so comply.

Information provided shall be transmitted to the COUNTY's Child Support Office, which has been charged with the establishment and enforcement of child support orders. Copies shall not be retained by the requesting agency.

Failure of the A-E to submit the data and/or certifications required above or to comply with all Federal and State reporting requirements for child support enforcement or to comply with all lawfully served Wage and Earnings Assignment Orders and Notices of Assignment shall constitute a material breach of the contract. Failure to cure such breach within 60 calendar days of notice from the COUNTY shall constitute grounds for termination of this Agreement.

# 43. JWA INFORMATION TECHNOLOGY REQUIREMENTS

- A. The COUNTY shall provide connection to its Information Technology network in support of A-E's required access to JWA's Electronic Project Management System, Oracle Primavera Unifier (Unifier).
- B. The A-E shall submit to the COUNTY a JWA User Access Request Form within seven (7) days of the Contract Award Date. The JWA User Access Request Form is required for each employee requiring access to Project documentation, including, but not limited to correspondence, monthly reports, schedules, RFIs, daily reports, payment requests, deliverables/submittals, change documentation, plans and drawings, and all other communication.

- C. For each user, JWA will create a user ID with approved access rights and provide an initial password to the user in a secure manner. As remote users, the A-E's employees shall acknowledge and comply with JWA's Portal Usage Policy <u>as</u> herein provided.
- D. Such internet connection will allow the A-E secured access to JWA's Electronic Project Document Management System.
- E. The A-E shall utilize Unifier as the predominant means of communication with JWA and its representatives for all Project documentation.
- F. JWA Process for Gaining Access and Using Unifier and Other Allowable Information Technology Domains.
  - 1) Process for Gaining Access to JWA Systems.

A-E shall complete and submit the following forms to obtain equipment, software, and/or access to JWA systems:

- IT Usage Policy Acknowledgement
- User Access Request Form Non-County Employees

User shall fill out the User Information section, Sections 2, 3, 4 if applicable and then sign within Section 5. The User Access Request Form will not be processed without user's company manager's signature in Section 6. User then submits the form to the JWA Project Manager. The JWA Project Manager will then obtain the JWA Manager's signature in Section 6 to begin processing the request through JWA IT Section.

For Unifier access, new companies may take as long as a week to process; existing companies with new access requests should only require one to three business days to process. Once processed, the requestor will receive two separate e-mails from the JWA IT Section. The first will have the user's user name and the other will have the password, respectively. The first time the user logs on the web-based application user will be required to reset the password and configure settings.

#### 2) Help Desk.

If user experience any errors or have difficulties with any of the equipment/software, a request must be submitted to the Help Desk at (949) 852-4004. User will need to provide name, e-mail, phone number, location, and a brief description of the problem. Once the information is entered into the system, a call ticket will be created and sent to a JWA IT representative, who will contact user within one to three business days.

G. JWA will provide Unifier training upon receipt of the JWA User Access Request Form(s).

# 1) Unifier Training.

For Unifier training, A-E shall coordinate with the Project Manager to schedule a time and date.

User's account will be deactivated if user does not log on within a 30 day period. To reactive the account, user shall submit a help desk request for Unifier reactivation. Also, after 4 failed attempts to log on user will be locked out of Unifier. To unlock the account and re-set password the user must call in a help desk request.

2) Access to Unifier Document Manager.

If access is needed to a folder in Unifier Document Manager, A-E shall contact the Project Manager.

# **44. AIRPORT SECURITY** (When Required by JWA)

The A-E's personnel must complete a background clearance Security Identification Display Area (SIDA) class in order to obtain an I.D. badge and a driving permit for access to drive on the Airport Operations Area.

# A. Badge Acquisition:

Prior to issuance of a security badge(s), designated A-E personnel who will be working onsite at the JWA terminal or other secure areas and engaged in the performance of work under this Agreement must pass JWA's screening requirements, which include an F.B.I. background investigation and finger printing (the estimated fee is \$29.00 per person. A-E shall verify actual fees with JWA's badging office). All actual fees shall be borne by A-E. A-E's designated personnel are required to attend a 4-hour SIDA training class at JWA, and pass the written test (the estimated fee is \$8.00 per person.) The A-E shall be responsible for all costs associated with the background checks, and abide by all of the security requirements set forth by the FAA and JWA.

# B. Badge Holder Requirements and Responsibilities:

The FAA-approved security program for JWA requires that each person issued a JWA security badge be made aware of his/her responsibilities regarding the privilege of access to restricted areas of JWA.

All persons within the restricted air operation areas of JWA are required to display, on their person, a JWA security badge, unless they are specifically exempted for safety reasons or they are under escort by a properly badged individual. Each JWA employee, or JWA tenant employee who has been issued a JWA security badge is responsible for challenging any individual who is not properly displaying a JWA issued or approved and valid identification badge. Any person who is not properly displaying or who cannot produce a valid JWA security badge must immediately be referred to the Sheriff's Department - Airport Police Services Office for proper handling.

The JWA security badge is the property of the County of Orange and must be returned upon termination of A-E's personnel employment and/or termination or expiration of this Agreement at JWA. The loss of a badge shall be reported within 24 hours to the Sheriff's Department - Airport Police Services by calling (949) 252-5000. Individuals that lose their badge shall be required to pay a fee before receiving a replacement badge. The charge for lost badge replacement will be at the current posted rate located in the JWA Administration Office. A report shall be made before a replacement badge will be issued.

The JWA security badge is nontransferable.

In the event that an A-E's badge is not returned to JWA upon termination of A-E's personnel employment and/or termination or expiration of this Agreement, a fine of \$250.00 per badge will be charged to the A-E. A-E's final payment may be held by JWA or a deduction from the A-E's payment(s) may be made to ensure that funding is available to cover the fine in the event that badges are not returned.

#### 45. GOVERNING LAW AND VENUE

This Agreement has been negotiated and executed in the State of California and shall be governed by and construed under the laws of the State of California. In the event of any legal action to enforce or interpret this Agreement, the sole and exclusive venue shall be a court of competent jurisdiction located in Orange County, California, and the Parties hereto agree to and do hereby submit to the jurisdiction of such court, notwithstanding Code of Civil Procedure, Section 394.

The Parties specifically agree that by soliciting and entering into and performing Projects/Services under this Agreement, the A-E shall be deemed to constitute doing business within Orange County from the time of solicitation of work, through the period when all Projects/Services under this Agreement is completed, and continuing until the expiration of any applicable limitations period.

#### **46. ATTORNEY'S FEES**

In any action or proceeding to enforce or interpret any provision of this Agreement, or where any provision hereof is validly asserted as a defense, each party shall bear its own attorney's fees, costs and expenses.

#### 48. INTERPRETATION

Agreement has been negotiated at arm's length and between persons sophisticated and knowledgeable in the matters dealt with in this Agreement.

In addition, each Party has been represented by experienced and knowledgeable independent legal counsel of their own choosing, or has knowingly declined to seek such counsel despite having the opportunity to do so.

Each Party further acknowledges that they have not been influenced to any extent whatsoever in executing this Agreement by any other Party hereto or by any person representing them, or both.

Accordingly, any rule of law (including California Civil Code Section 1654) or legal decision that would require interpretation of any ambiguities in this Agreement against the Party that has drafted it is not applicable and is waived.

The provisions of this Agreement shall be interpreted in a reasonable manner to affect the purpose of the Parties and this Agreement.

## 49. SEVERABILITY

If any part of this Agreement is held, determined, or adjudicated to be illegal, void, or unenforceable by a court of competent jurisdiction, the remainder of this Agreement shall be given effect to the fullest extent reasonably possible.

#### **50. HEADINGS**

The various headings and numbers herein, the grouping of provisions of this Agreement into separate clauses and articles, and the organization hereof are for the purpose of convenience only and shall not limit or otherwise affect the meaning hereof.

- Using, transmitting, or seeking inappropriate or offensive materials, including but not limited to vulgar, profane, obscene, abusive, harassing, belligerent, threatening, or defamatory (harming another's reputation by lies) language or materials.
- Accessing, attempting to access, or encouraging others to access controversial or offensive materials.
- Revealing PII without permission, such as another's home address, telephone number, credit card number or Social Security Number.
- Making offensive or harassing statements or jokes about language, race, color, religion, national origin, veteran status, ancestry, disability, age, sex, or sexual orientation.
- Sending or soliciting sexually oriented messages, images, video or sound files.
- Visiting sites featuring pornography, terrorism, espionage, theft, drugs or other subjects that violate or encourage violation of the law.
- Gambling or engaging in any other activity in violation of local, state, or federal law.
- Uses or activities that violate the law or County policy or encourage others to violate the law or County policy. These include:

#### **APPENDIX 1**

## SCOPE OF SERVICES

#### PROJECT DESCRIPTION

A-E has been retained by John Wayne Airport (County) to provide Architect-Engineer Preliminary Engineering for the General Aviation (GA) Improvement Program at John Wayne Airport (JWA). JWA has begun the process of evaluating and planning for the future needs of the GA community through a comprehensive GA Improvement Program and has identified three preliminary planning options as follows:

• Preliminary Option 1: Two full service FBOs split (1 Eastside and 1 Westside)

and optimize other GA uses

• Preliminary Option 2: Both full service FBOs on Eastside and optimize other GA

uses

• Preliminary Option 3: Retain Existing FBO configuration, but with required FAA

modifications

The following program requirements shall be incorporated in the project:

- Comply with all applicable FAA Advisory Circulars, Part 77 Surfaces, and TERPS Surfaces
- Accommodate small piston engine GA aircraft at 3 year projected levels
- Accommodate current number of small piston engine GA aircraft hangars
- Two full-service FBO's
- Two limited service FBO's including, at a minimum, maintenance for small piston engine GA aircraft
- Accommodate flight schools

The A-E will review and analyze the three preliminary planning options as identified by the County and provide comments, recommended changes, or alternative improvements.

The A-E will assess all GA facilities; identify and inventory the GA building systems, determine the conditions of the facilities and their remaining useful life, and prepare comprehensive facility condition assessment report.

The A-E will perform GA forecasting and analysis; develop existing GA baseline, analyze historical GA trends, develop model and forecast including design GA aircraft and detailed report.

A-E and its sub-consultants will perform preliminary engineering design services related to GA Improvements, lay out geometry for the new GA buildings, hangars, tiedowns, shade structures, aprons, taxilanes, fuel farms, self-service fueling, ground transportation, aircraft washing facilities, transient aprons, and helicopter pads and facilities, etc.; develop preliminary schedule and design report including 35% conceptual plans, construction safety and phasing plan (CSPP), and construction estimate. Construction phasing options shall be developed, presented and discussed with County staff and stakeholders.

#### DETAILED BREAKDOWN FOR THE A-E SERVICES

The A-E services to be delivered to the County are described in following Tasks:

# Task 1 Project Management and Coordination (Lump Sum)

#### Task 1.1 Prepare and Maintain Project Work Plan (Lump Sum):

A-E will prepare and maintain a project work plan (PWP) and project design schedule. A-E will prepare the PWP within 10 working days of the NTP. The PWP will outline the various assignments and responsibilities of A-E, and describe the activities to be performed by the County. The PWP will include:

- i. Project Description
- ii. Client Information
- iii. Contract Information
- iv. Project Scope of Services
- v. Project Budget and Cost Schedule
- vi. Controlling Criteria and Special Project Conditions,
- vii. Technical Project Approach,
- viii. Project Quality Control and Quality Assurance Plan,
- ix. Delineation of Work Performance, A-E's (Prime) and Sub-Consultants' Roles, County's Roles, and Organization Chart,
- x. Project Schedule (MS Project)
- xi. Project Deliverable List
- xii. Methods of Communication and Documentation, and
- xiii. Project CADD Standards.
- xiv. Project Safety, Health & Environment

A-E will prepare and maintain a project design schedule which will be tracked, updated, and presented at each Project Manager's meeting and at other submittal milestones.

# Task 1.2 Airport Coordination / Programming / Meetings (Lump Sum)

This task shall include project coordination meetings, site visits and preparation of progress reports. The anticipated meetings are described in Table 1 below:

- i. Kick off Meeting and coordination with design team –A-E will participate in a "pre-design" meeting with the County. A-E will record meeting notes, prepare exhibits, and prepare and issue a summary of the session.
- ii. Coordination meetings with Stakeholders, ATCT and FAA LA ADO A-E will participate in meetings with the airport stakeholders, ATCT and FAA LA ADO. The main purpose is to reach a consensus regarding the, GA Improvement Program planning alternatives, facility condition assessments, GA forecasting/analysis and construction phasing. A-E will facilitate the meetings, record meeting notes, and prepare exhibits.
- iii. Design Team site visits –A-E will visit the site as needed for data collection. The team will include engineering staff, lead engineer /planner and project manager.
- iv. Preliminary Engineering coordination and weekly progress meetings –A-E will participate in the weekly progress meetings and review meeting of the 15% "over-the-shoulder" and 35% design submittal. A-E will facilitate the meetings, record meeting notes, and prepare exhibits.
- v. CSPP Development meetings A-E will participate in the construction safety and phasing plan engaging the ATCT representatives, ARFF, Police, and the FAA ADO representatives to participate in the development of the construction phasing alternatives. County will facilitate this meeting with A-E presenting construction options and phasing alternatives.
- vi. Construction Cost Estimate and Schedule development coordination meetings

   A-E will participate in meetings with the County to develop the construction cost estimate and construction schedule.
- vii. Monthly progress reports and invoice preparation A-E will prepare monthly progress reports and invoices. Progress reports and invoicing formats will reasonably conform to the County requirements.
- viii. Constructability review meetings Prior to completion of the County review of the 35% Plans and Estimate the A-E and County staff will participate in a joint review of constructability issues related to the Project. This task will be performed in a single-day meeting. Location to be determined. The A-E will provide a facilitator.
- ix. Sub-consultants Coordination The A-E's design team includes sub-consultants. The A-E will coordinate sub-consultant activities including management, invoicing, scheduling, etc.

- x. Coordination meetings with EIR team A-E will participate in meetings with the EIR team for preparation of EIR by the County's environmental consultant.
- xi. Coordination meetings with the County A-E will participate in meetings with the County project manager and other staff as needed. A-E will facilitate the meetings and record meeting notes.

# Task 1.3 Quality Control (Lump Sum)

A-E will perform on-going quality control (QC) review prior to the submittal of each deliverable. The project design schedule shall include QC review and correction periods. A-E will maintain a separate QC plan and file for this project. The County may audit A-E's quality control procedures.

# Task 2 Planning Review and Analysis (Lump Sum)

The goal of this task is to conduct a fatal flaw analysis of the County developed GAIP options to identify any missed opportunities and potential conflicts with FAA standards and/or operations. This is intended to be a high level review.

- i. A-E will participate in a conference call with the former Airport Architect and the County to understand the rationale and methodology used to develop the options.
- ii. A-E will review and analyze the GAIP the three options created by the County. Particular attention will be paid to the detailed versions of the options that have been provided by the County. A-E will review the operational functionality and physical layout of the options.

iii. The deliverable of this task will be a technical memorandum that provides observations, potential changes and/or improvements to the options prepared by the County.

# Task 3 Facility Condition Assessments (Lump Sum)

# Task 3.1 General Aviation Building System/Facility Condition Assessments (Lump Sum)

The Facility Condition Assessments task will include reviewing existing conditions, standardizing the assessment data to be included in the decision making process, coordination amongst all stakeholders, existing facility interviews and site visits that will ultimately be included in a Facility Condition Assessments Report (deliverable).

The General Aviation building system/facility condition assessments will be as follows:

- i. Obtain existing condition drawings existing condition drawings include but are not limited to CAD As-Built files (as available) for buildings, structures, hangars and other in the areas to be assessed. The available drawings will be categorized, scanned the hard copies filed and saved electronically.
- ii. Review existing condition drawings The A-E site assessment team will review the drawings prior to scheduling site visits and field assessments.
- iii. Coordinate input format for assessments The input data obtained in the Facility Condition Assessments will be consistent and includes the key information needed for JWA staff and the A-E to make recommendations for impacts to existing structures, leaseholds, etc. Set up standardized form for assessments A-E will develop a standard form to ultimately be included in the Facility Condition Assessments Report (deliverable).
- iv. Westside and eastside facility staff interviews The interviews will be conducted with existing Westside and Eastside facility stakeholders as well as JWA staff.
- v. Westside and eastside field assessments The A-E will conduct site visits and field assessments of the existing Westside and Eastside facilities. The assessment will include visual observations of the exterior and interior of approximately 50 facilities. Roofing inspection will not be included in the buildings/facilities assessment.
- vi. Review and QC interview and assessment data The raw interview and assessment data will be compiled, reviewed and checked for quality.
- vii. Compile draft report The A-E will compile interview and assessment data and prepare a draft report (deliverable). The assessment report will include evaluation of the facility criteria that may include size, age, general condition, location and usage.

- viii. QA/QC draft report The draft report will go through a quality assurance and quality control process. The draft report will then be send to JWA staff for review and comment.
- ix. Respond to JWA comments & submit final report The JWA staff comments will be reviewed and incorporated as needed. A final report will be issued.

# Task 3.2 Focused Obstruction Data Collection of GA Areas (Lump Sum)

As part of the Facility Condition Assessments work, a focused obstruction survey will be conducted to determine true top elevations of all facilities in the GAIP development areas. This can be used in conjunction with the Facility Condition Assessment to determine what facilities must be removed in order to comply with FAA airspace standards. A-E will work with a vendor to collect building outlines at the ground elevation and roof information, along with the top elevation locations of structures with elevation data to be collected from the aerial topographic survey. Deliverables will include a CADD file that contains all buildings within the GAIP development area.

#### Task 3.3 Aerial Topographic Survey (Lump Sum)

As part of the Facility Condition Assessments work, an aerial topographic survey of JWA will be performed using remote sensing technologies (aerial imagery). For JWA area, we will acquire new vertical stereo digital imagery at a physical image scale of approximately 1"=700" of defined area. Then, from the imager, we will produce the following:

- 1"=40' scale mapping with 1' contours of the existing airport property (approximately 547 acres).
- Color digital orthophotos with a 0.25' pixel resolution.

The A-E will set the necessary ground control points to collect the aerial and topographic mapping data. Deliverables will include an electronic digital file on CD/DVD that contains all buildings and features within the JWA area.

#### Task 4 General Aviation Forecasting and Analysis (Lump Sum)

The task will develop a defensible, market based, forecast of general aviation activity at John Wayne Airport. The forecast base year is 2015 with a horizon of 2040. Interim year forecasts will also be prepared for 6 and 11 years out (e.g. 2021 and 2026).

The forecast will be conducted in a regional context. That is, the assessment will evaluate potential demand for aviation services at the airport in the context of potential demand within the regional market, existing and future competition from other airports, and the airport's location and role within the regional system. A-E will participate in the

coordination meetings with stakeholders throughout the development of the GA forecasting and analysis.

# **Task 4.1 Define Historical Aviation Activity (Lump Sum)**

- i. Define Competitive Market Area (CMA) the CMA for general aviation will be defined and will potentially include Orange County and portions of southern Los Angeles County, Western Riverside and San Bernardino Counties, and Northern San Diego County.
- ii. Understand Historic CMA Market, including:
  - 1. Demand –General Aviation based aircraft by type, general aviation operations, including HeliStream operations at facilities adjacent to JWA.
  - 2. Supply Competing airports, roles and market share
  - 3. Market drivers demographic and socioeconomic factors, employment base, special generators, etc.
- iii. Review and evaluate existing CMA market drivers, aviation demand and airport forecasts.
- iv. Conduct inventories of CMA airports to determine opportunities and constraints to serving general aviation activity (runway capabilities, NAVAIDs, ATCT, FBOs, fueling, availability of maintenance, other) as well as anticipated plans to enhance or augment general aviation services and capabilities. These inventories will be completed through secondary source research and telephone calls as needed.
- v. A-E will conduct telephone surveys of JWA FBO's and selected FBOs at other airports to determine the services and facilities needed to support and encourage general aviation at the airport. Surveys will be conducted by telephone with follow-up meetings in person, if needed.
- vi. Conduct surveys of based aircraft owners at JWA. Owners of general aviation aircraft based at JWA will be surveyed using Survey Monkey (or similar web based survey site) to determine the services and facilities needed to support and encourage general aviation at the airport. A-E will develop the survey questionnaire for County review and input.
- vii. The County will be responsible for mailings to tenants and/or posting on the JWA website. A-E will develop content for the mailings and posters that can be disseminated to FBOs for posting in their terminal areas.

## Task 4.2 Forecasts of Aviation Activity (Lump Sum)

i. Forecast CMA aviation activity. General Aviation activity in the CMA will be forecast based on historic and forecast market drivers, with consideration of significant changes in the CMA that may alter historic relationships. The baseline forecast for the CMA will be developed using information from the

- FAA's current Terminal Area Forecast (TAF) for based aircraft. Operations data source include the TAF along with other potential data sources such as FAA Traffic Flow Management System (TFMS), Air Traffic Activity System (ATADS), and/or a flight tracking service provider (e.g. FlightAware).
- ii. FlightAware data source. In order to track General Aviation traffic that clears customs at a different point of entry than SNA an alternative source such as flight tracking service provider "FlightAware" will be utilized. Using criteria defined by A-E and the County, FlightAware will assemble data from various FAA flight data sources and provide origination, stop over location, duration of stopover, and aircraft. This data will then be used to help determine FIS sizing for General Aviation users.
- iii. Evaluate the competitive strengths and weaknesses offered by the airport under alternative roles and competitive scenarios, including the type and level of services, type and level of facilities, type, level and distribution of growth in the CMA, etc.
- iv. Forecast JWA potential capture of CMA activity under alternative roles and competitive scenarios. This will include three forecast scenarios: a baseline, high and low forecast.
- v. Translate forecast JWA GA demand levels into airport activity (based aircraft, operations, etc.), including:
  - 1. Based aircraft
    - a. By aircraft type
  - 2. Operations
    - a. Local
    - b. Transient
    - c. International
    - d. By aircraft type
  - 3. Peak hour operations and time of day
  - 4. Determine design aircrafts
  - 5. Business jet/corporate users
  - 6. Recreational users
  - 7. Helicopter
  - 8. GA Fuel Flow Forecasts

# Task 4.3 General Aviation Forecasting and Analysis Technical Report (Lump Sum)

Prepare Technical Report documenting the information, methodology, and processes used to develop the GA forecasts.

## Task 5 Preliminary Engineering Design Services (Lump Sum)

# Task 5.1 Planning (Lump Sum)

Planning tasks include the following:

# **Task 5.1.1 Opportunities and Constraints Analysis (Lump Sum)**

Define opportunities and constraints of the GAIP. The goal is to define the physical limits of the GAIP developable areas on both the east and west side of the airport that comply with all applicable FAA criteria. Specific tasks include:

- i. Review of airport design standards using FAA Advisory Circular 150/5300-13A, Airport Design, Change 1 (AC-13A). This includes identification of appropriate Runway Design Codes (RDCs) for the runways and Taxiway Design Groups (TDGs) for Taxiways A and B. Specific airport design elements, by category, are identified below.
  - a. Runway
    - Runway Safety Area (RSA)
    - Runway Obstacle Free Zone (ROFZ)
    - Runway Object Free Area (ROFA)
    - Inner Transitional Obstacle Free Zone (ITOFZ)
    - Runway Protection Zone (RPZ)
    - Navigational aid (NAVAID) critical areas
  - b. Taxiway
    - Taxiway Safety Area (TSA)
    - Taxiway Object Free Area (TOFA)
    - Taxiway wingtip clearance
  - c. Apron
    - Taxilane width
    - Taxilane Object Free Area (TOFA)
    - Taxilane wingtip clearance
    - Taxiway centerline to parallel taxilane centerline separation
    - Taxilane centerline to parallel taxilane centerline separation
  - d. Airport Traffic Control Tower (ATCT) line of sight. A theoretical line of sight will be constructed to analyze potential ATCT constraints. This does not include three dimensional modeling of existing conditions of the ATCT line of sight. Should this be required, additional three dimensional data, collected through Optional Task 10 would be required
- ii. Review of airspace limitations in the form of imaginary surfaces for the runways. This includes review of the following standards and surfaces. These surfaces will be constructed in three dimensions to facilitate review of future facility layouts.
  - a. Title 14 Code of Federal Regulations Part 77 (Part 77)

- Primary surface
- Approach surface
- Transitional surface
- b. One Engine Inoperative (OEI) obstruction identification surface as defined in FAA Advisory Circular 150/5300-13 Airport Design, Change 15. This surface only applies to Part 121 operations and therefore will only be analyzed for the departure end of Runway 20R.
- c. United States Standard for Terminal Instrument Procedures (TERPS) as defined in FAA Order 8260.3C. Approaches to Runway 2L and missed approaches to Runway 20R will be analyzed. Departure procedures for Runway 20L and 20R will be reviewed; however, it is assumed that the OEI will be the most critical departure surface.
- iii. An inventory of adjacent land uses will be made based on Google Earth imagery, County Land Use maps, and site investigations. Land uses, by parcels adjacent to the airport, will be identified along with current aviation uses within JWA property.
- iv. Airfield access points will be identified along with limitations of the access points based on design standards review described above.
- v. Vehicle access points will be documented.

The results of this task will be documented in a series of graphics and tables to as needed to define the various elements described above and will be used to develop an overall constraints map for the GAIP development area.

# **Task 5.1.2** Facility Requirements (Lump Sum)

Define facility requirements for the GAIP development area. The facility requirements will be developed from the forecasted aviation demand in the preceding task. The following elements will be defined in tabular form:

- i. Based aircraft hangar facilities by type (tie-downs, box, conventional, Thangars, and shade hangars).
- ii. Office/commercial/passenger processing/flight planning/support area (e.g. restrooms and mechanical room)/tenant space requirements
- iii. FIS space requirements and ramp area requirements
- iv. Fuel storage requirements for 100LL and Jet A.
- v. Hazmat material/chemical material storage spaces as required.

# Task 5.1.3 Helicopter Operating Area Requirements (Lump Sum)

Define helicopter operating requirements and based helicopter area for a potential consolidated helicopter operating area. This includes a review of baseline conditions including the number of current helicopter operators, operations and based helicopters. Current helicopter traffic patterns will be defined, inclusive of

HeliStream's traffic and interaction with JWA based helicopters. A-E will interview ATC to determine current challenges and confirm traffic patterns. Opportunities for new traffic patterns and integration of traffic patterns that would facilitate easier operations based on potential helicopter operating areas will be defined.

# **Task 5.1.4 Facility Layouts (Lump Sum)**

Development of detailed facility layouts within the GAIP development areas will be prepared. These will expand upon County developed options and provide additional detail that will be used by the design team to develop the 35% design documents. The detailed facility layouts will define helicopter operating area(s) along with fuel facility location(s).

- i. Location of FIS; centralized or at the FBOs.
- ii. The detailed facility layouts including floor plan layouts will be presented to the County for review and comment. A-E will incorporate County feedback.
- iii. Working with the County, A-E will present the detailed facility layouts to stakeholders for their review and comment. Stakeholder feedback will be vetted with the County and incorporated as appropriate.

# Task 5.1.5 LEED/Environmental Considerations (Lump Sum)

A-E will work with the County to define appropriate LEED certification goals (if any) for the GAIP along with general aesthetics guidelines. This will include development of sustainability goals for the GAIP and identification of potential areas where sustainable design can be implemented.

# Task 5.2 Pre-Design Studies and Data Collection (Lump Sum)

The goal of this task is to perform the following:

- i. Data collection including review of existing as-built (record) drawings, latest ALP, topographic survey, geotechnical and hazmat reports.
- ii. Perform site investigations of existing features and take photos of structures and facilities.
- iii. Identify utilities including power and communications point of connections serving the facilities, water and wastewater service and landscaping opportunities. The utilities will include power, water, fire water, gas, sewer, storm drain, fuel and communications. All utilities necessary for future improvements will also be identified.
- iv. Identify location of existing access gates and the proposed gates.
- v. Identify existing structures, hangars and facilities to be demolished.
- vi. Assess the condition of existing storm drain facilities and security fences.
- vii. Determine project type for WQMP and will identify permanent BMP opportunities.

viii. Prepare a base plan and composite utilities plan of the project

## Task 5.3 Preliminary Engineering Design (35%) for Option 1 (Lump Sum)

The goal of this task is to provide preliminary engineering design services at 35% design level for GA improvements including new FBOs on the East and West sides of the Airport. A-E will submit an interim submittal at 15% design level for the County's review. The Preliminary Engineering design tasks will include the following:

- i. Develop 35% conceptual plans to include:
  - 1. General plans
  - 2. Contractor's staging, Laydown and access Plan
  - 3. Construction phasing plans
  - 4. Demolition plans

# **Task 5.6 Construction Cost Estimates (Lump Sum)**

- i. **Option 1-** The A-E will prepare a preliminary estimate of the probable construction cost for site improvements, infrastructures and buildings. Sufficient cost contingency will be applied and delivered at 15% and 35% design level.
- ii. **Option 2 -** The A-E will prepare a preliminary estimate of the probable construction cost for site improvements, infrastructures and buildings. Sufficient cost contingency will be applied and delivered at 15% and 35% design level.
- iii. **Option 3 -** The A-E will prepare a preliminary estimate of the probable construction cost for site improvements, infrastructures and buildings. Sufficient cost contingency will be applied and delivered at 15% and 35% design level.

## Task 5.7 Construction Schedules (Lump Sum)

- i. **Option 1** The A-E will prepare a construction schedule for GA improvements shown in Option 1. The construction schedule will be prepared based on the project narratives information and using construction cost estimate and delivered at 15% and 35% submittal.
- ii. **Option 2** The A-E will prepare a construction schedule for GA improvements shown in Option 2. The construction schedule will be prepared based on the project narratives information and using construction cost estimate and delivered at 15% and 35% submittal.
- iii. **Option 3** The A-E will prepare a construction schedule for GA improvements shown in Option 3. The construction schedule will be prepared based on the project narratives information and using construction cost estimate and delivered at 15% and 35% submittal.

# Task 6 Request for Proposals Support (Time and Materials)

The goal of this task is to assist the County in providing the following engineering design support services:

- Prepare exhibits and documents supporting the requests for proposals
- Provide support services in evaluations of the proposals
- Review and provide comments on design submittals

Construction support services during construction of the facilities are not included in this task and will be provided by A-E, if requested by the County, as a part of the Optional Services Task 11.

# Task 7 Airfield Improvements Analysis and Design (Time and Materials)

The goal of this task is to provide the following planning and engineering design services:

- Detailed Airfield Standards Review
   This includes a focused review of the existing airfield to ensure conformance with current and potential future design standards including review of proper placement of landing thresholds, proper placement of hold lines, runway to parallel taxiway separation, and impacts of the current release of JO 7110.65W <u>Air Traffic Control</u>, Change 1 (effective date of May 26, 2016).
- ii. Conceptual plans and profiles

  Development of plans and profiles of potential airfield geometry that accommodates aircraft that may be using JWA in the future. This may include, but is not limited to alignment of the parallel Taxiways A and B.

# Task 8 Airport Layout Plan Update (Lump Sum)

A-E shall develop an updated Airport Layout Plan (ALP) drawing set (traditional paper drawings) in compliance with the FAA SOP 2.00 (see Appendix A) to reflect the GAIP. Input will be provided by FAA Los Angeles Airports District Office (LAX ADO) and County Staff.

The ALP drawing set shall include the following sheets as applicable to JWA. ALP drawings will be developed from new topographic mapping data collected in association

with Task 3.2 of this scope of work. All drawings will be American National Standards Institute (ANSI) E size sheets (34 inch x 44 inch) to increase legibility. Below is a summary of the drawing sheets and anticipated number of sheets required for each drawing (a total of 31 drawing sheets are anticipated). A-E will provide the County with applicable AutoCAD and Microstation files for the final version of the ALP at the completion of the project.

- Cover Sheet (1 sheet);
- Airport Data Sheet (1 sheet);
- Existing Airport Layout Plan Drawing (1 sheet);
- Future Airport Layout Plan Drawing (1 sheet);
- Airport Airspace Drawing (Part 77) (plan view 3 sheets, data tables 3 sheets);
- Inner Portion of the Approach Surface Drawing (plan and profile views 5 sheets, data tables 4 sheets);
- Runway Departure Surface Drawing (plan and profile views 2 sheets, data tables 2 sheets);
- Terminal Area Drawing (1 sheet);
- General Aviation Area Drawing (plan view 2 sheets, data table 1 sheet);
- Land Use Drawing (2 sheets); and
- Airport Property Map (2 sheets).

This task provides the detail for the applicable sheets that will be developed to produce the JWA ALP drawing set.

#### Task 8.1 Cover Sheet (Lump Sum)

This plan will be developed to serve as the cover sheet and provide a drawing sheet index, a location map and vicinity map, and listing of all applicable abbreviations used throughout the ALP drawing set.

# Task 8.2 Airport Data Sheet (Lump Sum)

This plan will be developed to include all required tables, including but not limited to: Airport Data Table, Runway Data Table, Taxiway Data Table, Wind Data Table, NAVAID Data Table, Modification to Standard Data Table (if applicable), Deviation from Standard Data Table (if applicable), and Declared Distance Table (if applicable). Additionally, wind rose information will be provided for All Weather and Instrument Flight Rule (IFR) scenarios.

# Task 8.3 Airport Layout Plan –Existing (Lump Sum)

This plan will be a large-scale drawing (anticipated scale of drawing will be one (1)-inch equals 300 feet horizontal), which will graphically present the existing layout of JWA.

#### Task 8.4 Airport Layout Plan –Future (Lump Sum)

This plan will be a large-scale drawing (anticipated scale of drawing will be one (1)-inch equals 300 feet horizontal), which will indicate the staging of various future improvements to be constructed at JWA and will graphically present the recommended GAIP.

# Task 8.5 Airport Airspace Drawing (Lump Sum)

This plan will present the Part 77 airspace surfaces in a large-scale graphic presenting all Part 77 imaginary surfaces based on planned development. If required, the Part 77 airspace surfaces will be superimposed over a base map of current USGS quad sheets at an appropriate scale for the planned sheet size. If current USGS quad sheets are unavailable, A-E will seek for a suitable substitute. Anticipated scale of drawing will be one (1)-inch equals 2,000 feet horizontal and one (1)-inch equals 100 feet vertical.

Data table of obstruction information will be provided using existing obstruction data and supplemented by information collected in Task 3.2. Tabular information will include obstruction type, elevation, penetration of Part 77 surfaces, and proposed action will be included and prepared by the A-E. Current disposition information will be presented to the County to solicit input on status. Once the County input has been provided, disposition information will be refined on the data tables.

## Task 8.6 Inner Portion of the Approach Surface Drawing (Lump Sum)

This plan will present for each runway end a plan and profile view of the inner portion of the Part 77 approach surface out to a point where the approach surface reaches a height that is approximately 100 feet above the runway end elevation. Anticipated scale of drawing will be one (1)-inch equals 200 feet horizontal and one (1)-inch equals 20 feet vertical.

Plan views will consist of in-part the various airport safety areas listed herein: runway protection zones (RPZs); runway safety areas (RSAs); runway object free areas (ROFAs); and runway obstacle free zones (ROFZs). Traverse ways crossing the approach surface will be identified based on available information as well as other objects within the approach area.

Profile views of the corresponding plan views will be prepared. Obstruction tables identifying obstructions, elevation, penetration of Part 77 surfaces and threshold siting surfaces (TSS), and proposed action will be included and prepared by the A-E. Surfaces that will not be included are the glideslope qualification surface (GQS) and United States Standards for Instrument Procedures (TERPS).

Additional sheets will depict the full length of the runway and include the RSA, runway elevations, and a line representing the five (5)-foot line of site.

Data table of obstruction information will be provided using existing obstruction data and supplemented by information collected in Task 3.2. Tabular information will include obstruction type, elevation, penetration of Part 77 surfaces, and proposed action will be included and prepared by the A-E. Current disposition information will be presented to the County to solicit input on status. Once the County input has been provided, disposition information will be refined on the data tables.

# Task 8.7 Runway Departure Surface Drawing (Lump Sum)

This plan will present the departure surfaces for each of the applicable hard surface runways that support commercial service operations and/or designated for instrument departures. The drawing will depict a 40:1 TERPS departure surface and the OEI 62.5:1 departure surface in plan and profile view and obstructions will be identified. Anticipated scale of drawing will be one (1)-inch equals 2,000 feet horizontal and one (1)-inch equals 100 feet vertical.

Data table of obstruction information will be provided using existing obstruction data and supplemented by information collected in Task 3.2. Tabular information will include obstruction type, elevation, penetration of Part 77 surfaces, and proposed action will be included and prepared by the A-E. Current disposition information will be presented to the County to solicit input on status. Once the County input has been provided, disposition information will be refined on the data tables.

# Task 8.8 Terminal Area Drawing (Lump Sum)

This plan will depict the airline terminal area and associated aprons in a small scale format to provide applicable detail as required by the FAA SOP 2.00 checklist.

Data table source information for each building will be provided by the County. The County will provide additional information as required to complete data table requirements.

# Task 8.9 General Aviation Area Drawing (Lump Sum)

This plan will depict the general aviation areas and associated aprons in a small scale format (anticipated scale of drawing will be one (1)-inch equals 100 feet horizontal) to provide applicable detail as required by the FAA SOP 2.00 checklist. It is anticipated that the general aviation areas will be split out on multiple pages in order to provide the detail required of this drawing.

Data table source information for each building will be provided by the County. The County will provide additional information as required to complete data table requirements.

# Task 8.10 Land Use Drawing (Lump Sum)

This plan will depict existing and proposed land uses within the Airport property boundary. Approximate scale of this drawing will be similar to the ALP (e.g. anticipated scale of drawing of one (1)-inch equals 300 feet horizontal). The County will provide an electronic version (preferably in ESRI (.shp) or AutoCAD (.dwg) file format) of the most current version of the noise contour line representing the 65 CNEL. Additional sheets may be developed to depict future land uses. Future land uses depicted will be those that have been provided by the County. No noise modeling will be conducted as part of this scope of services.

#### Task 8.11 Airport Property Map (Lump Sum)

This plan will depict an updated Airport property map that will be prepared in accordance with FAA guidelines. The property map will be updated based input provided by the. Anticipated scale of this drawing will be similar to the ALP.

Deliverables for this task are as follows:

- Draft ALP Drawing Set and Draft FAA SOP 2.00 checklist for County review.
- Resolve County comments and submit to FAA.
- Draft Final ALP Drawing Set and Draft Final FAA SOP 2.00 checklist for FAA review.
- Resolve FAA comments and re-submit to FAA.
- Final ALP Drawing Set and Final FAA SOP 2.00 checklist for FAA approval.

# **DELIVERABLES**

1. Design plans will be delivered in Microstation V8. CADD standards shall conform to the John Wayne Airport CADD Standards Manual that is current at the Notice to

Proceed. The County will provide a copy of the manual to A-E. Plans will be prepared in accordance with current FAA guidelines and Advisory Circulars.

Plans for the GA Facilities will be prepared in accordance with the current applicable building code requirements.

Plans will be prepared on 24"x36" sheets. The County will provide CADD files for the format of the title sheet and sheet title blocks to A-E.

## Task 9.1 Construction Documents (TBD)

This task will involve developing construction documents if the County decides to construct the County facilities using the conceptual design-bid-build process. The A-E will prepare the plans, specifications and construction estimates for the facilities to be constructed by the County. A more detailed scope will be defined in association with the County if requested. The facilities that may be constructed by a design-bid-build process will include the following:

- a. OCSD Hangar
- b. Flight School
- c. Self Service Fueling
- d. Tie-Down and Hangar
- e. Other Facilities

# Task 9.2 Bridging Documents (TBD)

This task will involve developing bridging documents if the County decides to solicit design-build teams to construct some of the GA facilities. The A-E will develop performance specifications along with the preliminary design drawings and assist the County in preparation of bidding documents in order to procure a design-build team. A more detailed scope will be defined in association with the County if requested. The facilities that may be constructed by a design-build team include the following:

- a. OCSD Hangar
- b. Flight School
- c. Self Service Fueling
- d. Tie-Down and Hangar
- e. Other Facilities

#### Task 10 Airport GIS data collection (TBD)

A-E will set control, collect imagery, and develop features for the airport in accordance with the Airports-GIS Advisory Circulars (150/5300-16A General Guidance and Specifications for Aeronautical Surveys: Establishment of Geodetic Control and Submission to the National Geodetic Survey, 150/5300-17C Standards for Using Remote Sensing Technologies in Airport Surveys, and 150/5300-18B General Guidance and Specifications for Submission of Aeronautical Surveys to NGS: Field Collection and Geographic Information System (GIS) Standards). Data to be collected will include safety critical and non-safety critical data. Should the County wish to exercise this option; a more detailed scope will be defined in association with the County including a detailed listing of features and attributes to be collected.

#### Task 11 Construction support services during construction of facilities (TBD)

A-E will provide construction support services during construction of the facilities. A more detailed scope will be developed in association with the County when the County decides the construction process of the facilities (using the design-bid-build or design-build process). The construction support services during Construction will be performed on a time and material basis and may include but not limited to the following:

- Site Visits to observe and monitor for contractor's work for its' general and quality conformity with the contract design requirements on an as-needed basis. Periodic Records of Site Visit reports will be issued where appropriate.
- Attend the scheduled weekly progress meetings with the County, its' agents and the
  contractor on an as-needed basis and as requested. It is assumed that the construction
  and progress meetings will be arranged, coordinated, recorded and distributed by
  others.
- Perform shop drawing and other submittal reviews transmitted from the County or its' agents (as designated), and transmitted directly back to the County or its' agents (as designated) within a maximum of 14 calendar days of receipt. Efforts to reduce the turnaround review time for each submittal will be made.
- Prepare and issue design Change Orders in the agreed format as required during the construction.
- Respond to requests for information (RFI) transmitted from the County or its' agents (as designated), and transmit directly back to the County or its' agents (as designated) within a maximum of 7 calendar days of receipt. Efforts to reduce the turnaround review time for each submittal will be made.
- Assist the County if requested, in the negotiations and settlement of claims or disputes related to design issues arising out of the Work.
- Prepare CADD project record drawings based upon contractor red line drawings.
