This AMENDMENT is made as of _____ day of _____, 20____
("AMENDMENT") by and among Wood Environment & Infrastructure Solutions, Inc. with an address of 6001 Rickenbacker Road, Los Angeles, CA 90040-3031 ("WOOD"), and the County of Orange, a political subdivision of the State of California, with an address of 300 North Flower Street, Santa Ana, California ("COUNTY"), sometimes individually referred to as ("PARTY") or collectively referred to as ("PARTIES").

WHEREAS, the COUNTY and Amec Foster Wheeler Environment & Infrastructure, Inc. with an address of 6001 Rickenbacker Road, Los Angeles, CA 90040-3031 ("AMEC") entered into CONTRACT MA-080-16011241 (herein referred to as "CONTRACT") for On-Call Architect-Engineer Construction Testing & Inspection Services-Asbestos & Lead Services, effective January 12, 2016 through January 11, 2019, in the amount of seventy-five thousand dollars (\$75,000); and

WHEREAS, the Parties executed Amendment #1 on January 17, 2017, to increase the CONTRACT maximum allowable compensation by \$425,000; for a new total amount of \$500,000; and

WHEREAS, John Wood Group PLC ("JWG") acquired AMEC's parent company Amec Foster Wheeler PLC and therefore AMEC became a subsidiary company of JWG; and

WHEREAS, AMEC subsequently changed their name to WOOD; and

WHEREAS, WOOD wishes to continue to provide services to COUNTY in accordance with the terms and conditions of the CONTRACT under its new name and ownership; and,

WHEREAS, COUNTY consents to WOOD's change in ownership and name change and consents to WOOD to continue to provide services to the COUNTY in accordance with the terms and conditions of the CONTRACT under its new name and ownership; and

WHEREAS, the PARTIES now desire to amend the CONTRACT to reflect the name change of AMEC to WOOD; and

NOW, THEREFORE, in consideration of the premises hereto and the mutual covenants and agreements herein set forth, the PARTIES agree as follows:

1. COUNTY consents to the change of ownership of WOOD, from and after April 16, 2018, (the "Effective Date").
2. COUNTY consents to the name change of WOOD in place and instead of AMEC, from and after April 16, 2018, (the "Effective Date").
3. The PARTIES agree to amend CONTRACT to reflect the name change of WOOD in place and instead of AMEC in all references; from and after April 16, 2018, (the "Effective Date").
