



**AMENDMENT NUMBER TWO
TO CONTRACT NUMBER MA-017-16010615
BETWEEN
CEO/HUMAN RESOURCE SERVICES
AND
VERITEXT CORP. DBA HAHN & BOWERSOCK
(FORMERLY KNOWN AS HAHN & BOWERSOCK, INC.)
FOR COURT REPORTER SERVICES**

This Agreement, hereinafter referred to as “Amendment” is made and entered into upon execution of all necessary signatures and approval by the Orange County Board of Supervisors, whichever occurs later, between the County Executive Office/Human Resource Services, hereinafter referred to as “County” and Veritext Corp. DBA Hahn & Bowersock (formerly known as Hahn & Bowersock, Inc.) with a place of business at 151 Kalmus Dr., Suite L-1, Costa Mesa, CA 92626, hereinafter referred to as “Contractor”, with County and Contractor sometimes individually referred to as “Party”, or collectively referred to as “Parties”.

RECITALS

WHEREAS, County and Contractor entered into Contract MA-017-16010615 for Court Reporter Services, commencing on October 20, 2015 and expiring on September 30, 2020, hereinafter referred to as “Contract” in the amount of \$25,000.00 per year; and

WHEREAS, the Parties issued Amendment Number One to amend Attachment B Payment/Compensation, and

WHEREAS, County desires to amend the Contract to reflect an assignment of the Contract from Hahn & Bowersock, Inc., to Veritext Corp. DBA Hahn & Bowersock to be effective April 26, 2016; and

NOW, THEREFORE, in consideration of the mutual obligations set forth herein, both County and Contractor agree as follows:

1. Amend the Contract to reflect an assignment from Hahn & Bowersock, Inc. to Veritext Corp. DBA Hahn & Bowersock, which occurred April 26, 2016.
2. All terms and conditions contained in this Amendment are incorporated by this reference into the Contract. This Amendment modifies the Contract only as expressly set forth above. This Amendment does not modify, alter or amend the Contract in any other way whatsoever.
