This AMENDMENT NUMBER FOUR to Contract number MA-060-14010447 (hereinafter "AMENDMENT NUMBER FOUR") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY") and Yorba Regional Animal Hospital and Pet Resort Inc., (hereinafter "CONTRACTOR") with a business address of 8290 E. Crystal Drive, Anaheim, CA 92807, is made and entered upon execution of all necessary signatures.

RECITALS

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Veterinary and Boarding Services for Police Canines on December 20, 2013 as Contract Number MA-060-14010447 (hereinafter "ORIGINAL CONTRACT"), for a one-year term of December 20, 2013 through and including December 19, 2014, renewable for four (4) additional one-year terms; and

WHEREAS, COUNTY and CONTRACTOR administratively amended the ORIGINAL CONTRACT on July 14, 2014 (hereinafter "AMENDMENT NUMBER ONE") to increase the Contract amount by \$5,000 for a new not to exceed amount of \$86,000, and added County of Orange/118 as an additional ordering location; and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on November 25, 2014 (hereinafter "AMENDMENT NUMBER TWO") as Contract Number MA-060-15010645 for a one (1) year term of December 20, 2014 through and including December 19, 2015 and added the Narcotics Division as an additional ordering location and increased the Contract amount by \$40,000.00 for a new not to exceed amount of \$126,000.00; and

WHEREAS, COUNTY and CONTRACTOR administratively amended the ORIGINAL CONTRACT on August 11, 2015 (hereinafter "AMENDMENT NUMBER THREE") to increase the Contract amount by \$9,000 for a new not to exceed amount of \$135,000 and \ added the Intake Release Center as an additional ordering location; and

WHEREAS, COUNTY and CONTRACTOR desire to renew the ORIGINAL CONTRACT as Contract Number MA-060-16010463 for a one (1) year term of December 20, 2015 through and including December 19, 2016 and the CONTRACTOR agrees to provide these goods/services at the rates set forth in the ORIGINAL CONTRACT; and

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. **ARTICLES**

a. Additional Terms & Conditions, Section Term of Contract, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 12/20/13 through and including 12/19/16, unless otherwise terminated by the COUNTY. The period of 12/20/13 through and including 12/19/14 shall be known as Contract Number MA-060-14010447. The period of 12/20/14 through and including 12/19/15 shall be known as Contract Number MA-060-15010645. The period of 12/20/15 through and including 12/19/16 shall be known as Contract Number MA-060-16010463. This Contract may be renewed for two (2) separate additional one-year terms by mutual agreement of both parties. The County is not under any obligation to provide Contractor with a

reason should it elect not to renew this Contract, nor is the County obligated to provide any prior notice to Contractor of its intent not to renew the Contract.

- 2. A true and correct copy of the ORIGINAL CONTRACT (Contract Number MA-060-14010447) is attached hereto as Exhibit A and incorporated by this reference.
- 3. A true and correct copy of AMENDMENT NUMBER ONE (Contract Number MA-060-14010447) is attached hereto as Exhibit B and incorporated by this reference.

- 6. All other provisions of the ORIGINAL CONTRACT and AMENDMENT NUMBERS' ONE through THREE, except as amended herein, remain in full force and effect.

This agreement, hereinafter referred to as "Contract" is made and entered into as of the date fully executed by and between. Yo be Regional Animal Hospital and Pet Resort Inc., with a place of business at 8290 E. Crystal Drive, Anaheim, CA 92807; hereinafter referred to as "Contractor," and the County of Orange, a political subdivision of the State of California, through its Sheriff-Coroner Department with a place of business at 320 N. Flower Street, 2rd Floor, Santa Ang., CA 92703, hereinafter referred to as "County," which may be referred individually as "Party" or collectively as "Parties."

RECITALS

WHIREAS, Contractor responded to County issued solicitation offering the complete Scope of Work as requested in Attachment A, and Contractor represents that its proposed goods and services shall meet or exceed County's requirements and specifications as set forth herein; and,

WHIREAS, County's Board of Supervisors has authorized the Purchasing Agent or his designee to enter into a Con ract for Veterinary and Boarding Services for Police Canines.

NIDW', THEREFORE, the Parties mutually agree as follows:

General Terros and Conditions:

- A. Governing Law and Venue: This Contract has been negotiated and executed in the state of California and shall be governed by and construed under the laws of the state of California. In the event of any legal action to enforce or interpret this Contract, the sole and exclusive venue shall be a court of competent jurisdiction located in Orange County, California, and the Parties hereto agree to and do hereby submit to the jurisdiction of such court, notwithstanding Code of Civil Procedure Section 394. Furthermore, the Parties specifically agree to waive any and all rights to request that an action be transferred for trial to another county.
- B. Extin: Contract: This Contract, including Attachments A, B, C, Exhibit 1 (Blank Child Support Enforcement Certification Requirements Form), and Exhibit 2 (Blank EDD Reporting Requirement Compliance Form), which have been incorporated, when accepted by the Contractor either in writing or by the shipment of any article or other commencement of performance hereunder, contains the entire contract between the Parties with respect to the matters herein and there are no restrictions, promises, warranties or undertakings other than those set forth herein or referred to herein. No exceptions, alternatives, substitutes or revisions are valid or sin ling on County unless authorized by County in writing. Electronic acceptance of any additional terms, conditions or supplemental contracts by any County employee or agent, including but not limited to installers of equipment, shall not be valid or binding on County unless accepted in writing by County's Purchasing Agent or his designee, hereinafter "Purchasing Agent".
- C. An endments: No alteration or variation of the terms of this Contract shall be valid unless made in writing and signed by the Parties; no oral understanding or agreement not incorporated herein shall be binding on citder of the Parties; and no exceptions, alternatives, substitutes or revisions are valid or binding on County unless authorized by County in writing.
- D. Taxies: Unless otherwise provided herein or by law, price quoted does not include California state sales or use tax
- E. Delivery: Time of delivery of goods or services is of the essence in this Contract. County reserves the right to refuse any goods or services and to cancel all or any part of the goods not conforming to applicable specifications, drawings, samples or description, or services that do not conform to the prescribed statement of vorc. Acceptance of any part of the order for goods shall not bind County to accept future shipments, nor deprive it of the right to return goods already accepted, at Contractor's expense. Over shipments and under shipments of goods shall be only as agreed to in writing by County. Delivery shall not be deemed to be con plete until all goods, or services, have actually been received and accepted in writing by County.

- F. Acceptance/Payment: Unless otherwise agreed to in writing by County, 1) acceptance shall not be deemed complete unless in writing and until all the goods/services have actually been received, inspected, and tested to the satisfaction of County, and 2) payment shall be made in arrears after satisfactory acceptance by the Courty and in accordance to Attachment C, Compensation and Pricing.
- G. Warranty: Contractor expressly warrants that the goods/services covered by this Contract are 1) free of liens of encumbrances, 2) merchantable and good for the ordinary purposes for which they are used, and 3) fit for the particular purpose for which they are intended. Acceptance of this order shall constitute an agreement up on Contractor's part to indemnify, defend and hold County and its indemnities as identified in paragraph "I" telow, harmless from liability, loss, damage and expense, including reasonable counsel fees, incurred or su stained by County by reason of the failure of the goods/services to conform to such warranties, faulty work performance, negligent or unlawful acts, and non-compliance with any applicable state or federal codes, or linences, orders, or statutes, including the Occupational Safety and Health Act (OSHA) and the California In Justrial Safety Act. Such remedies shall be in addition to any other remedies provided by law.
- H. Pt tent/Copyright Materials/Proprietary Infringement: Unless otherwise expressly provided in this Contract, Contractor shall be solely responsible for clearing the right to use any patented or copyrighted materials in the performance of this Contract. Contractor warrants that any Software as modified through se vices provided hereunder will not infringe upon or violate any patent, proprietary right, or trade secret right of any third party. Contractor agrees that, in accordance with the more specific requirement contained in paragraph "P" below, it shall indemnify, defend and hold County and County Indemnitees harmless from any and all such claims and be responsible for payment of all costs, damages, penalties and expenses related to or an sing from such claim(s), including, but not limited to, attorney's fees, costs and expenses.
- I. As signment or Sub-contracting: The terms, covenants, and conditions contained herein shall apply to and bind the heirs, successors, executors, administrators and assigns of the Parties. Furthermore, neither the performance of this Contract nor any portion thereof may be assigned or sub-contracted by Contractor without the express written consent of County. Any attempt by Contractor to assign or sub-contract the performance or any portion thereof of this Contract without the express written consent of County shall be invalid and shall constitute a breach of this Contract.
- J. Non-Discrimination: In the performance of this Contract, Contractor agrees that it will comply with the requirements of Section 1735 of the California Labor Code and not engage nor permit any subcontractors to engage in discrimination in employment of persons because of the race, religious creed, color, national origin, an early, physical disability, mental disability, medical condition, marital status, or sex of such persons. Centractor acknowledges that a violation of this provision shall subject Contractor to all the penalties it noted for a violation of anti-discrimination law or regulation, including but not limited to, Section 1720 et sea, of the California Labor Code.
- K. Termination: In addition to any other remedies or rights it may have by law, County has the right to terminate this Contract without penalty immediately with cause or after thirty (30) days' written notice without cause, unless otherwise specified. Cause shall be defined as any breach of Contract, any mi representation or fraud on the part of the Contractor. Exercise by County of its right to terminate the Contract shall relieve County of all further obligation.
- L. Constant to Breach Not Waiver: No term or provision of this Contract shall be deemed waived and no breach excused, unless such waiver or consent shall be in writing and signed by the Party claimed to have wa vel or consented. Any consent by any Party to, or waiver of, a breach by the other, whether express or implied, shall not constitute consent to, waiver of, or excuse for any other different or subsequent breach.
- M. Re ne lies Not Exclusive: The remedies for breach set forth in this Contract are cumulative as to one another and at to any other provided by law, rather than exclusive; and the expression of certain remedies in this Contract does not preclude resort by either Party to any other remedies provided by law.
- N. In ep:ndent Contractor: Contractor shall be considered an independent Contractor and neither Contractor, its employees nor anyone working under Contractor shall be considered an agent or an employee of County. Neither Contractor, its employees nor anyone working under Contractor, shall qualify for workers' cor pensation or other fringe benefits of any kind through County.

- O. Promance: Contractor shall perform all work under this Contract, taking necessary steps and precautions to perform the work to County's satisfaction. Contractor shall be responsible for the professional quality, to the ical assurance, timely completion, and coordination of all documentation and other goods/services firmished by Contractor under this Contract. Contractor shall perform all work diligently, carefully, and in a good and workman-like manner; shall furnish all labor, supervision, machinery, equipment, materials, and at pplies necessary therefore; shall at its sole expense obtain and maintain all permits and licenses required by pt bliz authorities, including those of County required in its governmental capacity, in connection with performance of the work; and, if permitted to subcontract, shall be fully responsible for all work performed by subcontractors.
- P. In demnification: Contractor agrees to indemnify, defend with counsel approved in writing by County, and held County, its elected and appointed officials, officers, employees, agents and those special districts and agencies which County's Board of Supervisors acts as the governing Board ("County Indemnitees"), harmless from any claims, demands or liability of any kind or nature, including but not limited to personal injury or property damage, arising from or related to the services, products or other performance provided by Contractor pursuant to this Contract. If judgment is entered against Contractor and County by a court of competent jurisdiction because of the concurrent active negligence of County or County Indemnitees, Contractor and County agree that liability will be apportioned as determined by the court. Neither Party shall request a jury apportionment.

IN SL RANCE PROVISIONS

Pr or to the provision of services under this Contract, the Contractor agrees to purchase all required insurance at Contractor's expense and to deposit with the County Certificates of Insurance, including all endorsements required herein, necessary to satisfy the County that the insurance provisions of this Contract have been compiled with and to keep such insurance coverage and the certificates therefore on deposit with the County during the entire term of this Contract. In addition, all subcontractors performing work on behalf of Contractor pursuant to this Contract shall obtain insurance subject to the same terms and conditions as set for the terein for Contractor.

Al self-insured retentions (SIRs) and deductibles shall be clearly stated on the Certificate of Insurance. If no SII ts or deductibles apply, indicate this on the Certificate of Insurance with a 0 by the appropriate line of coverage. Any self-insured retention (SIR) or deductible in an amount in excess of \$25,000 (\$5,000 for automobile liability), shall specifically be approved by the County Executive Office (CEO)/Office of Risk Minagement.

If the Contractor fails to maintain insurance acceptable to the County for the full term of this Contract, the County may terminate this contract.

Qu ali fled Insurer

Mi innum insurance company ratings as determined by the most current edition of the <u>Best's Key Rating</u> Gu idt/Property-Casualty/United States or ambest.com shall be A- (Secure A.M. Best's Rating) and VIII (Fi iancial Size Category).

The policy or policies of insurance must be issued by an insurer licensed to do business in the state of California (California Admitted Carrier). If the carrier is a non-admitted carrier in the state of California and does not meet or exceed an A.M. Best rating of A-/VIII, CEO/Office of Risk Management retains the right to approve or reject carrier after a review of the company's performance and financial ratings. If the non-admitted carrier meets or exceeds the mix imum A.M. Best rating of A-/VIII, the agency can accept the insurance.

Required Endorsements

The Commercial General Liability policy shall contain the following endorsements, which shall accompany the Certificate of insurance:

- A primary non-contributing endorsement evidencing that the Contractor's insurance is primary and any insurance or self-insurance maintained by the County of Orange shall be excess and noncontributing.

A. I insurance policies required by this Contract shall waive all rights of subrogation against the County of Orange and members of the Board of Supervisors, its elected and appointed officials, officers, agents and en uplayees when acting within the scope of their appointment or employment.

The 'Norkers' Compensation policy shall contain a waiver of subrogation endorsement waiving all rights of subrogation against the County of Orange, and members of the Board of Supervisors, its elected and appointed officials, officers, agents and employees.

A I insurance policies required by this Contract shall give the County of Orange 30 days notice in the event of cancallation and 10 days for non-payment of premium. This shall be evidenced by policy provisions or an er do sement separate from the Certificate of Insurance.

If Centractor's Professional Liability policy is a "claims made" policy, Contractor shall agree to maintain professional liability coverage for two years following completion of Contract.

The Commercial General Liability policy shall contain a severability of interests clause also known as a "s speration of insureds" clause (standard in the ISO CG 0001 policy).

In sur more certificates should be forwarded to the agency/department address listed on the solicitation.

If the Contractor fails to provide the insurance certificates and endorsements within seven days of notification by C:30/Purchasing or the agency/department purchasing division, award may be made to the next qualified vendor.

County expressly retains the right to require Contractor to increase or decrease insurance of any of the above in an increase throughout the term of this Contract. Any increase or decrease in insurance will be as deemed by County of Orange Risk Manager as appropriate to adequately protect County.

County shall notify Contractor in writing of changes in the insurance requirements. If Contractor does not deposit copies of acceptable certificates of insurance and endorsements with County incorporating such changes within thirty days of receipt of such notice, this Contract may be in breach without further notice to Contractor, and County shall be entitled to all legal remedies.

The procuring of such required policy or policies of insurance shall not be construed to limit Contractor's liability hereunder nor to fulfill the indemnification provisions and requirements of this Contract, nor act in any way to reduce the policy coverage and limits available from the insurer.

- Q. Bills and Liens: Contractor shall pay promptly all indebtedness for labor, materials, and equipment used in performance of the work. Contractor shall not permit any lien or charge to attach to the work or the premises, but it any does so attach. Contractor shall promptly procure its release and, in accordance with the requirements of paragraph "P" above, indemnify, defend, and hold County harmless and be responsible for payment of all costs, damages, penalties and expenses related to or arising from or related thereto.
- R. Changes: Contractor shall make no changes in the work or perform any additional work without County's specific written approval.
- S. Change of Ownership: Contractor agrees that if there is a change or transfer in ownership of Contractor's but incess prior to completion of this Contract, the new owners shall be required under terms of sale or other transfer to assume Contractor's duties and obligations contained in this Contract and complete them to the sat sfaction of County.
- T. Fo 'ce Majeure: Contractor shall not be assessed with liquidated damages or unsatisfactory performance per alt es during any delay beyond the time named for the performance of this Contract caused by any act of Go 1, 1/ar, civil disorder, employment strike or other cause beyond its reasonable control, provided Contractor giv as written notice of the cause of the delay to County within thirty-six (36) hours of the start of the delay and Contractor avails himself of any available remedies.
- U. Co is identiality: Contractor agrees to maintain the confidentiality of all County and County-related records and information pursuant to all statutory laws relating to privacy and confidentiality that currently exist or exist at any time during the term of this Contract. All such records and information shall be considered confidential and kept confidential by Contractor and Contractor's staff, agents and employees.
- V. Compliance with Laws: Contractor represents and warrants that services to be provided under this Contract shall fully comply, at Contractor's expense, with all standards, laws, statutes, restrictions, ordinances, requirements, and regulations (collectively "laws"), including, but not limited to those issued by County in its governmental capacity and all other laws applicable to the services at the time services are provided to and accepted by County. Contractor acknowledges that County is relying on Contractor to ensure such compliance, and pursuant to the requirements of paragraph "P" above, Contractor agrees that it shall defend, indimnify and hold County and County Indemnitees harmless from all liability, damages, costs, and expenses arising from or related to a violation of such laws.
- W. Freight (F.O.B. Destination): Contractor assumes full responsibility for all transportation, transportation scheduling, packing, handling, insurance, and other services associated with delivery of all products deemed necessary under this Contract.

- X. Pricing: The Contract price shall include full compensation for providing all required goods in accordance with required specifications, or services as specified herein or when applicable, in the Scope of Work attached to this Contract, and no additional compensation will be allowed therefore, unless otherwise provided for in the Contract.
- Y. Waiver of Jury Trial: To the extent enforceable under California law, each Party acknowledges that it is avant of and has had the opportunity to seek advise of counsel of its choice with respect to its rights to trial by jury, and each Party, for itself and its successors, creditors, and assigns, does hereby expressly and knowingly waive and release all such rights to trial by jury in any action, proceeding or counterclaim brought by any Party hereto against the other (and/or against its officers, directors, employees, agents, or subsidiary or affiliated entities) on or with regard to any matters whatsoever arising out of or in any way connected with this Contract and /or any other claim of injury or damage.
- Z. Terms and Conditions: Contractor acknowledges that it has read and agrees to all terms and conditions included in this Contract.
- AA. He adings: The various headings and numbers herein, the grouping of provisions of this Contract into separate cleuses and paragraphs, and the organization hereof are for the purpose of convenience only and shall not limit or otherwise affect the meaning hereof.
- BB. Severability: If any term, covenant, condition, or provision of this Contract is held by a court of competent jurisdiction to be invalid, void or unenforceable, the remainder of the provisions hereof shall remain in full force and effect and shall in no way be affected, impaired or invalidated thereby.
- Cc. Caler dar Days: Any reference to the word "day" or "days" herein shall mean calendar day or calendar days, respectively, unless otherwise expressly provided.
- DD. Attorney Fees: In any action or proceeding to enforce or interpret any provisions of this Contract, or where an / p ovisions hereof is validly asserted as a defense, each Party shall bear its own attorney's fees, costs and ex senses.
- EE. In expretation: This Contract has been negotiated at arm's length and between persons sophisticated and knowledgeable in the matters dealt with in this Contract. In addition, each Party has been represented by experienced and knowledgeable independent legal counsel of their own choosing or has knowingly declined to seek such counsel despite being encouraged and given the opportunity to do so. Each Party further act mowledges that they have not been influenced to any extent whatsoever in executing this Contract by any offer Party hereto or by any person representing them, or both. Accordingly, any rule or law (including California Civil Code Section 1654) or legal decision that would require interpretation of any ambiguities in this Contract against the Party that has drafted it is not applicable and is waived. The provisions of this Contract shall be interpreted in a reasonable manner to affect the purpose of the Parties and this Contract.
- FF. At thursty: The Parties to this Contract represent and warrant that this Contract has been duly authorized and executed and constitutes the legally binding obligation of their respective organization or entity, enforceable in accordance with its terms.
- GG. Exployee Eligibility Verification: Contractor warrants that it fully complies with all Federal and State statutes and regulations regarding the employment of aliens and others and that all its employees performing work under this Contract meet the citizenship or alien status requirement set forth in Federal statues and requireions. Contractor shall obtain, from all employees performing work hereunder, all verification and other documentation of employment eligibility status required by Federal or State statutes and regulations including, but not limited to, the Immigration Reform and Control Act of 1986, 8 U.S.C. §1324 et seq., as they currently exist and as they may be hereafter amended. 


