AMENDMENT NUMBER TWO THREE TO CONTRACT NUMBER MA-060-18010091 BETWEEN THE COUNTY OF ORANGE AND

SF MOBILE-VISION, INC. (FORMERLY KNOWN AS L-3 MOBILE-VISION, INC.)

This AMENDMENT NUMBER TWO THREE to CONTRACT Number MA-060-18010091 (hereinafter "AMENDMENT NUMBER TWO THREE") between the County of Orange, a political subdivision of the state of California, operating through its Sheriff's Department (hereinafter "COUNTY") and SF Mobile-Vision, Inc., formerly known as L-3 Mobile-Vision, Inc. (hereinafter "CONTRACTOR") with a place of business at 400 Commons Way, Suite F, Rockaway, NJ 07866-2030, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed Contract Number MA-060-18010091 on August 16, 2017 for the purchase of L-3 Mobile Vision Parts (hereinafter "ORIGINAL CONTRACT"), for a three (3) year term of August 16, 2017 through and including August 15, 2020, renewable for two (2) additional one-year terms;

WHEREAS, COUNTY and CONTRACTOR amended the ORIGINAL CONTRACT on April 17, 2018 as CONTRACTOR informed COUNTY that effective January 1, 2018, L-3 Communications Mobile-Vision Inc., had officially been renamed L3 Mobile-Vision Inc. but there had been no change in ownership (hereinafter "AMENDMENT NUMBER ONE"); and

WHEREAS, the Orange County Board of Supervisors, pursuant to Resolution No. 94-904 adopted August 2, 1994, has authorized the Purchasing Agent of the County of Orange to change the name of a vendor in a contract where there is only a name change and not a change of ownership;

WHEREAS, COUNTY and CONTRACTOR amended the ORIGINAL CONTRACT on May 7, 2019 as CONTRACTOR informed COUNTY that effective February 5, 2019, the majority of CONTRACTOR's stock was acquired by Safe Fleet, from Mobile Vision, and CONTRACTOR successfully changed its name to from L-3 Mobile Vision, Inc. to SF Mobile Vision, Inc., but there had been no change to the CONTRACTOR'S federal tax identification number, management or employees (hereinafter "AMENDMENT NUMBER TWO"); and

WHEREAS, COUNTY desires to amend the ORIGINAL CONTRACT and revise ATTACHMENT A, Scope of Work to add additional parts, and ATTACHMENT B, Compensation and Pricing Provisions to reflect the prices of the additional parts, and increase the Contract not to exceed amount by \$240,000 for a new Contract not to exceed amount of \$360,000,
