

FIRST AMENDMENT TO AGREEMENT

SIGN LANGUAGE INTERPRETATION SERVICES

THIS AMENDMENT, entered into this 1st day of December 2016, which date is particularized for reference purposes only, is to that certain AGREEMENT Number MHL0216, dated March 22, 2016, hereinafter referred to as the "Agreement," by and between the COUNTY OF ORANGE, hereinafter referred to as "COUNTY," and GOODWILL INDUSTRIES OF ORANGE COUNTY CALIFORNIA, a California non-profit corporation, qualified to transact interstate business in the State of California, hereinafter referred to as "CONTRACTOR." This Amendment shall be administered by the County of Orange Social Services Agency, hereinafter referred to as "ADMINISTRATOR."

WHEREAS, COUNTY desires to modify the terms of the Agreement to increase funds to the Agreement in order to provide services to additional clients; and

WHEREAS, CONTRACTOR agrees to such modification and to provide these services under the terms and conditions set forth in this Agreement;

1. Paragraph 18 of the Agreement is hereby amended to read as follows:

"18. PAYMENT

18.1 Maximum Contractual Obligation:

The maximum obligation of COUNTY under this Agreement shall not exceed the amount of ~~\$120,000~~ \$180,000: the amount of ~~\$40,000~~ \$60,000 for July 1, 2016 through June 30, 2017; the amount of ~~\$40,000~~ \$60,000 for July 1, 2017 through June 30, 2018; and the amount of ~~\$40,000~~ \$60,000 for July 1, 2018 through June 30, 2019, or actual allowable costs, whichever is less."
