RECITALS:

WHEREAS, on September 30, 2013 COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT as Contract Number MA-060-14010486 for a one (1) year term from October 22, 2013 through and including October 21, 2014 (hereinafter "AMENDMENT NUMBER TWO");

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on September 16, 2014 as Contract Number MA-060-14012135 for a one (1) year term and increased the total contract value of \$70,000.00 by \$7,000.00 for a new not to exceed amount of \$77,000.00 (hereinafter "AMENDMENT NUMBER THREE);

WHEREAS, COUNTY desires to increase the dollar amount of Contract Number MA-060-14012135 of \$77,000.00 by \$10,000.00 for a new not to exceed amount of \$87,000.00 for the term of October 22, 2014 through October 21, 2015; and

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-15012079 for a one (1) year term and to add Item # 22-0080-01, 108 Liter Dry Gas Tank (.082) C at \$149.00/each and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT and AMENDMENT **NUMBER ONE and this AMENDMENT NUMBER FOUR;**

WHEREAS, COUNTY and CONTRACTOR renewed the CONTRACT as Contract Number MA-060-15012079 in the amount of \$77,000 for a one (1) year term of October 22, 2015 through October 21, 2016 and to added Item # 22-0080-01, 108 Folder 625225

Liter Dry Gas Tank (.082) C at \$149.00/each (hereinafter "AMENDMENT NUMBER FOUR");

WHEREAS, COUNTY desires to increase the dollar amount of Contract Number MA-060-15012079 of \$77,000 by \$15,000 for a new not to exceed amount of \$92,000 as well as adding Southeast Operations and the City of San Clemente as ordering locations and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT, AMENDMENT NUMBER ONE and AMENDMENT NUMBER FOUR;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows;

1. ARTICLES

a. Original Contract, Additional Terms and Conditions, Section Term 2, is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 10/22/12 through and including 10/21/16, unless otherwise terminated by COUNTY. The period of 10/22/12 through and including 10/21/13 shall be known as Contract Number MA-060-13010460. The period of 10/22/13 through and including 10/21/14 shall be known as Contract Number MA-060-14010486. The period of 10/22/14 through and including 10/21/15 shall be known as Contract Number MA-060-14012135. The period of 10/22/15 through and including 10/21/16 shall be known as Contract Number MA-060-15012079. Contract may be renewed up to one (1) additional one (1) year terms upon mutual agreement of both parties. The County does not have to give reason if it elects not to renew.
