AMENDMENT NUMBER ONE TWO TO AGREEMENT MA-060-12010709 BETWEEN THE COUNTY OF ORANGE AND NEC CORPORATION OF AMERICA

This AMENDMENT NUMBER ONE TWO to Contract Number MA-060-12010709 (hereinafter "AMENDMENT NUMBER ONE TWO") between the County of Orange, a political subdivision of the state of California (hereinafter "COUNTY") and NEC Corporation of America (hereinafter "CONTRACTOR") with a place of business at 6535 North State Highway 161, Irving TX 75039, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed an Agreement for Automated Fingerprint Identification Systems (AFIS) Maintenance under Contract Number MA-060-12010709 (hereinafter "ORIGINAL AGREEMENT") for a one (1) year term of December 13, 2011 through and including December 12, 2012;

WHEREAS, COUNTY desires to add the maintenance for one (1) Global Workstation and to add the AFIS System Tuning/Record Removal as well as to increase the contract total value by \$49,187.44 for a new not to exceed amount of \$250,000.00 and to continue receiving services from CONTRACTOR for an additional one (1) year term and;

WHEREAS, COUNTY desires to modify payment terms from payment in advance to monthly in arrears and the CONTRACTOR agrees to provide those services at the rates set forth in ORIGINAL AGREEMENT and this AMENDMENT NUMBER ONE:

WHEREAS, COUNTY desires to extend the ORIGINAL AGREEMENT for one (1) additional year as well as increase the contract dollar amount by \$6,955.14 for a new not to exceed amount of \$212,955.14 and the CONTRACTOR has agreed to provide these services at the rates set forth in this AMENDMENT NUMBER TWO:

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

a. ATTACHMENT A, SCOPE OF WORK ORANGE COUNTY AFIS MAINTENANCE is amended in its entirety as follows:

ATTACHMENT A

SCOPE OF WORK ORANGE COUNTY AFIS MAINTENANCE

Overview

The Contractor is responsible for all maintenance and repairs including but not limited to the supply of all parts, labor, travel related cost, hardware and software support, on the Orange County Global Workstation and the Automated Fingerprint Identification System (AFIS) and its attached AFIS21 Workstations and Fingerprint Workstation Verification (FWV) terminals provided for under this Contract. The Contractor will maintain the equipment in good operating condition and shall be responsive to the maintenance and repair requirements of the County within the timeframes established herein.

A. Scope of Service

The Contractor shall provide all Maintenance and Repair services as described herein on all items identified for the Global Workstation and Central Site AFIS System, AFIS21 Workstations and each FWV Workstation.

The Orange County Automated Fingerprint Identification System (AFIS) is comprised of a Central Site System, (15) AFIS21 workstation terminals and (2) Fingerprint Workstation Terminals (FWV) which are made up of the following components. All will be supported and maintained under this Contract as delineated below.

The Central Site System is composed of and supports the following components:

- 4 FMP5 Matching units, 1 added in April, 2009
- 1 System Controller UP790 SC/MC Previously listed as Mainframe
- 3 Clarion Cabinets (RAID Disk)
- 1 NT-TC (Transaction Controller)
- 2 NT-IPC (Image Processing Controller
- 1 SAS Workstation System Administration Station
- 2 DLT Library Tape Units 1 Loaner from NEC
- 1 Master Console UP790 with Dot Matrix Printer

<u>Fingerprint Workstation Verification Terminals</u>—as identified in Section B and Exhibit I (Equipment List) and consist of the following components:

- 2 Workstation PC base units formally labeled as CPU's
- 2 Monitor, Keyboards, and mouse

AFIS21 Fingerprint Workstations (15) These workstations are at various locations as identified in Section B and Exhibit I (Equipment List) and encompass all of the following components:

- 15 Workstation PC base units formally labeled CPU's
- 15 Monitors, keyboards and Mouse

15 - Compact Scanner

1. Maintenance

- a. Contractor shall provide maintenance services and support on all Orange County Global Workstation and AFIS21 Central Site Equipment, including AFIS21 Workstations as well as FWV Workstations in order to maintain the AFIS Identification System, as described in section A, and detailed in Exhibit 1, in good working order. The Contractor shall maintain a maintenance and monitoring schedule based upon Contractor's and County's mutual understanding of the particular service required to keep the Orange County AFIS system in operational order. The Contractor will inspect and monitor the system on a weekly basis and provide needed remedial or preventative maintenance measures.
- b. Contractor shall provide 1st and 2nd level support only, which includes field support, escalation, and engineering support and bug fixes.
 - 1st Level Support = Remote Access and Onsite Hardware/Software Support by Site assigned Support Engineer or assigned Software Engineers.
 - 2nd Level Support = Remote Access Secondary Support to facilitate Engineering Support; break-fix repair, escalation and bug fixes of existing software.
- c. Engineering changes or development needed to update or add functionality will not be part of this Contract. Any changes in system configuration will require mutual agreement outside this Contract and will incur additional charges.

2. Repair

Contractor shall be responsible for all repairs, no exclusion, in accordance with the required response time set forth herein:

- a. Central Site: Contractor shall provide repair services to the central site (Orange County Sheriff's Department located at 320 N. Flower Street, Santa Ana, CA 92703 as referenced in Section B. 13.), 24 hours a day, seven (7) days a week, including County Holidays, with a response time of no more than four (4) hours, each incident. Contractor shall provide the County with a report of the initiation and resolution to the call for service. Monthly maintenance payment will be reduced by one percent for each day Contractor fails to perform to the standard described above.
- b. Remote Sites: Contractor shall provide repair services to the remote sites (City Police Departments as referenced in Section B. 1. through 12.), 8 hours a day, five (5) days a week, with a response time of no more than four (4) hours, each incident.

3. Spare Parts

- a. Contractor shall maintain a supply of spare parts for the AFIS Workstations and FWV Stations which inventory is based on the general maintenance history of the installed system.
- b. Costs for this parts supply inventory are included in the maintenance charges of this Agreement.
- e. Worn or defective parts shall be replaced at no additional charge to County.
- d. Replacement parts shall be either new parts or parts equivalent in performance to new parts when used with the AFIS Central Site System and its associated Workstations, as mutually agreed to by Contractor and County. Exception: Those devices which are no longer supported under this maintenance Contract and the responsibility of the County.

4. <u>Software Support</u>

- a. Contractor shall support all software licensed to County for use with the system.
- b. Software Support consists of identifying, verifying, reporting, and resolving problems associated with software licensed to County in order to maintain system performance at a level equal to the requirements established for the initial System Acceptance Test pursuant to the 1999 Centralized Purchase Order and as determined by the County.
- c. Contractor shall provide toll-free telephone, fax, e-mail, or remote system access support to the County. The County will provide remote access availability to Contractor.
- d. Contractor shall provide on site software support as needed to provide full operations and with the same response requirements requirements as described in 2a and 2b.
- e. The following matters are not covered by software support after the Contractor has run tests to ensure there are no compatibility issues with the software:
 - 1. Any problem resulting from the misuse, improper use, alteration, or damage of the Software by the County;
 - 2. Any problem caused by modifications in any version of the Software initiated by the County and not made or authorized by Contractor;
 - 3. Any problem resulting from programming other than the Software supplied by Contractor; or
 - 4. Any problem resulting from the combination of the Software with such other programming or systems to the extent such combination has not been approved by Contractor.

Software Updates

a. Due to the age of the AFIS System, Contractor will not provide periodic Software Updates, but will maintain current level of software in operational condition and provided bug fixes as needed through the life of this Contract. Software enhancements will not be provided as part of this Contract. All bug

- fixes installed by Contractor leave system fully operational and must be approved by County.
- b. For the Global Workstation, Contractor will provide all applicable hardware and software fixes, patches, upgrades, improvements to County when they become available.

System Tuning/Record Removal

- a. Due to the design limits of the system and to keep the system operational, it may become necessary to mitigate the risk of failure by removing records from the system and temporarily storing the removed records for reinsertion at a later time.
- b. At the request of County/OCCL management, Contractor shall provide reports with the requested record types and counts to facilitate decision making regarding the records to be removed.
- e. County/OCCL management will identify and approve the records to be removed and Contractor shall:
 - i. Schedule and execute an 'offline' database save
 - ii. Run an extraction and conversion program
 - iii. Verify the quality of the removed records
 - iv. Export the records for safekeeping by County
 - v. Remove the records from the AFIS21 system
 - vi. Update the AFIS21 database configuration to allow reuse of removed records space in database
 - vii. Test and tune the new configuration as needed for correct processing of new records
 - viii. Return the system to full operational status, demonstrating correct processing and registration of new records
 - ix. Provide a summary of events for County management

7. Site Backup of Data

a. All Central Site systems will need full back up twice annually by Contractor to tape. County is responsible for offsite storage of tapes. The County is responsible for determining times during normal business hours for these backups to occur, and provide the tapes for this use.

8. Additional Services Not Covered

- a. Maintenance services provided under this Agreement do not include:
 - 1. Electrical work external to the system;
 - 2. Furnishing expendable supplies or accessories such as Live Scan platens, toner cartridges, magnetic or digital tape, compact disks, or paper;
 - 3. Painting or refurbishing the system.
 - 4. AFIS System replacement under this Maintenance Contract in the event of a natural or man made disaster.


