WHEREAS, COUNTY and CONTRACTOR increased desires to increase the dollar amount of Contract Number MA-060-13010961 on February 10, 2015 for the term of April 1, 2014 through and including March 31, 2015 of \$19,500.00 by \$5,500.00 for a not to exceed amount of \$25,000.00 due to new methods; renewed ORIGINAL CONTRACT for a one (1) year term of April 1, 2015 through and including March 31, 2016 as Contract Number MA-060-15010935 and increased the total Contract value of \$25,000.00 by \$5,000.00 for a new not to exceed amount of \$30,000.00 (hereinafter "AMENDMENT NUMBER TWO"); and

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one (1) year term of April 1, 2015 through and including March 31, 2016 as Contract Number MA 060-15010935 as well as to increase the total Contract value of \$25,000.00 by \$5,000.00 for a new not to exceed amount of \$30,000.00;

WHEREAS, COUNTY desires to increase the dollar amount of Contract Number MA-060-15010935 for the term of April 1, 2015 through and including March 31, 2016 of \$30,000 by \$45,000 for a new not to exceed amount of \$75,000; and

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

 Attachment B – Pricing, of the ORIGINAL CONTRACT is amended in its entirety by revised Attachment B attached hereto as Exhibit D and incorporated by reference.

2. ARTICLES

a. Additional Terms and Conditions, Section 2, Term of Contract, is amended to read in its entirety as follows:

1. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 4/1/14 through and including 3/31/16, unless otherwise terminated by COUNTY. The period of 4/1/14 through and including 3/31/15 shall be known as Contract Number MA-060-13010961. The period of 4/1/15 through and including 3/31/16 shall be known as Contract Number MA-060-15010935. Contract may be renewed up to three (3) additional one (1) year terms upon mutual agreement of both parties. The County does not have to give reason if it elects not to renew.

b. Attachment B Pricing, of the ORIGINAL CONTRACT is amended to read as follows:

Contract shall not exceed \$25,000.00 for the term of April 1, 2014 through and including March 31, 2015.

Additionally, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree Contract Number MA-060-15010935, which is for the term of April 1, 2015 through and including March 31, 2016, shall be increased and amended as follows:
