AMENDMENT NUMBER FOUR TO CONTRACT NUMBER MA-012-16011609 WITH IGI'S LANDSCAPE SERVICES LLC FOR WEED ABATEMENT FUEL MODIFICATION SERVICES

This Amendment to Contract MA-012-16011609, herein referred to as "Amendment", is made and entered into upon execution of all necessary signatures between the County of Orange, OC Community Resources, OC Parks, a political subdivision of the State of California, hereinafter referred to as "County" and Igi's Landscape Services, LLC, with a place of business at 313 S Andres Place, Santa Ana, CA 92704-1120, hereinafter referred to as "Contractor", with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

RECITALS

WHEREAS, County and Contractor entered into Contract MA-012-16011609, hereinafter referred to as "Contract", for Weed Abatement and Fuel Modification Services, commencing on April 13, 2016 through and including April 12, 2017, in an amount not to exceed \$450,000.00; and

WHEREAS, Parties executed Amendment One to renew Contract for one additional year effective April 13, 2017 through and including April 12, 2018, in an amount not to exceed \$450,000.00; and

WHEREAS, Parties executed Amendment Two to renew Contract for one additional year effective April 13, 2018 through and including April 12, 2019, in an amount not to exceed \$450,000.00; and

WHEREAS, Parties executed Amendment Three to revise Contract terms and conditions and renew Contract for one additional year effective April 13, 2019 through and including April 12, 2020, in an amount not to exceed \$450,000.00; and

WHEREAS, County now desires to increase Contract amount; and

WHEREAS, County now desires to renew Contract for one additional year; and

NOW THEREFORE, in consideration of the mutual obligations set forth herein, the Parties mutually agree as follows:

- 1. Contract shall be increased by \$50,000.00 for the period of April 13, 2019 through April 12, 2020, for a new not to exceed amount of \$500.000.00.
- 2. Contract shall be renewed for its fifth-year term effective from April 13, 2020 through and including April 12, 2021, in an amount not to exceed \$600,000.00.
- 3. Except as otherwise expressly set forth herein, all terms and conditions contained in the Original Contract, including any amendments/modifications, are hereby incorporated herein by this reference as if fully set forth herein and shall remain in full force and effect.
