AMENDMENT NO. 2 For UNARMED SECURITY GUARD SERVICES

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County"), Orange County Flood Control District, a body corporate and politic ("District"), and The Alpha & Omega Group Security Services Inc with a place of business at 11400 W. Olympic Blvd., F12, Los Angeles, CA 90064-1579 ("Contractor"), with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

RECITALS

WHEREAS, County of Orange, County Procurement Office, ("CPO") has issued a Regional Cooperative Agreement MA-017-20010010, for Unarmed Security Guard Services ("RCA"), now in effect; and,

WHEREAS, County and Contractor entered into Subordinate Contract MA-080-21011126, per the terms and conditions of RCA, effective June 4, 2021, through March 31, 2023, in the amount of \$1,200,000.00 ("Contract"); and,

WHEREAS, the Parties executed Amendment No. 1 to include the Orange County Flood Control District as a party to this Contract, renew Contract for 1 year affective April 1, 2023 through March 31, 2024, with a Not to Exceed of \$670,000.00, and amend Article 7 and Attachment C; and

WHEREAS, the Parties now desire to renew the Contract for 1 year effective April 1, 2024 through March 31, 2025, with a Not-To-Exceed Limit of \$470,000.00; and,

NOW THEREFORE, the Parties agree as follows:

AMENDMENT TO CONTRACT ARTICLES

1. Article 2 "Term" of the Contract shall be amended to include the following:

Contract shall be renewed for (1) year, effective April 1, 2024, through March 31, 2025, unless otherwise terminated as provided herein.

2. Article 5, "Not-to-Exceed Limit", shall be amended to include the following:

The total amount of this Subordinate Contract for the second renewal term shall not exceed \$470,000. The County shall have no obligation to pay any sum in excess of this amount unless authorized by written amendment signed by the Parties.

3. All other terms and conditions in this Contract shall remain unchanged and with full force and effect.
