AMENDMENT NO. 1 FOR HVAC EQUIPMENT AND DUCT CLEANING SERVICES

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County") and The Machado Environmental Corporation dba Air Duct Cleaning Company, with a place of business at 2219 Broadview Drive, Glendale CA, 91208 ("Contractor"), with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

RECITALS

WHEREAS, County and Contractor entered into Contract MA-080-20010375 for HVAC Equipment and Duct Cleaning Services, effective January 28, 2020 through January 27, 2023, in the Total Contract Aggregate Amount of \$3,000,000, ("Contract"); and,

WHEREAS, the Parties now desire to renew the Contract for one (1) year effective January 28, 2023 through January 27, 2024, with a new Total Contract Aggregate Amount of \$500,000; and,

NOW THEREFORE, the Parties agree as follows:

AMENDMENT TO CONTRACT ARTICLES

1. Article 2 of the Contract shall be amended to include:

Contract shall be renewed for one (1) year from January 28, 2023, to January 27, 2024, unless otherwise terminated as provided herein.

2. Article 4 of the Contract shall be amended to include:

For renewal term starting January 28, 2023, the Total Aggregate Contract Amount shall not exceed \$500,000.

- 3. "B. TOTAL AGGREGATE CONTRACT AMOUNT NOT TO EXCEED" in Attachment B, Section 2 "Fees and Charges" shall be amended to read in its entirety as follows:
- 4. All other terms and conditions in this Contract shall remain unchanged and with full force and effect.
