## AMENDMENT NUMBER TWO (2) TO CONTRACT NUMBER MA-012-19010782 WITH GREENTECH LANDSCAPE, INC. FOR LANDSCAPE MAINTENANCE SERVICES FOR O'NEILL REGIONAL, WHITING RANCH MCFADDEN HOUSE, AND SADDLEBACK GATEWAY PARKS

This Amendment to Contract MA-012-190108782 ("Amendment") is made and entered into upon execution of all necessary signatures between the County of Orange, OC Community Resources, OC Parks ("County"), a political subdivision of the State of California, and Greentech Landscape, Inc. **NOW THEREFORE,** in consideration of the mutual obligations set forth herein, Parties mutually agree as follows:

- 1. Contract shall be renewed for its fifth-year term effective from March 1, 2023 through February 28, 2024, in an amount not to exceed \$212,001.00 annually.
