AMENDMENT NUMBER TWO THREE TO CONTRACT MA-060-20011565 BETWEEN THE COUNTY OF ORANGE AND TRUTH BE TOLD POLYGRAPH LLC

This AMENDMENT NUMBER TWO THREE to Contract Number MA-060-20011565 (hereinafter "AMENDMENT NUMBER TWO THREE") between the County of Orange, a political subdivision of the State of California, operating through its Sheriff's Department (hereinafter "COUNTY") and Truth Be Told Polygraph LLC, (hereinafter "CONTRACTOR") with a place of business at 407 W. Imperial Hwy., Suite H-213, Brea, CA 92821, is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and CONTRACTOR executed a Contract for Polygraph Testing Services on May 5, 2020, for a two (2) year term of May 5, 2020 through and including May 4, 2022, in a not to exceed amount of \$420,000, renewable for three (3) additional one-year terms upon mutual agreement of both parties (hereinafter "ORIGINAL CONTRACT"); and

WHEREAS, COUNTY and CONTRACTOR renewed the ORIGINAL CONTRACT on March **§ 15**, 2022, for a one year term of May 5, 2022 through and including May 4, 2023 in a not to exceed amount of \$210,000 (hereinafter "AMENDMENT NUMBER ONE");

WHEREAS, COUNTY desires to and CONTRACTOR renewed the ORIGINAL CONTRACT on April 4, 2023 for a one year term of May 5, 2023 through and including May 4, 2024 in a not to exceed amount of \$210,000 and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT (hereinafter "AMENDMENT NUMBER TWO");

WHEREAS, COUNTY desires to amend the ORIGINAL CONTRACT to increase the rate/price for Polygraph Exams from \$195 to \$225, effective upon approval; and

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for a one year term of May 5, 2024 through and including May 4, 2025 in a not to exceed amount of \$210,000 and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in this AMENDMENT NUMBER THREE;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

- a. Additional Terms and Conditions, Section 2, Term of Contract, of the ORIGINAL CONTRACT is amended to read in its entirety as follows:
 - 2. Term of Contract:

MA-060-20011565 Polygraph Testing Services This Contract shall commence upon execution of all necessary signatures, and continue in effect from 5/5/2020 through and including 5/4/20245, unless otherwise terminated by COUNTY.

- b. Additional Terms and Conditions, Section 3 Renewal, of the ORIGINAL CONTRACT is amended in its entirety as follows:
 - 3. Renewal:

This Contract may not be renewed by mutual written agreement of both Parties for one (1) additional one-year term. The County does not have to give a reason if it elects not to renew. Renewal periods may be subject to approval by the County of Orange Boar of Supervisors.

- c. Attachment B, Compensation and Pricing Provisions, Section 2. Fees and Charges of the ORIGINAL CONTRACT is amended in its entirety as follows:
 - 2. Fees and Charges: County will pay the following fees in accordance with the provisions of this Contract. Payment shall be as follows:
 - 1. Compensatory fee rate listed below shall include all services, furnishings, all staffing and materials required to perform duties and for any reasonably unforeseen difficulties, which may arise or be encountered in the performance of the services.
 - 2. Contractor shall provide a fixed fee rate for applicants who fail to appear "No Shows", regardless of cause to their scheduled polygraph examination and without invoking a timely notice of cancellation.
 - 3. Contractor shall be paid for the actual polygraph examinations performed to the satisfaction of the County and documented instances of no shows without invoking timely cancellation. No payment above the stated rates will be authorized.
 - 4. "Approximate usage" is not the number of Polygraph exams that will be required but rather an estimated amount of the number of Polygraph examinations completed in the past year.
