

AMENDMENT NUMBER ONE

AGREEMENT MA-060-19011528
BETWEEN THE
COUNTY OF ORANGE
AND
PRAESES LLC

This AMENDMENT NUMBER ONE to agreement Number MA-060-19011528 (hereinafter "AMENDMENT NUMBER ONE") between the County of Orange, a political subdivision of the State of California (hereinafter "COUNTY"), and Praeses LLC ("CONTRACTOR") with a place of business at 330 Marshall St., Suite 800, Shreveport, LA 71101 is made and entered upon execution of all necessary signatures.

RECITALS:

WHEREAS, COUNTY and Praeses LLC executed a Contract for Consultant Services for Inmate Telephone System on April 23, 2019, as Contract Number MA-060-19011528 (hereinafter "ORIGINAL CONTRACT") for a one (1) year term of April 23, 2019 through and including April 22, 2020, renewable for four (4) additional one-year terms upon mutual agreement of both parties; and

WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT as Contract Number MA-060-20010904 for a one (1) year term of April 23, 2020 through and including April 22, 2021 and the CONTRACTOR has agreed to provide these services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:

1. ARTICLES

a. Additional Terms and Conditions, Section 2, Term of Contract of the ORIGINAL CONTRACT is amended to read in its entirety as follows:

2. Term of Contract:

This Contract shall commence upon execution of all necessary signatures, and continue in effect from 4/23/19 through and including 4/22/21, unless otherwise terminated by COUNTY. The 4/23/19 through and including 4/22/20 shall be known as Contract Number MA-060-19011528. The period of 4/23/20 through and including 4/22/21 shall be known as Contract Number MA-060-20010904. This Contract may be renewed for three (3) additional one-year terms by mutual written agreement of both Parties. The County does not have to give a reason if it elects not to renew.

3. A true and correct copy of the ORIGINAL CONTRACT (Contract Number MA-060-19011528) is attached hereto as Exhibit A and incorporated by this reference.
4. All other provisions of the ORIGINAL CONTRACT, except as amended herein and to the extent they are not inconsistent with this AMENDMENT NUMBER ONE, remain in full force and effect.

In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signature to bind the company.
