

AMENDMENT NO. 2
TO CONTRACT MA-080-19010564
FOR
A-E DESIGN & ENVIRONMENTAL SERVICES FOR BRIDGE NO. 55C0177 IN SILVERADO
CANYON

This Amendment is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("COUNTY"), and Dokken Engineering, Inc., ("A-E"), with County and A-E sometimes individually referred to as "Party" or collectively referred to as "Parties."

RECITALS

WHEREAS, the COUNTY and A-E entered into Contract MA-080-19010564 for A-E Design & Environmental Services for Bridge No. 55C0177 in Silverdo Canyon, effective June 25, 2019 through June 24, 2024, in an amount not-to-exceed \$360,000; and

WHEREAS, Pursuant to Amendment No. 1, the Parties amended the Contract to increase the Total Contract not-to-exceed amount to \$390,455; and

WHEREAS, the Parties now desire to extend the term of the contract for a period of two additional years, effective June 25, 2024 through June 24, 2026; and

NOW, THEREFORE, the Parties agree as follows:

ARTICLES

1. Article 1.4.1 shall be amended to read as follows:

This CONTRACT shall go into effect upon Board approval and A-E shall commence work after notification to proceed by COUNTY'S Contract Administrator. The CONTRACT shall end after the sixth year, unless extended by contract amendment.

The term of this CONTRACT shall be effective June 25, 2019 through June 24, 2026, commencing upon execution of all necessary signatures.

2. All other terms and conditions of the Contract shall remain unchanged and with full force and effect.
