**AMENDMENT NO. 1

This AMENDMENT is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California ("County"), Orange County Flood Control District, a body corporate and politic, ("District"), and J. Orozco Enterprises Inc. DBA Orozco Landscape and Tree Company, with a place of business at 1419 S. East End Ave., Pomona CA 91766 ("Contractor"), with County, District and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

**RECITALS**

WHEREAS, County, District and Contractor entered into Contract MA-080-21011342 for Channel Cleaning Services, effective June 10, 2021 through June 9, 2024, in the Total Contract Not-to-Exceed Aggregate Amount of \$3,000,000.00, ("Contract"); and,

WHEREAS, the Parties now desire to include the Orange County Flood Control District as a party to this Contract; and,

WHEREAS, the Parties now desire renew the Contract for one (1) additional year effective June 10, 2024 through June 9, 2025, with a Total Contract Not-to-Exceed Amount of \$1,000,000.00; and

NOW THEREFORE, the Parties agree as follows:

**AMENDMENT TO CONTRACT ARTICLES**

1. The preamble of Contract MA-080-21011342 for Channel Cleaning Services shall be amended to include Orange County Flood Control District, a body corporate and politic, ("District") as a Party and shall read in its entirety as follows:

THIS Contract MA-080-21011342 for Channel Cleaning Services ("Contract") is made and entered into as of the date fully executed by and between the County of Orange, a political subdivision of the State of California, ("County") Orange County Flood Control District, a body corporate and politic, ("District"), and J. Orozco Enterprises Inc. DBA Orozco Landscape and Tree Company, with a place of business at 1419 S. East End Ave., Pomona, CA 91766 ("Contractor"), with County, District, and Contractor sometimes referred to as "Party" or collectively as "Parties."

2. The Recitals shall be amended to include the following:

WHEREAS, the District relies on County staff to carry out its duties pursuant to the Orange County Flood Control District Act, Water Code App. §§ 36-1 et seq., and County staff may request Contractor to perform services under this Contract on behalf of District; and

3. Article 2 of the Contract shall be amended to include the following:

Contract shall be renewed for one (1) year from June 10, 2024 through June 9, 2025, unless otherwise terminated by the County

4. Article 4 of the Contract shall be amended to include the following:

The first renewal term for the Aggregate Contract with J. Orozco Enterprises Inc. DBA Orozco Landscape and Tree company and Natures Image Inc. shall have a Total Aggregate Contract Amount not to exceed \$1,000,000.00.

6. All other terms and conditions in this Contract shall remain unchanged and with full force and effect.

\* If the contracting party is a corporation, (2) two signatures are required: one (1) signature by the Chairman of the Board, the President or any Vice President; and one (1) signature by the Secretary, any Assistant Secretary, the Chief Financial Officer or any Assistant Treasurer. The signature of one person alone is sufficient to bind a corporation, as long as he or she holds corporate offices in each of the two categories described above. For County purposes, proof of such dual office holding will be satisfied by having the individual sign the instrument twice, each time indicating his or her office that qualifies under the above described provision. In the alternative, a single corporate signature is acceptable when accompanied by a corporate resolution demonstrating the legal authority of the signatory to bind the corporation.
