WHEREAS, COUNTY desires to renew the ORIGINAL CONTRACT for the term of February 28, 2024 through and including February 27, 2025 in an amount not to exceed \$265,000.00 and to amend Attachment A, Scope of Work, of the ORIGINAL CONTRACT to modify Emergency Contacts and to reduce the number of guards, and the CONTRACTOR has agreed to continue to provide those services at the rates set forth in the ORIGINAL CONTRACT;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, both COUNTY and CONTRACTOR agree as follows:
