

AMENDMENT NUMBER TWO TO CONTRACT MA-012-19011131 FOR LANDSCAPE MAINTENANCE SERVICES FOR HISTORIC SITES BETWEEN OC COMMUNITY RESOURCES, OC PARKS AND MISSION LANDSCAPE COMPANIES, INC.

This Amendment to Contract MA-012-19011131, herein referred to as "Amendment", is made and entered into upon execution of all necessary signatures between the County of Orange, OC Community Resources OC Parks, a political subdivision of the State of California, hereinafter referred to as "County" and Mission Landscape Companies, Inc., with a place of business at 536 East Dyer Road, Santa Ana, CA 92707, hereinafter referred to as "Contractor", with County and Contractor sometimes individually referred to as "Party" or collectively referred to as "Parties".

RECITALS

WHEREAS, Contractor responded to a Request for Proposal ("RFP") for Landscape Maintenance Services for the County of Orange; and

WHEREAS, County and Contractor entered into Contract Number MA-012-19011131 hereinafter referred to as "Contract", for Landscape Maintenance Services, commencing on May 24, 2019 through and including May 23, 2022, not to exceed \$600,000 annual and;

WHEREAS, County and Contractor issued Amendment No. 1, effective December 31, 2020 to amend Attachment C, Fee Schedule, I-Standard Work (Price Increase-Irvine Ranch Historical Park and Katie Wheeler Library, Arden Modjeska Historical Park, Heritage Hill Historical Park and Key Ranch Historical Park)

WHEREAS County desires to renew Contract for one (1) additional year, and;

NOW THEREFORE, in consideration of the mutual obligations set forth herein, Parties mutually agree as follows:

ARTICLES

- 1. Contract MA-012-19011131, shall be renewed for the fourth year commencing on May 24, 2022 through and including May 23, 2023, with a not to exceed annual amount of \$600,000 and;
- 2. Except as otherwise expressly set forth herein, all terms and conditions contained in the original contract, including any amendments/modifications, are hereby incorporated herein by this reference as if fully set forth herein and shall remain in full force and effect.
