~~— THIS CONTRACT entered into this 1st day of July 2019, is by and between the COUNTY OF ORANGE, a political subdivision of State of California (COUNTY), and AMERICAN MED AMBULANCE, a [California], (CONTRACTOR). COUNTY and CONTRACTOR may sometimes be referred to herein individually as “Party” or collectively as “Parties.” This Contract shall be administered by the County of Orange Health Care Agency (ADMINISTRATOR).~~

This Amendment (“Amendment No. 1”) to Contract No. MA-042-22011309 for Medical Transportation Services is made and entered into on July 1, 2022 (“Effective Date”) between American Med Ambulance (“Contractor”) with a place of business at 3750 W. Warner Ave., Santa Ana, CA 92704 and the County of Orange a political subdivision of the State of California (“County”) through its Health Care Agency with a place business at 405 W. 5th St., Ste. 600, Santa Ana, CA 92701. Contractor and County may sometimes be referred to individually as “Party” or collectively as “Parties”.

WITNESSETH:

WHEREAS, COUNTY wishes to contract with CONTRACTOR with availability of prompt Medical Transportation Services for Persons for whom COUNTY has statutory obligations to provide medical care, and for other Persons whose transport by ambulance or van will assist COUNTY’s employees in carrying out their duties; and

WHEREAS, CONTRACTOR is licensed to operate a Medical Transportation Service within all or some portion of the County of Orange, the County of Riverside, the County of San Bernardino, the County of San Diego, and the County of Los Angeles and desires to provide the medical transportation service to COUNTY upon the terms and conditions set forth in the Contract;

NOW, THEREFORE, in consideration of the mutual covenants, benefits, and promises contained herein, COUNTY and CONTRACTOR do hereby agree as follows:

1 WHEREAS, the Parties now desire to enter into this Amendment No. 1 to renew the Contract for
2 County to continue receiving and Contractor to continue providing the services set forth in the Contract.

3 NOW THEREFORE, Contractor and County agree to amend the Contract as follows:

8 **II. ALTERATION OF TERMS**

9 A. This Contract, together with Exhibits A, B, and C attached hereto and incorporated herein, fully
10 expresses the complete understanding of COUNTY and CONTRACTOR with respect to the subject
11 matter of this Contract.

12 B. Unless otherwise expressly stated in this Contract, no addition to, or alteration of the terms of
13 this Contract or Exhibits A, B, C, and C whether written or verbal, made by the parties, their officers,
14 employees or agents shall be valid unless made in the form of a written amendment to this Contract,
15 which has been formally approved and executed by both parties.

16 **III ASSIGNMENT OF DEBTS**

17 Unless this Contract is followed without interruption by another Contract between the parties hereto
18 for the same services and substantially the same scope, at the termination of this Contract,
19 CONTRACTOR shall assign to COUNTY any debts owing to CONTRACTOR by or on behalf of
20 persons receiving services pursuant to this Contract. CONTRACTOR shall immediately notify by mail
21 each of these persons, specifying the date of assignment, the County of Orange as assignee, and the
22 address to which payments are to be sent. Payments received by CONTRACTOR from or on behalf of
23 said persons, shall be immediately given to COUNTY.
24

25 **IV. COMPLIANCE**

26 A. COMPLIANCE PROGRAM - ADMINISTRATOR has established a Compliance Program for
27 the purpose of ensuring adherence to all rules and regulations related to federal and state health care
28 programs.
29

30 1. ADMINISTRATOR shall provide CONTRACTOR with a copy of the policies and
31 procedures relating to ADMINISTRATOR's Compliance Program, Code of Conduct and access to
32 General Compliance and Annual Provider Trainings.

33 2. CONTRACTOR has the option to provide ADMINISTRATOR with proof of its own
34 Compliance Program, Code of Conduct and any Compliance related policies and procedures.
35 CONTRACTOR's Compliance Program, Code of Conduct and any related policies and procedures shall
36 be verified by ADMINISTRATOR's Compliance Department to ensure they include all required
37

1 elements by ADMINISTRATOR's Compliance Officer as described in this Compliance Paragraph to
2 this Contract. These elements include:

- 3 a. Designation of a Compliance Officer and/or compliance staff.
- 4 b. Written standards, policies and/or procedures.
- 5 c. Compliance related training and/or education program and proof of completion.
- 6 d. Communication methods for reporting concerns to the Compliance Officer.
- 7 e. Methodology for conducting internal monitoring and auditing.
- 8 f. Methodology for detecting and correcting offenses.
- 9 g. Methodology/Procedure for enforcing disciplinary standards.

10 3. If CONTRACTOR does not provide proof of its own Compliance Program to
11 ADMINISTRATOR, CONTRACTOR shall acknowledge ADMINISTRATOR's Compliance Program
12 and Code of Conduct, the CONTRACTOR shall submit to the ADMINISTRATOR within thirty (30)
13 calendar days of execution of this Contract a signed acknowledgement that CONTRACTOR is aware of
14 the ADMINISTRATOR's Compliance Program and Code of Conduct.

15 4. If CONTRACTOR elects to have its own Compliance Program, Code of Conduct and any
16 Compliance related policies and procedures reviewed by ADMINISTRATOR, then CONTRACTOR
17 shall submit a copy of its Compliance Program, Code of Conduct and all relevant policies and
18 procedures to ADMINISTRATOR within thirty (30) calendar days of execution of this Contract.
19 ADMINISTRATOR's Compliance Officer, or designee, shall review said documents within a
20 reasonable time, which shall not exceed forty-five (45) calendar days, and determine if
21 CONTRACTOR's proposed Compliance Program and Code of Conduct contain all required elements to
22 the ADMINISTRATOR's satisfaction as consistent with the HCA's Compliance Program and Code of
23 Conduct. ADMINISTRATOR shall inform CONTRACTOR of any missing required elements and
24 CONTRACTOR shall revise its Compliance Program and Code of Conduct to meet
25 ADMINISTRATOR's required elements within thirty (30) calendar days after ADMINISTRATOR's
26 Compliance Officer's determination and resubmit the same for review by the ADMINISTRATOR.

27 5. Upon written confirmation from ADMINISTRATOR's Compliance Officer that the
28 CONTRACTOR's Compliance Program, Code of Conduct and any Compliance related policies and
29 procedures contain all required elements, CONTRACTOR shall ensure that all Covered Individuals
30 relative to this Contract are made aware of CONTRACTOR's compliance program, code of conduct,
31 related policies and procedures and contact information for the ADMINISTRATOR's Compliance
32 Program.

33 B. SANCTION SCREENING – CONTRACTOR shall screen all Covered Individuals employed or
34 retained to provide services related to this Contract semi-annually to ensure that they are not designated
35 as Ineligible Persons, as pursuant to this Contract. Screening shall be conducted against the General
36 Services Administration's Excluded Parties List System or System for Award Management, the Health
37 and Human Services/Office of Inspector General List of Excluded Individuals/Entities, and the

1 California Medi-Cal Suspended and Ineligible Provider List, the Social Security Administration's Death
2 Master File, and/or any other list or system as identified by ADMINISTRATOR.

3 1. For purposes of this Compliance Paragraph, Covered Individuals includes all employees,
4 interns, volunteers, contractors, subcontractors, agents, and other persons who provide health care items
5 or services or who perform billing or coding functions on behalf of ADMINISTRATOR.
6 CONTRACTOR shall ensure that all Covered Individuals relative to this Contract are made aware of
7 ADMINISTRATOR's Compliance Program, Code of Conduct and related policies and procedures (or
8 CONTRACTOR's own Compliance Program, Code of Conduct and related policies and procedures if
9 CONTRACTOR has elected to use its own).

10 2. An Ineligible Person shall be any individual or entity who:

11 a. is currently excluded, suspended, debarred or otherwise ineligible to participate in
12 federal and state health care programs; or

13 b. has been convicted of a criminal offense related to the provision of health care items or
14 services and has not been reinstated in the federal and state health care programs after a period of
15 exclusion, suspension, debarment, or ineligibility.

16 3. CONTRACTOR shall screen prospective Covered Individuals prior to hire or engagement.
17 CONTRACTOR shall not hire or engage any Ineligible Person to provide services relative to this
18 Contract.

19 4. CONTRACTOR shall screen all current Covered Individuals and subcontractors semi-
20 annually to ensure that they have not become Ineligible Persons. CONTRACTOR shall also request that
21 its subcontractors use their best efforts to verify that they are eligible to participate in all federal and
22 State of California health programs and have not been excluded or debarred from participation in any
23 federal or state health care programs, and to further represent to CONTRACTOR that they do not have
24 any Ineligible Person in their employ or under contract.

25 5. Covered Individuals shall be required to disclose to CONTRACTOR immediately any
26 debarment, exclusion or other event that makes the Covered Individual an Ineligible Person.
27 CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual providing
28 services directly relative to this Contract becomes debarred, excluded or otherwise becomes an
29 Ineligible Person.

30 6. CONTRACTOR acknowledges that Ineligible Persons are precluded from providing
31 federal and state funded health care services by contract with COUNTY in the event that they are
32 currently sanctioned or excluded by a federal or state law enforcement regulatory or licensing agency.
33 If CONTRACTOR becomes aware that a Covered Individual has become an Ineligible Person,
34 CONTRACTOR shall remove such individual from responsibility for, or involvement with, COUNTY
35 business operations related to this Contract.

36 7. CONTRACTOR shall notify ADMINISTRATOR immediately if a Covered Individual or
37 entity is currently excluded, suspended or debarred, or is identified as such after being sanction

1 screened. Such individual or entity shall be immediately removed from participating in any activity
2 associated with this Contract. ADMINISTRATOR will determine appropriate repayment from, or
3 sanction(s) to CONTRACTOR for services provided by ineligible person or individual.
4 CONTRACTOR shall promptly return any overpayments within forty-five (45) business days after the
5 overpayment is verified by ADMINISTRATOR.

6 C. GENERAL COMPLIANCE TRAINING - ADMINISTRATOR shall make General
7 Compliance Training available to Covered Individuals.

8 1. CONTRACTORS that have acknowledged to comply with ADMINISTRATOR's
9 Compliance Program shall use its best efforts to encourage completion by all Covered Individuals;
10 provided, however, that at a minimum CONTRACTOR shall assign at least one (1) designated
11 representative to complete the General Compliance Training when offered.

12 2. Such training will be made available to Covered Individuals within thirty (30) calendar
13 days of employment or engagement.

14 3. Such training will be made available to each Covered Individual annually.

15 4. ADMINISTRATOR will track training completion while CONTRACTOR shall provide
16 copies of training certification upon request.

17 5. Each Covered Individual attending a group training shall certify, in writing, attendance at
18 compliance training. ADMINISTRATOR shall provide instruction on group training completion while
19 CONTRACTOR shall retain the training certifications. Upon written request by ADMINISTRATOR,
20 CONTRACTOR shall provide copies of the certifications.

21 D. SPECIALIZED PROVIDER TRAINING – ADMINISTRATOR shall make Specialized
22 Provider Training, where appropriate, available to Covered Individuals.

23 1. CONTRACTOR shall ensure completion of Specialized Provider Training by all Covered
24 Individuals relative to this Contract. This includes compliance with federal and state healthcare
25 program regulations and procedures or instructions otherwise communicated by regulatory agencies;
26 including the Centers for Medicare and Medicaid Services or their agents.

27 2. Such training will be made available to Covered Individuals within thirty (30) calendar
28 days of employment or engagement.

29 3. Such training will be made available to each Covered Individual annually.

30 4. ADMINISTRATOR will track online completion of training while CONTRACTOR shall
31 provide copies of the certifications upon request.

32 5. Each Covered Individual attending a group training shall certify, in writing, attendance at
33 compliance training. ADMINISTRATOR shall provide instructions on completing the training in a
34 group setting while CONTRACTOR shall retain the certifications. Upon written request by
35 ADMINISTRATOR, CONTRACTOR shall provide copies of the certifications.

36 E. MEDI-CAL BILLING, CODING, AND DOCUMENTATION COMPLIANCE STANDARDS
37

1 1. CONTRACTOR shall take reasonable precaution to ensure that the coding of health care
2 claims, billings and/or invoices for same are prepared and submitted in an accurate and timely manner
3 and are consistent with federal, state and county laws and regulations. This includes compliance with
4 federal and state health care program regulations and procedures or instructions otherwise
5 communicated by regulatory agencies including the Centers for Medicare and Medicaid Services or
6 their agents.

7 2. CONTRACTOR shall not submit any false, fraudulent, inaccurate and/or fictitious claims
8 for payment or reimbursement of any kind.

9 3. CONTRACTOR shall bill only for those eligible services actually rendered which are also
10 fully documented. When such services are coded, CONTRACTOR shall use proper billing codes which
11 accurately describes the services provided and must ensure compliance with all billing and
12 documentation requirements.

13 4. CONTRACTOR shall act promptly to investigate and correct any problems or errors in
14 coding of claims and billing, if and when, any such problems or errors are identified.

15 5. CONTRACTOR shall promptly return any overpayments within forty-five (45) business
16 days after the overpayment is verified by the ADMINISTRATOR.

17 6. CONTRACTOR shall meet the HCA MHP Quality Management Program Standards and
18 participate in the quality improvement activities developed in the implementation of the Quality
19 Management Program.

20 7. CONTRACTOR shall comply with the provisions of the ADMINISTRATOR's Cultural
21 Competency Plan submitted and approved by the state. ADMINISTRATOR shall update the Cultural
22 Competency Plan and submit the updates to the State for review and approval annually. (CCR, Title 9,
23 §1810.410.subds.(c)-(d)).

24 F. Failure to comply with the obligations stated in this Compliance Paragraph shall constitute a
25 breach of the Contract on the part of CONTRACTOR and grounds for COUNTY to terminate the
26 Contract. Unless the circumstances require a sooner period of cure, CONTRACTOR shall have thirty
27 (30) calendar days from the date of the written notice of default to cure any defaults grounded on this
28 Compliance Paragraph prior to ADMINISTRATOR's right to terminate this Contract on the basis of
29 such default.

30 **V. CONFIDENTIALITY**

31
32 A. CONTRACTOR shall maintain the confidentiality of all records, including billings and any
33 audio and/or video recordings, in accordance with all applicable federal, state and county codes and
34 regulations, as they now exist or may hereafter be amended or changed.

35 B. Prior to providing any services pursuant to this Contract, all members of the
36 CONTRACTORS's governing body or its designee or authorized agent, employees, consultants,
37 subcontractors, volunteers and interns of the CONTRACTOR shall agree, in writing, with

1 CONTRACTOR to maintain the confidentiality of any and all information and records which may be
 2 obtained in the course of providing such services. This Contract shall specify that it is effective
 3 irrespective of all subsequent resignations or terminations of CONTRACTOR members of the
 4 CONTRACTORS's governing body or its designee or authorized agent, employees, consultants,
 5 subcontractors, volunteers and interns.

6 7 **VI. CONFLICT OF INTEREST**

8 CONTRACTOR shall exercise reasonable care and diligence to prevent any actions or conditions
 9 that could result in a conflict with COUNTY interests. In addition to CONTRACTOR, this obligation
 10 shall apply to CONTRACTOR's employees, agents, and subcontractors associated with the provision of
 11 goods and services provided under this Contract. CONTRACTOR's efforts shall include, but not be
 12 limited to establishing rules and procedures preventing its employees, agents, and subcontractors from
 13 providing or offering gifts, entertainment, payments, loans or other considerations which could be
 14 deemed to influence or appear to influence COUNTY staff or elected officers in the performance of
 15 their duties.

16 17 **VII. DELEGATION, ASSIGNMENT AND SUBCONTRACTS**

18 A. CONTRACTOR may not delegate the obligations hereunder, either in whole or in part, without
 19 prior written consent of COUNTY. CONTRACTOR shall provide written notification of
 20 CONTRACTOR's intent to delegate the obligations hereunder, either in whole or part, to
 21 ADMINISTRATOR not less than sixty (60) calendar days prior to the effective date of the delegation.
 22 Any attempted assignment or delegation in derogation of this paragraph shall be void.

23 B. CONTRACTOR agrees that if there is a change or transfer in ownership of CONTRACTORS's
 24 business prior to completion of this Contract, and COUNTY agrees to an assignment of the Contract, the
 25 new owners shall be required under the terms of sale or other instruments of transfer to assume
 26 CONTRACTOR's duties and obligations contained in this Contract and complete them to the
 27 satisfaction of COUNTY. CONTRACTOR may not assign the rights hereunder, either in whole or in
 28 part, without the prior written consent of COUNTY.

29 1. If CONTRACTOR is a nonprofit organization, any change from a nonprofit corporation to
 30 any other corporate structure of CONTRACTOR, including a change in more than fifty percent (50%)
 31 of the composition of the Board of Directors within a two (2) month period of time, shall be deemed an
 32 assignment for purposes of this paragraph, unless CONTRACTOR is transitioning from a community
 33 clinic/health center to a Federally Qualified Health Center and has been so designated by the Federal
 34 Government. Any attempted assignment or delegation in derogation of this subparagraph shall be void.

35 2. If CONTRACTOR is a for-profit organization, any change in the business structure,
 36 including but not limited to, the sale or transfer of more than ten percent (10%) of the assets or stocks of
 37 CONTRACTOR, change to another corporate structure, including a change to a sole proprietorship, or a

1 change in fifty percent (50%) or more of Board of Directors or any governing body of CONTRACTOR
 2 at one time shall be deemed an assignment pursuant to this paragraph. Any attempted assignment or
 3 delegation in derogation of this subparagraph shall be void.

4 3. If CONTRACTOR is a governmental organization, any change to another structure,
 5 including a change in more than fifty percent (50%) of the composition of its governing body (i.e. Board
 6 of Supervisors, City Council, School Board) within a two (2) month period of time, shall be deemed an
 7 assignment for purposes of this paragraph. Any attempted assignment or delegation in derogation of
 8 this subparagraph shall be void.

9 4. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization,
 10 CONTRACTOR shall provide written notification of CONTRACTOR's intent to assign the obligations
 11 hereunder, either in whole or part, to ADMINISTRATOR not less than sixty (60) calendar days prior to
 12 the effective date of the assignment.

13 5. Whether CONTRACTOR is a nonprofit, for-profit, or a governmental organization,
 14 CONTRACTOR shall provide written notification within thirty (30) calendar days to
 15 ADMINISTRATOR when there is change of less than fifty percent (50%) of Board of Directors or any
 16 governing body of CONTRACTOR at one time.

17 6. COUNTY reserves the right to immediately terminate the Contract in the event COUNTY
 18 determines, in its sole discretion, that the assignee is not qualified or is otherwise unacceptable to
 19 COUNTY for the provision of services under the Contract.

20 C. CONTRACTOR's obligations undertaken pursuant to this Contract may be carried out by
 21 means of subcontracts, provided such subcontractors are approved in advance by ADMINISTRATOR,
 22 meet the requirements of this Contract as they relate to the service or activity under subcontract, include
 23 any provisions that ADMINISTRATOR may require, and are authorized in writing by
 24 ADMINISTRATOR prior to the beginning of service delivery.

25 1. After approval of the subcontractor, ADMINISTRATOR may revoke the approval of the
 26 subcontractor upon five (5) calendar days; written notice to CONTRACTOR if the subcontractor
 27 subsequently fails to meet the requirements of this Contract or any provisions that ADMINISTRATOR
 28 has required. ADMINISTRATOR may disallow subcontractor expenses reported by CONTRACTOR.

29 2. No subcontract shall terminate or alter the responsibilities of CONTRACTOR to COUNTY
 30 pursuant to this Contract.

31 3. ADMINISTRATOR may disallow, from payments otherwise due CONTRACTOR,
 32 amounts claimed for subcontracts not approved in accordance with this paragraph.

33 4. This provision shall not be applicable to service contracts usually and customarily entered
 34 into by CONTRACTOR to obtain or arrange for supplies, technical support, and professional services
 35 provided by consultants.

36 D. CONTRACTOR shall notify COUNTY in writing of any change in the CONTRACTOR's
 37 status with respect to name changes that do not require an assignment of the Contract. CONTRACTOR

1 is also obligated to notify COUNTY in writing if the CONTRACTOR becomes a party to any litigation
 2 against COUNTY, or a party to litigation that may reasonably affect the CONTRACTOR's performance
 3 under the Contract, as well as any potential conflicts of interest between CONTRACTOR and County
 4 that may arise prior to or during the period of Contract performance. While CONTRACTOR will be
 5 required to provide this information without prompting from COUNTY any time there is a change in
 6 CONTRACTOR's name, conflict of interest or litigation status, CONTRACTOR must also provide an
 7 update to COUNTY of its status in these areas whenever requested by COUNTY.

8 9 **VIII. DISPUTE RESOLUTION**

10 A. The Parties shall deal in good faith and attempt to resolve potential disputes informally. If the
 11 dispute concerning a question of fact arising under the terms of this Contract is not disposed of in a
 12 reasonable period of time by the CONTRACTOR and the ADMINISTRATOR, such matter shall be
 13 brought to the attention of the COUNTY Purchasing Agency by way of the following process:

14 1. CONTRACTOR shall submit to the COUNTY Purchasing Agency a written demand for a
 15 final decision regarding the disposition of any dispute between the Parties arising under, related to, or
 16 involving this Contract, unless COUNTY, on its own initiative, has already rendered such a final
 17 decision.

18 2. CONTRACTOR's written demand shall be fully supported by factual information, and, if
 19 such demand involves a cost adjustment to the Contract, CONTRACTOR shall include with the demand
 20 a written statement signed by an authorized representative indicating that the demand is made in good
 21 faith, that the supporting data are accurate and complete, and that the amount requested accurately
 22 reflects the Contract adjustment for which CONTRACTOR believes COUNTY is liable.

23 B. Pending the final resolution of any dispute arising under, related to, or involving this Contract,
 24 CONTRACTOR agrees to proceed diligently with the performance of services secured via this Contract,
 25 including the delivery of goods and/or provision of services. CONTRACTOR's failure to proceed
 26 diligently shall be considered a material breach of this Contract.

27 C. Any final decision of COUNTY shall be expressly identified as such, shall be in writing, and
 28 shall be signed by a COUNTY Deputy Purchasing Agent or designee. If COUNTY fails to render a
 29 decision within ninety (90) calendar days after receipt of CONTRACTOR's demand, it shall be deemed
 30 a final decision adverse to CONTRACTOR's contentions.

31 D. This Contract has been negotiated and executed in the State of California and shall be governed
 32 by and construed under the laws of the State of California. In the event of any legal action to enforce or
 33 interpret this Contract, the sole and exclusive venue shall be a court of competent jurisdiction located in
 34 Orange County, California, and the Parties hereto agree to and do hereby submit to the jurisdiction of
 35 such court, notwithstanding Code of Civil Procedure Section 394. Furthermore, the Parties specifically
 36 agree to waive any and all rights to request that an action be transferred for adjudication to another
 37 county.

1 //

2 **IX. EMPLOYEE ELIGIBILITY VERIFICATION**

3 CONTRACTOR attests that it shall fully comply with all federal and state statutes and regulations
4 regarding the employment of aliens and others and to ensure that employees, subcontractors, and
5 consultants performing work under this Contract meet the citizenship or alien status requirements set
6 forth in federal statutes and regulations. CONTRACTOR shall obtain, from all employees,
7 subcontractors, and consultants performing work hereunder, all verification and other documentation of
8 employment eligibility status required by federal or state statutes and regulations including, but not
9 limited to, the Immigration Reform and Control Act of 1986, 8 USC §1324 et seq., as they currently
10 exist and as they may be hereafter amended. CONTRACTOR shall retain all such documentation for all
11 covered employees, subcontractors, and consultants for the period prescribed by the law.

12
13 **X. FACILITIES, PAYMENTS AND SERVICES**

14 CONTRACTOR agrees to provide the services, staffing, facilities, and supplies in accordance with
15 this Contract. COUNTY shall compensate, and authorize, when applicable, said services.
16 CONTRACTOR shall operate continuously throughout the term of this Contract with at least the
17 minimum number and type of staff which meet applicable federal and state requirements, and which are
18 necessary for the provision of the services hereunder.

19
20 **XI. INDEMNIFICATION AND INSURANCE**

21 A. CONTRACTOR agrees to indemnify, defend with counsel approved in writing by COUNTY,
22 and hold COUNTY, its elected and appointed officials, officers, employees, agents and those special
23 districts and agencies for which COUNTY's Board of Supervisors acts as the governing Board
24 ("COUNTY INDEMNITEES") harmless from any claims, demands or liability of any kind or nature,
25 including but not limited to personal injury or property damage, arising from or related to the services,
26 products or other performance provided by CONTRACTOR pursuant to this Contract. If judgment is
27 entered against CONTRACTOR and COUNTY by a court of competent jurisdiction because of the
28 concurrent active negligence of COUNTY or COUNTY INDEMNITEES, CONTRACTOR and
29 COUNTY agree that liability will be apportioned as determined by the court. Neither Party shall
30 request a jury apportionment.

31 B. Prior to the provision of services under this Contract, CONTRACTOR agrees to purchase all
32 required insurance at CONTRACTOR's expense, including all endorsements required herein, necessary
33 to satisfy COUNTY that the insurance provisions of this Contract have been complied with.
34 CONTRACTOR agrees to keep such insurance coverage, Certificates of Insurance, and endorsements
35 on deposit with COUNTY during the entire term of this Contract. In addition, all subcontractors
36 performing work on behalf of CONTRACTOR pursuant to this Contract shall obtain insurance subject
37 to the same terms and conditions as set forth herein for CONTRACTOR.

1 //

2 C. CONTRACTOR shall ensure that all subcontractors performing work on behalf of
3 CONTRACTOR pursuant to this Contract shall be covered under CONTRACTOR's insurance as an
4 Additional Insured or maintain insurance subject to the same terms and conditions as set forth herein for
5 CONTRACTOR. CONTRACTOR shall not allow subcontractors to work if subcontractors have less
6 than the level of coverage required by COUNTY from CONTRACTOR under this Contract. It is the
7 obligation of CONTRACTOR to provide notice of the insurance requirements to every subcontractor
8 and to receive proof of insurance prior to allowing any subcontractor to begin work. Such proof of
9 insurance must be maintained by CONTRACTOR through the entirety of this Contract for inspection by
10 COUNTY representative(s) at any reasonable time.

11 D. All SIRs and deductibles shall be clearly stated on the COI. Any SIR in an amount in excess of
12 fifty thousand dollars (\$50,000) shall specifically be approved by the CEO/Office of Risk Management
13 upon review of CONTRACTOR's current audited financial report. If CONTRACTOR's SIR is
14 approved, CONTRACTOR, in addition to, and without limitation of, any other indemnity provision(s)
15 in this Contract, agrees to all of the following.

16 1. In addition to the duty to indemnify and hold the COUNTY harmless against any and all
17 liability, claim, demand or suit resulting from CONTRACTOR's, its agents, employee's or
18 subcontractor's performance of this Contract, CONTRACTOR shall defend the COUNTY at its sole
19 cost and expense with counsel approved by Board of Supervisors against same; and

20 2. CONTRACTOR's duty to defend, as stated above, shall be absolute and irrespective of any
21 duty to indemnify or hold harmless; and

22 3. The provisions of California Civil Code Section 2860 shall apply to any and all actions to
23 which the duty to defend stated above applies, and the CONTRACTOR's SIR provision shall be
24 interpreted as though the CONTRACTOR was an insurer and the COUNTY was the insured.

25 E. If CONTRACTOR fails to maintain insurance acceptable to the COUNTY for the full term of
26 this Contract, the COUNTY may terminate this contract

27 F. QUALIFIED INSURER

28 1. The policy or policies of insurance must be issued by an insurer with a minimum rating of
29 A- (Secure A.M. Best's Rating) and VIII (Financial Size Category as determined by the most current
30 edition of the **Best's Key Rating Guide/Property-Casualty/United States or ambest.com**). It is
31 preferred, but not mandatory, that the insurer be licensed to do business in the state of California
32 (California Admitted Carrier).

33 2. If the insurance carrier does not have an A.M. Best Rating of A-/VIII, the CEO/Office of
34 Risk Management retains the right to approve or reject a carrier after a review of the company's
35 performance and financial ratings.

36 G. The policy or policies of insurance maintained by CONTRACTOR shall provide the minimum
37 limits and coverage as set forth below:

H. REQUIRED COVERAGE FORMS

1. The Commercial General Liability coverage shall be written on ISO form CG 00 01, or a substitute form providing liability coverage at least as broad.

2. The Business Automobile Liability coverage shall be written on ISO form CA 00 01, CA 00 05, CA 00 12, CA 00 20, or a substitute form providing coverage at least as broad.

I. REQUIRED ENDORSEMENTS

1. The Commercial General Liability policy shall contain the following endorsements, which shall accompany the COI:

a. An Additional Insured endorsement using ISO form CG 20 26 04 13 or a form at least as broad naming the *County of Orange, its elected and appointed officials, officers, agents and employees* as Additional Insureds, or provide blanket coverage, which will state **AS REQUIRED BY WRITTEN AGREEMENT**.

b. A primary non-contributing endorsement using ISO form CG 20 01 04 13, or a form at least as broad evidencing that the CONTRACTOR's insurance is primary and any insurance or self-insurance maintained by the County of Orange shall be excess and non-contributing.

2. The Network Security and Privacy Liability policy shall contain the following endorsements which shall accompany the COI:

1 a. An Additional Insured endorsement naming the *County of Orange, its elected and*
2 *appointed officials, officers, agents and employees* as Additional Insureds for its vicarious liability.

3 b. A primary and non-contributing endorsement evidencing that the Contractor's
4 insurance is primary and any insurance or self-insurance maintained by the County of Orange shall be
5 excess and non-contributing.

6 J. All insurance policies required by this Contract shall waive all rights of subrogation against the
7 County of Orange, its elected and appointed officials, officers, agents and employees when acting within
8 the scope of their appointment or employment.

9 K. The Workers' Compensation policy shall contain a waiver of subrogation endorsement waiving
10 all rights of subrogation against the *County of Orange, its elected and appointed officials, officers,*
11 *agents and employees*, or provide blanket coverage, which will state **AS REQUIRED BY WRITTEN**
12 **AGREEMENT**.

13 L. All insurance policies required by this Contract shall waive all rights of subrogation against the
14 County of Orange, its elected and appointed officials, officers, agents and employees when acting within
15 the scope of their appointment or employment.

16 M. CONTRACTOR shall notify COUNTY in writing within thirty (30) days of any policy
17 cancellation and within ten (10) days for non-payment of premium and provide a copy of the
18 cancellation notice to COUNTY. Failure to provide written notice of cancellation shall constitute a
19 breach of CONTRACTOR's obligation hereunder and ground for COUNTY to suspend or terminate
20 this Contract.

21 N. If CONTRACTOR's Professional Liability and/or Network Security & Privacy Liability are
22 "Claims Made" policies, CONTRACTOR shall agree to maintain coverage for two (2) years following
23 the completion of the Contract.

24 O. The Commercial General Liability policy shall contain a "severability of interests" clause also
25 known as a "separation of insureds" clause (standard in the ISO CG 0001 policy).

26 P. Insurance certificates should be forwarded to the agency/department address listed on the
27 solicitation.

28 Q. COUNTY expressly retains the right to require CONTRACTOR to increase or decrease
29 insurance of any of the above insurance types throughout the term of this Contract. Any increase or
30 decrease in insurance will be as deemed by County of Orange Risk Manager as appropriate to
31 adequately protect COUNTY.

32 R. COUNTY shall notify CONTRACTOR in writing of changes in the insurance requirements. If
33 CONTRACTOR does not deposit copies of acceptable Certificate of Insurance (COI) and endorsements
34 with COUNTY incorporating such changes within thirty (30) calendar days of receipt of such notice,
35 this Contract may be in breach without further notice to CONTRACTOR, and COUNTY shall be
36 entitled to all legal remedies.

37

1 S. The procuring of such required policy or policies of insurance shall not be construed to limit
 2 CONTRACTOR's liability hereunder nor to fulfill the indemnification provisions and requirements of
 3 this Contract, nor act in any way to reduce the policy coverage and limits available from the insurer.

4 T. SUBMISSION OF INSURANCE DOCUMENTS

5 1. The COI and endorsements shall be provided to COUNTY as follows:
 6 a. Prior to the start date of this Contract.
 7 b. No later than the expiration date for each policy.
 8 c. Within thirty (30) calendar days upon receipt of written notice by COUNTY regarding
 9 changes to any of the insurance requirements as set forth in Subparagraph G, above.

10 2. The COI and endorsements shall be provided to the COUNTY at the address as specified in
 11 the Referenced Contract Provisions of this Contract.

12 3. If CONTRACTOR fails to submit the COI and endorsements that meet the insurance
 13 provisions stipulated in this Contract by the above specified due dates, ADMINISTRATOR shall have
 14 sole discretion to impose one or both of the following:

15 a. ADMINISTRATOR may withhold or delay any or all payments due CONTRACTOR
 16 pursuant to any and all Contracts between COUNTY and CONTRACTOR until such time that the
 17 required COI and endorsements that meet the insurance provisions stipulated in this Contract are
 18 submitted to ADMINISTRATOR.

19 b. CONTRACTOR may be assessed a penalty of one hundred dollars (\$100) for each late
 20 COI or endorsement for each business day, pursuant to any and all Contracts between COUNTY and
 21 CONTRACTOR, until such time that the required COI and endorsements that meet the insurance
 22 provisions stipulated in this Contract are submitted to ADMINISTRATOR.

23 c. If CONTRACTOR is assessed a late penalty, the amount shall be deducted from
 24 CONTRACTOR's monthly invoice.

25 4. In no cases shall assurances by CONTRACTOR, its employees, agents, including any
 26 insurance agent, be construed as adequate evidence of insurance. COUNTY will only accept valid COIs
 27 and endorsements, or in the interim, an insurance binder as adequate evidence of insurance coverage.

28
 29 **XII. INSPECTIONS AND AUDITS**

30 A. ADMINISTRATOR, any authorized representative of COUNTY, any authorized representative
 31 of the State of California, the Secretary of the United States Department of Health and Human Services,
 32 the Comptroller General of the United States, or any other of their authorized representatives, shall to
 33 the extent permissible under applicable law have access to any books, documents, and records, including
 34 but not limited to, financial statements, general ledgers, relevant accounting systems, medical and Client
 35 records, of CONTRACTOR that are directly pertinent to this Contract, for the purpose of responding to
 36 a beneficiary complaint or conducting an audit, review, evaluation, or examination, or making
 37 transcripts during the periods of retention set forth in the Records Management and Maintenance

1 Paragraph of this Contract. Such persons may at all reasonable times inspect or otherwise evaluate the
2 services provided pursuant to this Contract, and the premises in which they are provided.

3 //

4 B. CONTRACTOR shall actively participate and cooperate with any person specified in
5 Subparagraph A. above in any evaluation or monitoring of the services provided pursuant to this
6 Contract, and shall provide the above-mentioned persons adequate office space to conduct such
7 evaluation or monitoring.

8 C. AUDIT RESPONSE

9 1. Following an audit report, in the event of non-compliance with applicable laws and
10 regulations governing funds provided through this Contract, COUNTY may terminate this Contract as
11 provided for in the Termination Paragraph or direct CONTRACTOR to immediately implement
12 appropriate corrective action. A CAP shall be submitted to ADMINISTRATOR in writing within thirty
13 (30) calendar days after receiving notice from ADMINISTRATOR.

14 2. If the audit reveals that money is payable from one Party to the other, that is,
15 reimbursement by CONTRACTOR to COUNTY, or payment of sums due from COUNTY to
16 CONTRACTOR, said funds shall be due and payable from one Party to the other within sixty (60)
17 calendar days of receipt of the audit results. If reimbursement is due from CONTRACTOR to
18 COUNTY, and such reimbursement is not received within said sixty (60) calendar days, COUNTY may,
19 in addition to any other remedies provided by law, reduce any amount owed CONTRACTOR by an
20 amount not to exceed the reimbursement due COUNTY.

21 D. CONTRACTOR shall retain a licensed certified public accountant, who will prepare and file
22 with ADMINISTRATOR, an annual, independent, organization-wide audit of related expenditures as
23 may be required during the term of this Contract.

24 E. CONTRACTOR shall forward to ADMINISTRATOR a copy of any audit report within
25 fourteen (14) calendar days of receipt. Such audit shall include, but not be limited to, management,
26 financial, programmatic or any other type of audit of CONTRACTOR's operations, whether or not the
27 cost of such operation or audit is reimbursed in whole or in part through this Contract.

28
29 **XIII. LICENSES AND LAWS**

30 A. CONTRACTOR, its officers, agents, employees, affiliates, and subcontractors shall, throughout
31 the term of this Contract, maintain all necessary licenses, permits, approvals, certificates, accreditations,
32 waivers, and exemptions necessary for the provision of the services hereunder and required by the laws,
33 regulations and requirements of the United States, the State of California, COUNTY, and all other
34 applicable governmental agencies.

35 B. ENFORCEMENT OF CHILD SUPPORT OBLIGATIONS

36 1. CONTRACTOR certifies it is in full compliance with all applicable federal and State
37 reporting requirements regarding its employees and with all lawfully served Wage and Earnings

1 Assignment Orders and Notices of Assignments and will continue to be in compliance throughout the
 2 term of the Contract with the County of Orange. Failure to comply shall constitute a material breach of
 3 the Contract and failure to cure such breach within sixty (60) calendar days of notice from the
 4 COUNTY shall constitute grounds for termination of the Contract.

5 2. CONTRACTOR agrees to furnish to ADMINISTRATOR within thirty (30) calendar days
 6 of the award of this Contract:

7 a. In the case of an individual CONTRACTOR, his/her name, date of birth, social security
 8 number, and residence address;

9 b. In the case of a CONTRACTOR doing business in a form other than as an individual,
 10 the name, date of birth, social security number, and residence address of each individual who owns an
 11 interest of ten percent (10%) or more in the contracting entity;

12 3. It is expressly understood that this data will be transmitted to governmental agencies
 13 charged with the establishment and enforcement of child support orders, or as permitted by federal
 14 and/or state statute.

15 16 **XIV. MAXIMUM OBLIGATION**

17 A. The Aggregate Maximum Obligation of COUNTY for services provided in accordance with all
 18 contracts for Medical Transportation Services is as specified in the Referenced Contract Provisions of
 19 this Contract. This specific Contract with CONTRACTOR is only one of several contracts to which this
 20 Aggregate Maximum Obligation applies. It therefore is understood by the Parties that reimbursement to
 21 CONTRACTOR will be only a fraction of this Aggregate Maximum Obligation.

22 B. ADMINISTRATOR may amend the Maximum Obligation by an amount not to exceed ten
 23 percent (10%) of Period One funding for this Contract.

24 25 **XV. MINIMUM WAGE LAWS**

26 A. Pursuant to the United States of America Fair Labor Standards Act of 1938, as amended, and
 27 State of California Labor Code, §1178.5, CONTRACTOR shall pay no less than the greater of the
 28 federal or California Minimum Wage to all its employees that directly or indirectly provide services
 29 pursuant to this Contract, in any manner whatsoever. CONTRACTOR shall require and verify that all
 30 of its employees or other persons providing services pursuant to this Contract be paid no less than the
 31 greater of the federal or California Minimum Wage.

32 B. CONTRACTOR shall comply and verify that its Covered Individuals comply with all other
 33 federal and State of California laws for minimum wage, overtime pay, record keeping, and child labor
 34 standards pursuant to providing services pursuant to this Contract.

35 C. Notwithstanding the minimum wage requirements provided for in this clause, CONTRACTOR,
 36 where applicable, shall comply with the prevailing wage and related requirements, as provided for in
 37

1 accordance with the provisions of Article 2 of Chapter 1, Part 7, Division 2 of the Labor Code of the
2 State of California (§§1770, et seq.), as it now exists or may hereafter be amended.

3 //

4 **XVI. NONDISCRIMINATION**

5 **A. EMPLOYMENT**

6 1. During the term of this Contract, CONTRACTOR and its Covered Individuals (as defined
7 in the "Compliance" paragraph of this Contract) shall not unlawfully discriminate against any employee
8 or applicant for employment because of his/her race, religious creed, color, national origin, ancestry,
9 physical disability, mental disability, medical condition, genetic information, marital status, sex, gender,
10 gender identity, gender expression, age, sexual orientation, or military and veteran status. Additionally,
11 during the term of this Contract, CONTRACTOR and its Covered Individuals shall require in its
12 subcontracts that subcontractors shall not unlawfully discriminate against any employee or applicant for
13 employment because of his/her race, religious creed, color, national origin, ancestry, physical disability,
14 mental disability, medical condition, genetic information, marital status, sex, gender, gender identity,
15 gender expression, age, sexual orientation, or military and veteran status.

16 2. CONTRACTOR and its Covered Individuals shall not discriminate against employees or
17 applicants for employment in the areas of employment, promotion, demotion or transfer; recruitment or
18 recruitment advertising, layoff or termination; rate of pay or other forms of compensation; and selection
19 for training, including apprenticeship.

20 3. CONTRACTOR shall not discriminate between employees with spouses and employees
21 with domestic partners, or discriminate between domestic partners and spouses of those employees, in
22 the provision of benefits.

23 4. CONTRACTOR shall post in conspicuous places, available to employees and applicants for
24 employment, notices from ADMINISTRATOR and/or the United States Equal Employment
25 Opportunity Commission (EOC) setting forth the provisions of the EOC.

26 5. All solicitations or advertisements for employees placed by or on behalf of
27 CONTRACTOR and/or subcontractor shall state that all qualified applicants will receive consideration
28 for employment without regard to race, religious creed, color, national origin, ancestry, physical
29 disability, mental disability, medical condition, genetic information, marital status, sex, gender, gender
30 identity, gender expression, age, sexual orientation, or military and veteran status. Such requirements
31 shall be deemed fulfilled by use of the term EOE.

32 6. Each labor union or representative of workers with which CONTRACTOR and/or
33 subcontractor has a collective bargaining contract or other contract or understanding must post a notice
34 advising the labor union or workers' representative of the commitments under this Nondiscrimination
35 Paragraph and shall post copies of the notice in conspicuous places, available to employees and
36 applicants for employment.

37

1 B. SERVICES, BENEFITS AND FACILITIES – CONTRACTOR and/or subcontractor shall not
 2 discriminate in the provision of services, the allocation of benefits, or in the accommodation in facilities
 3 on the basis of race, religious creed, color, national origin, ancestry, physical disability, mental
 4 disability, medical condition, genetic information, marital status, sex, gender, gender identity, gender
 5 expression, age, sexual orientation, or military and veteran status in accordance with Title IX of the
 6 Education Amendments of 1972 as they relate to 20 USC §1681 - §1688; Title VI of the Civil Rights
 7 Act of 1964 (42 USC §2000d); the Age Discrimination Act of 1975 (42 USC §6101); Title 9, Division
 8 4, Chapter 6, Article 1 (§10800, et seq.) of the CCR; and Title II of the Genetic Information
 9 Nondiscrimination Act of 2008, 42 USC 2000ff, et seq. as applicable, and all other pertinent rules and
 10 regulations promulgated pursuant thereto, and as otherwise provided by state law and regulations, as all
 11 may now exist or be hereafter amended or changed. For the purpose of this Nondiscrimination
 12 paragraph, discrimination includes, but is not limited to the following based on one or more of the
 13 factors identified above:

- 14 1. Denying a Client or potential Client any service, benefit, or accommodation.
- 15 2. Providing any service or benefit to a Client which is different or is provided in a different
 16 manner or at a different time from that provided to other Clients.
- 17 3. Restricting a Client in any way in the enjoyment of any advantage or privilege enjoyed by
 18 others receiving any service and/or benefit.
- 19 4. Treating a Client differently from others in satisfying any admission requirement or
 20 condition, or eligibility requirement or condition, which individuals must meet in order to be provided
 21 any service and/or benefit.
- 22 5. Assignment of times or places for the provision of services.

23 C. COMPLAINT PROCESS – CONTRACTOR shall establish procedures for advising all Clients
 24 through a written statement that CONTRACTOR’s and/or subcontractor’s Clients may file all
 25 complaints alleging discrimination in the delivery of services with CONTRACTOR, subcontractor, and
 26 ADMINISTRATOR.

27 1. Whenever possible, problems shall be resolved informally and at the point of service.
 28 CONTRACTOR shall establish an internal informal problem resolution process for Clients not able to

3 E. RETALIATION – Neither CONTRACTOR nor subcontractor, nor its employees or agents shall

35 If the contracting party is a corporation, two (2) signatures are required: one (1) signature by the Chairman of the Board, the
36 President or any Vice President; and one (1) signature by the Secretary, any Assistant Secretary, the Chief Financial Officer
37 or any Assistant Treasurer. If the contract is signed by one (1) authorized individual only, a copy of the corporate resolution
or by-laws whereby the Board of Directors has empowered said authorized individual to act on its behalf by his or her
signature alone is required by ADMINISTRATOR.

I. AUTHORIZED AGENCIES

A. Agencies authorized to request services pursuant to the Contract are the following:

1. The Orange County Sheriff as to Persons described in Subparagraphs IV. A, IV.B, IV.D, and IV.I of this Exhibit A.
2. The law enforcement agency which has made an arrest of a Person described in Subparagraph IV.B of this Exhibit A.
3. The Orange County Probation Department and the Social Services Agency as to Persons described in Subparagraph IV.C of this Exhibit A.
4. The Behavioral Health Care Services Function of the Orange County Health Care Agency as to Persons described in Subparagraphs IV.D, IV.E, IV.H, and IV.K of this Exhibit A.
5. The Orange County Public Defender as to Persons described in Subparagraph IV.F of this Exhibit A.
6. The Orange County Public Guardian as to Persons described in Subparagraph IV.G of this Exhibit A.
7. The Public Health Services Function of the Orange County Health Care Agency as to Persons described in Subparagraph IV.J of this Exhibit A.
8. The Orange County Fire Authority which dispatches medical transportation on behalf of any authorized agency.

B. CONTRACTOR shall be responsible for ascertaining the identity of Persons requesting services pursuant to the Contract and their position with the agencies listed above as being authorized signers pursuant to the Authorized Signature List. COUNTY shall have no responsibility for the transportation of Persons where agencies other than the above request such service.

C. CONTRACTOR shall be responsible for obtaining the Authorization for Medical Transportation form filled out with all information from the service requester at the time of service. If the form is not obtained, CONTRACTOR may not bill COUNTY or patient for the services.

II. AVAILABILITY OF SERVICES

CONTRACTOR agrees to provide the services specified in this Exhibit A to the Contract.

A. AMBULANCE SERVICES

1. If CONTRACTOR agrees to provide ambulance services, CONTRACTOR agrees to keep ambulance equipment available on a twenty-four (24)-hour basis and to respond with its own equipment

1 to all calls made pursuant to the Contract. However, when CONTRACTOR's own equipment is not
 2 available by reason of prior use or for any reason beyond the control of the CONTRACTOR, such fact
 3 will be immediately made known to the Person or agency requesting the service so that alternate
 4 arrangements may be made to provide the requested transportation. CONTRACTOR shall not refer the
 5 request to another service provider.

6 2. CONTRACTOR shall communicate to the designated authorized signer at the Authorized
 7 Agency prior to placing any Person in soft restraints of such intent.

8 3. Reimbursement for Ambulance services provided pursuant to the Contract shall be as
 9 specified in Exhibit B to the Contract.

10 B. ADMINISTRATOR shall distribute on a monthly basis a Rotation Schedule which shall be
 11 used to determine which CONTRACTOR will be called first for requested service.

12 **III. DEFINITION OF PERSONS EXCLUDED FROM SERVICE**

13 Persons to whom service has been provided through use of 911 dispatches are not covered under
 14 this Contract.
 15

16 **IV. DEFINITION OF PERSONS TO BE SERVED**

17 COUNTY shall be responsible for services provided to the following Persons only:

18 A. Persons in the custody of the Orange County Sheriff by reason of the alleged commission or the
 19 conviction of a crime.
 20

21 B. Persons arrested by any law enforcement agency for a violation of any provisions of the laws of
 22 the State of California or County Ordinances which are made a crime and where the proper place for
 23 detention is in the custody of the Orange County Sheriff.

24 C. Juveniles residing in or being transported to or from a COUNTY juvenile institution.

25 D. Persons detained by Orange County Behavioral Health Care Services Function clinical
 26 Personnel or the Orange County Sheriff pursuant to Welfare and Institutions Code Section 5150 for
 27 transportation to an evaluation and treatment facility.

28 E. Persons who are the responsibility of COUNTY under the Lanterman-Petris-Short Act or the
 29 Short-Doyle Act, Welfare and Institutions Code Sections 5000-58001 and who require transportation
 30 between one mental health facility and another mental health facility, or between a mental health facility
 31 and a health facility.

32 F. Persons who are clients of the Orange County Public Defender and who require transportation
 33 to or from court in connection with conservatorship proceedings.

34 G. Persons who are conservatees of the Orange County Public Guardian and who require
 35 transportation to or from court in connection with conservatorship proceedings.

36 H. Persons in a COUNTY-operated Drug or Alcohol Program or COUNTY-contracted Drug or
 37 Alcohol Residential Treatment Program and who require transportation to or from a COUNTY-operated

1 Drug or Alcohol Program, COUNTY-contracted Drug or Alcohol Residential Treatment Program, a
2 mental health or health treatment facility.

3 I. Persons for whom transportation services have been requested by the Orange County Sheriff
4 pursuant to California Government Code Section 26612.

5 J. Persons who, while attending an Orange County Public Health Clinic, experience an
6 anaphylactic reaction to treatment or other factor related to the COUNTY's medical management of the
7 patient and requires emergency transportation to a hospital or non-emergency transportation to an
8 alternate location determined by COUNTY.

9 K. Persons for whom transportation services have been requested by Orange County Behavioral
10 Health Care Services Function clinical personnel or Correctional Health Services personnel for
11 transportation to an inpatient mental health facility, other mental health facilities, or a health facility.

12 **V. DEFINITION OF SERVICE CATEGORIES**

13
14 A. Emergency Service shall mean any sudden or serious illness or injury requiring immediate
15 medical attention, where delay in providing such services may aggravate the medical condition or cause
16 the loss of life. Emergency Service shall be determined by the requesting agency and communicated to
17 the CONTRACTOR at the time of the request for service.

18 1. Performance Requirements

19 a. CONTRACTOR must arrive on site as quickly as possible and in no event longer than
20 thirty (30) minutes; provided, however, that where the service is provided to Persons described in
21 Paragraph IV to this Exhibit A to the Contract, the requesting agency may permit a forty-five (45)
22 minute response time when the incident is unaccompanied by any life-threatening medical emergency.
23 The determination by COUNTY as to whether or not a particular incident requires emergency service
24 shall be binding on COUNTY and CONTRACTOR.

25 1) CONTRACTOR must meet response times at a minimum of eighty-five (85)
26 percent of the time for high volume service areas as determined by ADMINISTRATOR.

27 2) CONTRACTOR must meet response times at a minimum of seventy (70) percent
28 of the time for low volume service areas as determined by ADMINISTRATOR.

29 b. CONTRACTOR shall not exceed ten (10) Denial of Transport Requests in a single
30 month.

31 1) Denial of Transport Request means all instances where CONTRACTOR:

- 32 a) Denies requesting agency's transport request,
33 b) Provides an estimated time of arrival (ETA) that does not meet the needs of the
34 requesting agency,
35 c) Does not have vehicles available at the time of request,
36 d) Cancels a scheduled transport, or
37 e) Fails to appear for scheduled transport.

1 c. At ADMINISTRATOR's discretion, ADMINISTRATOR reserves the right to develop
2 a corrective action plan, remove CONTRACTOR from call list, or terminate the Contract per Article
3 XXVI of the Contract in response to CONTRACTOR's non-compliance.

4 C. Dry Run shall occur whenever an authorized agency has requested medical transportation
5 service for Persons to be served and, for whatever reason, after CONTRACTOR responds,
6 CONTRACTOR's services are not required.

7 D. Night Rate payment will be authorized by COUNTY whenever the request for such service
8 occurs after 7 p.m. in the evening and before 7 a.m. in the morning.

9 E. Multiple Passengers means that more than one patient is transported on the same request for
10 services. Multiple passenger bills shall be submitted on County Form F272-01.1841 and attached
11 together in order to preclude the possibility of billing mileage more than once for one (1) authorized
12 request for services.

13 **VI. LICENCES**

14 CONTRACTOR shall maintain and provide to ADMINISTRATOR, an updated list of cities and
15 corresponding licenses in which CONTRACTOR is licensed to pick up patients semi-annually.
16

17 **VII. PAYMENTS**

18 A. CONTRACTOR shall submit invoices for completed runs in the form and manner required by
19 ADMINISTRATOR and in no event later than nine (9) months following provision of the service.
20 CONTRACTOR shall submit the following:
21

- 22 1. Original Bill to COUNTY for Medical Transportation;
- 23 2. Authorization for Medical Transportation form with original or digital signature;
- 24 3. Copy of Medi-Cal or insurance denial, if applicable.

25 B. CONTRACTOR shall make a reasonable effort to collect reimbursement from Medi-Cal,
26 Medicare, or any third party insurance carrier for the service provided before billing COUNTY.
27 Notwithstanding the foregoing, no collection attempts from the patient shall be made if the COUNTY
28 representative authorized to order the medical transportation certifies on the Medical Transportation
29 form that the patient is a Behavioral Health Care patient, as specified in Subparagraphs IV.D., IV.E.,
30 IV.H., and IV.K., of this Exhibit A, and has no financial liability for the service. CONTRACTOR shall
31 not contract for, or otherwise utilize; collection agents, collection agencies, or other organizations or
32 individuals to secure payment for services rendered to Persons transported under Subparagraphs IV.D.,
33 IV.E., IV.F., IV.G., IV.H., and IV.K. of this Exhibit A to the Contract. All collection efforts shall be
34 conducted by Persons directly and solely responsible to, and on the paid staff of, the CONTRACTOR.

35 C. CONTRACTOR may request information from COUNTY concerning addresses of Persons
36 transported by CONTRACTOR and such Person's current eligibility for Federal or State benefits in
37 connection with such transportation only where transportation has been provided to a Person under one

1 of the defined Service Categories in Subparagraph V. of this Exhibit A of the Contract at the request of
 2 an Authorized Agency.

4 **VIII. REIMBURSEMENT**

5 A. COUNTY shall compensate CONTRACTOR, and CONTRACTOR agrees to provide the
 6 services, staffing, any equipment and supplies, and reports in accordance with Exhibit A to this
 7 Contract. CONTRACTOR shall operate continuously throughout the term of this Contract with at least
 8 the minimum number and type of staff which meet applicable state and federal requirements, and which
 9 are necessary for the provision of the services hereunder. COUNTY shall reimburse CONTRACTOR
 10 for services provided to Persons identified in Subparagraph IV of this Exhibit A, less revenue from any
 11 other source, within forty-five (45) days after receipt of approved invoices and required supporting
 12 documentation submitted within the time limit set forth in Subparagraph IV. Reimbursement shall be
 13 made in accordance with the rates set forth in Exhibit B to the Contract. COUNTY shall have no
 14 obligation to process or pay invoices which are not submitted within such time limits, as stated in
 15 Subparagraph VII. A of this Exhibit A to the Contract. CONTRACTOR shall comply with the invoice
 16 submittal process established by ADMINISTRATOR.

17 B. All payments made to CONTRACTOR by or on behalf of a Person transported shall be credited
 18 to said Person's account and the liability of COUNTY shall be decreased by a like amount.

19 1. If any payment is received by CONTRACTOR from or on behalf of a Person to or for
 20 whom services were rendered by CONTRACTOR, and CONTRACTOR has previously been paid by
 21 COUNTY, within thirty (30) days of receipt CONTRACTOR shall refund to COUNTY an amount not
 22 to exceed the total amount previously paid by COUNTY. COUNTY may deduct these amounts from
 23 any sums due to CONTRACTOR from future billings.

24 2. Upon submission of invoices to COUNTY as provided herein, CONTRACTOR agrees to
 25 cease all further attempts at collection from the Person transported, his estate, or Persons legally liable
 26 for the cost of such medical transportation service.

27 3. CONTRACTOR shall maintain on a monthly basis, financial records to include the
 28 following information for all ambulance trips made under the Contract:

- 29 a. Patient's name
- 30 b. Date of trip
- 31 c. Pick-up and drop-off times
- 32 d. Pick-up location and destination
- 33 e. Amount billed
- 34 f. Amount collected
- 35 g. Source of revenue: COUNTY; private provider; Medi-Cal; Medicare
- 36 h. Amount to be refunded to COUNTY if payment was made by COUNTY prior to

37 CONTRACTOR receiving payment from any other source.

C. CONTRACTOR shall receive no reimbursement for Dry Runs.

D. Unlisted supplies provided in service of the Contract must be itemized when billed for with an attached manufacturer or supplier invoice showing the wholesale price. An internal company invoice or catalog page shall not be accepted, and such costs shall be deducted from the invoice. The contents of any kit billed for must be listed in the Other "itemized" field of the COUNTY billing form (F272-01.1846.3). Identify items billed on the invoice with an underline, check mark or circle, or the claim may be denied for inadequate documentation.

E. All appeals to reimbursements must be made within thirty (30) days of the date of the subject reimbursement check; after which such reimbursements provided by COUNTY shall be final and not subject to appeal.

F. CONTRACTOR and ADMINISTRATOR may mutually agree in writing to allow CONTRACTOR to submit supplemental invoices for services provided to a Person for whom contracted Medi-Cal rates are not set forth in this Contract.

G. ADMINISTRATOR has sole discretion to negotiate rates on an as needed basis upon mutual contract between ADMINISTRATOR and CONTRACTOR.

IX. REPORTS

A. CONTRACTOR shall submit, on forms provided or approved by ADMINISTRATOR, financial and/or programmatic reports as requested by ADMINISTRATOR concerning CONTRACTOR's activities as they relate to this Contract. ADMINISTRATOR will be specific as to the nature of the information requested and allow thirty (30) calendar days for CONTRACTOR to respond.

B. ADMINISTRATOR and CONTRACTOR may mutually agree, in writing, to modify the Reports Paragraph of this Exhibit A to the Contract.

X. SPECIFIC SERVICES

CONTRACTOR agrees to provide the following medical transportation services pursuant to the terms and conditions specified in the Contract for Provision of Medical Transportation Services by and between COUNTY and CONTRACTOR dated July 1, 2019 as hereinafter indicated. CONTRACTOR and COUNTY may mutually agree, in writing, to add or delete services to be provided by CONTRACTOR as follows at the rates specified below:

I. BUSINESS ASSOCIATE CONTRACT

A. GENERAL PROVISIONS AND RECITALS

1. The parties agree that the terms used, but not otherwise defined below in Paragraph B, shall have the same meaning given to such terms under the Health Insurance Portability and Accountability Act of 1996, Public Law 104-191 (“HIPAA”), the Health Information Technology for Economic and Clinical Health Act, Public Law 111-005 (“the HITECH Act”), and their implementing regulations at 45 CFR Parts 160 and 164 (“the HIPAA regulations”) as they may exist now or be hereafter amended.

2. The parties agree that a business associate relationship under HIPAA, the HITECH Act, and the HIPAA regulations between the CONTRACTOR and COUNTY arises to the extent that CONTRACTOR performs, or delegates to subcontractors to perform, functions or activities on behalf of COUNTY pursuant to, and as set forth in, the Contract that are described in the definition of “Business Associate” in 45 CFR § 160.103.

3. The COUNTY wishes to disclose to CONTRACTOR certain information pursuant to the terms of the Contract, some of which may constitute Protected Health Information (“PHI”), as defined below in Subparagraph B.10, to be used or disclosed in the course of providing services and activities pursuant to, and as set forth, in the Contract.

4. The parties intend to protect the privacy and provide for the security of PHI that may be created, received, maintained, transmitted, used, or disclosed pursuant to the Contract in compliance with the applicable standards, implementation specifications, and requirements of HIPAA, the HITECH Act, and the HIPAA regulations as they may exist now or be hereafter amended.

5. The parties understand and acknowledge that HIPAA, the HITECH Act, and the HIPAA regulations do not pre-empt any state statutes, rules, or regulations that are not otherwise pre-empted by other Federal law(s) and impose more stringent requirements with respect to privacy of PHI.

6. The parties understand that the HIPAA Privacy and Security rules, as defined below in Subparagraphs B.9. and B.14., apply to the CONTRACTOR in the same manner as they apply to a covered entity (COUNTY). CONTRACTOR agrees therefore to be in compliance at all times with the terms of this Business Associate Contract, as it exists now or be hereafter updated with notice to CONTRACTOR, and the applicable standards, implementation specifications, and requirements of the Security rules, as they may exist now or be hereafter amended, with respect to PHI and electronic PHI created, received, maintained, transmitted, used, or disclosed pursuant to the Contract.

1 B. DEFINITIONS

2 1. "Administrative Safeguards" are administrative actions, and policies and procedures, to
3 manage the selection, development, implementation, and maintenance of security measures to protect
4 electronic PHI and to manage the conduct of CONTRACTOR's workforce in relation to the protection
5 of that information.

6 2. "Breach" means the acquisition, access, use, or disclosure of PHI in a manner not permitted
7 under the HIPAA Privacy Rule which compromises the security or privacy of the PHI.

8 a. Breach excludes:

9 1) Any unintentional acquisition, access, or use of PHI by a workforce member or
10 person acting under the authority of CONTRACTOR or COUNTY, if such acquisition, access, or use
11 was made in good faith and within the scope of authority and does not result in further use or disclosure
12 in a manner not permitted under the Privacy Rule.

13 2) Any inadvertent disclosure by a person who is authorized to access PHI at
14 CONTRACTOR to another person authorized to access PHI at the CONTRACTOR, or organized health
15 care arrangement in which COUNTY participates, and the information received as a result of such
16 disclosure is not further used or disclosed in a manner not permitted under the HIPAA Privacy Rule.

17 3) A disclosure of PHI where CONTRACTOR or COUNTY has a good faith belief
18 that an unauthorized person to whom the disclosure was made would not reasonably have been able to
19 retain such information.

20 b. Except as provided in paragraph (a) of this definition, an acquisition, access, use, or
21 disclosure of PHI in a manner not permitted under the HIPAA Privacy Rule is presumed to be a breach
22 unless CONTRACTOR demonstrates that there is a low probability that the PHI has been compromised
23 based on a risk assessment of at least the following factors:

24 1) The nature and extent of the PHI involved, including the types of identifiers and the
25 likelihood of re-identification;

26 2) The unauthorized person who used the PHI or to whom the disclosure was made;

27 3) Whether the PHI was actually acquired or viewed; and

28 4) The extent to which the risk to the PHI has been mitigated.

29 3. "Data Aggregation" shall have the meaning given to such term under the HIPAA Privacy
30 Rule in 45 CFR § 164.501.

31 4. "Designated Record Set" shall have the meaning given to such term under the HIPAA
32 Privacy Rule in 45 CFR § 164.501.

33 5. "Disclosure" shall have the meaning given to such term under the HIPAA regulations in 45
34 CFR § 160.103.

35 6. "Health Care Operations" shall have the meaning given to such term under the HIPAA
36 Privacy Rule in 45 CFR § 164.501.

37 //

1 7. “Individual” shall have the meaning given to such term under the HIPAA Privacy Rule in
2 45 CFR § 160.103 and shall include a person who qualifies as a personal representative in accordance
3 with 45 CFR § 164.502(g).

4 8. “Physical Safeguards” are physical measures, policies, and procedures to protect
5 CONTRACTOR’s electronic information systems and related buildings and equipment, from natural
6 and environmental hazards, and unauthorized intrusion.

7 9. “The HIPAA Privacy Rule” shall mean the Standards for Privacy of Individually
8 Identifiable Health Information at 45 CFR Part 160 and Part 164, Subparts A and E.

9 10. “Protected Health Information” or “PHI” shall have the meaning given to such term under
10 the HIPAA regulations in 45 CFR § 160.103.

11 11. “Required by Law” shall have the meaning given to such term under the HIPAA Privacy
12 Rule in 45 CFR § 164.103.

13 12. “Secretary” shall mean the Secretary of the Department of Health and Human Services or
14 his or her designee.

15 13. “Security Incident” means attempted or successful unauthorized access, use, disclosure,
16 modification, or destruction of information or interference with system operations in an information
17 system. “Security incident” does not include trivial incidents that occur on a daily basis, such as scans,
18 “pings”, or unsuccessful attempts to penetrate computer networks or servers maintained by
19 CONTRACTOR.

20 14. “The HIPAA Security Rule” shall mean the Security Standards for the Protection of
21 electronic PHI at 45 CFR Part 160, Part 162, and Part 164, Subparts A and C.

22 15. “Subcontractor” shall have the meaning given to such term under the HIPAA regulations in
23 45 CFR § 160.103.

24 16. “Technical safeguards” means the technology and the policy and procedures for its use that
25 protect electronic PHI and control access to it.

26 17. “Unsecured PHI” or “PHI that is unsecured” means PHI that is not rendered unusable,
27 unreadable, or indecipherable to unauthorized individuals through the use of a technology or
28 methodology specified by the Secretary of Health and Human Services in the guidance issued on the
29 HHS Web site.

30 18. “Use” shall have the meaning given to such term under the HIPAA regulations in
31 45 CFR § 160.103.

32 C. OBLIGATIONS AND ACTIVITIES OF CONTRACTOR AS BUSINESS ASSOCIATE:

33 1. CONTRACTOR agrees not to use or further disclose PHI COUNTY discloses to
34 CONTRACTOR other than as permitted or required by this Business Associate Contract or as required
35 by law.

36 2. CONTRACTOR agrees to use appropriate safeguards, as provided for in this Business
37 Associate Contract and the Contract, to prevent use or disclosure of PHI COUNTY discloses to

1 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY
2 other than as provided for by this Business Associate Contract.

3 3. CONTRACTOR agrees to comply with the HIPAA Security Rule at Subpart C of 45 CFR
4 Part 164 with respect to electronic PHI COUNTY discloses to CONTRACTOR or CONTRACTOR
5 creates, receives, maintains, or transmits on behalf of COUNTY.

6 4. CONTRACTOR agrees to mitigate, to the extent practicable, any harmful effect that is
7 known to CONTRACTOR of a Use or Disclosure of PHI by CONTRACTOR in violation of the
8 requirements of this Business Associate Contract.

9 5. CONTRACTOR agrees to report to COUNTY immediately any Use or Disclosure of PHI
10 not provided for by this Business Associate Contract of which CONTRACTOR becomes aware.
11 CONTRACTOR must report Breaches of Unsecured PHI in accordance with Paragraph E below and as
12 required by 45 CFR § 164.410.

13 6. CONTRACTOR agrees to ensure that any Subcontractors that create, receive, maintain, or
14 transmit PHI on behalf of CONTRACTOR agree to the same restrictions and conditions that apply
15 through this Business Associate Contract to CONTRACTOR with respect to such information.

16 7. CONTRACTOR agrees to provide access, within fifteen (15) calendar days of receipt of a
17 written request by COUNTY, to PHI in a Designated Record Set, to COUNTY or, as directed by
18 COUNTY, to an Individual in order to meet the requirements under 45 CFR § 164.524.

19 8. CONTRACTOR agrees to make any amendment(s) to PHI in a Designated Record Set that
20 COUNTY directs or agrees to pursuant to 45 CFR § 164.526 at the request of COUNTY or an
21 Individual, within thirty (30) calendar days of receipt of said request by COUNTY. CONTRACTOR
22 agrees to notify COUNTY in writing no later than ten (10) calendar days after said amendment is
23 completed.

24 9. CONTRACTOR agrees to make internal practices, books, and records, including policies
25 and procedures, relating to the use and disclosure of PHI received from, or created or received by
26 CONTRACTOR on behalf of, COUNTY available to COUNTY and the Secretary in a time and manner
27 as determined by COUNTY or as designated by the Secretary for purposes of the Secretary determining
28 COUNTY's compliance with the HIPAA Privacy Rule.

29 10. CONTRACTOR agrees to document any Disclosures of PHI COUNTY discloses to
30 CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of COUNTY,
31 and to make information related to such Disclosures available as would be required for COUNTY to
32 respond to a request by an Individual for an accounting of Disclosures of PHI in accordance with 45
33 CFR § 164.528.

34 11. CONTRACTOR agrees to provide COUNTY or an Individual, as directed by COUNTY, in
35 a time and manner to be determined by COUNTY, that information collected in accordance with the
36 Contract, in order to permit COUNTY to respond to a request by an Individual for an accounting of
37 Disclosures of PHI in accordance with 45 CFR § 164.528.

1 12. CONTRACTOR agrees that to the extent CONTRACTOR carries out COUNTY's
2 obligation under the HIPAA Privacy and/or Security rules CONTRACTOR will comply with the
3 requirements of 45 CFR Part 164 that apply to COUNTY in the performance of such obligation.

4 13. CONTRACTOR shall work with COUNTY upon notification by CONTRACTOR to
5 COUNTY of a Breach to properly determine if any Breach exclusions exist as defined in Subparagraph
6 B.2.a. above.

7 D. SECURITY RULE

8 1. CONTRACTOR shall comply with the requirements of 45 CFR § 164.306 and establish
9 and maintain appropriate Administrative, Physical and Technical Safeguards in accordance with
10 45 CFR § 164.308, § 164.310, § 164.312, and § 164.316 with respect to electronic PHI COUNTY
11 discloses to CONTRACTOR or CONTRACTOR creates, receives, maintains, or transmits on behalf of
12 COUNTY. CONTRACTOR shall follow generally accepted system security principles and the
13 requirements of the HIPAA Security Rule pertaining to the security of electronic PHI.

14 2. CONTRACTOR shall ensure that any subcontractors that create, receive, maintain, or
15 transmit electronic PHI on behalf of CONTRACTOR agree through a contract with CONTRACTOR to
16 the same restrictions and requirements contained in this Paragraph D of this Business Associate
17 Contract.

18 3. CONTRACTOR shall report to COUNTY immediately any Security Incident of which it
19 becomes aware. CONTRACTOR shall report Breaches of Unsecured PHI in accordance with
20 Subparagraph E. below and as required by 45 CFR § 164.410.

21 E. BREACH DISCOVERY AND NOTIFICATION

22 1. Following the discovery of a Breach of Unsecured PHI, CONTRACTOR shall notify
23 COUNTY of such Breach, however both parties agree to a delay in the notification if so advised by a
24 law enforcement official pursuant to 45 CFR § 164.412.

25 a. A Breach shall be treated as discovered by CONTRACTOR as of the first day on which
26 such Breach is known to CONTRACTOR or, by exercising reasonable diligence, would have been
27 known to CONTRACTOR.

28 b. CONTRACTOR shall be deemed to have knowledge of a Breach, if the Breach is
29 known, or by exercising reasonable diligence would have known, to any person who is an employee,
30 officer, or other agent of CONTRACTOR, as determined by federal common law of agency.

31 2. CONTRACTOR shall provide the notification of the Breach immediately to the County
32 Privacy Officer. CONTRACTOR's notification may be oral, but shall be followed by written
33 notification within 24 hours of the oral notification.

34 3. CONTRACTOR's notification shall include, to the extent possible:

35 a. The identification of each Individual whose Unsecured PHI has been, or is reasonably
36 believed by CONTRACTOR to have been, accessed, acquired, used, or disclosed during the Breach;

37

1 b. Any other information that COUNTY is required to include in the notification to
2 Individual under 45 CFR §164.404 (c) at the time CONTRACTOR is required to notify COUNTY or
3 promptly thereafter as this information becomes available, even after the regulatory sixty (60) day
4 period set forth in 45 CFR § 164.410 (b) has elapsed, including:

5 1) A brief description of what happened, including the date of the Breach and the date
6 of the discovery of the Breach, if known;

7 2) A description of the types of Unsecured PHI that were involved in the Breach (such
8 as whether full name, social security number, date of birth, home address, account number, diagnosis,
9 disability code, or other types of information were involved);

10 3) Any steps Individuals should take to protect themselves from potential harm
11 resulting from the Breach;

12 4) A brief description of what CONTRACTOR is doing to investigate the Breach, to
13 mitigate harm to Individuals, and to protect against any future Breaches; and

14 5) Contact procedures for Individuals to ask questions or learn additional information,
15 which shall include a toll-free telephone number, an e-mail address, Web site, or postal address.

16 4. COUNTY may require CONTRACTOR to provide notice to the Individual as required in
17 45 CFR § 164.404, if it is reasonable to do so under the circumstances, at the sole discretion of the
18 COUNTY.

19 5. In the event that CONTRACTOR is responsible for a Breach of Unsecured PHI in violation
20 of the HIPAA Privacy Rule, CONTRACTOR shall have the burden of demonstrating that
21 CONTRACTOR made all notifications to COUNTY consistent with this Paragraph E and as required by
22 the Breach notification regulations, or, in the alternative, that the acquisition, access, use, or disclosure
23 of PHI did not constitute a Breach.

24 6. CONTRACTOR shall maintain documentation of all required notifications of a Breach or
25 its risk assessment under 45 CFR § 164.402 to demonstrate that a Breach did not occur.

26 7. CONTRACTOR shall provide to COUNTY all specific and pertinent information about the
27 Breach, including the information listed in Section E.3.b.(1)-(5) above, if not yet provided, to permit
28 COUNTY to meet its notification obligations under Subpart D of 45 CFR Part 164 as soon as
29 practicable, but in no event later than fifteen (15) calendar days after CONTRACTOR's initial report of
30 the Breach to COUNTY pursuant to Subparagraph E.2 above.

31 8. CONTRACTOR shall continue to provide all additional pertinent information about the
32 Breach to COUNTY as it may become available, in reporting increments of five (5) business days after
33 the last report to COUNTY. CONTRACTOR shall also respond in good faith to any reasonable
34 requests for further information, or follow-up information after report to COUNTY, when such request
35 is made by COUNTY.

36 9. If the Breach is the fault of CONTRACTOR, CONTRACTOR shall bear all expense or
37 other costs associated with the Breach and shall reimburse COUNTY for all expenses COUNTY incurs

1 in addressing the Breach and consequences thereof, including costs of investigation, notification,
2 remediation, documentation or other costs associated with addressing the Breach.

3 F. PERMITTED USES AND DISCLOSURES BY CONTRACTOR

4 1. CONTRACTOR may use or further disclose PHI COUNTY discloses to CONTRACTOR
5 as necessary to perform functions, activities, or services for, or on behalf of, COUNTY as specified in
6 the Contract, provided that such use or Disclosure would not violate the HIPAA Privacy Rule if done by
7 COUNTY except for the specific Uses and Disclosures set forth below.

8 a. CONTRACTOR may use PHI COUNTY discloses to CONTRACTOR, if necessary,
9 for the proper management and administration of CONTRACTOR.

10 b. CONTRACTOR may disclose PHI COUNTY discloses to CONTRACTOR for the
11 proper management and administration of CONTRACTOR or to carry out the legal responsibilities of
12 CONTRACTOR, if:

13 1) The Disclosure is required by law; or

14 2) CONTRACTOR obtains reasonable assurances from the person to whom the PHI
15 is disclosed that it will be held confidentially and used or further disclosed only as required by law or for
16 the purposes for which it was disclosed to the person and the person immediately notifies
17 CONTRACTOR of any instance of which it is aware in which the confidentiality of the information has
18 been breached.

19 c. CONTRACTOR may use or further disclose PHI COUNTY discloses to
20 CONTRACTOR to provide Data Aggregation services relating to the Health Care Operations of
21 CONTRACTOR.

22 2. CONTRACTOR may use PHI COUNTY discloses to CONTRACTOR, if necessary, to
23 carry out legal responsibilities of CONTRACTOR.

24 3. CONTRACTOR may use and disclose PHI COUNTY discloses to CONTRACTOR
25 consistent with the minimum necessary policies and procedures of COUNTY.

26 4. CONTRACTOR may use or disclose PHI COUNTY discloses to CONTRACTOR as
27 required by law.

28 G. OBLIGATIONS OF COUNTY

29 1. COUNTY shall notify CONTRACTOR of any limitation(s) in COUNTY's notice of
30 privacy practices in accordance with 45 CFR § 164.520, to the extent that such limitation may affect
31 CONTRACTOR's Use or Disclosure of PHI.

32 2. COUNTY shall notify CONTRACTOR of any changes in, or revocation of, the permission
33 by an Individual to use or disclose his or her PHI, to the extent that such changes may affect
34 CONTRACTOR's Use or Disclosure of PHI.

35 3. COUNTY shall notify CONTRACTOR of any restriction to the Use or Disclosure of PHI
36 that COUNTY has agreed to in accordance with 45 CFR § 164.522, to the extent that such restriction
37 may affect CONTRACTOR's Use or Disclosure of PHI.

1 4. COUNTY shall not request CONTRACTOR to use or disclose PHI in any manner that
2 would not be permissible under the HIPAA Privacy Rule if done by COUNTY.

3 H. BUSINESS ASSOCIATE TERMINATION

4 1. Upon COUNTY's knowledge of a material breach or violation by CONTRACTOR of the
5 requirements of this Business Associate Contract, COUNTY shall:

6 a. Provide an opportunity for CONTRACTOR to cure the material breach or end the
7 violation within thirty (30) business days; or

8 b. Immediately terminate the Contract, if CONTRACTOR is unwilling or unable to cure
9 the material breach or end the violation within (30) days, provided termination of the Contract is
10 feasible.

11 2. Upon termination of the Contract, CONTRACTOR shall either destroy or return to
12 COUNTY all PHI CONTRACTOR received from COUNTY or CONTRACTOR created, maintained,
13 or received on behalf of COUNTY in conformity with the HIPAA Privacy Rule.

14 a. This provision shall apply to all PHI that is in the possession of Subcontractors or
15 agents of CONTRACTOR.

16 b. CONTRACTOR shall retain no copies of the PHI.

17 c. In the event that CONTRACTOR determines that returning or destroying the PHI is not
18 feasible, CONTRACTOR shall provide to COUNTY notification of the conditions that make return or
19 destruction infeasible. Upon determination by COUNTY that return or destruction of PHI is infeasible,
20 CONTRACTOR shall extend the protections of this Business Associate Contract to such PHI and limit
21 further Uses and Disclosures of such PHI to those purposes that make the return or destruction
22 infeasible, for as long as CONTRACTOR maintains such PHI.

23 3. The obligations of this Business Associate Contract shall survive the termination of the
24 Contract.

EXHIBIT C

I. PERSONAL INFORMATION PRIVACY AND SECURITY CONTRACT

Any reference to statutory, regulatory, or contractual language herein shall be to such language as in effect or as amended.

A. DEFINITIONS

1. "Breach" shall have the meaning given to such term under the IEA and CMPPA. It shall include a "PII loss" as that term is defined in the CMPPA.

2. "Breach of the security of the system" shall have the meaning given to such term under the California Information Practices Act, Civil Code § 1798.29(d).

3. "CMPPA Agreement" means the Computer Matching and Privacy Protection Act Agreement between the Social Security Administration and the California Health and Human Services Agency (CHHS).

4. "DHCS PI" shall mean Personal Information, as defined below, accessed in a database maintained by the COUNTY or California Department of Health Care Services (DHCS), received by CONTRACTOR from the COUNTY or DHCS or acquired or created by CONTRACTOR in connection with performing the functions, activities and services specified in the Contract on behalf of the COUNTY.

5. "IEA" shall mean the Information Exchange Agreement currently in effect between the Social Security Administration (SSA) and DHCS.

6. "Notice-triggering Personal Information" shall mean the personal information identified in Civil Code section 1798.29(e) whose unauthorized access may trigger notification requirements under Civil Code § 1709.29. For purposes of this provision, identity shall include, but not be limited to, name, identifying number, symbol, or other identifying particular assigned to the individual, such as a finger or voice print, a photograph or a biometric identifier. Notice-triggering Personal Information includes PI in electronic, paper or any other medium.

7. "Personally Identifiable Information" (PII) shall have the meaning given to such term in the IEA and CMPPA.

8. "Personal Information" (PI) shall have the meaning given to such term in California Civil Code § 1798.3(a).

9. "Required by law" means a mandate contained in law that compels an entity to make a use or disclosure of PI or PII that is enforceable in a court of law. This includes, but is not limited to, court orders and court-ordered warrants, subpoenas or summons issued by a court, grand jury, a governmental

1 or tribal inspector general, or an administrative body authorized to require the production of
 2 information, and a civil or an authorized investigative demand. It also includes Medicare conditions of
 3 participation with respect to health care providers participating in the program, and statutes or
 4 regulations that require the production of information, including statutes or regulations that require such
 5 information if payment is sought under a government program providing public benefits.

6 10. "Security Incident" means the attempted or successful unauthorized access, use, disclosure,
 7 modification, or destruction of PI, or confidential data utilized in complying with this Contract; or
 8 interference with system operations in an information system that processes, maintains or stores PI.

9 B. TERMS OF AGREEMENT

10 1. Permitted Uses and Disclosures of DHCS PI and PII by CONTRACTOR. Except as
 11 otherwise indicated in this Exhibit, CONTRACTOR may use or disclose DHCS PI only to perform
 12 functions, activities, or services for or on behalf of the COUNTY pursuant to the terms of the Contract
 13 provided that such use or disclosure would not violate the California Information Practices Act (CIPA)
 14 if done by the COUNTY.

15 2. Responsibilities of CONTRACTOR

16 CONTRACTOR agrees:

17 a. Nondisclosure. Not to use or disclose DHCS PI or PII other than as permitted or
 18 required by this Personal Information Privacy and Security Contract or as required by applicable state
 19 and federal law.

20 b. Safeguards. To implement appropriate and reasonable administrative, technical, and
 21 physical safeguards to protect the security, confidentiality and integrity of DHCS PI and PII, to protect
 22 against anticipated threats or hazards to the security or integrity of DHCS PI and PII, and to prevent use
 23 or disclosure of DHCS PI or PII other than as provided for by this Personal Information Privacy and
 24 Security Contract. CONTRACTOR shall develop and maintain a written information privacy and
 25 security program that include administrative, technical and physical safeguards appropriate to the size
 26 and complexity of CONTRACTOR's operations and the nature and scope of its activities, which
 27 incorporate the requirements of Paragraph (c), below. CONTRACTOR will provide COUNTY with its
 28 current policies upon request.

29 c. Security. CONTRACTOR shall ensure the continuous security of all computerized data
 30 systems containing DHCS PI and PII. CONTRACTOR shall protect paper documents containing
 31 DHCS PI and PII. These steps shall include, at a minimum:

32 1) Complying with all of the data system security precautions listed in Paragraph E of
 33 the Business Associate Contract, Exhibit C to the Contract; and

34 2) Providing a level and scope of security that is at least comparable to the level and
 35 scope of security established by the Office of Management and Budget in OMB Circular No. A-130,
 36 Appendix III-Security of Federal Automated Information Systems, which sets forth guidelines for
 37 automated information systems in Federal agencies.

1 3) If the data obtained by CONTRACTOR from COUNTY includes PII,
 2 CONTRACTOR shall also comply with the substantive privacy and security requirements in the
 3 Computer Matching and Privacy Protection Act Agreement between the SSA and the California Health
 4 and Human Services Agency (CHHS) and in the Agreement between the SSA and DHCS, known as the
 5 Information Exchange Agreement (IEA). The specific sections of the IEA with substantive privacy and
 6 security requirements to be complied with are sections E, F, and G, and in Attachment 4 to the IEA,
 7 Electronic Information Exchange Security Requirements, Guidelines and Procedures for Federal, State
 8 and Local Agencies Exchanging Electronic Information with the SSA. CONTRACTOR also agrees to
 9 ensure that any of CONTRACTOR's agents or subcontractors, to whom CONTRACTOR provides
 10 DHCS PII agree to the same requirements for privacy and security safeguards for confidential data that
 11 apply to CONTRACTOR with respect to such information.

12 d. Mitigation of Harmful Effects. To mitigate, to the extent practicable, any harmful effect
 13 that is known to CONTRACTOR of a use or disclosure of DHCS PI or PII by CONTRACTOR or its
 14 subcontractors in violation of this Personal Information Privacy and Security Contract.

15 e. CONTRACTOR's Agents and Subcontractors. To impose the same restrictions and
 16 conditions set forth in this Personal Information and Security Contract on any subcontractors or other
 17 agents with whom CONTRACTOR subcontracts any activities under the Contract that involve the
 18 disclosure of DHCS PI or PII to such subcontractors or other agents.

19 f. Availability of Information. To make DHCS PI and PII available to the DHCS and/or
 20 COUNTY for purposes of oversight, inspection, amendment, and response to requests for records,
 21 injunctions, judgments, and orders for production of DHCS PI and PII. If CONTRACTOR receives
 22 DHCS PII, upon request by COUNTY and/or DHCS, CONTRACTOR shall provide COUNTY and/or
 23 DHCS with a list of all employees, contractors and agents who have access to DHCS PII, including
 24 employees, contractors and agents of its subcontractors and agents.

25 g. Cooperation with COUNTY. With respect to DHCS PI, to cooperate with and assist the
 26 COUNTY to the extent necessary to ensure the DHCS's compliance with the applicable terms of the
 27 CIPA including, but not limited to, accounting of disclosures of DHCS PI, correction of errors in DHCS
 28 PI, production of DHCS PI, disclosure of a security breach involving DHCS PI and notice of such
 29 breach to the affected individual(s).

30 h. Breaches and Security Incidents. During the term of the Contract, CONTRACTOR
 31 agrees to implement reasonable systems for the discovery of any breach of unsecured DHCS PI and PII
 32 or security incident. CONTRACTOR agrees to give notification of any beach of unsecured DHCS PI
 33 and PII or security incident in accordance with Paragraph F, of the Business Associate Contract,
 34 Exhibit C to the Contract.

35 i. Designation of Individual Responsible for Security. CONTRACTOR shall designate an
 36 individual, (e.g., Security Officer), to oversee its data security program who shall be responsible for
 37 //

1 carrying out the requirements of this Personal Information Privacy and Security Contract and for
2 communicating on security matters with the COUNTY.
